## HOUSE BILL 1266

Read first time 01/22/2003. Referred to Committee on Judiciary.

- AN ACT Relating to vehicular homicide and assault by unlicensed or uninsured drivers; reenacting and amending RCW 9.94A.515 and 9.94A.515; adding new sections to chapter 46.61 RCW; creating a new section; prescribing penalties; providing an effective date; and providing an expiration date.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- NEW SECTION. **Sec. 1.** A new section is added to chapter 46.61 RCW to read as follows:
- 9 VEHICULAR HOMICIDE WITHOUT VALID INSURANCE--PENALTY. (1) When the death of a person ensues within three years as a proximate result of injury proximately caused by the driving of a vehicle by a person, the driver is guilty of vehicular homicide without valid insurance if the driver was operating a motor vehicle without valid insurance as required under chapter 46.30 RCW.
- 15 (2) Vehicular homicide without valid insurance is a class B felony 16 punishable under chapter 9A.20 RCW.
- NEW SECTION. Sec. 2. A new section is added to chapter 46.61 RCW to read as follows:

- VEHICULAR HOMICIDE WITHOUT A VALID DRIVER'S LICENSE--PENALTY. (1)
  When the death of a person ensues within three years as a proximate
  result of injury proximately caused by the driving of a vehicle by a
  person, the driver is guilty of vehicular homicide without a valid
  driver's license if the driver was operating a motor vehicle without a
  valid driver's license as required under chapter 46.20 RCW.
- 7 (2) Vehicular homicide without a valid driver's license is a class 8 B felony punishable under chapter 9A.20 RCW.
- 9 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 46.61 RCW to read as follows:
- VEHICULAR ASSAULT WITHOUT VALID INSURANCE--PENALTY. (1) A person is guilty of vehicular assault without valid insurance if he or she operates or drives a vehicle without valid insurance as required under chapter 46.30 RCW and causes substantial bodily harm to another.
- 15 (2) Vehicular assault without valid insurance is a class C felony 16 punishable under chapter 9A.20 RCW.
- 17 (3) As used in this section, "substantial bodily harm" has the same 18 meaning as in RCW 9A.04.110.
- 19 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 46.61 RCW 20 to read as follows:
- VEHICULAR ASSAULT WITHOUT A VALID DRIVER'S LICENSE--PENALTY. (1)
  A person is guilty of vehicular assault without a valid driver's
  license if he or she operates or drives a vehicle without a valid
  driver's license as required under chapter 46.20 RCW and causes
  substantial bodily harm to another.
- 26 (2) Vehicular assault without a valid driver's license is a class 27 C felony punishable under chapter 9A.20 RCW.
- 28 (3) As used in this section, "substantial bodily harm" has the same 29 meaning as in RCW 9A.04.110.
