- AN ACT Relating to poultry; amending RCW 69.07.100; adding a new

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 43.20 RCW to read as follows:
- Rules adopted by the state board of health, the department of
- 8 health, or a local health jurisdiction, as defined in RCW 43.70.575,
- 9 regulating food or food service establishments do not apply to the
- 10 slaughter and preparation of one thousand or fewer poultry animals in
- 11 a calendar year by the agricultural producer of the poultry for the
- 12 sale of the whole or cut-up raw poultry by the producer directly to
- 13 retail customers, or to such sale. The state board of health, the
- 14 department of health, or a local health jurisdiction, as defined in RCW
- 15 43.70.575, shall not apply such rules directly or indirectly to such an
- 16 activity or sale.
- NEW SECTION. Sec. 2. A new section is added to chapter 16.49 RCW
- 18 to read as follows:

- This chapter does not apply to the slaughter and preparation of one thousand or fewer poultry animals in a calendar year by the agricultural producer of the poultry for the sale of the whole or cutup raw poultry by the producer directly to retail customers or to such a sale.
- 6 **Sec. 3.** RCW 69.07.100 and 2002 c 301 s 10 are each amended to read 7 as follows:
- 8 <u>(1)</u> The provisions of this chapter shall not apply to establishments issued a permit or licensed under the provisions of:
- 10  $((\frac{1}{1}))$  <u>(a)</u> Chapter 69.25 RCW, the Washington wholesome eggs and 11 egg products act;
- 12  $((\frac{2}{2}))$  (b) Chapter 69.28 RCW, the Washington state honey act;
- 13 (((3))) (c) Chapter 16.49 RCW, the meat inspection act;
- 14  $((\frac{4}{1}))$  <u>(d)</u> Chapter 77.65 RCW, relating to the direct retail endorsement for wild-caught seafood;
- 16 (((5))) (e) Title 66 RCW, relating to alcoholic beverage control; 17 and
- $((\frac{(6)}{(6)}))$  (f) Chapter 69.30 RCW, the <u>sanitary</u> control of shellfish act. However, if any such establishments process foods not specifically provided for in the above entitled acts, such establishments shall be subject to the provisions of this chapter.
- 22 (2) The provisions of this chapter shall not apply to:
- 23 (a) Restaurants or food service establishments; and
- 24 (b) The slaughter and preparation of one thousand or fewer poultry
- 25 <u>animals in a calendar year by the agricultural producer of the poultry</u>
- 26 for the sale of the whole or cut-up raw poultry by the producer
- 27 <u>directly to retail customers or to such a sale</u>.
- NEW SECTION. Sec. 4. A new section is added to chapter 69.04 RCW to read as follows:
- This chapter does not apply to the slaughter and preparation of one thousand or fewer poultry animals in a calendar year by the agricultural producer of the poultry for the sale of the whole or cutup raw poultry by the producer directly to retail customers, or to such
