1 AN ACT Relating to school district capital demonstration projects;
2 and amending RCW 39.10.067 and 39.10.902.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 39.10.067 and 2002 c 46 s 3 are each amended to read
5 as follows:

6 In addition to the projects authorized in RCW 39.10.061, public
7 bodies may also use the general contractor/construction manager
8 contracting procedure for the construction of school district capital
9 demonstration projects, subject to the following conditions:

10 (1) The project must receive approval from the school district
11 project review board established under RCW 39.10.115.

12 (2) The school district project review board may not authorize more
13 than ~~((ten))~~ twenty demonstration projects valued over five million
14 dollars, of which ~~((at least))~~ no more than two demonstration projects
15 ~~((must))~~ may be valued between five and ten million dollars.
