- 1 AN ACT Relating to increasing the penalty for intercepting,
- 2 recording, or divulging private communications in executive sessions;
- 3 amending RCW 9.73.080; reenacting and amending RCW 9.94A.515;
- 4 prescribing penalties; and providing an effective date.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 9.73.080 and 2000 c 195 s 3 are each amended to read 7 as follows:
 - (1) Except as otherwise provided in this chapter ((-)):
- 9 (a) Any person who violates RCW 9.73.030 by intercepting or 10 recording communications or conversations in an executive session held
- 11 pursuant to chapter 42.30 RCW is guilty of a class C felony.
- 12 <u>(b) Any person who violates RCW 9.73.030 in a manner other than</u>
- 13 <u>intercepting or recording communications or conversations in an</u>
- 14 <u>executive session held pursuant to chapter 42.30 RCW</u> is guilty of a
- 15 gross misdemeanor.

- 16 (2) Any person who knowingly alters, erases, or wrongfully
- discloses any recording in violation of RCW 9.73.090(1)(c) is guilty of
- 18 a gross misdemeanor.
