AN ACT Relating to the developmental disabilities community trust account; reenacting and amending RCW 43.84.092 and 43.84.092; adding new sections to chapter 71A.20 RCW; creating a new section; providing an effective date; providing an expiration date; and declaring an emergency.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 Sec. 1. The legislature finds that: There are unmet NEW SECTION. 8 needs for community-based services for persons with developmental disabilities and excess resources at residential habilitation centers 9 10 unrelated to current residential habilitation center operations; funding shortfalls in the 2003-2005 biennium and beyond may adversely 11 12 impact the ability of the state to fund programs for growing numbers of with developmental disabilities 13 persons 14 community-based services; and statistics generated by the department of social and health services' division of developmental disabilities 15 demonstrate a growing caseload with insufficient funding and planning 16 to address this growth. 17

The December 4, 2002, capital study of the division of developmental disabilities residential habilitation centers by the

joint legislative audit and review committee identifies options to dispose of excess property at Lakeland Village, Rainier School, and Yakima Valley School that would not impact current residential habilitation center operations.

It is the intent of the legislature to dispose of excess capital properties at residential habilitation centers for persons with developmental disabilities and to place the proceeds from their disposal into a perpetual trust account for unserved persons with developmental disabilities waiting for community-based developmental disability services.

- NEW SECTION. Sec. 2. A new section is added to chapter 71A.20 RCW to read as follows:
 - (1) By December 1, 2004, excess property and harvestable timber identified in the 2002 joint legislative audit and review committee capital study of the division of developmental disabilities residential habilitation centers must be disposed of and the proceeds deposited into the developmental disabilities community trust account. Proceeds from future disposal of excess or unused lands at the residential habilitation centers must be deposited into the developmental disabilities community trust account within ninety days of the date of their disposal.
- (2) As used in this act, "disposal" means the sale or lease at fair market value, or other transaction involving lands, timber, or other natural resources of the residential habilitation centers.
- NEW SECTION. Sec. 3. A new section is added to chapter 71A.20 RCW to read as follows:

The developmental disabilities community trust account is created 27 in the state treasury. All proceeds from the disposal of any building, 28 29 facility, timber, or tract of land not held in trust at any of the 30 residential habilitation centers identified in this chapter must be deposited into this account. "Proceeds" include the net receipts from 31 the disposal of all or a portion of the properties. Only investment 32 income from the principal of the proceeds deposited into the trust 33 34 account may be spent from the account. Investment income from the 35 account may be spent only after appropriation and must be used solely 36 for community developmental disability services for persons with

- 1 developmental disabilities who are unserved. Moneys in the account may
- 2 not be used to supplant ongoing expenditures for community services to
- 3 persons with developmental disabilities.

- 4 Sec. 4. RCW 43.84.092 and 2003 c 361 s 602, 2003 c 324 s 1, and 5 2003 c 48 s 2 are each reenacted and amended to read as follows:
 - (1) All earnings of investments of surplus balances in the state treasury shall be deposited to the treasury income account, which account is hereby established in the state treasury.
 - (2) The treasury income account shall be utilized to pay or receive funds associated with federal programs as required by the federal cash management improvement act of 1990. The treasury income account is subject in all respects to chapter 43.88 RCW, but no appropriation is required for refunds or allocations of interest earnings required by the cash management improvement act. Refunds of interest to the federal treasury required under the cash management improvement act fall under RCW 43.88.180 and shall not require appropriation. The office of financial management shall determine the amounts due to or from the federal government pursuant to the cash management improvement act. The office of financial management may direct transfers of funds between accounts as deemed necessary to implement the provisions of the cash management improvement act, and this subsection. Refunds or allocations shall occur prior to the distributions of earnings set forth in subsection (4) of this section.
 - (3) Except for the provisions of RCW 43.84.160, the treasury income account may be utilized for the payment of purchased banking services on behalf of treasury funds including, but not limited to, depository, safekeeping, and disbursement functions for the state treasury and affected state agencies. The treasury income account is subject in all respects to chapter 43.88 RCW, but no appropriation is required for payments to financial institutions. Payments shall occur prior to distribution of earnings set forth in subsection (4) of this section.
 - (4) Monthly, the state treasurer shall distribute the earnings credited to the treasury income account. The state treasurer shall credit the general fund with all the earnings credited to the treasury income account except:
 - (a) The following accounts and funds shall receive their proportionate share of earnings based upon each account's and fund's

Earnings 19 derived from investing balances of the agricultural permanent fund, the 20 21 normal school permanent fund, the permanent common school fund, the 22 scientific permanent fund, and the state university permanent fund shall be allocated to their respective beneficiary accounts. 23 24 earnings to be distributed under this subsection (4)(a) shall first be 25 reduced by the allocation to the state treasurer's service fund 26 pursuant to RCW 43.08.190.

(b) The following accounts and funds shall receive eighty percent of their proportionate share of earnings based upon each account's or fund's average daily balance for the period: The aeronautics account, the aircraft search and rescue account, the county arterial preservation account, the department of licensing services account, the essential rail assistance account, the ferry bond retirement fund, the grade crossing protective fund, the high capacity transportation account, the highway bond retirement fund, the highway safety account, the motor vehicle fund, the motorcycle safety education account, the pilotage account, the public transportation systems account, the Puget Sound capital construction account, the Puget Sound ferry operations account, the recreational vehicle account, the rural arterial trust

- account, the safety and education account, the special category C account, the state patrol highway account, the transportation 2003 account (nickel account), the transportation equipment fund, the transportation fund, the transportation improvement account, the transportation improvement board bond retirement account, and the urban arterial trust account.
 - (5) In conformance with Article II, section 37 of the state Constitution, no treasury accounts or funds shall be allocated earnings without the specific affirmative directive of this section.

Earnings derived from investing 28 balances of the agricultural permanent fund, the normal school 29 permanent fund, the permanent common school fund, the scientific 30 permanent fund, and the state university permanent fund shall be 31 32 allocated to their respective beneficiary accounts. All earnings to be distributed under this subsection (4)(a) shall first be reduced by the 33 allocation to the state treasurer's service fund pursuant to RCW 34 35 43.08.190.

(b) The following accounts and funds shall receive eighty percent of their proportionate share of earnings based upon each account's or fund's average daily balance for the period: The aeronautics account,
