- 1 AN ACT Relating to dissolving or deactivating joint housing 2 authorities; and amending RCW 35.82.300 and 35.82.320.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

- 4 **Sec. 1.** RCW 35.82.300 and 2002 c 258 s 1 are each amended to read 5 as follows:
- 6 This section applies to all cities and counties.
- 7 (1) Joint housing authorities are hereby authorized when the 8 legislative authorities of one or more counties and the legislative 9 authorities of any city or cities within any of those counties or in 10 another county or counties have authorized such joint housing authority 11 by ordinance.
- 12 (2) The ordinances enacted by the legislative authorities creating 13 the joint housing authority shall prescribe the number of 14 commissioners, the method for their appointment and length of their 15 terms, the election of officers, and the method for removal of 16 commissioners.
- 17 (3) The ordinances enacted by the legislative authorities creating 18 the joint housing authority shall prescribe the allocation of all costs

of the joint housing authority and any other matters necessary for the operation of the joint housing authority.

- (4) A joint housing authority shall have all the powers as prescribed by this chapter for any housing authority. The area of operation of a joint housing authority shall be the combined areas, defined by RCW 35.82.020(6), of the housing authorities created in each city and county authorizing the joint housing authority.
- 8 (5) The provisions of RCW 35.82.040 and 35.82.060 shall not apply 9 to a joint housing authority created pursuant to this section.
- (6) The ordinances enacted by the legislative authorities creating 10 the joint housing authority shall prescribe the procedure for 11 12 dissolution or deactivation of a joint housing authority and any other 13 matters necessary to effectuate the dissolution or deactivation of a joint housing authority, including distribution of the assets, 14 liabilities, and obligations of a joint housing authority to the 15 original activating governing bodies for the limited purposes of 16 winding up the affairs of a deactivated joint housing authority or 17 transferring assets, obligations, or liabilities to the housing 18 authority of a city, town, or county. 19
- 20 **Sec. 2.** RCW 35.82.320 and 1987 c 275 s 1 are each amended to read 21 as follows:

A housing authority or joint housing authority created under this 22 23 chapter and activated by a resolution or ordinance by the governing 24 body of a city, town, or county may be deactivated by a resolution or 25 ordinance by ((the)) any city, town, or county that created the housing 26 authority or joint housing authority. The findings listed in RCW 35.82.030 to activate the housing authority or joint housing authority 27 shall be considered prior to deactivating the housing authority. 28 29 However, a city, town, or county is authorized to deactivate a joint housing authority based on additional considerations of the local needs 30 of the city, town, or county. For the ((sole)) limited purposes of 31 winding up the affairs of a deactivated housing authority or 32 transferring the assets, liabilities, and obligations of a joint 33 housing authority to the housing authority of a city, town, or county, 34 35 the governing body of ((the)) <u>a</u> city, town, or county may exercise any
