1 AN ACT Relating to moving a web site address from statute to rule;
2 amending RCW 15.54.340; and providing an effective date.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 15.54.340 and 1999 c 381 s 1 are each amended to read
5 as follows:

6 (1) Any commercial fertilizer distributed in this state shall have
7 placed on or affixed to the package a label setting forth in clearly
8 legible and conspicuous form the following information:

9 (a) The net weight;

10 (b) The product name, brand, and grade. The grade is not required
11 if no primary nutrients are claimed;

12 (c) The guaranteed analysis;

13 (d) The name and address of the registrant or licensee. The name
14 and address of the manufacturer, if different from the registrant or
15 licensee, may also be stated;

16 (e) Any information required under WAC 296-62-054;

17 (f) ~~((At a minimum, one of the following labeling statements:~~

22 (2) If a commercial fertilizer is distributed in bulk, a written or
23 printed statement of the information required by subsection (1) of this
24 section shall accompany delivery and be supplied to the purchaser at
25 the time of delivery.
26 (3) Each delivery of a customer-formula fertilizer shall be subject
27 to containing those ingredients specified by the purchaser, which
28 ingredients shall be shown on the statement or invoice with the amount
29 contained therein, and a record of all invoices of customer-formula
30 grade mixes shall be kept by the registrant or licensee for a period of
31 twelve months and shall be available to the department upon request:
32 PROVIDED, That each such delivery shall be accompanied by either a
33 statement, invoice, a delivery slip, or a label if bagged, containing
34 the following information: The net weight; the brand; the guaranteed
35 analysis which may be stated to the nearest tenth of a percent or to
36 the next lower whole number; the name and address of the registrant or
37 licensee, or manufacturer, or both; and the name and address of the
38 purchaser.

1 NEW SECTION. **Sec. 2.** Section 1 of this act takes effect January
2 1, 2004.
