1 AN ACT Relating to tuition-setting authority at institutions of
2 higher education; amending RCW 28B.15.031, 28B.15.066, 28B.15.067,
3 28B.15.069, and 28B.15.100; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature finds that, as a partner in
6 financing public higher education with students and parents who pay
7 tuition and fees, periodic increases in state funding, state financial
8 aid, and tuition must be authorized to provide high quality higher
9 education for the citizens of Washington. It is the intent of the
10 legislature to address higher education through a cooperative
11 bipartisan effort that includes the legislative and executive branches
12 of government, parents, students, educators, as well as business,
13 labor, and community leaders. The legislature recognizes the
14 importance of keeping the public commitment to public higher education
15 and will continue searching for policies that halt the trend for the
16 growth in tuition revenue to outpace the revenue provided by the state.
17 The legislature believes that a well-educated citizenry is essential to
18 both the private and the public good. The economic and civic health of
19 the state require both an educated citizenry and a well-trained work

1 force. The six-year time limitation authorizing the governing boards
2 to establish tuition rates for all students other than undergraduate
3 resident students will give the legislature, the governor, and the
4 higher education institutions an opportunity to determine whether this
5 policy achieves the goal of maintaining quality and access for all who
6 are eligible for and can benefit from a higher education. Using data
7 from six years of this tuition policy, the state will be able to
8 identify options for long-term funding of higher education including
9 not only tuition but general fund and financial aid sources.

10 **Sec. 2.** RCW 28B.15.031 and 1996 c 142 s 2 are each amended to read
11 as follows:

12 The term "operating fees" as used in this chapter shall include the
13 fees, other than building fees, charged all students registering at the
14 state's colleges and universities but shall not include fees for short
15 courses, self-supporting degree credit programs and courses, marine
16 station work, experimental station work, correspondence or extension
17 courses, and individual instruction and student deposits or rentals,
18 disciplinary and library fines, which colleges and universities shall
19 have the right to impose, laboratory, gymnasium, health, technology and
20 student activity fees, or fees, charges, rentals, and other income
21 derived from any or all revenue producing lands, buildings and
22 facilities of the colleges or universities heretofore or hereafter
23 acquired, constructed or installed, including but not limited to income
24 from rooms, dormitories, dining rooms, hospitals, infirmaries, housing
25 or student activity buildings, vehicular parking facilities, land, or
26 the appurtenances thereon, or such other special fees as may be
27 established by any college or university board of trustees or regents
28 from time to time. All moneys received as operating fees at any
29 institution of higher education shall be deposited in a local account
30 containing only operating fees revenue and related interest: PROVIDED,
31 That a minimum of three and one-half percent of operating fees shall be
32 retained by the institutions(~~(, except the technical colleges,)~~) for
33 the purposes of RCW 28B.15.820. Local operating fee accounts shall not
34 be subject to appropriation by the legislature or allotment procedures
35 under chapter 43.88 RCW.

1 **Sec. 3.** RCW 28B.15.066 and 2000 c 152 s 2 are each amended to read
2 as follows:

3 It is the intent of the legislature that:

4 In making appropriations from the state's general fund to
5 institutions of higher education, each appropriation shall conform to
6 the following:

7 (1) The appropriation shall not be reduced by the amount of
8 operating fees revenue estimated to be collected from students enrolled
9 at the state-funded enrollment level specified in the omnibus biennial
10 operating appropriations act;

11 (2) The appropriation shall not be reduced by the amount of
12 operating fees revenue collected from students enrolled above the
13 state-funded level(~~(, but within the over enrollment limitations,)~~)
14 specified in the omnibus biennial operating appropriations act; and

15 (3) The general fund state appropriation shall not be reduced by
16 the amount of operating fees revenue collected as a result of waiving
17 less operating fees revenue than the amounts authorized under RCW
18 28B.15.910. State general fund appropriations shall not be provided
19 for revenue foregone as a result of or for waivers granted under RCW
20 28B.15.915.

13 (5)) Beginning with the 2003-04 academic year and ending with the
14 2008-09 academic year, reductions or increases in full-time tuition
15 fees for resident undergraduates shall be as provided in the omnibus
16 appropriations act.

17 (3) Beginning with the 2003-04 academic year and ending with the
18 2008-09 academic year, the governing boards of the state universities,
19 the regional universities, The Evergreen State College, and the state
20 board for community and technical colleges may reduce or increase full-
21 time tuition fees for all students other than resident undergraduates,
22 including summer school students and students in other self-supporting
23 degree programs. Percentage increases in full-time tuition fees may
24 exceed the fiscal growth factor. Reductions or increases may be made
25 for all or portions of an institution's programs, campuses, courses, or
26 students.

27 (4) Academic year tuition for full-time students at the state's
28 institutions of higher education beginning with 2009-10, other than
29 summer term, shall be as charged during the 2008-09 academic year
30 unless different rates are adopted by the legislature.

31 (5) The tuition fees established under this chapter shall not apply
32 to high school students enrolling in participating institutions of
33 higher education under RCW 28A.600.300 through ((28A.600.395))
34 28A.600.400.

35 (6) For the academic years 2003-04 through 2008-09, the University
36 of Washington shall use an amount equivalent to ten percent of all
37 revenues received as a result of law school tuition increases beginning

1 in academic year 2000-01 through academic year 2008-09 to assist needy
2 low and middle income resident law students.

3 (7) For the academic years 2003-04 through 2008-09, institutions of
4 higher education shall use an amount equivalent to ten percent of all
5 revenues received as a result of graduate academic school tuition
6 increases beginning in academic year 2003-04 through academic year
7 2008-09 to assist needy low and middle-income resident graduate
8 academic students.

9 **Sec. 5.** RCW 28B.15.069 and 1997 c 403 s 2 are each amended to read
10 as follows:

11 ~~(1) ((As used in this section, each of the following subsections is~~

33 ~~((4))~~ (2) The governing boards of each institution of higher
34 education, except for the technical colleges, shall charge to and
35 collect from each student a services and activities fee. A governing
36 board may increase the existing fee annually, consistent with budgeting
37 procedures set forth in RCW 28B.15.045, by a percentage not to exceed

1 the annual percentage increase in student tuition fees for (~~the~~
2 ~~applicable tuition category~~) resident undergraduate students:
3 PROVIDED, That such percentage increase shall not apply to that portion
4 of the services and activities fee previously committed to the
5 repayment of bonded debt. These rate adjustments may exceed the fiscal
6 growth factor. For the 2003-04 academic year, the services and
7 activities fee shall be based upon the resident undergraduate services

16 ~~((+6))~~ (4) Subject to the limitations of RCW 28B.15.910, each
17 governing board of a community college may charge such fees for
18 ungraded courses, noncredit courses, community services courses, and
19 self-supporting courses as it, in its discretion, may determine,
20 consistent with the rules of the state board for community and
21 technical colleges.

22 **Sec. 6.** RCW 28B.15.100 and 1999 c 321 s 2 are each amended to read
23 as follows:

24 (1) The governing boards of the state universities, the regional
25 universities, The Evergreen State College, and the community colleges
26 shall charge to and collect from each of the students registering at
27 the particular institution for any quarter or semester such tuition
28 fees and services and activities fees, and other fees as such board
29 shall in its discretion determine. The total of all fees shall be
30 rounded to the nearest whole dollar amount: PROVIDED, That such
31 tuition fees (~~for other than the summer term~~) shall be (~~in the~~
32 ~~amounts for the respective institutions as otherwise set forth in~~)
33 established in accordance with RCW 28B.15.067.

34 (2) Part-time students shall be charged tuition and services and
35 activities fees proportionate to full-time student rates established
36 for residents and nonresidents: PROVIDED, That except for students
37 registered at community colleges, students registered for fewer than

1 two credit hours shall be charged tuition and services and activities
2 fees at the rate established for two credit hours: PROVIDED FURTHER,
3 That, subject to the limitations of RCW 28B.15.910, residents of Idaho
4 or Oregon who are enrolled in community college district number twenty
5 for six or fewer credits during any quarter or semester may be exempted
6 from payment of all or a portion of the nonresident tuition fees
7 differential upon a declaration by the higher education coordinating
8 board that it finds Washington residents from the community college
9 district are afforded substantially equivalent treatment by such other
10 states.

11 (3) Full-time students registered for more than eighteen credit
12 hours shall be charged an additional operating fee for each credit hour
13 in excess of eighteen hours at the applicable established per credit
14 hour tuition fee rate for part-time students: PROVIDED, That, subject
15 to the limitations of RCW 28B.15.910, the governing boards of the state
16 universities and the community colleges may exempt all or a portion of
17 the additional charge, for students who are registered exclusively in
18 first professional programs in medicine, dental medicine, veterinary
19 medicine, doctor of pharmacy, or law, or who are registered exclusively
20 in required courses in vocational preparatory programs.
