31 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

32 NEW SECTION. **Sec. 1.** The legislature intends by this act to
33 reorganize criminal provisions throughout the Revised Code of
34 Washington to clarify and simplify the identification and referencing
35 of crimes. It is not intended that this act effectuate any substantive
36 change to any criminal provision in the Revised Code of Washington.

1 **Sec. 2.** RCW 2.48.180 and 2001 c 310 s 2 are each amended to read
2 as follows:

3 (1) As used in this section:

4 (a) "Legal provider" means an active member in good standing of the
5 state bar, and any other person authorized by the Washington state
6 supreme court to engage in full or limited practice of law;

7 (b) "Nonlawyer" means a person to whom the Washington supreme court
8 has granted a limited authorization to practice law but who practices
9 law outside that authorization, and a person who is not an active
10 member in good standing of the state bar, including persons who are
11 disbarred or suspended from membership;

12 (c) "Ownership interest" means the right to control the affairs of
13 a business, or the right to share in the profits of a business, and
14 includes a loan to the business when the interest on the loan is based
15 upon the income of the business or the loan carries more than a
16 commercially reasonable rate of interest.

17 (2) The following constitutes unlawful practice of law:

18 (a) A nonlawyer practices law, or holds himself or herself out as
19 entitled to practice law;

20 (b) A legal provider holds an investment or ownership interest in
21 a business primarily engaged in the practice of law, knowing that a
22 nonlawyer holds an investment or ownership interest in the business;

23 (c) A nonlawyer knowingly holds an investment or ownership interest
24 in a business primarily engaged in the practice of law;

25 (d) A legal provider works for a business that is primarily engaged
26 in the practice of law, knowing that a nonlawyer holds an investment or
27 ownership interest in the business; or

28 (e) A nonlawyer shares legal fees with a legal provider.

29 (3)(a) Unlawful practice of law is a crime. A single violation of
30 this section is a gross misdemeanor.

31 (b) Each subsequent violation of this section, whether alleged in
32 the same or in subsequent prosecutions, is a class C felony punishable
33 according to chapter 9A.20 RCW.

34 (4) Nothing contained in this section affects the power of the
35 courts to grant injunctive or other equitable relief or to punish as
36 for contempt.

37 (5) Whenever a legal provider or a person licensed by the state in
38 a business or profession is convicted, enjoined, or found liable for

1 damages or a civil penalty or other equitable relief under this
2 section, the plaintiff's attorney shall provide written notification of
3 the judgment to the appropriate regulatory or disciplinary body or
4 agency.

5 (6) A violation of this section is cause for discipline and
6 constitutes unprofessional conduct that could result in any regulatory
7 penalty provided by law, including refusal, revocation, or suspension
8 of a business or professional license, or right or admission to
9 practice. Conduct that constitutes a violation of this section is
10 unprofessional conduct in violation of RCW 18.130.180.

11 (7) In a proceeding under this section it is a defense if proven by
12 the defendant by a preponderance of the evidence that, at the time of
13 the offense, the conduct alleged was authorized by the rules of
14 professional conduct or the admission to practice rules, or Washington
15 business and professions licensing statutes or rules.

16 (8) Independent of authority granted to the attorney general, the
17 prosecuting attorney may petition the superior court for an injunction
18 against a person who has violated this chapter. Remedies in an
19 injunctive action brought by a prosecuting attorney are limited to an
20 order enjoining, restraining, or preventing the doing of any act or
21 practice that constitutes a violation of this chapter and imposing a
22 civil penalty of up to five thousand dollars for each violation. The
23 prevailing party in the action may, in the discretion of the court,
24 recover its reasonable investigative costs and the costs of the action
25 including a reasonable attorney's fee. The degree of proof required in
26 an action brought under this subsection is a preponderance of the
27 evidence. An action under this subsection must be brought within three
28 years after the violation of this chapter occurred.

30 as follows:

31 Every person convicted by the municipal court of a violation of the
32 criminal provisions of an ordinance for which no punishment is
33 specifically prescribed in the ordinance is guilty of a gross
34 misdemeanor and shall be punished by a fine of not more than five
35 thousand dollars or imprisonment in the city jail for a period not to
36 exceed one year, or both such fine and imprisonment.

2 as follows:

3 Any person who suffers damages as a result of actions described in
4 RCW 9A.48.080(c) or any owner of a horse, mule, cow, heifer, bull,
5 steer, swine, or sheep who suffers damages as a result of a willful,
6 unauthorized act described in RCW 9A.56.080 or section 75 of this act
7 may bring an action against the person or persons committing the act in
8 a court of competent jurisdiction for exemplary damages up to three
9 times the actual damages sustained, plus attorney's fees.

10 **Sec. 5.** RCW 7.40.230 and 1990 c 11 s 4 are each amended to read as
11 follows:

12 (1) Whenever it appears that any person is engaged in or about to
13 engage in any act that constitutes or will constitute a violation of
14 RCW 9.26A.110, section 21 of this act, or 9.26A.090, the prosecuting
15 attorney, a telecommunications company, or any person harmed by an
16 alleged violation of RCW 9.26A.110, section 21 of this act, or
17 9.26A.090 may initiate a civil proceeding in superior court to enjoin
18 such violation, and may petition the court to issue an order for the
19 discontinuance of the specific telephone service being used in
20 violation of RCW 9.26A.110, section 21 of this act, or 9.26A.090.

21 (2) An action under this section shall be brought in the county in
22 which the unlawful act or acts are alleged to have taken place, and
23 shall be commenced by the filing of a verified complaint, or shall be
24 accompanied by an affidavit.

25 (3) If it is shown to the satisfaction of the court, either by
26 verified complaint or affidavit, that a person is engaged in or about
27 to engage in any act that constitutes a violation of RCW 9.26A.110,
28 section 21 of this act, or 9.26A.090, the court may issue a temporary
29 restraining order to abate and prevent the continuance or recurrence of
30 the act. The court may direct the sheriff to seize and retain until
31 further order of the court any device that is being used in violation
32 of RCW 9.26A.110, section 21 of this act, or 9.26A.090. All property
33 seized pursuant to the order of the court shall remain in the custody
34 of the court.

35 (4) The court may issue a permanent injunction to restrain, abate
36 or prevent the continuance or recurrence of the violation of RCW
37 9.26A.110, section 21 of this act, or 9.26A.090. The court may grant

1 declaratory relief, mandatory orders, or any other relief deemed
2 necessary to accomplish the purposes of the injunction. The court may
3 retain jurisdiction of the case for the purpose of enforcing its
4 orders.

5 (5) If it is shown to the satisfaction of the court, either by
6 verified complaint or affidavit, that a person is engaged in or is
7 about to engage in any act that constitutes a violation of RCW
8 9.26A.110, section 21 of this act, or 9.26A.090, the court may issue an
9 order which shall be promptly served upon the person in whose name the
10 telecommunications device is listed, requiring the party, within a
11 reasonable time, to be fixed by the court, from the time of service of
12 the petition on (~~said~~) the party, to show cause before the judge why
13 telephone service should not promptly be discontinued. At the hearing
14 the burden of proof shall be on the complainant.

15 (6) Upon a finding by the court that the telecommunications device
16 is being used or has been used in violation of RCW 9.26A.110 or section
17 21 of this act, the court may issue an order requiring the telephone
18 company which is rendering service over the device to disconnect such
19 service. Upon receipt of such order, which shall be served upon an
20 officer of the telephone company by the sheriff or deputy of the county
21 in which the telecommunications device is installed, the telephone
22 company shall proceed promptly to disconnect and remove such device and
23 discontinue all telephone service until further order of the court,
24 provided that the telephone company may do so without breach of the
25 peace or trespass.

26 (7) The telecommunications company that petitions the court for the
27 removal of any telecommunications device under this section shall be a
28 necessary party to any proceeding or action arising out of or under RCW
29 9.26A.110 or section 21 of this act.

30 (8) No telephone company shall be liable for any damages, penalty,
31 or forfeiture, whether civil or criminal, for any legal act performed
32 in compliance with any order issued by the court.

33 (9) Property seized pursuant to the direction of the court that the
34 court has determined to have been used in violation of RCW 9.26A.110 or
35 section 21 of this act shall be forfeited after notice and hearing.
36 The court may remit or mitigate the forfeiture upon terms and
37 conditions as the court deems reasonable if it finds that such
38 forfeiture was incurred without gross negligence or without any intent

1 of the petitioner to violate the law, or it finds the existence of such
2 mitigating circumstances as to justify the remission or the mitigation
3 of the forfeiture. In determining whether to remit or mitigate
4 forfeiture, the court shall consider losses that may have been suffered
5 by victims as the result of the use of the forfeited property.

6 **Sec. 6.** RCW 9.05.030 and 1999 c 191 s 1 are each amended to read
7 as follows:

8 Whenever two or more persons assemble for the purpose of committing
9 criminal sabotage, as defined in RCW 9.05.060, such an assembly is
10 unlawful, and every person voluntarily and knowingly participating
11 therein by his or her presence, aid, or instigation, is guilty of a
12 class B felony and shall be punished by imprisonment in a state
13 correctional facility for not more than ten years, or by a fine of not
14 more than five thousand dollars, or both.

15 **Sec. 7.** RCW 9.05.060 and 1999 c 191 s 2 are each amended to read
16 as follows:

17 (1) Whoever, with intent that his or her act shall, or with reason
18 to believe that it may, injure, interfere with, interrupt, supplant,
19 nullify, impair, or obstruct the owner's or operator's management,
20 operation, or control of any agricultural, stockraising, lumbering,
21 mining, quarrying, fishing, manufacturing, transportation, mercantile,
22 or building enterprise, or any other public or private business or
23 commercial enterprise, wherein any person is employed for wage, shall
24 willfully damage or destroy, or attempt or threaten to damage or
25 destroy, any property whatsoever, or shall unlawfully take or retain,
26 or attempt or threaten unlawfully to take or retain, possession or
27 control of any property, instrumentality, machine, mechanism, or
28 appliance used in such business or enterprise, shall be guilty of
29 criminal sabotage.

30 (2) Criminal sabotage is a class B felony punishable according to
31 chapter 9A.20 RCW.

32 **Sec. 8.** RCW 9.08.065 and 1989 c 359 s 1 are each amended to read
33 as follows:

34 As used in RCW 9.08.070 and sections 10 through 13 of this act:

1 (1) "Pet animal" means a tamed or domesticated animal legally
2 retained by a person and kept as a companion. "Pet animal" does not
3 include livestock raised for commercial purposes.

4 (2) "Research institution" means a facility licensed by the United
5 States department of agriculture to use animals in biomedical or
6 product research.

7 (3) "U.S.D.A. licensed dealer" means a person who is licensed or
8 required to be licensed by the United States department of agriculture
9 to commercially buy, receive, sell, negotiate for sale, or transport
10 animals.

11 **Sec. 9.** RCW 9.08.070 and 1989 c 359 s 2 are each amended to read
12 as follows:

13 (1) Any person who, with intent to deprive or defraud the owner
14 thereof, does any of the following shall be guilty of a gross
15 misdemeanor ~~((and shall be punished as prescribed under RCW~~
16 ~~9A.20.021(2))~~ punishable according to chapter 9A.20 RCW and by a
17 mandatory fine of not less than five hundred dollars per pet animal,
18 except as provided by ~~((d) of this))~~ subsection (2) of this section:

20 animal, except in cases in which the value of the pet animal exceeds
21 two hundred fifty dollars;

20 threat thereof, and whether acting in concert or not, they shall be
21 guilty of prison riot.

22 (2) Every inmate of a correctional institution who is guilty of
23 prison riot or of voluntarily participating therein by being present
24 at, or by instigating, aiding, or abetting the same, is guilty of a
25 class B felony and shall be punished by imprisonment in a state
26 correctional institution for not less than one year nor more than ten
27 years, which shall be in addition to the sentence being served.

11 means that the department, either directly or through a collection
12 agreement authorized by RCW 9.94A.760, is responsible for monitoring

26 community subject to controls placed on the offender's movement and
27 activities by the department. For offenders placed on community
28 custody for crimes committed on or after July 1, 2000, the department
29 shall assess the offender's risk of reoffense and may establish and
30 modify conditions of community custody, in addition to those imposed by
31 the court, based upon the risk to community safety.

32 (6) "Community custody range" means the minimum and maximum period
33 of community custody included as part of a sentence under RCW
34 9.94A.715, as established by the commission or the legislature under
35 RCW 9.94A.850, for crimes committed on or after July 1, 2000.

36 (7) "Community placement" means that period during which the
37 offender is subject to the conditions of community custody and/or

1 postrelease supervision, which begins either upon completion of the
2 term of confinement (postrelease supervision) or at such time as the
3 offender is transferred to community custody in lieu of earned release.
4 Community placement may consist of entirely community custody, entirely
5 postrelease supervision, or a combination of the two.

6 (8) "Community restitution" means compulsory service, without
7 compensation, performed for the benefit of the community by the

9 (9) "Community supervision" means a period of time during which a
10 convicted offender is subject to crime-related prohibitions and other
11 sentence conditions imposed by a court pursuant to this chapter or RCW
12 16.52.200(6) or 46.61.524. Where the court finds that any offender has
13 a chemical dependency that has contributed to his or her offense, the
14 conditions of supervision may, subject to available resources, include
15 treatment. For purposes of the interstate compact for out-of-state
16 supervision of parolees and probationers, RCW 9.95.270, community
17 supervision is the functional equivalent of probation and should be
18 considered the same as probation by other states.

19 (10) "Confinement" means total or partial confinement.

20 (11) "Conviction" means an adjudication of guilt pursuant to Titles
21 10 or 13 RCW and includes a verdict of guilty, a finding of guilty, and
22 acceptance of a plea of guilty.

23 (12) "Crime-related prohibition" means an order of a court
24 prohibiting conduct that directly relates to the circumstances of the
25 crime for which the offender has been convicted, and shall not be
26 construed to mean orders directing an offender affirmatively to
27 participate in rehabilitative programs or to otherwise perform
28 affirmative conduct. However, affirmative acts necessary to monitor
29 compliance with the order of a court may be required by the department.

30 (13) "Criminal history" means the list of a defendant's prior
31 convictions and juvenile adjudications, whether in this state, in
32 federal court, or elsewhere.

33 (a) The history shall include, where known, for each conviction (i)
34 whether the defendant has been placed on probation and the length and
35 terms thereof; and (ii) whether the defendant has been incarcerated and
36 the length of incarceration.

37 (b) A conviction may be removed from a defendant's criminal history

1 only if it is vacated pursuant to RCW 9.96.060, 9.94A.640, 9.95.240, or
2 a similar out-of-state statute, or if the conviction has been vacated
3 pursuant to a governor's pardon.

19 (17) "Determinate sentence" means a sentence that states with

24 offender through earned release can reduce the actual period of

6 (a) Any felony violation of chapter 69.50 RCW except possession of
7 a controlled substance (~~((RCW 69.50.401(d)))~~) section 334 of this act
8 or forged prescription for a controlled substance (RCW 69.50.403);

9 (b) Any offense defined as a felony under federal law that relates
10 to the possession, manufacture, distribution, or transportation of a
11 controlled substance; or

12 (c) Any out-of-state conviction for an offense that under the laws
13 of this state would be a felony classified as a drug offense under (a)
14 of this subsection.

15 (21) "Earned release" means earned release from confinement as
16 provided in RCW 9.94A.728.

17 (22) "Escape" means:

18 (a) Sexually violent predator escape (RCW 9A.76.115), escape in the
19 first degree (RCW 9A.76.110), escape in the second degree (RCW
20 9A.76.120), willful failure to return from furlough (RCW 72.66.060),
21 willful failure to return from work release (RCW 72.65.070), or willful
22 failure to be available for supervision by the department while in
23 community custody (RCW 72.09.310); or

24 (b) Any federal or out-of-state conviction for an offense that
25 under the laws of this state would be a felony classified as an escape
26 under (a) of this subsection.

27 (23) "Felony traffic offense" means:

28 (a) Vehicular homicide (RCW 46.61.520), vehicular assault (RCW
29 46.61.522), eluding a police officer (RCW 46.61.024), or felony hit-
30 and-run injury-accident (RCW 46.52.020(4)); or

31 (b) Any federal or out-of-state conviction for an offense that
32 under the laws of this state would be a felony classified as a felony
33 traffic offense under (a) of this subsection.

34 (24) "Fine" means a specific sum of money ordered by the sentencing
35 court to be paid by the offender to the court over a specific period of
36 time.

37 (25) "First-time offender" means any person who has no prior

1 convictions for a felony and is eligible for the first-time offender
2 waiver under RCW 9.94A.650.

3 (26) "Home detention" means a program of partial confinement
4 available to offenders wherein the offender is confined in a private
5 residence subject to electronic surveillance.

6 (27) "Legal financial obligation" means a sum of money that is
7 ordered by a superior court of the state of Washington for legal
8 financial obligations which may include restitution to the victim,
9 statutorily imposed crime victims' compensation fees as assessed

5 the cost of corrections by requiring offenders to complete a

8 development, substance abuse rehabilitation, counseling, literacy
9 training, and basic adult education.

10 (48) "Work release" means a program of partial confinement
11 available to offenders who are employed or engaged as a student in a
12 regular course of study at school.

31 program for medical or health-related reasons is conditioned on the
32 offender abiding by the rules of the home detention program and
33 complying with court-ordered restitution.

26 (iv) OFFENDERS WHO ARE CONVICTED BUT NOT CONFINED. Sex offenders
27 who are convicted of a sex offense on or after July 28, 1991, for a sex
28 offense that was committed on or after February 28, 1990, and
29 kidnapping offenders who are convicted on or after July 27, 1997, for
30 a kidnapping offense that was committed on or after July 27, 1997, but
31 who are not sentenced to serve a term of confinement immediately upon

21 as a result of that finding, of the state department of social and
22 health services, or (B) committing a kidnapping offense on, before, or

36 department of social and health services shall make reasonable attempts
37 within available resources to notify sex offenders who were released
38 before July 23, 1995, and kidnapping offenders who were released before

1 July 27, 1997. Failure to register within twenty-four hours of
2 release, or of receiving notice, constitutes a violation of this
3 section and is punishable as provided in subsection (10) of this
4 section.

5 (vii) OFFENDERS WHO LACK A FIXED RESIDENCE. Any person who lacks
6 a fixed residence and leaves the county in which he or she is
7 registered and enters and remains within a new county for twenty-four
8 hours is required to register with the county sheriff not more than
9 twenty-four hours after entering the county and provide the information
10 required in subsection (3)(b) of this section.

11 (viii) OFFENDERS WHO LACK A FIXED RESIDENCE AND WHO ARE UNDER
12 SUPERVISION. Offenders who lack a fixed residence and who are under
