1 AN ACT Relating to port districts; adding a new section to chapter
2 53.08 RCW; and providing an expiration date.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 53.08 RCW
5 to read as follows:

6 A port district may provide advisory consulting services for
7 compensation on matters within the scope of this title or Title 14 RCW.
8 A port district may provide these services only to other public
9 agencies and governments, including foreign governments and government-
10 sponsored organizations. A port district providing consulting services
11 must create and maintain an open roster of Washington firms interested
12 in bidding on opportunities generated as a result.

13 By enacting this legislation, the legislature intends to enhance
14 the ability of Washington port districts to facilitate economic
15 opportunities for the benefit of Washington businesses. Nothing in
16 this section is intended to authorize direct competition by port
17 districts with private business.

1 NEW SECTION. **Sec. 2.** This act expires July 1, 2008.
