HB 1190-S by House Committee on Education (originally sponsored by Representatives Quall, Tom, Grant, Talcott, Benson, Ahern, Shabro, Lovick, Dunshee, Anderson, Delvin, McCoy, Cody, Miloscia, Eickmeyer, Mielke, Linville, Pearson, Kessler, Cairnes and Mastin)

Changing provisions for classified staff in alternative certification programs.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides that, for a maximum of one year, a route two candidate shall retain his or her employee status during the time the candidate is participating in the program.

HB 1257-S by House Committee on Criminal Justice & Corrections (originally sponsored by Representatives Carrell, Haigh, O'Brien and Shabro)

Using dogs for fighting.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides that any person who sells or purchases any dog (Canidae) with the intent that the dog shall be engaged in an exhibition of fighting with another animal is guilty of a gross misdemeanor punishable by imprisonment not to exceed one year, or by a fine not to exceed five thousand dollars, or by both fine and imprisonment.

Declares that mere ownership or possession of any animal does not create a presumption that the animal is owned or possessed for any purpose prohibited under chapter 16.52 RCW.

HB 1269-S by House Committee on Agriculture & Natural Resources (originally sponsored by Representatives Linville and Schoesler; by request of Department of Agriculture)

Regulating structural pest inspectors.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Declares that it is prohibited for a business to conduct one or more complete wood destroying organism inspections without first having obtained a structural pest inspection company license from the department.

Provides that the director shall require each applicant for a structural pest inspector license to demonstrate to the director the applicant's knowledge of applicable laws and regulations; structural pest identification and damage; and conditions conducive to the development of wood destroying

organisms by satisfactorily passing a written examination for the classifications for which the applicant has applied prior to issuing the license.

Declares it is unlawful for any business to conduct complete wood destroying organism inspections without having obtained a company license from the director.

Provides that the director shall not issue a license to any individual who intends to act as a structural pest inspector until evidence of financial responsibility, required and described in this act, is furnished by the applicant or the business employing the applicant. Licensed commercial applicators that have met the requirements of RCW 17.21.160 and their licensed commercial operator employees are exempt from this financial responsibility requirement when performing specific wood destroying organism inspections. Public employees licensed to perform structural pest inspections are exempt from this licensing requirement when acting within their official capacities.

HB 1310-S by House Committee on State Government (originally sponsored by Representatives Shabro, Holmquist, Armstrong, Anderson, Linville, Nixon, Condotta, Roach, Miloscia, Kristiansen, Bush, Carrell, McDonald, Woods, Benson, McMahan, Chase and Pflug)

Providing businesses with notice of administrative rules.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides that, within two hundred days of the effective date of a rule that imposes additional requirements on businesses the violation of which subjects the business to a penalty, assessment, or administrative sanction, an agency identified in RCW 34.05.220(6) shall notify businesses affected by the rule of the requirements of the rule and how to obtain technical assistance to comply.

HB 1334-S by House Committee on State Government (originally sponsored by Representatives Haigh, Armstrong, Kristiansen, Tom, Anderson, Shabro, Hatfield, Nixon, Hunt, Roach, Holmquist, Grant, O'Brien, Kagi, Kessler, Upthegrove and Morris)

Requiring cost and benefit assessments early in the rule-making process.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires notification that, if RCW 34.05.328 applies, a statement indicating that a copy of the preliminary cost-benefit analysis described in RCW 34.05.328(1)(c) is available.

Requires notification in the notice of proposed rule making under RCW 34.05.320 that a preliminary cost-benefit analysis is available. The preliminary cost-benefit analysis must fulfill the requirements of the cost-benefit analysis under this act. If the agency files a supplemental

notice under RCW 34.05.340, the supplemental notice shall include notification that a revised preliminary cost-benefit analysis is available. A final cost-benefit analysis shall be available when the rule is adopted under RCW 34.05.360.

Allowing limited marketing of bottled wine at farmers markets.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes limited marketing of bottled wine at farmers markets.

HB 1485-S by House Committee on Criminal Justice & Corrections (originally sponsored by Representatives Lovick, O'Brien and Campbell)

Changing provisions relating to auto theft.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Directs the Washington association of sheriffs and police chiefs to create and facilitate the Washington state auto theft task force program.

Provides that a unit of local government or a team consisting of multiple units of local governments may apply to the Washington association of sheriffs and police chiefs for the regional auto theft task force grants.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Revises the duties of and renames the office of permit assistance.

HB 1624-S by House Committee on Technology, Telecommunications & Energy (originally sponsored by Representatives Hudgins, Pettigrew, Crouse, Morris, Nixon, Linville and Sullivan; by request of Department of Social and Health Services)

Modifying provisions of the Washington telephone assistance program.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Finds that: (1) It is in the public interest to take steps to mitigate the effects of these changes on low-income persons; and

(2) Advances in telecommunications technologies, such as community service voice mail provide new and economically efficient ways to secure many of the benefits of universal service to low-income persons who are not customers of local exchange telephone service.

Authorizes a discount on a community service voice mailbox that provides recipients with: (1) An individually assigned telephone number;

(2) The ability to record a personal greeting; and

(3) A secure private security code to retrieve messages.

Directs the department to enter into an agreement with the department of community, trade, and economic development for an amount not to exceed eight percent of the prior fiscal year's total revenue for the administrative and program expenses of providing community service voice mail services. The community service voice mail service may include toll-free lines in community action agencies through which recipients can access their community service voice mailboxes at no charge.

HB 1949 by Representatives Nixon and Wood

Providing financial assistance for victims of domestic violence seeking protection orders.

Provides that, in addition to any other relief authorized under chapter 10.14 RCW, the court may order that the respondent transfer, or otherwise provide, a specified amount of funds, as determined by the court, to the petitioner to provide temporary financial assistance to the petitioner if the court finds that such assistance is necessary. The court may order such a transfer of funds under this act only once per petition involving the petitioner and respondent. At any subsequent proceeding for dissolution, legal separation, or invalidity of the marriage, or any subsequent proceeding for the establishment or modification of child support or maintenance, the petitioner shall disclose the amount transferred under this act and the court or agency must consider that amount transferred in determining property distribution, support, or maintenance.

HB 1950 by Representative Nixon

Facilitating transfer of a vehicle upon death.

Provides that a sole owner of a motor vehicle or trailer, and multiple owners of a motor vehicle or trailer who hold their interest as joint tenants with right of survivorship or as tenants by the entirety, on application and payment of the fee required for an original certificate of ownership, may request the department to issue a certificate of ownership for the motor vehicle or trailer in beneficiary form that includes a directive to the department to transfer the certificate of ownership on death of the sole owner or on death of all multiple owners to one beneficiary or to two or more beneficiaries as joint tenants with right of survivorship or as tenants by the entirety named on the face of the certificate.

Designating highways of statewide significance.

Designates that portion of state route number 6 that runs from a junction with state route number 101 at Raymond, thence easterly by way of Lebam and Pe Ell to a junction with state route number 5 at Chehalis.

HB 1953 by Representatives Kagi, McIntire, Dickerson, Cody, Pflug, Schual-Berke, Anderson and Darneille

Limiting administrative overhead costs of contract administration for state agencies, state offices, and institutions of higher education.

Provides that, except as otherwise authorized by law or the omnibus operating appropriations act, a state agency may not charge another state agency an administrative overhead cost in excess of ten percent to administer a contract. This limitation does not apply to interagency contracts solely involving specific federal grant moneys.

HB 1954 by Representatives Moeller and McMahan

Permitting a retired judge acting as a judge pro tempore to decline compensation.

HB 1955 by Representatives Nixon, Sullivan, Anderson, Kristiansen, Tom and Berkey

Allowing the use of agricultural lands not currently being farmed as sites for recreational activities.

Declares that nothing in chapter 36.70A RCW may be construed as preventing a county or city from allowing agricultural lands that are not currently being used in commercial production from being used for recreational activities, including, but not limited to, playing fields for sports played on grass, provided that no permanent structures are erected and no substantial subsurface modifications are performed on the agricultural land.

HB 1956 by Representative Moeller

Removing restaurants from the provisions of the clean indoor air act.

Removing concurrency requirements under the growth management act.

HB 1958 by Representatives Lantz, Chase, Rockefeller, Dunshee and Hunt

Coordinating geoduck management activities.

Requires that nonstate-owned bedlands or tidelands owned or held under contract or deed upon which a private party is commercially harvesting or cultivating geoduck must be surveyed by the private party and a record of survey filed in compliance with chapter 58.09 RCW prior to harvest.

Directs the joint legislative audit and review committee to evaluate the current status of the geoduck resource in Washington and report to the legislature by December 1,

2004. The report must: Include an update on the current harvest trends and policies to determine the sustainability of the geoduck harvest; include the role of aquaculture and reseedling in geoduck management and enforcement; and make recommendations for improving the health of the geoduck resource while maximizing economic benefits.

HB 1960 by Representatives Murray, Jarrett, Cooper, Dickerson and Hudgins

Governing regional transportation.

Declares that it is the policy of the state of Washington to ensure a single regional government council, more directly accountable to the public, with adequate resources to develop and encourage implementation of a comprehensive transportation plan within the state's largest urbanized region.

HB 1968 by Representatives O'Brien, Cooper, Romero, Kessler, Carrell, Delvin and Lantz

Allowing the use of body-gripping traps under certain circumstances.

Provides that, until July 1, 2008, nothing in this act prohibits the use of a number 110 Conibear trap to trap mountain beaver (*Aplodontia rufa*) on land by the owner or operator of commercial timber if nonlethal control tools,

including but not limited to fencing, electric fencing, or tree-wrapping, cannot be reasonably applied.

Declares an intent to increase the attention of the K-12 system on the importance of world language instruction by reestablishing the position of world language specialist at the office of the superintendent of public instruction.

Requires the office of the superintendent of public instruction to assign at least one-half of a full-time equivalent employee to help school districts in their efforts to offer world language instruction in the state's public schools.

Requires the deaf education task force to develop a strategic plan for the school for the deaf. The strategic plan must include, at a minimum, the following: (1) The appropriate service delivery model for serving hearing impaired children throughout the state;

(2) The role of the school for the deaf in the development of quality services for hearing impaired children throughout the state;

(3) The role of the school for the deaf in providing direct and indirect services to hearing impaired children both on campus and in the children's local communities; and

(4) The role of the school for the deaf in relation to local school districts and other partners throughout the state.

Requires the deaf education task force to report to the governor and the appropriate fiscal and policy committees of the legislature no later than December 1, 2004.

Expires January 1, 2005.

HB 1972 by Representative Hatfield

Making a commercial fish seller's failure to account for commercial harvest a misdemeanor.

Declares that a commercial fish seller's failure to account for commercial harvest is a misdemeanor.

HB 1973 by Representatives Veloria, McCoy and Kenney

Promoting tourism.

Requires the department of community, trade, and economic development to develop an annual nature-based business and marketing plan and coordinate with the department of fish and wildlife and other appropriate agencies and organizations to promote and market nature-based tourism in Washington to maximize efforts and benefits. This effort shall include the coordination of: (1) The promotion of nature-based tourism;

(2) The promotion of fishing, hunting, and wildlife viewing;

(3) The creation of partnerships among agencies, organizations, tribes, and local communities to develop and promote nature-based tourism;
