3 "PART 1

4 DEPARTMENT OF EARLY LEARNING CREATED

5 NEW SECTION. **Sec. 101.** (1) The legislature recognizes that:

6 (a) Parents are their children's first and most important teachers
7 and decision makers;

8 (b) Research across disciplines now demonstrates that what happens
9 in the earliest years makes a critical difference in children's
10 readiness to succeed in school and life;

11 (c) Washington's competitiveness in the global economy requires a
12 world-class education system that starts early and supports life-long
13 learning;

14 (d) Washington state currently makes substantial investments in
15 voluntary child care and early learning services and supports, but
16 because services are fragmented across multiple state agencies, and
17 early learning providers lack the supports and incentives needed to
18 improve the quality of services they provide, many parents have
19 difficulty accessing high quality early learning services;

20 (e) A more cohesive and integrated voluntary early learning system
21 would result in greater efficiencies for the state, increased
22 partnership between the state and the private sector, improved access
23 to high quality early learning services, and better employment and
24 early learning outcomes for families and all children.

25 (2) The legislature finds that the early years of a child's life
26 are critical to the child's healthy brain development and that the
27 quality of caregiving during the early years can significantly impact
28 the child's intellectual, social, and emotional development.

29 (3) The purpose of this chapter is:

1 (a) To establish the department of early learning;

2 (b) To coordinate and consolidate state activities relating to
3 child care and early learning programs;

4 (c) To safeguard and promote the health, safety, and well-being of
5 children receiving child care and early learning assistance;

6 (d) To promote linkages and alignment between early learning
7 programs and elementary schools and support the transition of children
8 and families from prekindergarten environments to kindergarten;

9 (e) To promote the development of a sufficient number and variety
10 of adequate child care and early learning facilities, both public and
11 private; and

12 (f) To license agencies and to assure the users of such agencies,
13 their parents, the community at large and the agencies themselves that
14 adequate minimum standards are maintained by all child care and early
15 learning facilities.

16 (4) This chapter does not expand the state's authority to license
17 or regulate activities or programs beyond those licensed or regulated
18 under existing law.

19 NEW SECTION. **Sec. 102.** The definitions in this section apply
20 throughout this chapter unless the context clearly requires otherwise.

21 (1) "Agency" means any person, firm, partnership, association,
22 corporation, or facility that provides child care and early learning
23 services outside a child's own home and includes the following
24 irrespective of whether there is compensation to the agency:

25 (a) "Child day care center" means an agency that regularly provides
26 child day care and early learning services for a group of children for
27 periods of less than twenty-four hours;

28 (b) "Early learning" includes but is not limited to programs and
29 services for child care; state, federal, private, and nonprofit
30 preschool; child care subsidies; child care resource and referral;
31 parental education and support; and training and professional
32 development for early learning professionals;

33 (c) "Family day care provider" means a child day care provider who
34 regularly provides child day care and early learning services for not
35 more than twelve children in the provider's home in the family living
36 quarters;

1 (d) "Service provider" means the entity that operates a community
2 facility.

3 (2) "Agency" does not include the following:

4 (a) Persons related to the child in the following ways:

5 (i) Any blood relative, including those of half-blood, and
6 including first cousins, nephews or nieces, and persons of preceding
7 generations as denoted by prefixes of grand, great, or great-great;

8 (ii) Stepfather, stepmother, stepbrother, and stepsister;

9 (iii) A person who legally adopts a child or the child's parent as
10 well as the natural and other legally adopted children of such persons,
11 and other relatives of the adoptive parents in accordance with state
12 law; or

13 (iv) Spouses of any persons named in (i), (ii), or (iii) of this
14 subsection (2)(a), even after the marriage is terminated;

15 (b) Persons who are legal guardians of the child;

16 (c) Persons who care for a neighbor's or friend's child or
17 children, with or without compensation, where the person providing care
18 for periods of less than twenty-four hours does not conduct such
19 activity on an ongoing, regularly scheduled basis for the purpose of
20 engaging in business, which includes, but is not limited to,
21 advertising such care;

22 (d) Parents on a mutually cooperative basis exchange care of one
23 another's children;

24 (e) Nursery schools or kindergartens that are engaged primarily in
25 educational work with preschool children and in which no child is
26 enrolled on a regular basis for more than four hours per day;

27 (f) Schools, including boarding schools, that are engaged primarily
28 in education, operate on a definite school year schedule, follow a
29 stated academic curriculum, accept only school-age children, and do not
30 accept custody of children;

31 (g) Seasonal camps of three months' or less duration engaged
32 primarily in recreational or educational activities;

33 (h) Facilities providing care to children for periods of less than
34 twenty-four hours whose parents remain on the premises to participate
35 in activities other than employment;

36 (i) Any agency having been in operation in this state ten years
37 before June 8, 1967, and not seeking or accepting moneys or assistance

1 from any state or federal agency, and is supported in part by an
2 endowment or trust fund;

3 (j) An agency operated by any unit of local, state, or federal
4 government or an agency, located within the boundaries of a federally
5 recognized Indian reservation, licensed by the Indian tribe;

6 (k) An agency located on a federal military reservation, except
7 where the military authorities request that such agency be subject to
8 the licensing requirements of this chapter;

9 (l) An agency that offers early learning and support services, such
10 as parent education, and does not provide child care services on a
11 regular basis.

12 (3) "Department" means the department of early learning.

13 (4) "Director" means the director of the department.

14 (5) "Enforcement action" means denial, suspension, revocation,
15 modification, or nonrenewal of a license pursuant to section 311(1) of
16 this act or assessment of civil monetary penalties pursuant to section
17 311(3) of this act.

18 (6) "Probationary license" means a license issued as a disciplinary
19 measure to an agency that has previously been issued a full license but
20 is out of compliance with licensing standards.

21 (7) "Requirement" means any rule, regulation, or standard of care
22 to be maintained by an agency.

23 NEW SECTION. **Sec. 103.** (1) The department of early learning is
24 created as an executive branch agency. The department is vested with
25 all powers and duties transferred to it under this chapter and such
26 other powers and duties as may be authorized by law.

27 (2) The primary duties of the department are to implement state
28 early learning policy and to coordinate, consolidate, and integrate
29 child care and early learning programs in order to administer programs
30 and funding as efficiently as possible. The department's duties
31 include, but are not limited to, the following:

32 (a) To support both public and private sectors toward a
33 comprehensive and collaborative system of early learning that serves
34 parents, children, and providers and to encourage best practices in
35 child care and early learning programs;

36 (b) To improve parent education and support;

1 (c) To carry out activities to improve the quality of early
2 learning opportunities for young children including activities in
3 cooperation with the private-public partnership;

4 (d) To administer child care and early learning programs;

5 (e) To standardize internal financial audits, oversight visits,
6 performance benchmarks, and licensing criteria, so that programs can
7 function in an integrated fashion;

8 (f) To assist in the implementation of the private-public
9 partnership and cooperate with that partnership in pursuing its goals
10 including providing data and support necessary for the successful work
11 of the partnership;

12 (g) To work cooperatively and in coordination with the early
13 learning council; and

14 (h) To collaborate with the K-12 school system at the state and
15 local levels to ensure appropriate connections and smooth transitions
16 between early learning and K-12 programs.

17 (3) The department's programs shall be designed in a way that
18 respects and preserves the ability of parents and legal guardians to
19 direct the education, development, and upbringing of their children.
20 The department shall include parents and legal guardians in the
21 development of policies and program decisions affecting their children.

22 NEW SECTION. **Sec. 104.** (1) The executive head and appointing
23 authority of the department is the director. The director shall be
24 appointed by the governor with the consent of the senate, and shall
25 serve at the pleasure of the governor. The governor shall solicit
26 input from all parties involved in the private-public partnership
27 concerning this appointment. The director shall be paid a salary to be
28 fixed by the governor in accordance with RCW 43.03.040. If a vacancy
29 occurs in the position of director while the senate is not in session,
30 the governor shall make a temporary appointment until the next meeting
31 of the senate when the governor's nomination for the office of director
32 shall be presented.

33 (2) The director may employ staff members, who shall be exempt from
34 chapter 41.06 RCW, and any additional staff members as are necessary to
35 administer this chapter. The director may delegate any power or duty
36 vested in him or her by this chapter, including authority to make final

1 decisions and enter final orders in hearings conducted under chapter
2 34.05 RCW.

3 NEW SECTION. **Sec. 105.** It is the intent of the legislature
4 wherever possible to place the internal affairs of the department under
5 the control of the director in order that the director may institute
6 therein the flexible, alert, and intelligent management of its business
7 that changing contemporary circumstances require. Therefore, whenever
8 the director's authority is not specifically limited by law, the
9 director has complete charge and supervisory powers over the
10 department. The director may create such administrative structures as
11 the director considers appropriate, except as otherwise specified by
12 law. The director may employ such assistants and personnel as
13 necessary for the general administration of the department. This
14 employment shall be in accordance with the state civil service law,
15 chapter 41.06 RCW, except as otherwise provided.

16 NEW SECTION. **Sec. 106.** The director may appoint such advisory
17 committees or councils as may be required by any federal legislation as
18 a condition to the receipt of federal funds by the department. The
19 director may also appoint statewide committees or councils on such
20 subject matters as are or come within the department's
21 responsibilities. The committees or councils shall be constituted as
22 required by federal law or as the director may determine.

23 Members of such state advisory committees or councils may be paid
24 their travel expenses in accordance with RCW 43.03.050 and 43.03.060.

25 NEW SECTION. **Sec. 107.** In furtherance of the policy of the state
26 to cooperate with the federal government in all of the programs under
27 the jurisdiction of the department, such rules as may become necessary
28 to entitle the state to participate in federal funds may be adopted,
29 unless expressly prohibited by law. Any internal reorganization
30 carried out under the terms of this chapter shall meet federal
31 requirements that are a necessary condition to state receipt of federal
32 funds. Any section or provision of law dealing with the department
33 that may be susceptible to more than one construction shall be
34 interpreted in favor of the construction most likely to comply with

1 federal laws entitling this state to receive federal funds for the
2 various programs of the department.

3 NEW SECTION. **Sec. 108.** (1) In addition to other duties under this
4 chapter, the director shall actively participate in a nongovernmental
5 private-public partnership focused on supporting government's
6 investments in early learning and ensuring that every child in the
7 state is prepared to succeed in school and in life. Except for
8 licensing as required by Washington state law and to the extent
9 permitted by federal law, the director of the department of early
10 learning shall grant waivers from the rules of state agencies for the
11 operation of early learning programs requested by the nongovernmental
12 private-public partnership to allow for flexibility to pursue market-
13 based approaches to achieving the best outcomes for children and
14 families.

15 (2) In addition to other powers granted to the director, the
16 director may:

17 (a) Enter into contracts on behalf of the department to carry out
18 the purposes of this chapter;

19 (b) Accept gifts, grants, or other funds for the purposes of this
20 chapter; and

21 (c) Adopt, in accordance with chapter 34.05 RCW, rules necessary to
22 implement this chapter, including rules governing child day care and
23 early learning programs under this chapter. This section does not
24 expand the rule-making authority of the director beyond that necessary
25 to implement and administer programs and services existing July 1,
26 2006, as transferred to the department of early learning under section
27 501 of this act. The rule-making authority does not include any
28 authority to set mandatory curriculum or establish what must be taught
29 in child day care centers or by family day care providers.

30 NEW SECTION. **Sec. 109.** Two years after the implementation of the
31 department's early learning program, and every two years thereafter by
32 July 1st, the department shall submit to the governor and the
33 legislature a report measuring the effectiveness of its programs in
34 improving early childhood education. The first report shall include
35 program objectives and identified valid performance measures for
36 evaluating progress toward achieving the objectives, as well as a plan

1 for commissioning a longitudinal study comparing the kindergarten
2 readiness of children participating in the department's programs with
3 the readiness of other children, using nationally accepted testing and
4 assessment methods. Such comparison shall include, but not be limited
5 to, achievement as children of both groups progress through the K-12
6 system and identify year-to-year changes in achievement, if any, in
7 later years of elementary, middle school, and high school education.

8 NEW SECTION. **Sec. 110.** A new section is added to chapter 41.06
9 RCW to read as follows:

10 In addition to the exemptions under RCW 41.06.070, the provisions
11 of this chapter shall not apply in the department of early learning to
12 the director, the director's personal secretary, and any other exempt
13 staff members provided for in section 104(2) of this act.

14 **Sec. 111.** RCW 43.17.010 and 2005 c 333 s 10 are each amended to
15 read as follows:

16 There shall be departments of the state government which shall be
17 known as (1) the department of social and health services, (2) the
18 department of ecology, (3) the department of labor and industries, (4)
19 the department of agriculture, (5) the department of fish and wildlife,
20 (6) the department of transportation, (7) the department of licensing,
21 (8) the department of general administration, (9) the department of
22 community, trade, and economic development, (10) the department of
23 veterans affairs, (11) the department of revenue, (12) the department
24 of retirement systems, (13) the department of corrections, (14) the
25 department of health, (15) the department of financial institutions,
26 (~~and~~) (16) the department of archaeology and historic preservation,
27 and (17) the department of early learning, which shall be charged with
28 the execution, enforcement, and administration of such laws, and
29 invested with such powers and required to perform such duties, as the
30 legislature may provide.

31 **Sec. 112.** RCW 43.17.020 and 2005 c 333 s 11 and 2005 c 319 s 2 are
32 each reenacted and amended to read as follows:

33 There shall be a chief executive officer of each department to be
34 known as: (1) The secretary of social and health services, (2) the
35 director of ecology, (3) the director of labor and industries, (4) the

1 director of agriculture, (5) the director of fish and wildlife, (6) the
2 secretary of transportation, (7) the director of licensing, (8) the
3 director of general administration, (9) the director of community,
4 trade, and economic development, (10) the director of veterans affairs,
5 (11) the director of revenue, (12) the director of retirement systems,
6 (13) the secretary of corrections, (14) the secretary of health, (15)
7 the director of financial institutions, (~~and~~) (16) the director of
8 the department of archaeology and historic preservation, and (17) the
9 director of early learning.

10 Such officers, except the director of fish and wildlife, shall be
11 appointed by the governor, with the consent of the senate, and hold
12 office at the pleasure of the governor. The director of fish and
13 wildlife shall be appointed by the fish and wildlife commission as
14 prescribed by RCW 77.04.055.

15 **Sec. 113.** RCW 42.17.2401 and 2005 c 424 s 17 are each amended to
16 read as follows:

17 For the purposes of RCW 42.17.240, the term "executive state
18 officer" includes:

19 (1) The chief administrative law judge, the director of
20 agriculture, the administrator of the Washington basic health plan, the
21 director of the department of services for the blind, the director of
22 the state system of community and technical colleges, the director of
23 community, trade, and economic development, the secretary of
24 corrections, the director of early learning, the director of ecology,
25 the commissioner of employment security, the chair of the energy
26 facility site evaluation council, the secretary of the state finance
27 committee, the director of financial management, the director of fish
28 and wildlife, the executive secretary of the forest practices appeals
29 board, the director of the gambling commission, the director of general
30 administration, the secretary of health, the administrator of the
31 Washington state health care authority, the executive secretary of the
32 health care facilities authority, the executive secretary of the higher
33 education facilities authority, the executive secretary of the horse
34 racing commission, the executive secretary of the human rights
35 commission, the executive secretary of the indeterminate sentence
36 review board, the director of the department of information services,
37 the director of the interagency committee for outdoor recreation, the

1 executive director of the state investment board, the director of labor
2 and industries, the director of licensing, the director of the lottery
3 commission, the director of the office of minority and women's business
4 enterprises, the director of parks and recreation, the director of
5 personnel, the executive director of the public disclosure commission,
6 the director of retirement systems, the director of revenue, the
7 secretary of social and health services, the chief of the Washington
8 state patrol, the executive secretary of the board of tax appeals, the
9 secretary of transportation, the secretary of the utilities and
10 transportation commission, the director of veterans affairs, the
11 president of each of the regional and state universities and the
12 president of The Evergreen State College, each district and each campus
13 president of each state community college;

14 (2) Each professional staff member of the office of the governor;

15 (3) Each professional staff member of the legislature; and

16 (4) Central Washington University board of trustees, board of
17 trustees of each community college, each member of the state board for
18 community and technical colleges, state convention and trade center
19 board of directors, committee for deferred compensation, Eastern
20 Washington University board of trustees, Washington economic
21 development finance authority, The Evergreen State College board of
22 trustees, executive ethics board, forest practices appeals board,
23 forest practices board, gambling commission, life sciences discovery
24 fund authority board of trustees, Washington health care facilities
25 authority, each member of the Washington health services commission,
26 higher education coordinating board, higher education facilities
27 authority, horse racing commission, state housing finance commission,
28 human rights commission, indeterminate sentence review board, board of
29 industrial insurance appeals, information services board, interagency
30 committee for outdoor recreation, state investment board, commission on
31 judicial conduct, legislative ethics board, liquor control board,
32 lottery commission, marine oversight board, Pacific Northwest electric
33 power and conservation planning council, parks and recreation

7 **POLICIES AND PROGRAMS TRANSFERRED**

8 **Sec. 201.** RCW 41.04.385 and 2005 c 490 s 9 are each amended to
9 read as follows:

10 The legislature finds that (1) demographic, economic, and social
11 trends underlie a critical and increasing demand for child care in the
12 state of Washington; (2) working parents and their children benefit
13 when the employees' child care needs have been resolved; (3) the state
14 of Washington should serve as a model employer by creating a supportive
15 atmosphere, to the extent feasible, in which its employees may meet
16 their child care needs; and (4) the state of Washington should
17 encourage the development of partnerships between state agencies, state
18 employees, state employee labor organizations, and private employers to
19 expand the availability of affordable quality child care. The
20 legislature finds further that resolving employee child care concerns
21 not only benefits the employees and their children, but may benefit the
22 employer by reducing absenteeism, increasing employee productivity,
23 improving morale, and enhancing the employer's position in recruiting
24 and retaining employees. Therefore, the legislature declares that it
25 is the policy of the state of Washington to assist state employees by
26 creating a supportive atmosphere in which they may meet their child
27 care needs. Policies and procedures for state agencies to address
28 employee child care needs will be the responsibility of the director of
29 personnel in consultation with the director of the department of early
30 learning and state employee representatives.

31 **Sec. 202.** RCW 74.13.085 and 1989 c 381 s 2 are each amended to
32 read as follows:

33 It shall be the policy of the state of Washington to:

34 (1) Recognize the family as the most important social and economic
35 unit of society and support the central role parents play in child

1 rearing. All parents are encouraged to care for and nurture their
2 children through the traditional methods of parental care at home.
3 (~~However, there has been a dramatic increase in participation of women~~
4 ~~in the workforce which has made~~) The availability of quality,
5 affordable child care is a (~~critical~~) concern for (~~the state and its~~
6 ~~citizens. There are not enough child care services and facilities to~~
7 ~~meet the needs of~~) working parents, the costs of care are often beyond
8 the resources of working parents, and child care facilities are not
9 located conveniently to work places and neighborhoods. Parents are
10 encouraged to participate fully in the effort to improve the quality of
11 child care services.

12 (2) Promote a variety of culturally and developmentally appropriate
13 child care settings and services of the highest possible quality in
14 accordance with the basic principle of continuity of care. These
15 settings shall include, but not be limited to, family day care homes,
16 mini-centers, centers and schools.

17 (3) Promote the growth, development and safety of children by
18 working with community groups including providers and parents to
19 establish standards for quality service, training of child care
20 providers, fair and equitable monitoring, and salary levels
21 commensurate with provider responsibilities and support services.

22 (4) Promote equal access to quality, affordable, socio-economically
23 integrated child care for all children and families.

24 (5) Facilitate broad community and private sector involvement in
25 the provision of quality child care services to foster economic
26 development and assist industry through the department of early
27 learning.

28 **Sec. 203.** RCW 74.13.0902 and 1989 c 381 s 6 are each amended to
29 read as follows:

30 An employer liaison position is established in the department of
31 (~~social and health services to be colocated at the business assistance~~
32 ~~center established under RCW 43.31.083~~) early learning to be colocated
33 with the department of community, trade, and economic development. The
34 employer liaison shall, within appropriated funds:

35 (1) Staff and assist the child care partnership in the
36 implementation of its duties (~~under RCW 74.13.0901~~);

1 (2) Provide technical assistance to employers regarding child care
2 services, working with and through local resource and referral
3 organizations whenever possible. Such technical assistance shall
4 include at a minimum:

5 (a) Assessing the child care needs of employees and prospective
6 employees;

7 (b) Reviewing options available to employers interested in
8 increasing access to child care for their employees;

9 (c) Developing techniques to permit small businesses to increase
10 access to child care for their employees;

11 (d) Reviewing methods of evaluating the impact of child care
12 activities on employers; and

13 (e) Preparing, collecting, and distributing current information for
14 employers on options for increasing involvement in child care; and

15 (3) Provide assistance to local child care resource and referral
16 organizations to increase their capacity to provide quality technical
17 assistance to employers in their community.

18 **Sec. 204.** RCW 74.13.0903 and 2005 c 490 s 10 are each amended to
19 read as follows:

20 ~~The ((office of child care policy is established to operate under~~
21 ~~the authority of the department of social and health services. The~~
22 ~~duties and responsibilities of the office include, but are not limited~~
23 ~~to, the following, within appropriated funds)) department of early~~
24 ~~learning shall:~~

25 (1) Work in conjunction with the statewide child care resource and
26 referral network as well as local governments, nonprofit organizations,
27 businesses, and community child care advocates to create local child
28 care resource and referral organizations. These organizations may
29 carry out needs assessments, resource development, provider training,
30 technical assistance, and parent information and training;

31 (2) Actively seek public and private money for distribution as
32 grants to the statewide child care resource and referral network and to
33 existing or potential local child care resource and referral
34 organizations;

35 (3) Adopt rules regarding the application for and distribution of
36 grants to local child care resource and referral organizations. The

1 rules shall, at a minimum, require an applicant to submit a plan for
2 achieving the following objectives:

3 (a) Provide parents with information about child care resources,
4 including location of services and subsidies;

5 (b) Carry out child care provider recruitment and training
6 programs, including training under RCW 74.25.040;

7 (c) Offer support services, such as parent and provider seminars,
8 toy-lending libraries, and substitute banks;

9 (d) Provide information for businesses regarding child care supply
10 and demand;

11 (e) Advocate for increased public and private sector resources
12 devoted to child care;

13 (f) Provide technical assistance to employers regarding employee
14 child care services; and

15 (g) Serve recipients of temporary assistance for needy families and
16 working parents with incomes at or below household incomes of one
17 hundred seventy-five percent of the federal poverty line;

18 (4) Provide staff support and technical assistance to the statewide
19 child care resource and referral network and local child care resource
20 and referral organizations;

21 (5) Maintain a statewide child care licensing data bank and work
22 with department (~~of social and health services~~) licensors to provide
23 information to local child care resource and referral organizations
24 about licensed child care providers in the state;

25 (6) Through the statewide child care resource and referral network
26 and local resource and referral organizations, compile data about local
27 child care needs and availability for future planning and development;

28 (7) Coordinate with the statewide child care resource and referral
29 network and local child care resource and referral organizations for
30 the provision of training and technical assistance to child care
31 providers; and

32 (8) Collect and assemble information regarding the availability of
33 insurance and of federal and other child care funding to assist state
34 and local agencies, businesses, and other child care providers in
35 offering child care services.

36 **Sec. 205.** RCW 74.13.098 and 2005 c 507 s 2 are each amended to
37 read as follows:

1 (1) Subject to the availability of funds appropriated for this
2 specific purpose, the (~~division of child care and early learning in~~
3 ~~the~~) department (~~of social and health services~~) shall establish a
4 child care career and wage ladder in licensed child care centers that
5 meet the following criteria: (a) At least ten percent of child care
6 slots are dedicated to children whose care is subsidized by the state
7 or any political subdivision thereof or any local government; (b) the
8 center agrees to adopt the child care career and wage ladder, which, at
9 a minimum, shall be at the same pay schedule as existed in the previous
10 child care career and wage ladder pilot project; and (c) the center
11 meets further program standards as established by rule pursuant to

19 **DEPARTMENT OF EARLY LEARNING LICENSING**

20 NEW SECTION. **Sec. 301.** It shall be the director's duty with
21 regard to licensing:

22 (1) In consultation and with the advice and assistance of persons
23 representative of the various type agencies to be licensed, to
24 designate categories of child care facilities for which separate or
25 different requirements shall be developed as may be appropriate whether
26 because of variations in the ages and other characteristics of the
27 children served, variations in the purposes and services offered or
28 size or structure of the agencies to be licensed, or because of any
29 other factor relevant thereto;

30 (2) In consultation and with the advice and assistance of persons
31 representative of the various type agencies to be licensed, to adopt
32 and publish minimum requirements for licensing applicable to each of
33 the various categories of agencies to be licensed under this chapter.

34 The minimum requirements shall be limited to:

1 (a) The size and suitability of a facility and the plan of
2 operation for carrying out the purpose for which an applicant seeks a
3 license;

4 (b) The character, suitability, and competence of an agency and
5 other persons associated with an agency directly responsible for the
6 care of children. In consultation with law enforcement personnel, the
7 director shall investigate the conviction record or pending charges and
8 dependency record information under chapter 43.43 RCW of each agency
9 and its staff seeking licensure or relicensure. No unfounded
10 allegation of child abuse or neglect as defined in RCW 26.44.020 may be
11 disclosed to a provider licensed under this chapter. In order to
12 determine the suitability of applicants for an agency license,
13 licensees, their employees, and other persons who have unsupervised
14 access to children in care, and who have not resided in the state of
15 Washington during the three-year period before being authorized to care
16 for children shall be fingerprinted. The fingerprints shall be
17 forwarded to the Washington state patrol and federal bureau of
18 investigation for a criminal history records check. The fingerprint
19 criminal history records checks will be at the expense of the licensee.
20 The licensee may not pass this cost on to the employee or prospective
21 employee, unless the employee is determined to be unsuitable due to his
22 or her criminal history record. The director shall use the information
23 solely for the purpose of determining eligibility for a license and for
24 determining the character, suitability, and competence of those persons
25 or agencies, excluding parents, not required to be licensed who are
26 authorized to care for children. Criminal justice agencies shall
27 provide the director such information as they may have and that the
28 director may require for such purpose;

29 (c) The number of qualified persons required to render the type of
30 care for which an agency seeks a license;

31 (d) The health, safety, cleanliness, and general adequacy of the
32 premises to provide for the comfort, care, and well-being of children;

33 (e) The provision of necessary care and early learning, including
34 food, supervision, and discipline; physical, mental, and social well-
35 being; and educational and recreational opportunities for those served;

36 (f) The financial ability of an agency to comply with minimum
37 requirements established under this chapter; and

38 (g) The maintenance of records pertaining to the care of children;

1 (3) To issue, revoke, or deny licenses to agencies pursuant to this
2 chapter. Licenses shall specify the category of care that an agency is
3 authorized to render and the ages and number of children to be served;

4 (4) To prescribe the procedures and the form and contents of
5 reports necessary for the administration of this chapter and to require
6 regular reports from each licensee;

7 (5) To inspect agencies periodically to determine whether or not
8 there is compliance with this chapter and the requirements adopted
9 under this chapter;

10 (6) To review requirements adopted under this chapter at least
11 every two years and to adopt appropriate changes after consultation
12 with affected groups for child day care requirements; and

13 (7) To consult with public and private agencies in order to help

23 necessary to protect all persons residing therein from fire hazards;

24 (2) To make or cause to be made such inspections and investigations
25 of agencies as he or she deems necessary;

27 of this act and to adopt necessary changes after consultation as
28 required in subsection (1) of this section;

29 (4) To issue to applicants for licenses under this chapter who
30 comply with the requirements, a certificate of compliance, a copy of
31 which shall be presented to the department before a license shall be
32 issued, except that an initial license may be issued as provided in
33 section 309 of this act.

35 provide notice of pesticide use to parents or guardians of students and

3 agencies shall be sent by the secretary of state to the department at

8 entrance and the privilege of access to and inspection of records for

20 either grant or deny a license within ninety days. A license shall be

33 renewal of its license, a request for a renewal shall be filed ninety
34 days before the expiration date of the license. If the department has

1 failed to act at the time of the expiration date of the license, the
2 license shall continue in effect until such time as the department
3 acts.

4 NEW SECTION. **Sec. 309.** The director may, at his or her
5 discretion, issue an initial license instead of a full license, to an
6 agency or facility for a period not to exceed six months, renewable for
7 a period not to exceed two years, to allow such agency or facility
8 reasonable time to become eligible for full license.

9 NEW SECTION. **Sec. 310.** (1) The department may issue a
10 probationary license to a licensee who has had a license but is
11 temporarily unable to comply with a rule or has been the subject of
12 multiple complaints or concerns about noncompliance if:

13 (a) The noncompliance does not present an immediate threat to the
14 health and well-being of the children but would be likely to do so if
15 allowed to continue; and

16 (b) The licensee has a plan approved by the department to correct
17 the area of noncompliance within the probationary period.

18 (2) A probationary license may be issued for up to six months, and
19 at the discretion of the department it may be extended for an
20 additional six months. The department shall immediately terminate the
21 probationary license, if at any time the noncompliance for which the
22 probationary license was issued presents an immediate threat to the
23 health or well-being of the children.

24 (3) The department may, at any time, issue a probationary license
25 for due cause that states the conditions of probation.

26 (4) An existing license is invalidated when a probationary license
27 is issued.

28 (5) At the expiration of the probationary license, the department
29 shall reinstate the original license for the remainder of its term,
30 issue a new license, or revoke the original license.

31 (6) A right to an adjudicative proceeding shall not accrue to the
32 licensee whose license has been placed on probationary status unless
33 the licensee does not agree with the placement on probationary status
34 and the department then suspends, revokes, or modifies the license.

1 NEW SECTION. **Sec. 311.** (1) An agency may be denied a license, or
2 any license issued pursuant to this chapter may be suspended, revoked,
3 modified, or not renewed by the director upon proof (a) that the agency
4 has failed or refused to comply with the provisions of this chapter or
5 the requirements adopted pursuant to this chapter; or (b) that the
6 conditions required for the issuance of a license under this chapter
7 have ceased to exist with respect to such licenses. RCW 43.20A.205
8 governs notice of a license denial, revocation, suspension, or
9 modification and provides the right to an adjudicative proceeding.

10 (2) In any adjudicative proceeding regarding the denial,
11 modification, suspension, or revocation of any license under this
12 chapter, the department's decision shall be upheld if it is supported
13 by a preponderance of the evidence.

14 (3) The department may assess civil monetary penalties upon proof
15 that an agency has failed or refused to comply with the rules adopted
16 under this chapter or that an agency subject to licensing under this
17 chapter is operating without a license except that civil monetary
18 penalties shall not be levied against a licensed foster home. Monetary
19 penalties levied against unlicensed agencies that submit an application
20 for licensure within thirty days of notification and subsequently
21 become licensed will be forgiven. These penalties may be assessed in
22 addition to or in lieu of other disciplinary actions. Civil monetary
23 penalties, if imposed, may be assessed and collected, with interest,
24 for each day an agency is or was out of compliance. Civil monetary
25 penalties shall not exceed seventy-five dollars per violation for a
26 family day care home and two hundred fifty dollars per violation for
27 child day care centers. Each day upon which the same or substantially
28 similar action occurs is a separate violation subject to the assessment
29 of a separate penalty. The department shall provide a notification
30 period before a monetary penalty is effective and may forgive the
31 penalty levied if the agency comes into compliance during this period.
32 The department may suspend, revoke, or not renew a license for failure
33 to pay a civil monetary penalty it has assessed pursuant to this
34 chapter within ten days after such assessment becomes final. Chapter
35 43.20A RCW governs notice of a civil monetary penalty and provides the
36 right of an adjudicative proceeding. The preponderance of evidence
37 standard shall apply in adjudicative proceedings related to assessment
38 of civil monetary penalties.

1 (4)(a) In addition to or in lieu of an enforcement action being
2 taken, the department may place a child day care center or family day
3 care provider on nonreferral status if the center or provider has
4 failed or refused to comply with this chapter or rules adopted under
5 this chapter or an enforcement action has been taken. The nonreferral
6 status may continue until the department determines that: (i) No
7 enforcement action is appropriate; or (ii) a corrective action plan has
8 been successfully concluded.

9 (b) Whenever a child day care center or family day care provider is
10 placed on nonreferral status, the department shall provide written
11 notification to the child day care center or family day care provider.

12 (5) The department shall notify appropriate public and private
13 child care resource and referral agencies of the department's decision
14 to: (a) Take an enforcement action against a child day care center or
15 family day care provider; or (b) place or remove a child day care
16 center or family day care provider on nonreferral status.

17 NEW SECTION. **Sec. 312.** (1) The office of administrative hearings
18 shall not assign nor allow an administrative law judge to preside over
19 an adjudicative hearing regarding denial, modification, suspension, or
20 revocation of any license to provide child care under this chapter,
21 unless such judge has received training related to state and federal
22 laws and department policies and procedures regarding:

- 23 (a) Child abuse, neglect, and maltreatment;
- 24 (b) Child protective services investigations and standards;
- 25 (c) Licensing activities and standards;
- 26 (d) Child development; and
- 27 (e) Parenting skills.

28 (2) The office of administrative hearings shall develop and
29 implement a training program that carries out the requirements of this
30 section. The office of administrative hearings shall consult and
31 coordinate with the department in developing the training program. The
32 department may assist the office of administrative hearings in
33 developing and providing training to administrative law judges.

34 NEW SECTION. **Sec. 313.** The director shall immediately suspend the
35 license or certificate of a person who has been certified pursuant to
36 RCW 74.20A.320 by the department of social and health services as a

1 person who is not in compliance with a support order or a residential
2 or visitation order. If the person has continued to meet all other
3 requirements for reinstatement during the suspension, reissuance of the
4 license or certificate shall be automatic upon the director's receipt
5 of a release issued by the department of social and health services
6 stating that the licensee is in compliance with the order.

7 NEW SECTION. **Sec. 314.** Notwithstanding the existence or pursuit
8 of any other remedy, the director may, in the manner provided by law,
9 upon the advice of the attorney general, who shall represent the
10 department in the proceeding, maintain an action in the name of the
11 state for injunction or such other relief as he or she may deem
12 advisable against any agency subject to licensing under the provisions
13 of this chapter or against any such agency not having a license as
14 heretofore provided in this chapter.

15 NEW SECTION. **Sec. 315.** Any agency operating without a license
16 shall be guilty of a misdemeanor. This section shall not be
17 enforceable against an agency until sixty days after the effective date
18 of new rules, applicable to such agency, have been adopted under this
19 chapter.

31 placement of, or assists in the placement of children, expectant
32 mothers, or persons with developmental disabilities for foster care or
33 placement of children for adoption, and shall include the following

1 irrespective of whether there is compensation to the agency or to the
2 children, expectant mothers or persons with developmental disabilities
3 for services rendered:

4 ~~((a)) ("Child day care center" means an agency which regularly
5 provides care for a group of children for periods of less than twenty-
6 four hours;~~

7 ~~(b))~~ "Child-placing agency" means an agency which places a child
8 or children for temporary care, continued care, or for adoption;

9 ~~((c))~~ (b) "Community facility" means a group care facility
10 operated for the care of juveniles committed to the department under
11 RCW 13.40.185. A county detention facility that houses juveniles
12 committed to the department under RCW 13.40.185 pursuant to a contract
13 with the department is not a community facility;

14 ~~((d))~~ (c) "Crisis residential center" means an agency which is a
15 temporary protective residential facility operated to perform the
16 duties specified in chapter 13.32A RCW, in the manner provided in RCW
17 74.13.032 through 74.13.036;

18 ~~((e))~~ (d) "Emergency respite center" is an agency that may be
19 commonly known as a crisis nursery, that provides emergency and crisis
20 care for up to seventy-two hours to children who have been admitted by
21 their parents or guardians to prevent abuse or neglect. Emergency
22 respite centers may operate for up to twenty-four hours a day, and for
23 up to seven days a week. Emergency respite centers may provide care

5 **TRANSFER OF POWERS, DUTIES, AND FUNCTIONS**

6 NEW SECTION. **Sec. 501.** (1) All powers, duties, and functions of
7 the office of the superintendent of public instruction and the
8 department of community, trade, and economic development pertaining to
9 the early childhood education and assistance (ECEAP) program and the
10 early reading initiative are transferred to the department of early
11 learning. All references to the director or the department of
12 community, trade, and economic development in the Revised Code of
13 Washington shall be construed to mean the director or the department of
14 early learning when referring to the functions transferred in this
15 section.

16 (2) All powers, duties, and functions of the division of child care
17 and early learning in the department of social and health services
18 pertaining to the working connections child care program, child care
19 licensing, child care quality activities, and the head start
20 collaboration office are transferred to the department of early
21 learning. However, eligibility staffing and eligibility payment
22 functions for the working connections child care program shall not be
23 transferred to the department of early learning. All references to the
24 secretary or the department of social and health services in the
25 Revised Code of Washington shall be construed to mean the director or
26 the department of early learning when referring to the functions
27 transferred in this section.

28 (3) Child day care services provided through the children's
29 administration within the department of social and health services are
30 not transferred to the department of early learning.

31 NEW SECTION. **Sec. 502.** All reports, documents, surveys, books,
32 records, files, papers, or written material in the possession of the
33 office of the superintendent of public instruction, the department of
34 social and health services, and the department of community, trade, and
35 economic development pertaining to the powers, functions, and duties

1 transferred in section 501 of this act shall be delivered to the
2 custody of the department of early learning. All cabinets, furniture,

16 department of early learning;

17 (2) Any appropriations made to the department of social and health
18 services for carrying out the powers, functions, and duties transferred
19 shall, on the effective date of this section, be transferred to the
20 department of early learning through an interagency agreement.

21 NEW SECTION. **Sec. 504.** (1) All employees of the office of the
22 superintendent of public instruction, the department of social and
23 health services, and the department of community, trade, and economic
24 development engaged in performing the powers, functions, and duties
25 transferred in section 501 of this act are transferred to the
26 jurisdiction of the department of early learning. All employees
27 classified under chapter 41.06 RCW, the state civil service law, are
28 assigned to the department of early learning to perform their usual
29 duties upon the same terms as formerly, without any loss of rights,
30 subject to any action that may be appropriate thereafter in accordance
31 with the laws and rules governing state civil service.

32 (2) Nothing contained in this section may be construed to alter any
33 existing collective bargaining unit or the provisions of any existing

7 existing contracts and obligations shall remain in full force and shall

23 apportionments to the agencies affected, the state auditor, and the
24 state treasurer. Each of these shall make the appropriate transfer and
25 adjustments in funds and appropriation accounts and equipment records
26 in accordance with the certification.

27 NEW SECTION. **Sec. 506.** By November 15, 2006, the department of
28 early learning, in collaboration with the early learning council, shall
29 prepare a report and make recommendations to the governor and
30 appropriate committees of the legislature detailing:

31 (1) Coordination and collaboration between the department and the
32 K-12 system at the state and local levels to ensure appropriate
33 connections and smooth transitions between early learning and K-12;

34 (2) Ongoing coordination and collaboration between the department
35 and other programs not included in the department;

36 (3) Ways the department will support local communities in

12 audit and review committee shall conduct an evaluation of the

16 separately have been effectively integrated;

17 (2) Reporting and monitoring activities have been consolidated and
18 made more efficient;

19 (3) Consolidation has resulted in administrative efficiencies
