1 AN ACT Relating to the revised uniform arbitration act; amending
2 RCW 3.46.150, 3.50.800, 3.50.805, 15.49.071, 35.20.010, 35.22.425,
3 35.23.555, 35.27.515, 35.30.100, 35A.11.200, 46.96.150, 49.66.090,
4 59.18.320, 59.18.330, 59.20.260, 59.20.270, and 70.87.205; adding a new
5 chapter to Title 7 RCW; repealing RCW 7.04.010, 7.04.020, 7.04.030,
6 7.04.040, 7.04.050, 7.04.060, 7.04.070, 7.04.080, 7.04.090, 7.04.100,
7 7.04.110, 7.04.120, 7.04.130, 7.04.140, 7.04.150, 7.04.160, 7.04.170,
8 7.04.175, 7.04.180, 7.04.190, 7.04.200, 7.04.210, and 7.04.220; and
9 providing an effective date.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

11 NEW SECTION. **Sec. 1.** DEFINITIONS. The definitions set forth in
12 this section apply throughout this chapter.

13 (1) "Arbitration organization" means a neutral association, agency,
14 board, commission, or other entity that initiates, sponsors, or
15 administers arbitration proceedings or is involved in the appointment
16 of arbitrators.

17 (2) "Arbitrator" means an individual appointed to render an award
18 in a controversy between persons who are parties to an agreement to
19 arbitrate.

1 (3) "Authenticate" means:

2 (a) To sign; or

3 (b) To execute or adopt a record by attaching to or logically
4 associating with the record, an electronic sound, symbol, or process
5 with the intent to sign the record.

6 (4) "Court" means a court of competent jurisdiction in this state.

7 (5) "Knowledge" means actual knowledge.

8 (6) "Person" means an individual, corporation, business trust,
9 estate, trust, partnership, limited liability company, association,
10 joint venture, or government; governmental subdivision, agency, or
11 instrumentality; public corporation; or any other legal or commercial
12 entity.

13 (7) "Record" means information that is inscribed on a tangible
14 medium or that is stored in an electronic or other medium and is
15 retrievable in perceivable form.

16 NEW SECTION. **Sec. 2.** NOTICE. Unless the parties to an agreement
17 to arbitrate otherwise agree or except as otherwise provided in this
18 chapter, a person gives notice to another person by taking action that
19 is reasonably necessary to inform the other person in ordinary course,
20 whether or not the other person acquires knowledge of the notice. A
21 person has notice if the person has knowledge of the notice or has
22 received notice. A person receives notice when it comes to the
23 person's attention or the notice is delivered at the person's place of
24 residence or place of business, or at another location held out by the
25 person as a place of delivery of such communications.

26 NEW SECTION. **Sec. 3.** WHEN CHAPTER APPLIES. (1) Before July 1,
27 2006, this chapter governs agreements to arbitrate entered into:

28 (a) On or after the effective date of this act; and

29 (b) Before the effective date of this act, if all parties to the
30 agreement to arbitrate or to arbitration proceedings agree in a record
31 to be governed by this chapter.

32 (2) On or after July 1, 2006, this chapter governs agreements to
33 arbitrate even if the arbitration agreement was entered into before the
34 effective date of this act.

35 (3) This chapter does not apply to any arbitration governed by
36 chapter 7.06 RCW.

1 (4) This chapter does not apply to any arbitration agreement
2 between employers and employees or between employers and associations
3 of employees.

4 NEW SECTION. **Sec. 4.** EFFECT OF AGREEMENT TO ARBITRATE--
5 NONWAIVABLE PROVISIONS. (1) Except as otherwise provided in
6 subsections (2) and (3) of this section, the parties to an agreement to
7 arbitrate or to an arbitration proceeding may waive or vary the
8 requirements of this chapter to the extent permitted by law.

9 (2) Before a controversy arises that is subject to an agreement to
10 arbitrate, the parties to the agreement may not:

11 (a) Waive or vary the requirements of section 5(1), 6(1), 8, 17 (1)
12 or (2), 26, or 28 of this act;

13 (b) Unreasonably restrict the right under section 9 of this act to
14 notice of the initiation of an arbitration proceeding;

15 (c) Unreasonably restrict the right under section 12 of this act to
16 disclosure of any facts by a neutral arbitrator; or

17 (d) Waive the right under section 16 of this act of a party to an
18 agreement to arbitrate to be represented by a lawyer at any proceeding
19 or hearing under this chapter, except that an employer and a labor
20 organization may waive the right to representation by a lawyer in a
21 labor arbitration.

22 (3) The parties to an agreement to arbitrate may not waive or vary
23 the requirements of this section or section 3 (1)(a) or (2), 7, 14, 18,
24 20 (3) or (4), 22, 23, 24, 25 (1) or (2), 29, 31, 50, or 51 of this
25 act.

26 NEW SECTION. **Sec. 5.** APPLICATION TO COURT. (1) Except as
27 otherwise provided in section 28 of this act, an application for
28 judicial relief under this chapter must be made by motion to the court
29 and heard in the manner and upon the notice provided by law or rule of
30 court for making and hearing motions.

31 (2) Notice of an initial motion to the court under this chapter
32 must be served in the manner provided by law for the service of a
33 summons in a civil action unless a civil action is already pending
34 involving the agreement to arbitrate.

1 NEW SECTION. **Sec. 6.** VALIDITY OF AGREEMENT TO ARBITRATE. (1) An
2 agreement contained in a record to submit to arbitration any existing
3 or subsequent controversy arising between the parties to the agreement
4 is valid, enforceable, and irrevocable except upon a ground that exists
5 at law or in equity for the revocation of contract.

6 (2) The court shall decide whether an agreement to arbitrate exists
7 or a controversy is subject to an agreement to arbitrate.

8 (3) An arbitrator shall decide whether a condition precedent to
9 arbitrability has been fulfilled and whether a contract containing a
10 valid agreement to arbitrate is enforceable.

11 (4) If a party to a judicial proceeding challenges the existence
12 of, or claims that a controversy is not subject to, an agreement to
13 arbitrate, the arbitration proceeding may continue pending final
14 resolution of the issue by the court, unless the court otherwise
15 orders.

16 NEW SECTION. **Sec. 7.** MOTION TO COMPEL OR STAY ARBITRATION. (1)
17 On motion of a person showing an agreement to arbitrate and alleging
18 another person's refusal to arbitrate pursuant to the agreement, the
19 court shall order the parties to arbitrate if the refusing party does
20 not appear or does not oppose the motion. If the refusing party
21 opposes the motion, the court shall proceed summarily to decide the
22 issue. Unless the court finds that there is no enforceable agreement
23 to arbitrate, it shall order the parties to arbitrate. If the court
24 finds that there is no enforceable agreement, it may not order the
25 parties to arbitrate.

26 (2) On motion of a person alleging that an arbitration proceeding
27 has been initiated or threatened but that there is no agreement to
28 arbitrate, the court shall proceed summarily to decide the issue. If
29 the court finds that there is an enforceable agreement to arbitrate, it
30 shall order the parties to arbitrate. If the court finds that there is
31 no enforceable agreement, it may not order the parties to arbitrate.

32 (3) The court may not refuse to order arbitration because the claim
33 subject to arbitration lacks merit or grounds for the claim have not
34 been established.

35 (4) If a proceeding involving a claim referable to arbitration
36 under an alleged agreement to arbitrate is pending in court, a motion

1 under this section must be filed in that court. Otherwise a motion
2 under this section may be filed in any court as required by section 27
3 of this act.

4 (5) If a party files a motion with the court to order arbitration
5 under this section, the court shall on just terms stay any judicial
6 proceeding that involves a claim alleged to be subject to the
7 arbitration until the court renders a final decision under this
8 section.

9 (6) If the court orders arbitration, the court shall on just terms
10 stay any judicial proceeding that involves a claim subject to the
11 arbitration. If a claim subject to the arbitration is severable, the
12 court may sever it and limit the stay to that claim.

13 NEW SECTION. **Sec. 8.** PROVISIONAL REMEDIES. (1) Before an
14 arbitrator is appointed and is authorized and able to act, the court,
15 upon motion of a party to an arbitration proceeding and for good cause
16 shown, may enter an order for provisional remedies to protect the
17 effectiveness of the arbitration proceeding to the same extent and
18 under the same conditions as if the controversy were the subject of a
19 civil action.

20 (2) After an arbitrator is appointed and is authorized and able to
21 act, the arbitrator may issue such orders for provisional remedies,
22 including interim awards, as the arbitrator finds necessary to protect
23 the effectiveness of the arbitration proceeding and to promote the fair
24 and expeditious resolution of the controversy, to the same extent and
25 under the same conditions as if the controversy were the subject of a
26 civil action. After an arbitrator is appointed and is authorized and
27 able to act, a party to an arbitration proceeding may move the court
28 for a provisional remedy only if the matter is urgent and the
29 arbitrator is not able to act timely or if the arbitrator cannot
30 provide an adequate remedy.

31 (3) A motion to a court for a provisional remedy under subsection
32 (1) or (2) of this section does not waive any right of arbitration.

33 NEW SECTION. **Sec. 9.** INITIATION OF ARBITRATION. (1) A person
34 initiates an arbitration proceeding by giving notice in a record to the
35 other parties to the agreement to arbitrate in the agreed manner
36 between the parties or, in the absence of agreement, by mail certified

1 or registered, return receipt requested and obtained, or by service as
2 authorized for the initiation of a civil action. The notice must
3 describe the nature of the controversy and the remedy sought.

4 (2) Unless a person interposes an objection as to lack or
5 insufficiency of notice under section 15(3) of this act not later than
6 the commencement of the arbitration hearing, the person's appearance at
7 the hearing waives any objection to lack of or insufficiency of notice.

8 NEW SECTION. **Sec. 10.** CONSOLIDATION OF SEPARATE ARBITRATION
9 PROCEEDINGS. (1) Except as otherwise provided in subsection (3) of
10 this section, upon motion of a party to an agreement to arbitrate or to
11 an arbitration proceeding, the court may order consolidation of
12 separate arbitration proceedings as to all or some of the claims if:

13 (a) There are separate agreements to arbitrate or separate
14 arbitration proceedings between the same persons or one of them is a
15 party to a separate agreement to arbitrate or a separate arbitration
16 proceeding with a third person;

17 (b) The claims subject to the agreements to arbitrate arise in
18 substantial part from the same transaction or series of related
19 transactions;

20 (c) The existence of a common issue of law or fact creates the
21 possibility of conflicting decisions in the separate arbitration
22 proceedings; and

23 (d) Prejudice resulting from a failure to consolidate is not
24 outweighed by the risk of undue delay or prejudice to the rights of or
25 hardship to parties opposing consolidation.

26 (2) The court may order consolidation of separate arbitration
27 proceedings as to certain claims and allow other claims to be resolved
28 in separate arbitration proceedings.

29 (3) The court may not order consolidation of the claims of a party
30 to an agreement to arbitrate that prohibits consolidation.

31 NEW SECTION. **Sec. 11.** APPOINTMENT OF ARBITRATOR--SERVICE AS A
32 NEUTRAL ARBITRATOR. (1) If the parties to an agreement to arbitrate
33 agree on a method for appointing an arbitrator, that method must be
34 followed, unless the method fails. If the parties have not agreed on
35 a method, the agreed method fails, or an arbitrator appointed fails or
36 is unable to act and a successor has not been appointed, the court, on

1 motion of a party to the arbitration proceeding, shall appoint the
2 arbitrator. The arbitrator so appointed has all the powers of an
3 arbitrator designated in the agreement to arbitrate or appointed under
4 the agreed method.

5 (2) An arbitrator who has a known, direct, and material interest in
6 the outcome of the arbitration proceeding or a known, existing, and
7 substantial relationship with a party may not serve as a neutral
8 arbitrator.

9 NEW SECTION. **Sec. 12.** DISCLOSURE BY ARBITRATOR. (1) Before
10 accepting appointment, an individual who is requested to serve as an
11 arbitrator, after making a reasonable inquiry, shall disclose to all
12 parties to the agreement to arbitrate and arbitration proceeding and to
13 any other arbitrators any known facts that a reasonable person would
14 consider likely to affect the impartiality of the arbitrator in the
15 arbitration proceeding, including:

16 (a) A financial or personal interest in the outcome of the
17 arbitration proceeding; and

18 (b) An existing or past relationship with any of the parties to the
19 agreement to arbitrate or the arbitration proceeding, their counsel or
20 representatives, witnesses, or the other arbitrators.

21 (2) An arbitrator has a continuing obligation to disclose to all
22 parties to the agreement to arbitrate and arbitration proceedings and
23 to any other arbitrators any facts that the arbitrator learns after
24 accepting appointment that a reasonable person would consider likely to
25 affect the impartiality of the arbitrator.

26 (3) If an arbitrator discloses a fact required by subsection (1) or
27 (2) of this section to be disclosed and a party timely objects to the
28 appointment or continued service of the arbitrator based upon the
29 disclosure, the objection may be a ground to vacate the award under
30 section 23(1)(b) of this act.

31 (4) If the arbitrator did not disclose a fact as required by
32 subsection (1) or (2) of this section, upon timely objection of a
33 party, an award may be vacated under section 23(1)(b) of this act.

34 (5) An arbitrator appointed as a neutral who does not disclose a
35 known, direct, and material interest in the outcome of the arbitration
36 proceeding or a known, existing, and substantial relationship with a

1 party is presumed to act with evident partiality under section 23(1)(b)
2 of this act.

3 (6) If the parties to an arbitration proceeding agree to the
4 procedures of an arbitration organization or any other procedures for
5 challenges to arbitrators before an award is made, substantial
6 compliance with those procedures is a condition precedent to a motion
7 to vacate an award on that ground under section 23(1)(b) of this act.

8 NEW SECTION. **Sec. 13.** ACTION BY MAJORITY. If there is more than
9 one arbitrator, the powers of the arbitrators must be exercised by a
10 majority of them.

11 NEW SECTION. **Sec. 14.** IMMUNITY OF ARBITRATOR--COMPETENCY TO
12 TESTIFY--ATTORNEYS' FEES AND COSTS. (1) An arbitrator or an
13 arbitration organization acting in that capacity is immune from civil
14 liability to the same extent as a judge of a court of this state acting
15 in a judicial capacity.

16 (2) The immunity afforded by this section supplements any other
17 immunity.

18 (3) If an arbitrator does not make a disclosure required by section
19 12 of this act, the nondisclosure does not cause a loss of immunity
20 under this section.

21 (4) In any judicial, administrative, or similar proceeding, an
22 arbitrator or representative of an arbitration organization is not
23 competent to testify or required to produce records as to any
24 statement, conduct, decision, or ruling occurring during the
25 arbitration proceeding to the same extent as a judge of a court of this
26 state acting in a judicial capacity. This subsection does not apply:

27 (a) To the extent necessary to determine the claim of an arbitrator
28 or an arbitration organization or a representative of the arbitration
29 organization against a party to the arbitration proceeding; or

30 (b) If a party to the arbitration proceeding files a motion to
31 vacate an award under section 23(1) (a) or (b) of this act and
32 establishes prima facie that a ground for vacating the award exists.

33 (5) If a person commences a civil action against an arbitrator, an
34 arbitration organization, or a representative of an arbitration
35 organization arising from the services of the arbitrator, organization,
36 or representative or if a person seeks to compel an arbitrator or a

1 representative of an arbitration organization to testify in violation
2 of subsection (4) of this section, and the court decides that the
3 arbitrator, arbitration organization, or representative of an
4 arbitration organization is immune from civil liability or that the
5 arbitrator or representative of the organization is incompetent to
6 testify, the court shall award to the arbitrator, organization, or
7 representative reasonable attorneys' fees and other reasonable expenses
8 of litigation.

9 NEW SECTION. **Sec. 15.** ARBITRATION PROCESS. (1) The arbitrator
10 may conduct the arbitration in such manner as the arbitrator considers
11 appropriate so as to aid in the fair and expeditious disposition of the
12 proceeding. The authority conferred upon the arbitrator includes the
13 power to hold conferences with the parties to the arbitration
14 proceeding before the hearing and to determine the admissibility,
15 relevance, materiality, and weight of any evidence.

16 (2) The arbitrator may decide a request for summary disposition of
17 a claim or particular issue by agreement of all interested parties or
18 upon request of one party to the arbitration proceeding if that party
19 gives notice to all other parties to the arbitration proceeding and the
20 other parties have a reasonable opportunity to respond.

21 (3) The arbitrator shall set a time and place for a hearing and
22 give notice of the hearing not less than five days before the hearing.
23 Unless a party to the arbitration proceeding interposes an objection to
24 lack of or insufficiency of notice not later than the commencement of
25 the hearing, the party's appearance at the hearing waives the
26 objection. Upon request of a party to the arbitration proceeding and
27 for good cause shown, or upon the arbitrator's own initiative, the
28 arbitrator may adjourn the hearing from time to time as necessary but
29 may not postpone the hearing to a time later than that fixed by the
30 agreement to arbitrate for making the award unless the parties to the
31 arbitration proceeding consent to a later date. The arbitrator may
32 hear and decide the controversy upon the evidence produced although a
33 party who was duly notified of the arbitration proceeding did not
34 appear. The court, on request, may direct the arbitrator to promptly
35 conduct the hearing and render a timely decision.

36 (4) If an arbitrator orders a hearing under subsection (3) of this

1 section, the parties to the arbitration proceeding are entitled to be
2 heard, to present evidence material to the controversy, and to cross-
3 examine witnesses appearing at the hearing.

4 (5) If there is more than one arbitrator, all of them shall conduct
5 the hearing under subsection (3) of this section; however, a majority
6 shall decide any issue and make a final award.

7 (6) If an arbitrator ceases, or is unable, to act during the
8 arbitration proceeding, a replacement arbitrator must be appointed in
9 accordance with section 11 of this act to continue the hearing and to
10 decide the controversy.

11 NEW SECTION. **Sec. 16.** REPRESENTATION BY LAWYER. A party to an
12 arbitration proceeding may be represented by a lawyer.

13 NEW SECTION. **Sec. 17.** WITNESSES--SUBPOENAS--DEPOSITIONS--
14 DISCOVERY. (1) An arbitrator may issue a subpoena for the attendance
15 of a witness and for the production of records and other evidence at
16 any hearing and may administer oaths. A subpoena must be served in the
17 manner for service of subpoenas in a civil action and, upon motion to
18 the court by a party to the arbitration proceeding or the arbitrator,
19 enforced in the manner for enforcement of subpoenas in a civil action.

20 (2) On request of a party to or a witness in an arbitration
21 proceeding, an arbitrator may permit a deposition of any witness,
22 including a witness who cannot be subpoenaed for or is unable to attend
23 a hearing, to be taken under conditions determined by the arbitrator
24 for use as evidence in order to make the proceeding fair, expeditious,
25 and cost-effective.

26 (3) An arbitrator may permit such discovery as the arbitrator
27 decides is appropriate in the circumstances, taking into account the
28 needs of the parties to the arbitration proceeding and other affected
29 persons and the desirability of making the proceeding fair,
30 expeditious, and cost-effective.

31 (4) If an arbitrator permits discovery under subsection (3) of this
32 section, the arbitrator may order a party to the arbitration proceeding
33 to comply with the arbitrator's discovery-related orders, including the
34 issuance of a subpoena for the attendance of a witness and for the
35 production of records and other evidence at a discovery proceeding, and

1 may take action against a party to the arbitration proceeding who does
2 not comply to the extent permitted by law as if the controversy were
3 the subject of a civil action in this state.

4 (5) An arbitrator may issue a protective order to prevent the
5 disclosure of privileged information, confidential information, trade
6 secrets, and other information protected from disclosure as if the
7 controversy were the subject of a civil action in this state.

8 (6) All laws compelling a person under subpoena to testify and all
9 fees for attending a judicial proceeding, a deposition, or a discovery
10 proceeding as a witness apply to an arbitration proceeding as if the
11 controversy were the subject of a civil action in this state.

12 (7) The court may enforce a subpoena or discovery-related order for
13 the attendance of a witness within this state and for the production of
14 records and other evidence issued by an arbitrator in connection with
15 an arbitration proceeding in another state upon conditions determined
16 by the court in order to make the arbitration proceeding fair,
17 expeditious, and cost-effective. A subpoena or discovery-related order
18 issued by an arbitrator must be served in the manner provided by law
19 for service of subpoenas in a civil action in this state and, upon
20 motion to the court by a party to the arbitration proceeding or the
21 arbitrator, enforced in the manner provided by law for enforcement of
22 subpoenas in a civil action in this state.

23 NEW SECTION. **Sec. 18.** COURT ENFORCEMENT OF PREAWARD RULING BY
24 ARBITRATOR. If an arbitrator makes a preaward ruling in favor of a
25 party to the arbitration proceeding, the party may request the
26 arbitrator to incorporate the ruling into an award under section 19 of
27 this act. The successful party may file a motion to the court for an
28 expedited order to confirm the award under section 22 of this act, in
29 which case the court shall proceed summarily to decide the motion. The
30 court shall issue an order to confirm the award unless the court
31 vacates, modifies, or corrects the award of the arbitrator under
32 sections 23 and 24 of this act.

33 NEW SECTION. **Sec. 19.** AWARD. (1) An arbitrator shall make a
34 record of an award. The record must be authenticated by any arbitrator
35 who concurs with the award. The arbitrator or the arbitration

1 organization shall give notice of the award, including a copy of the
2 award, to each party to the arbitration proceeding.

3 (2) An award must be made within the time specified by the
4 agreement to arbitrate or, if not specified therein, within the time
5 ordered by the court. The court may extend or the parties to the
6 arbitration proceeding may agree in a record to extend the time. The
7 court or the parties may do so within or after the time specified or
8 ordered. A party waives any objection that an award was not timely
9 made unless the party gives notice of the objection to the arbitrator
10 before receiving notice of the award.

11 NEW SECTION. **Sec. 20.** CHANGE OF AWARD BY ARBITRATOR. (1) On
12 motion to an arbitrator by a party to the arbitration proceeding, the
13 arbitrator may modify or correct an award:

14 (a) Upon the grounds stated in section 24(1) (a) or (c) of this
15 act;

16 (b) Because the arbitrator has not made a final and definite award
17 upon a claim submitted by the parties to the arbitration proceeding; or

18 (c) To clarify the award.

19 (2) A motion under subsection (1) of this section must be made and
20 served on all parties within twenty days after the movant receives
21 notice of the award.

22 (3) A party to the arbitration proceeding must serve any objections
23 to the motion within ten days after receipt of the notice.

24 (4) If a motion to the court is pending under section 22, 23, or 24
25 of this act, the court may submit the claim to the arbitrator to
26 consider whether to modify or correct the award:

27 (a) Upon the grounds stated in section 24(1) (a) or (c) of this
28 act;

29 (b) Because the arbitrator has not made a final and definite award
30 upon a claim submitted by the parties to the arbitration proceeding; or

31 (c) To clarify the award.

32 (5) An award modified or corrected under this section is subject to
33 sections 22, 23, and 24 of this act.

34 NEW SECTION. **Sec. 21.** REMEDIES--FEES AND EXPENSES OF ARBITRATION
35 PROCEEDING. (1) An arbitrator may award punitive damages or other
36 exemplary relief if such an award is authorized under the applicable

1 law in a civil action involving the same claim and the evidence
2 produced at the hearing justifies the award under the legal standards
3 otherwise applicable to the claim.

4 (2) An arbitrator may award attorneys' fees and other reasonable
5 expenses of arbitration if such an award is authorized by law in a
6 civil action involving the same claim or by the agreement of the
7 parties to the arbitration proceeding.

8 (3) As to all remedies other than those authorized by subsections
9 (1) and (2) of this section, an arbitrator may order such remedies as
10 the arbitrator considers just and appropriate under the circumstances
11 of the arbitration proceeding. The fact that such a remedy could not
12 or would not be granted by the court is not a ground for refusing to
13 confirm an award under section 22 of this act or for vacating an award
14 under section 23 of this act.

15 (4) An arbitrator's expenses and fees, together with other
16 expenses, must be paid as provided in the award.

17 (5) If an arbitrator awards punitive damages or other exemplary
18 relief under subsection (1) of this section, the arbitrator shall
19 specify in the award the basis in fact justifying and the basis in law
20 authorizing the award and state separately the amount of the punitive
21 damages or other exemplary relief.

22 NEW SECTION. **Sec. 22.** CONFIRMATION OF AWARD. After a party to
23 the arbitration proceeding receives notice of an award, the party may
24 file a motion with the court for an order confirming the award, at
25 which time the court shall issue such an order unless the award is

28 NEW SECTION. **Sec. 32.** RELATIONSHIP TO ELECTRONIC SIGNATURES IN
29 GLOBAL AND NATIONAL COMMERCE ACT. The provisions of this chapter
30 governing the legal effect, validity, and enforceability of electronic
31 records or electronic signatures, and of contracts performed with the
32 use of such records or signatures conform to the requirements of

1 section 102 of the electronic signatures in global and national
2 commerce act.

31 after receipt of the notice under RCW 46.96.140.

32 (3) The dispute shall be referred for arbitration to such
33 arbitrator as may be agreed upon by the parties to the dispute. If the
34 parties cannot agree upon a single arbitrator within thirty days from
35 the date the protest is filed, the protesting dealer will select an
36 arbitrator, the manufacturer will select an arbitrator, and the two
37 arbitrators will then select a third. If a third arbitrator is not
38 agreed upon within thirty days, any party may apply to the superior

1 court, and the judge of the superior court having jurisdiction will
2 appoint the third arbitrator. The protesting dealer will pay the
3 arbitrator selected by him, and the manufacturer will pay the
4 arbitrator it selected. The expense of the third arbitrator and all
5 other expenses of arbitration will be shared equally by the parties.
6 Attorneys' fees and fees paid to expert witnesses are not expenses of
7 arbitration and will be paid by the person incurring them.

8 (4) Notwithstanding the terms of a franchise or written statement
9 of the manufacturer and notwithstanding the terms of a waiver, the
10 arbitration will take place in the state of Washington in the county
11 where the protesting dealer has his principal place of business. RCW
12 46.96.160 applies to a determination made by the arbitrator or
13 arbitrators in determining whether good cause exists for permitting the
14 proposed establishment or relocation of a new motor vehicle dealer, and
15 the manufacturer has the burden of proof to establish that good cause
16 exists for permitting the proposed establishment or relocation. After
17 a hearing has been held, the arbitrator or arbitrators shall render a
18 decision as expeditiously as possible, but in any event not later than
19 one hundred twenty days from the date the arbitrator or arbitrators are
20 selected or appointed. The manufacturer shall not establish or
21 relocate the new motor vehicle dealer until the arbitration hearing has
22 been held and the arbitrator or arbitrators have determined that there
23 is good cause for permitting the proposed establishment or relocation.
24 The written decision of the arbitrator is binding upon the parties
25 unless modified, corrected, or vacated under the Washington Arbitration
26 Act. Any party may appeal the decision of the arbitrator under the
27 (~~Washington~~) Uniform Arbitration Act, chapter (~~7.04~~) 7.-- RCW
28 (sections 1 through 32 of this act).

29 (5) If the franchise agreement or the manufacturer's written
30 statement distributed and provided to its dealers does not provide for
31 arbitration under the (~~Washington~~) Uniform Arbitration Act as a
32 mechanism for resolving disputes relating to the establishment of an
33 additional new motor vehicle dealer or the relocation of a new motor
34 vehicle dealer, then the hearing provisions of this section and RCW
35 46.96.170 apply. Nothing in this section is intended to preclude a new
36 motor vehicle dealer from electing to use any other dispute resolution
37 mechanism offered by a manufacturer.

37 process shall be administered by any arbitrator agreed upon by the

1 parties at the time the dispute arises: PROVIDED, That the procedures
2 shall comply with the requirements of chapter ((7.04)) 7.-- RCW
3 (sections 1 through 32 of this act) (relating to arbitration) and of
4 this chapter.

7 (1) Unless otherwise mutually agreed to, in the event a controversy
