1 AN ACT Relating to offender registration; amending RCW 9A.44.130;
2 reenacting and amending RCW 9A.44.130; prescribing penalties; providing
3 an effective date; and providing an expiration date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 9A.44.130 and 2003 c 215 s 1 and 2003 c 53 s 68 are
6 each reenacted and amended to read as follows:

7 (1) Any adult or juvenile residing whether or not the person has a
8 fixed residence, or who is a student, is employed, or carries on a
9 vocation in this state who has been found to have committed or has been
10 convicted of any sex offense or kidnapping offense, or who has been
11 found not guilty by reason of insanity under chapter 10.77 RCW of
12 committing any sex offense or kidnapping offense, shall register with
13 the county sheriff for the county of the person's residence, or if the
14 person is not a resident of Washington, the county of the person's
15 school, or place of employment or vocation, or as otherwise specified
16 in this section. Where a person required to register under this
17 section is in custody of the state department of corrections, the state
18 department of social and health services, a local division of youth
19 services, or a local jail or juvenile detention facility as a result of

1 a sex offense or kidnapping offense, the person shall also register at
2 the time of release from custody with an official designated by the
3 agency that has jurisdiction over the person. In addition, any such
4 adult or juvenile: (a) Who is admitted to a public or private
5 institution of higher education shall, within ten days of enrolling or
6 by the first business day after arriving at the institution, whichever
7 is earlier, notify the sheriff for the county of the person's residence
8 of the person's intent to attend the institution; (b) who gains
9 employment at a public or private institution of higher education
10 shall, within ten days of accepting employment or by the first business
11 day after commencing work at the institution, whichever is earlier,
12 notify the sheriff for the county of the person's residence of the
13 person's employment by the institution; or (c) whose enrollment or
14 employment at a public or private institution of higher education is
15 terminated shall, within ten days of such termination, notify the
16 sheriff for the county of the person's residence of the person's
17 termination of enrollment or employment at the institution. Persons
18 required to register under this section who are enrolled in a public or
19 private institution of higher education on June 11, 1998, must notify
20 the county sheriff immediately. The sheriff shall notify the
21 institution's department of public safety and shall provide that
22 department with the same information provided to a county sheriff under
23 subsection (3) of this section.

24 (2) This section may not be construed to confer any powers pursuant
25 to RCW ((~~4.24.500~~)) 4.24.550 upon the public safety department of any
26 public or private institution of higher education.

27 (3)(a) The person shall provide the following information when
28 registering: (i) Name; (ii) address; (iii) date and place of birth;
29 (iv) place of employment; (v) crime for which convicted; (vi) date and
30 place of conviction; (vii) aliases used; (viii) social security number;
31 (ix) photograph; and (x) fingerprints.

32 (b) Any person who lacks a fixed residence shall provide the
33 following information when registering: (i) Name; (ii) date and place
34 of birth; (iii) place of employment; (iv) crime for which convicted;
35 (v) date and place of conviction; (vi) aliases used; (vii) social
36 security number; (viii) photograph; (ix) fingerprints; and (x) where he
37 or she plans to stay.

1 (4)(a) Offenders shall register with the county sheriff within the
2 following deadlines. For purposes of this section the term
3 "conviction" refers to adult convictions and juvenile adjudications for
4 sex offenses or kidnapping offenses:

5 (i) OFFENDERS IN CUSTODY. (A) Sex offenders who committed a sex
6 offense on, before, or after February 28, 1990, and who, on or after
7 July 28, 1991, are in custody, as a result of that offense, of the
8 state department of corrections, the state department of social and
9 health services, a local division of youth services, or a local jail or
10 juvenile detention facility, and (B) kidnapping offenders who on or
11 after July 27, 1997, are in custody of the state department of
12 corrections, the state department of social and health services, a
13 local division of youth services, or a local jail or juvenile detention
14 facility, must register at the time of release from custody with an
15 official designated by the agency that has jurisdiction over the
16 offender. The agency shall within three days forward the registration
17 information to the county sheriff for the county of the offender's
18 anticipated residence. The offender must also register within twenty-
19 four hours from the time of release with the county sheriff for the
20 county of the person's residence, or if the person is not a resident of
21 Washington, the county of the person's school, or place of employment
22 or vocation. The agency that has jurisdiction over the offender shall
23 provide notice to the offender of the duty to register. Failure to
24 register at the time of release and within twenty-four hours of release
25 constitutes a violation of this section and is punishable as provided
26 in subsection (~~((10))~~) (11) of this section.

27 When the agency with jurisdiction intends to release an offender
28 with a duty to register under this section, and the agency has
29 knowledge that the offender is eligible for developmental disability
30 services from the department of social and health services, the agency
31 shall notify the division of developmental disabilities of the release.
32 Notice shall occur not more than thirty days before the offender is to
33 be released. The agency and the division shall assist the offender in
34 meeting the initial registration requirement under this section.
35 Failure to provide such assistance shall not constitute a defense for
36 any violation of this section.

37 (ii) OFFENDERS NOT IN CUSTODY BUT UNDER STATE OR LOCAL
38 JURISDICTION. Sex offenders who, on July 28, 1991, are not in custody

1 but are under the jurisdiction of the indeterminate sentence review
2 board or under the department of correction's active supervision, as
3 defined by the department of corrections, the state department of
4 social and health services, or a local division of youth services, for
5 sex offenses committed before, on, or after February 28, 1990, must
6 register within ten days of July 28, 1991. Kidnapping offenders who,
7 on July 27, 1997, are not in custody but are under the jurisdiction of
8 the indeterminate sentence review board or under the department of
9 correction's active supervision, as defined by the department of
10 corrections, the state department of social and health services, or a
11 local division of youth services, for kidnapping offenses committed
12 before, on, or after July 27, 1997, must register within ten days of
13 July 27, 1997. A change in supervision status of a sex offender who
14 was required to register under this subsection (4)(a)(ii) as of July
15 28, 1991, or a kidnapping offender required to register as of July 27,
16 1997, shall not relieve the offender of the duty to register or to
17 reregister following a change in residence. The obligation to register
18 shall only cease pursuant to RCW 9A.44.140.

19 (iii) OFFENDERS UNDER FEDERAL JURISDICTION. Sex offenders who, on
20 or after July 23, 1995, and kidnapping offenders who, on or after July
21 27, 1997, as a result of that offense are in the custody of the United
22 States bureau of prisons or other federal or military correctional
23 agency for sex offenses committed before, on, or after February 28,
24 1990, or kidnapping offenses committed on, before, or after July 27,
25 1997, must register within twenty-four hours from the time of release
26 with the county sheriff for the county of the person's residence, or if
27 the person is not a resident of Washington, the county of the person's
28 school, or place of employment or vocation. Sex offenders who, on July
29 23, 1995, are not in custody but are under the jurisdiction of the
30 United States bureau of prisons, United States courts, United States
31 parole commission, or military parole board for sex offenses committed
32 before, on, or after February 28, 1990, must register within ten days
33 of July 23, 1995. Kidnapping offenders who, on July 27, 1997, are not
34 in custody but are under the jurisdiction of the United States bureau
35 of prisons, United States courts, United States parole commission, or
36 military parole board for kidnapping offenses committed before, on, or
37 after July 27, 1997, must register within ten days of July 27, 1997.
38 A change in supervision status of a sex offender who was required to

1 register under this subsection (4)(a)(iii) as of July 23, 1995, or a
2 kidnapping offender required to register as of July 27, 1997 shall not
3 relieve the offender of the duty to register or to reregister following
4 a change in residence, or if the person is not a resident of
5 Washington, the county of the person's school, or place of employment
6 or vocation. The obligation to register shall only cease pursuant to
7 RCW 9A.44.140.

8 (iv) OFFENDERS WHO ARE CONVICTED BUT NOT CONFINED. Sex offenders
9 who are convicted of a sex offense on or after July 28, 1991, for a sex
10 offense that was committed on or after February 28, 1990, and
11 kidnapping offenders who are convicted on or after July 27, 1997, for
12 a kidnapping offense that was committed on or after July 27, 1997, but
13 who are not sentenced to serve a term of confinement immediately upon
14 sentencing, shall report to the county sheriff to register immediately
15 upon completion of being sentenced.

16 (v) OFFENDERS WHO ARE NEW RESIDENTS OR RETURNING WASHINGTON
17 RESIDENTS. Sex offenders and kidnapping offenders who move to
18 Washington state from another state or a foreign country that are not
19 under the jurisdiction of the state department of corrections, the
20 indeterminate sentence review board, or the state department of social
21 and health services at the time of moving to Washington, must register
22 within thirty days of establishing residence or reestablishing
23 residence if the person is a former Washington resident. The duty to
24 register under this subsection applies to sex offenders convicted under
25 the laws of another state or a foreign country, federal or military
26 statutes, or Washington state for offenses committed before, on, or
27 after February 28, 1990, and to kidnapping offenders convicted under
28 the laws of another state or a foreign country, federal or military
29 statutes, or Washington state for offenses committed before, on, or
30 after July 27, 1997. Sex offenders and kidnapping offenders from other
31 states or a foreign country who, when they move to Washington, are
32 under the jurisdiction of the department of corrections, the
33 indeterminate sentence review board, or the department of social and
34 health services must register within twenty-four hours of moving to
35 Washington. The agency that has jurisdiction over the offender shall
36 notify the offender of the registration requirements before the
37 offender moves to Washington.

1 (vi) OFFENDERS FOUND NOT GUILTY BY REASON OF INSANITY. Any adult
2 or juvenile who has been found not guilty by reason of insanity under
3 chapter 10.77 RCW of (A) committing a sex offense on, before, or after
4 February 28, 1990, and who, on or after July 23, 1995, is in custody,
5 as a result of that finding, of the state department of social and
6 health services, or (B) committing a kidnapping offense on, before, or
7 after July 27, 1997, and who on or after July 27, 1997, is in custody,
8 as a result of that finding, of the state department of social and
9 health services, must register within twenty-four hours from the time
10 of release with the county sheriff for the county of the person's
11 residence. The state department of social and health services shall
12 provide notice to the adult or juvenile in its custody of the duty to
13 register. Any adult or juvenile who has been found not guilty by
14 reason of insanity of committing a sex offense on, before, or after
15 February 28, 1990, but who was released before July 23, 1995, or any
16 adult or juvenile who has been found not guilty by reason of insanity
17 of committing a kidnapping offense but who was released before July 27,
18 1997, shall be required to register within twenty-four hours of
19 receiving notice of this registration requirement. The state
20 department of social and health services shall make reasonable attempts
21 within available resources to notify sex offenders who were released
22 before July 23, 1995, and kidnapping offenders who were released before
23 July 27, 1997. Failure to register within twenty-four hours of
24 release, or of receiving notice, constitutes a violation of this
25 section and is punishable as provided in subsection (~~(10)~~) (11) of
26 this section.

27 (vii) OFFENDERS WHO LACK A FIXED RESIDENCE. Any person who lacks
28 a fixed residence and leaves the county in which he or she is
29 registered and enters and remains within a new county for twenty-four
30 hours is required to register with the county sheriff not more than
31 twenty-four hours after entering the county and provide the information
32 required in subsection (3)(b) of this section.

33 (viii) OFFENDERS WHO LACK A FIXED RESIDENCE AND WHO ARE UNDER
34 SUPERVISION. Offenders who lack a fixed residence and who are under
35 the supervision of the department shall register in the county of their
36 supervision.

37 (ix) OFFENDERS WHO MOVE TO, WORK, CARRY ON A VOCATION, OR ATTEND
38 SCHOOL IN ANOTHER STATE. Offenders required to register in Washington,

1 who move to another state, or who work, carry on a vocation, or attend
2 school in another state shall register a new address, fingerprints, and
3 photograph with the new state within ten days after establishing
4 residence, or after beginning to work, carry on a vocation, or attend
5 school in the new state. The person must also send written notice
6 within ten days of moving to the new state or to a foreign country to
7 the county sheriff with whom the person last registered in Washington
8 state. The county sheriff shall promptly forward this information to
9 the Washington state patrol.

10 (b) Failure to register within the time required under this section
11 constitutes a per se violation of this section and is punishable as
12 provided in subsection (~~(10)~~) (11) of this section. The county
13 sheriff shall not be required to determine whether the person is living
14 within the county.

15 (c) An arrest on charges of failure to register, service of an
16 information, or a complaint for a violation of this section, or
17 arraignment on charges for a violation of this section, constitutes
18 actual notice of the duty to register. Any person charged with the
19 crime of failure to register under this section who asserts as a
20 defense the lack of notice of the duty to register shall register
21 immediately following actual notice of the duty through arrest,
22 service, or arraignment. Failure to register as required under this
23 subsection (4)(c) constitutes grounds for filing another charge of
24 failing to register. Registering following arrest, service, or
25 arraignment on charges shall not relieve the offender from criminal
26 liability for failure to register prior to the filing of the original
27 charge.

28 (d) The deadlines for the duty to register under this section do
29 not relieve any sex offender of the duty to register under this section
30 as it existed prior to July 28, 1991.

31 (5)(a) If any person required to register pursuant to this section
32 changes his or her residence address within the same county, the person
33 must send written notice of the change of address to the county sheriff
34 within seventy-two hours of moving. If any person required to register
35 pursuant to this section moves to a new county, the person must send
36 written notice of the change of address at least fourteen days before
37 moving to the county sheriff in the new county of residence and must
38 register with that county sheriff within twenty-four hours of moving.

1 The person must also send written notice within ten days of the change
2 of address in the new county to the county sheriff with whom the person
3 last registered. The county sheriff with whom the person last
4 registered shall promptly forward the information concerning the change
5 of address to the county sheriff for the county of the person's new
6 residence. Upon receipt of notice of change of address to a new state,
7 the county sheriff shall promptly forward the information regarding the
8 change of address to the agency designated by the new state as the
9 state's offender registration agency.

10 (b) It is an affirmative defense to a charge that the person failed
11 to send a notice at least fourteen days in advance of moving as
12 required under (a) of this subsection that the person did not know the
13 location of his or her new residence at least fourteen days before
14 moving. The defendant must establish the defense by a preponderance of
15 the evidence and, to prevail on the defense, must also prove by a
16 preponderance that the defendant sent the required notice within
17 twenty-four hours of determining the new address.

18 (6)(a) Any person required to register under this section who lacks
19 a fixed residence shall provide written notice to the sheriff of the
20 county where he or she last registered within forty-eight hours
21 excluding weekends and holidays after ceasing to have a fixed
22 residence. The notice shall include the information required by
23 subsection (3)(b) of this section, except the photograph and
24 fingerprints. The county sheriff may, for reasonable cause, require
25 the offender to provide a photograph and fingerprints. The sheriff
26 shall forward this information to the sheriff of the county in which
27 the person intends to reside, if the person intends to reside in
28 another county.

29 (b) A person who lacks a fixed residence must report weekly, in
30 person, to the sheriff of the county where he or she is registered.
31 The weekly report shall be on a day specified by the county sheriff's
32 office, and shall occur during normal business hours. The county
33 sheriff's office may require the person to list the locations where the
34 person has stayed during the last seven days. The lack of a fixed
35 residence is a factor that may be considered in determining an
36 offender's risk level and shall make the offender subject to disclosure
37 of information to the public at large pursuant to RCW 4.24.550.

1 (c) If any person required to register pursuant to this section
2 does not have a fixed residence, it is an affirmative defense to the
3 charge of failure to register, that he or she provided written notice
4 to the sheriff of the county where he or she last registered within
5 forty-eight hours excluding weekends and holidays after ceasing to have
6 a fixed residence and has subsequently complied with the requirements
7 of subsections (4)(a)(vii) or (viii) and (6) of this section. To
8 prevail, the person must prove the defense by a preponderance of the
9 evidence.

10 (7) All offenders who are required to register pursuant to this
11 section who have a fixed residence and who are designated as a risk
12 level II or III must report, in person, every ninety days to the
13 sheriff of the county where he or she is registered. The report shall
14 be on a day specified by the county sheriff's office, and shall occur
15 during normal business hours. Failure to report as specified
16 constitutes a per se violation of this section and is punishable as
17 provided in subsection (11) of this section.

18 (8) A sex offender subject to registration requirements under this
19 section who applies to change his or her name under RCW 4.24.130 or any
20 other law shall submit a copy of the application to the county sheriff
21 of the county of the person's residence and to the state patrol not
22 fewer than five days before the entry of an order granting the name
23 change. No sex offender under the requirement to register under this
24 section at the time of application shall be granted an order changing
25 his or her name if the court finds that doing so will interfere with
26 legitimate law enforcement interests, except that no order shall be
27 denied when the name change is requested for religious or legitimate
28 cultural reasons or in recognition of marriage or dissolution of
29 marriage. A sex offender under the requirement to register under this
30 section who receives an order changing his or her name shall submit a
31 copy of the order to the county sheriff of the county of the person's
32 residence and to the state patrol within five days of the entry of the
33 order.

34 ~~((+8))~~ (9) The county sheriff shall obtain a photograph of the
35 individual and shall obtain a copy of the individual's fingerprints.

36 ~~((+9))~~ (10) For the purpose of RCW 9A.44.130, 10.01.200,
37 43.43.540, 70.48.470, and 72.09.330:

38 (a) "Sex offense" means:

1 (i) Any offense defined as a sex offense by RCW 9.94A.030;
2 (ii) Any violation under RCW 9A.44.096 (sexual misconduct with a
3 minor in the second degree);
4 (iii) Any violation under RCW 9.68A.090 (communication with a minor
5 for immoral purposes);
6 (iv) Any federal or out-of-state conviction for an offense that
7 under the laws of this state would be classified as a sex offense under
8 this subsection; and
9 (v) Any gross misdemeanor that is, under chapter 9A.28 RCW, a
10 criminal attempt, criminal solicitation, or criminal conspiracy to
11 commit an offense that is classified as a sex offense under RCW
12 9.94A.030 or this subsection.

13 (b) "Kidnapping offense" means: (i) The crimes of kidnapping in
14 the first degree, kidnapping in the second degree, and unlawful
15 imprisonment, as defined in chapter 9A.40 RCW, where the victim is a
16 minor and the offender is not the minor's parent; (ii) any offense that
17 is, under chapter 9A.28 RCW, a criminal attempt, criminal solicitation,
18 or criminal conspiracy to commit an offense that is classified as a
19 kidnapping offense under this subsection (~~((9))~~) (10)(b); and (iii) any
20 federal or out-of-state conviction for an offense that under the laws
21 of this state would be classified as a kidnapping offense under this
22 subsection (~~((9))~~) (10)(b).

23 (c) "Employed" or "carries on a vocation" means employment that is
24 full-time or part-time for a period of time exceeding fourteen days, or
25 for an aggregate period of time exceeding thirty days during any
26 calendar year. A person is employed or carries on a vocation whether
27 the person's employment is financially compensated, volunteered, or for
28 the purpose of government or educational benefit.

29 (d) "Student" means a person who is enrolled, on a full-time or
30 part-time basis, in any public or private educational institution. An
31 educational institution includes any secondary school, trade or
32 professional institution, or institution of higher education.

33 (~~((10))~~) (11)(a) A person who knowingly fails to register with the
34 county sheriff or notify the county sheriff, or who changes his or her
35 name without notifying the county sheriff and the state patrol, as
36 required by this section is guilty of a class C felony if the crime for
37 which the individual was convicted was a felony sex offense as defined
38 in subsection (~~((9))~~) (10)(a) of this section or a federal or out-of-

1 state conviction for an offense that under the laws of this state would
2 be a felony sex offense as defined in subsection (~~(+9+)~~) (10)(a) of
3 this section.

4 (b) If the crime for which the individual was convicted was other
5 than a felony or a federal or out-of-state conviction for an offense
6 that under the laws of this state would be other than a felony,
7 violation of this section is a gross misdemeanor.

8 (~~(+11+)~~) (12)(a) A person who knowingly fails to register or who
9 moves within the state without notifying the county sheriff as required
10 by this section is guilty of a class C felony if the crime for which
11 the individual was convicted was a felony kidnapping offense as defined
12 in subsection (~~(+9+)~~) (10)(b) of this section or a federal or out-of-
13 state conviction for an offense that under the laws of this state would
14 be a felony kidnapping offense as defined in subsection (~~(+9+)~~) (10)(b)
15 of this section.

16 (b) If the crime for which the individual was convicted was other
17 than a felony or a federal or out-of-state conviction for an offense
18 that under the laws of this state would be other than a felony,
19 violation of this section is a gross misdemeanor.

20 **Sec. 2.** RCW 9A.44.130 and 2005 c 380 s 1 are each amended to read
21 as follows:

22 (1)(a) Any adult or juvenile residing whether or not the person has
23 a fixed residence, or who is a student, is employed, or carries on a
24 vocation in this state who has been found to have committed or has been
25 convicted of any sex offense or kidnapping offense, or who has been
26 found not guilty by reason of insanity under chapter 10.77 RCW of
27 committing any sex offense or kidnapping offense, shall register with
28 the county sheriff for the county of the person's residence, or if the
29 person is not a resident of Washington, the county of the person's
30 school, or place of employment or vocation, or as otherwise specified
31 in this section. Where a person required to register under this
32 section is in custody of the state department of corrections, the state
33 department of social and health services, a local division of youth
34 services, or a local jail or juvenile detention facility as a result of
35 a sex offense or kidnapping offense, the person shall also register at
36 the time of release from custody with an official designated by the
37 agency that has jurisdiction over the person.

1 (b) Any adult or juvenile who is required to register under (a) of
2 this subsection:

3 (i) Who is attending, or planning to attend, a public or private
4 school regulated under Title 28A RCW or chapter 72.40 RCW shall, within
5 ten days of enrolling or prior to arriving at the school to attend
6 classes, whichever is earlier, notify the sheriff for the county of the
7 person's residence of the person's intent to attend the school, and the
8 sheriff shall promptly notify the principal of the school;

9 (ii) Who is admitted to a public or private institution of higher
10 education shall, within ten days of enrolling or by the first business
11 day after arriving at the institution, whichever is earlier, notify the
12 sheriff for the county of the person's residence of the person's intent
13 to attend the institution;

14 (iii) Who gains employment at a public or private institution of
15 higher education shall, within ten days of accepting employment or by
16 the first business day after commencing work at the institution,
17 whichever is earlier, notify the sheriff for the county of the person's
18 residence of the person's employment by the institution; or

19 (iv) Whose enrollment or employment at a public or private
20 institution of higher education is terminated shall, within ten days of
21 such termination, notify the sheriff for the county of the person's
22 residence of the person's termination of enrollment or employment at
23 the institution.

24 (c) Persons required to register under this section who are
25 enrolled in a public or private institution of higher education on June
26 11, 1998, or a public or private school regulated under Title 28A RCW
27 or chapter 72.40 RCW on September 1, 2006, must notify the county
28 sheriff immediately.

29 (d) The sheriff shall notify the school's principal or
30 institution's department of public safety and shall provide that
31 department with the same information provided to a county sheriff under
32 subsection (3) of this section.

33 (e)(i) A principal receiving notice under this subsection must
34 disclose the information received from the sheriff under (b) of this
35 subsection as follows:

36 (A) If the student who is required to register as a sex offender is
37 classified as a risk level II or III, the principal shall provide the
38 information received to every teacher of any student required to

1 register under (a) of this subsection and to any other personnel who,
2 in the judgment of the principal, supervises the student or for
3 security purposes should be aware of the student's record;

4 (B) If the student who is required to register as a sex offender is
5 classified as a risk level I, the principal shall provide the
6 information received only to personnel who, in the judgment of the
7 principal, for security purposes should be aware of the student's
8 record.

9 (ii) Any information received by a principal or school personnel
10 under this subsection is confidential and may not be further
11 disseminated except as provided in RCW 28A.225.330, other statutes or
12 case law, and the family and educational and privacy rights act of
13 1994, 20 U.S.C. Sec. 1232g et seq.

14 (2) This section may not be construed to confer any powers pursuant
15 to RCW ((~~4.24.500~~) 4.24.550) upon the public safety department of any
16 public or private school or institution of higher education.

17 (3)(a) The person shall provide the following information when
18 registering: (i) Name; (ii) address; (iii) date and place of birth;
19 (iv) place of employment; (v) crime for which convicted; (vi) date and
20 place of conviction; (vii) aliases used; (viii) social security number;
21 (ix) photograph; and (x) fingerprints.

22 (b) Any person who lacks a fixed residence shall provide the
23 following information when registering: (i) Name; (ii) date and place
24 of birth; (iii) place of employment; (iv) crime for which convicted;
25 (v) date and place of conviction; (vi) aliases used; (vii) social
26 security number; (viii) photograph; (ix) fingerprints; and (x) where he
27 or she plans to stay.

28 (4)(a) Offenders shall register with the county sheriff within the
29 following deadlines. For purposes of this section the term
30 "conviction" refers to adult convictions and juvenile adjudications for
31 sex offenses or kidnapping offenses:

32 (i) OFFENDERS IN CUSTODY. (A) Sex offenders who committed a sex
33 offense on, before, or after February 28, 1990, and who, on or after
34 July 28, 1991, are in custody, as a result of that offense, of the
35 state department of corrections, the state department of social and
36 health services, a local division of youth services, or a local jail or
37 juvenile detention facility, and (B) kidnapping offenders who on or
38 after July 27, 1997, are in custody of the state department of

1 corrections, the state department of social and health services, a
2 local division of youth services, or a local jail or juvenile detention
3 facility, must register at the time of release from custody with an
4 official designated by the agency that has jurisdiction over the
5 offender. The agency shall within three days forward the registration
6 information to the county sheriff for the county of the offender's
7 anticipated residence. The offender must also register within twenty-
8 four hours from the time of release with the county sheriff for the
9 county of the person's residence, or if the person is not a resident of
10 Washington, the county of the person's school, or place of employment
11 or vocation. The agency that has jurisdiction over the offender shall
12 provide notice to the offender of the duty to register. Failure to
13 register at the time of release and within twenty-four hours of release
14 constitutes a violation of this section and is punishable as provided
15 in subsection (~~(10)~~) (11) of this section.

16 When the agency with jurisdiction intends to release an offender
17 with a duty to register under this section, and the agency has
18 knowledge that the offender is eligible for developmental disability
19 services from the department of social and health services, the agency
20 shall notify the division of developmental disabilities of the release.
21 Notice shall occur not more than thirty days before the offender is to
22 be released. The agency and the division shall assist the offender in
23 meeting the initial registration requirement under this section.
24 Failure to provide such assistance shall not constitute a defense for
25 any violation of this section.

26 (ii) OFFENDERS NOT IN CUSTODY BUT UNDER STATE OR LOCAL
27 JURISDICTION. Sex offenders who, on July 28, 1991, are not in custody
28 but are under the jurisdiction of the indeterminate sentence review
29 board or under the department of corrections' active supervision, as
30 defined by the department of corrections, the state department of
31 social and health services, or a local division of youth services, for
32 sex offenses committed before, on, or after February 28, 1990, must
33 register within ten days of July 28, 1991. Kidnapping offenders who,
34 on July 27, 1997, are not in custody but are under the jurisdiction of
35 the indeterminate sentence review board or under the department of
36 corrections' active supervision, as defined by the department of
37 corrections, the state department of social and health services, or a
38 local division of youth services, for kidnapping offenses committed

1 before, on, or after July 27, 1997, must register within ten days of
2 July 27, 1997. A change in supervision status of a sex offender who
3 was required to register under this subsection (4)(a)(ii) as of July
4 28, 1991, or a kidnapping offender required to register as of July 27,
5 1997, shall not relieve the offender of the duty to register or to
6 reregister following a change in residence. The obligation to register
7 shall only cease pursuant to RCW 9A.44.140.

8 (iii) OFFENDERS UNDER FEDERAL JURISDICTION. Sex offenders who, on
9 or after July 23, 1995, and kidnapping offenders who, on or after July
10 27, 1997, as a result of that offense are in the custody of the United
11 States bureau of prisons or other federal or military correctional
12 agency for sex offenses committed before, on, or after February 28,
13 1990, or kidnapping offenses committed on, before, or after July 27,
14 1997, must register within twenty-four hours from the time of release
15 with the county sheriff for the county of the person's residence, or if
16 the person is not a resident of Washington, the county of the person's
17 school, or place of employment or vocation. Sex offenders who, on July
18 23, 1995, are not in custody but are under the jurisdiction of the
19 United States bureau of prisons, United States courts, United States
20 parole commission, or military parole board for sex offenses committed
21 before, on, or after February 28, 1990, must register within ten days
22 of July 23, 1995. Kidnapping offenders who, on July 27, 1997, are not
23 in custody but are under the jurisdiction of the United States bureau
24 of prisons, United States courts, United States parole commission, or
25 military parole board for kidnapping offenses committed before, on, or
26 after July 27, 1997, must register within ten days of July 27, 1997.
27 A change in supervision status of a sex offender who was required to
28 register under this subsection (4)(a)(iii) as of July 23, 1995, or a
29 kidnapping offender required to register as of July 27, 1997 shall not
30 relieve the offender of the duty to register or to reregister following
31 a change in residence, or if the person is not a resident of
32 Washington, the county of the person's school, or place of employment
33 or vocation. The obligation to register shall only cease pursuant to
34 RCW 9A.44.140.

35 (iv) OFFENDERS WHO ARE CONVICTED BUT NOT CONFINED. Sex offenders
36 who are convicted of a sex offense on or after July 28, 1991, for a sex
37 offense that was committed on or after February 28, 1990, and
38 kidnapping offenders who are convicted on or after July 27, 1997, for

1 a kidnapping offense that was committed on or after July 27, 1997, but
2 who are not sentenced to serve a term of confinement immediately upon
3 sentencing, shall report to the county sheriff to register immediately
4 upon completion of being sentenced.

5 (v) OFFENDERS WHO ARE NEW RESIDENTS OR RETURNING WASHINGTON
6 RESIDENTS. Sex offenders and kidnapping offenders who move to
7 Washington state from another state or a foreign country that are not
8 under the jurisdiction of the state department of corrections, the
9 indeterminate sentence review board, or the state department of social
10 and health services at the time of moving to Washington, must register
11 within thirty days of establishing residence or reestablishing
12 residence if the person is a former Washington resident. The duty to
13 register under this subsection applies to sex offenders convicted under
14 the laws of another state or a foreign country, federal or military
15 statutes, or Washington state for offenses committed before, on, or
16 after February 28, 1990, and to kidnapping offenders convicted under
17 the laws of another state or a foreign country, federal or military
18 statutes, or Washington state for offenses committed before, on, or
19 after July 27, 1997. Sex offenders and kidnapping offenders from other
20 states or a foreign country who, when they move to Washington, are
21 under the jurisdiction of the department of corrections, the
22 indeterminate sentence review board, or the department of social and
23 health services must register within twenty-four hours of moving to
24 Washington. The agency that has jurisdiction over the offender shall
25 notify the offender of the registration requirements before the
26 offender moves to Washington.

27 (vi) OFFENDERS FOUND NOT GUILTY BY REASON OF INSANITY. Any adult
28 or juvenile who has been found not guilty by reason of insanity under
29 chapter 10.77 RCW of (A) committing a sex offense on, before, or after
30 February 28, 1990, and who, on or after July 23, 1995, is in custody,
31 as a result of that finding, of the state department of social and
32 health services, or (B) committing a kidnapping offense on, before, or
33 after July 27, 1997, and who on or after July 27, 1997, is in custody,
34 as a result of that finding, of the state department of social and
35 health services, must register within twenty-four hours from the time
36 of release with the county sheriff for the county of the person's
37 residence. The state department of social and health services shall
38 provide notice to the adult or juvenile in its custody of the duty to

1 register. Any adult or juvenile who has been found not guilty by
2 reason of insanity of committing a sex offense on, before, or after
3 February 28, 1990, but who was released before July 23, 1995, or any
4 adult or juvenile who has been found not guilty by reason of insanity
5 of committing a kidnapping offense but who was released before July 27,
6 1997, shall be required to register within twenty-four hours of
7 receiving notice of this registration requirement. The state
8 department of social and health services shall make reasonable attempts
9 within available resources to notify sex offenders who were released
10 before July 23, 1995, and kidnapping offenders who were released before
11 July 27, 1997. Failure to register within twenty-four hours of
12 release, or of receiving notice, constitutes a violation of this
13 section and is punishable as provided in subsection (~~(10)~~) (11) of
14 this section.

15 (vii) OFFENDERS WHO LACK A FIXED RESIDENCE. Any person who lacks
16 a fixed residence and leaves the county in which he or she is
17 registered and enters and remains within a new county for twenty-four
18 hours is required to register with the county sheriff not more than
19 twenty-four hours after entering the county and provide the information
20 required in subsection (3)(b) of this section.

21 (viii) OFFENDERS WHO LACK A FIXED RESIDENCE AND WHO ARE UNDER
22 SUPERVISION. Offenders who lack a fixed residence and who are under
23 the supervision of the department shall register in the county of their
24 supervision.

25 (ix) OFFENDERS WHO MOVE TO, WORK, CARRY ON A VOCATION, OR ATTEND
26 SCHOOL IN ANOTHER STATE. Offenders required to register in Washington,
27 who move to another state, or who work, carry on a vocation, or attend
28 school in another state shall register a new address, fingerprints, and
29 photograph with the new state within ten days after establishing
30 residence, or after beginning to work, carry on a vocation, or attend
31 school in the new state. The person must also send written notice
32 within ten days of moving to the new state or to a foreign country to
33 the county sheriff with whom the person last registered in Washington
34 state. The county sheriff shall promptly forward this information to
35 the Washington state patrol.

36 (b) Failure to register within the time required under this section
37 constitutes a per se violation of this section and is punishable as

1 provided in subsection (~~(10)~~) (11) of this section. The county
2 sheriff shall not be required to determine whether the person is living
3 within the county.

4 (c) An arrest on charges of failure to register, service of an
5 information, or a complaint for a violation of this section, or
6 arraignment on charges for a violation of this section, constitutes
7 actual notice of the duty to register. Any person charged with the
8 crime of failure to register under this section who asserts as a
9 defense the lack of notice of the duty to register shall register
10 immediately following actual notice of the duty through arrest,
11 service, or arraignment. Failure to register as required under this
12 subsection (4)(c) constitutes grounds for filing another charge of
13 failing to register. Registering following arrest, service, or
14 arraignment on charges shall not relieve the offender from criminal
15 liability for failure to register prior to the filing of the original
16 charge.

17 (d) The deadlines for the duty to register under this section do
18 not relieve any sex offender of the duty to register under this section
19 as it existed prior to July 28, 1991.

20 (5)(a) If any person required to register pursuant to this section
21 changes his or her residence address within the same county, the person
22 must send written notice of the change of address to the county sheriff
23 within seventy-two hours of moving. If any person required to register
24 pursuant to this section moves to a new county, the person must send
25 written notice of the change of address at least fourteen days before
26 moving to the county sheriff in the new county of residence and must
27 register with that county sheriff within twenty-four hours of moving.
28 The person must also send written notice within ten days of the change
29 of address in the new county to the county sheriff with whom the person
30 last registered. The county sheriff with whom the person last
31 registered shall promptly forward the information concerning the change
32 of address to the county sheriff for the county of the person's new
33 residence. Upon receipt of notice of change of address to a new state,
34 the county sheriff shall promptly forward the information regarding the
35 change of address to the agency designated by the new state as the
36 state's offender registration agency.

37 (b) It is an affirmative defense to a charge that the person failed
38 to send a notice at least fourteen days in advance of moving as

1 required under (a) of this subsection that the person did not know the
2 location of his or her new residence at least fourteen days before
3 moving. The defendant must establish the defense by a preponderance of
4 the evidence and, to prevail on the defense, must also prove by a
5 preponderance that the defendant sent the required notice within
6 twenty-four hours of determining the new address.

7 (6)(a) Any person required to register under this section who lacks
8 a fixed residence shall provide written notice to the sheriff of the
9 county where he or she last registered within forty-eight hours
10 excluding weekends and holidays after ceasing to have a fixed
11 residence. The notice shall include the information required by
12 subsection (3)(b) of this section, except the photograph and
13 fingerprints. The county sheriff may, for reasonable cause, require
14 the offender to provide a photograph and fingerprints. The sheriff
15 shall forward this information to the sheriff of the county in which
16 the person intends to reside, if the person intends to reside in
17 another county.

18 (b) A person who lacks a fixed residence must report weekly, in
19 person, to the sheriff of the county where he or she is registered.
20 The weekly report shall be on a day specified by the county sheriff's
21 office, and shall occur during normal business hours. The county
22 sheriff's office may require the person to list the locations where the
23 person has stayed during the last seven days. The lack of a fixed
24 residence is a factor that may be considered in determining an
25 offender's risk level and shall make the offender subject to disclosure
26 of information to the public at large pursuant to RCW 4.24.550.

27 (c) If any person required to register pursuant to this section
28 does not have a fixed residence, it is an affirmative defense to the
29 charge of failure to register, that he or she provided written notice
30 to the sheriff of the county where he or she last registered within
31 forty-eight hours excluding weekends and holidays after ceasing to have
32 a fixed residence and has subsequently complied with the requirements
33 of subsections (4)(a)(vii) or (viii) and (6) of this section. To
34 prevail, the person must prove the defense by a preponderance of the
35 evidence.

36 (7) All offenders who are required to register pursuant to this
37 section who have a fixed residence and who are designated as a risk
38 level II or III must report, in person, every ninety days to the

1 sheriff of the county where he or she is registered. The report shall
2 be on a day specified by the county sheriff's office, and shall occur
3 during normal business hours. Failure to report as specified
4 constitutes a per se violation of this section and is punishable as
5 provided in subsection (11) of this section.

6 (8) A sex offender subject to registration requirements under this
7 section who applies to change his or her name under RCW 4.24.130 or any
8 other law shall submit a copy of the application to the county sheriff
9 of the county of the person's residence and to the state patrol not
10 fewer than five days before the entry of an order granting the name
11 change. No sex offender under the requirement to register under this
12 section at the time of application shall be granted an order changing
13 his or her name if the court finds that doing so will interfere with
14 legitimate law enforcement interests, except that no order shall be
15 denied when the name change is requested for religious or legitimate
16 cultural reasons or in recognition of marriage or dissolution of
17 marriage. A sex offender under the requirement to register under this
18 section who receives an order changing his or her name shall submit a
19 copy of the order to the county sheriff of the county of the person's

23 individual and shall obtain a copy of the individual's fingerprints.

26 (a) "Sex offense" means:

27 (i) Any offense defined as a sex offense by RCW 9.94A.030;

28 (ii) Any violation under RCW 9A.44.096 (sexual misconduct with a

30 (iii) Any violation under RCW 9.68A.090 (communication with a minor
31 for immoral purposes);

32 (iv) Any federal or out-of-state conviction for an offense that
