1            AN ACT Relating to providing tax exemptions for solar hot water  
2 systems; adding a new section to chapter 82.08 RCW; adding a new  
3 section to chapter 82.12 RCW; providing an effective date; and  
4 providing an expiration date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6            NEW SECTION.    **Sec. 1.** A new section is added to chapter 82.08 RCW  
7 to read as follows:

8            (1) The tax levied by RCW 82.08.020 shall not apply to sales of OG-  
9 300 rated solar water heating systems, OG-100 rated solar water heating  
10 collectors, solar heat exchangers, or differential solar controllers,  
11 including repair and replacement parts for such equipment, or to sales  
12 of or charges made for labor and services rendered in respect to  
13 installing, repairing, cleaning, altering, or improving such equipment.

14            (2) A person taking the exemption under this section must keep  
15 records necessary for the department to verify eligibility under this  
16 section. This exemption is available only when the buyer provides the  
17 seller with an exemption certificate in a form and manner prescribed by  
18 the department. The seller shall retain a copy of the certificate for  
19 the seller's files.

1 (3) Unless the context clearly requires otherwise, the definitions  
2 in this subsection apply throughout this section.

3 (a) "OG-300 rated solar water heating system" means those fully  
4 integrated solar water heating systems that have been rated as having  
5 met the operational guidelines currently set and listed by the solar  
6 rating and certification corporation.

7 (b) "OG-100 rated solar water heating collector" means those  
8 collectors that convert light energy to heat and that have been rated  
9 as having met the operational guidelines currently set and listed by  
10 the solar rating and certification corporation.

11 (c) "Solar heat exchanger" means a device that is used to transfer  
12 heat from one fluid to another through a separating wall.

13 (d) "Differential solar controller" means a controlling device that  
14 reads and adjusts the temperature at the solar water heating collector  
15 and the heated water collection tank.

16 NEW SECTION. **Sec. 2.** A new section is added to chapter 82.12 RCW  
17 to read as follows:

18 (1) The provisions of this chapter shall not apply in respect to  
19 the use of OG-300 rated solar water heating systems, OG-100 rated solar  
20 water heating collectors, solar heat exchangers, or differential solar  
21 controllers; repair and replacement parts for such equipment; or to  
22 sales of or charges made for labor and services rendered in respect to  
23 installing, repairing, cleaning, altering, or improving such equipment.

24 (2) For the purposes of this section, the definitions in section 1  
25 of this act apply.

26 NEW SECTION. **Sec. 3.** This act takes effect July 1, 2006.

27 NEW SECTION. **Sec. 4.** This act expires July 1, 2009.
