1 AN ACT Relating to health care services; adding a new section to
2 chapter 70.47 RCW; adding a new section to chapter 74.09 RCW; and
3 creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** A new section is added to chapter 70.47 RCW
6 to read as follows:

7 (1) The health care authority, in coordination with the department
8 of social and health services, shall by November 15th of each year
9 report to the legislature:

10 (a) The number of basic health plan enrollees who: (i) Upon
11 enrollment or recertification had reported being employed, and
12 beginning with the 2008 report, the month and year they reported being
13 hired; or (ii) upon enrollment or recertification had reported being
14 the dependent of someone who was employed, and beginning with the 2008
15 report, the month and year they reported the employed person was hired;
16 and (iii) the total cost to the state for these enrollees. The
17 information shall be reported by employer for employers having more
18 than fifty employees as enrollees or with dependents as enrollees.

1 This information shall be provided for the preceding January and June
2 of that year.

3 (b) The following aggregated information: (i) The number of
4 employees who are enrollees or with dependents as enrollees by private
5 and governmental employers; (ii) the number of employees who are
6 enrollees or with dependents as enrollees by employer size for
7 employers with fifty or fewer employees, fifty-one to one hundred
8 employees, one hundred one to one thousand employees, one thousand one
9 to five thousand employees and more than five thousand employees; and
10 (iii) the number of employees who are enrollees or with dependents as
11 enrollees by industry type.

12 For each aggregated classification, the report will include the
13 number of hours worked and total cost to the state for these enrollees.
14 This information shall be for each quarter of the preceding year.

15 NEW SECTION. **Sec. 2.** A new section is added to chapter 74.09 RCW
16 to read as follows:

17 (1) The department of social and health services, in coordination
18 with the health care authority, shall by November 15th of each year
19 report to the legislature:

20 (a) The number of medical assistance recipients who: (i) Upon
21 enrollment or recertification had reported being employed, and
22 beginning with the 2008 report, the month and year they reported being
23 hired; or (ii) upon enrollment or recertification had reported being
24 the dependent of someone who was employed, and beginning with the 2008
25 report, the month and year they reported the employed person was hired.
26 For recipients identified under (a)(i) and (ii) of this subsection, the
27 department shall report the basis for their medical assistance
28 eligibility, including but not limited to family medical coverage,
29 transitional medical assistance, children's medical or aged or disabled
30 coverage; member months; and the total cost to the state for these
31 recipients, expressed as general fund-state, health services account
32 and general fund-federal dollars. The information shall be reported by
33 employer for employers having more than fifty employees as recipients
34 or with dependents as recipients. This information shall be provided
35 for the preceding January and June of that year.

36 (b) The following aggregated information: (i) The number of
37 employees who are recipients or with dependents as recipients by

1 private and governmental employers; (ii) the number of employees who
2 are recipients or with dependents as recipients by employer size for
3 employers with fifty or fewer employees, fifty-one to one hundred
4 employees, one hundred one to one thousand employees, one thousand one
5 to five thousand employees and more than five thousand employees; and
6 (iii) the number of employees who are recipients or with dependents as
7 recipients by industry type.

8 For each aggregated classification, the report will include the
9 number of hours worked, the number of department of social and health
10 services covered lives, and the total cost to the state for these
11 recipients. This information shall be for each quarter of the
12 preceding year.

13 NEW SECTION. **Sec. 3.** If specific funding for the purpose of this
14 act, referencing this act by bill or chapter number, is not provided by
15 June 30, 2006, in the omnibus appropriations act, this act is null and
16 void.
