
SENATE BILL 6062

State of Washington 59th Legislature 2005 Regular Session

1 AN ACT Relating to ferry charges for frequent users; and amending
2 RCW 47.60.326.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 47.60.326 and 2003 c 374 s 4 are each amended to read
5 as follows:

6 (1) In order to maintain an adequate, fair, and economically sound
7 schedule of charges for the transportation of passengers, vehicles, and
8 commodities on the Washington state ferries, the department of
9 transportation each year shall conduct a full review of such charges.

10 (2) Prior to February 1st of each odd-numbered year the department
11 shall transmit to the transportation commission a report of its review
12 together with its recommendations for the revision of a schedule of
13 charges for the ensuing biennium. The commission on or before July 1st
14 of that year shall adopt as a rule, in the manner provided by the
15 Washington administrative procedure act, a schedule of charges for the
16 Washington state ferries for the ensuing biennium commencing July 1st.
17 The schedule may initially be adopted as an emergency rule if necessary
18 to take effect on, or as near as possible to, July 1st.

1 (3) The department in making its review and formulating
2 recommendations and the commission in adopting a schedule of charges
3 may consider any of the following factors:

4 (a) The amount of subsidy available to the ferry system for
5 maintenance and operation;

6 (b) The time and distance of ferry runs;

7 (c) The maintenance and operation costs for ferry runs with a
8 proper adjustment for higher costs of operating outmoded or less
9 efficient equipment;

10 (d) The efficient distribution of traffic between cross-sound
11 routes;

12 (e) The desirability of reasonable (~~commutation~~) rates for
13 persons using the ferry system to commute daily to work and other
14 frequent users who live in ferry-dependent communities;

15 (f) The effect of proposed fares in increasing walk-on and
16 vehicular passenger use;

17 (g) The effect of proposed fares in promoting all types of ferry
18 use during nonpeak periods;

19 (h) The estimated revenues that are projected to be earned by the
20 ferry system from commercial advertisements, parking, contracts,
21 leases, and other sources;

22 (i) Such other factors as prudent managers of a major ferry system
23 would consider.

24 (4) If at any time during the biennium it appears that projected
25 revenues from the Puget Sound ferry operations account and any other
26 operating subsidy available to the Washington state ferries will be
27 less than the projected total cost of maintenance and operation of the
28 Washington state ferries for the biennium, the department shall
29 forthwith undertake a review of its schedule of charges to ascertain
30 whether or not the schedule of charges should be revised. The
31 department shall, upon completion of its review report, submit its
32 recommendation to the transportation commission which may in its sound
33 discretion revise the schedule of charges as required to meet necessary
34 maintenance and operation expenditures of the ferry system for the
35 biennium or may defer action until the regular annual review and
36 revision of ferry charges as provided in subsection (2) of this
37 section.

1 (5) The provisions of RCW 47.60.330 relating to public
2 participation shall apply to the process of revising ferry tolls under
3 this section.

4 (6) Under RCW 43.135.055, the transportation commission may
5 increase ferry tolls included in the schedule of charges adopted under
6 this section by a percentage that exceeds the fiscal growth factor.

7 (7) Notwithstanding the provisions of this section and chapter
8 81.28 RCW, and using sound business judgment, the chief executive
9 officer of the ferry system may authorize the use of promotional,
10 discounted, and special event fares to the general public and
11 commercial enterprises for the purpose of maximizing capacity use and
12 the revenues collected by the ferry system. The department shall
13 report to the transportation commission a summary of the promotional,
14 discounted, and special event fares offered during each fiscal year and
15 the financial results from these activities.
