**SUBSTITUTE SENATE BILL 6330**

1       AN ACT Relating to the establishment of the Washington trade corps  
2 fellowship program; adding new sections to chapter 43.31 RCW; and  
3 creating new sections.

4       BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5       NEW SECTION. **Sec. 1.** The Washington trade corps fellowship  
6 program is established in the department of community, trade, and  
7 economic development. The purpose of the program is to promote  
8 international trade and enhance the work of Washington's trade offices.  
9 The program will award fellowships to students who have shown  
10 significant interest in pursuing a career in international trade and  
11 place them in trade offices. The fellows will be expected to learn the  
12 practice of trade promotion and fulfill the mission of the offices to  
13 promote overseas trade and commerce.

14       NEW SECTION. **Sec. 2.** Unless the context clearly requires  
15 otherwise, the definitions in this section apply to sections 1 through  
16 7 of this act.

17       (1) "Department" means the department of community, trade, and  
18 economic development.

1 (2) "Fellow" means the recipient of a Washington trade corps  
2 fellowship award.

3 (3) "Institution" means an accredited public or private university  
4 or college within the state of Washington.

5 (4) "Trade office" means an office located outside the United  
6 States operated or contracted by the department of community, trade,  
7 and economic development or the department of agriculture for the  
8 purpose of promoting overseas trade and commerce.

9 NEW SECTION. **Sec. 3.** (1) Candidates for the fellowship must be:

10 (a) A resident student as defined in RCW 28B.15.012;

11 (b) Enrolled in an institution's program offering a degree or  
12 credential in international trade, international relations,  
13 international business, or a related area;

14 (c) Proficient in the language common to the area in which they  
15 will be placed.

16 (2) The department may require that fellowship candidates intern  
17 with the department prior to final selection. The department may  
18 impose additional requirements as necessary to facilitate the efficient  
19 operation of its trade offices.

20 NEW SECTION. **Sec. 4.** A fellowship shall be available for no more  
21 than five persons per year. Fellows shall serve a minimum of six  
22 months and may serve a maximum of eighteen months. Fellows shall be  
23 compensated with a stipend of no less than ten thousand dollars.  
24 Fellows shall be provided living and travel expenses while overseas,  
25 but the total cost provided by the department per fellow, per year,  
26 shall not exceed sixty percent of the state's average yearly wage, or  
27 twenty-five thousand dollars, whichever is greater. Institutions are  
28 encouraged to and may provide students with college credit for serving  
29 as a fellow.

30 NEW SECTION. **Sec. 5.** The department shall appoint a committee to  
31 assist it in evaluating and selecting applicants for the fellowships.  
32 At least three of the committee members shall be members of  
33 organizations concerned with international trade; at least one shall be  
34 from a statewide organization; and at least two shall represent  
35 regional organizations from different regions of the state. At least

1 three of the committee members shall be from institutions and have  
2 expertise in international trade. The decision of the department in  
3 selecting fellows is final.

4 NEW SECTION. **Sec. 6.** (1) The department shall assign fellows to  
5 trade offices in consultation with each fellow's institution. No more  
6 than two fellows shall be assigned to any trade office at one time.

7 (2) The department shall establish reporting requirements which the  
8 fellows must meet. The department's reporting requirements may include  
9 research of value to the department's international trade staff or to  
10 trade promotion groups in the state and may be in conjunction with or  
11 in addition to any requirements of the institution.

12 (3) The department may require that the fellow enter into  
13 postfellowship employment with the department for one year and may  
14 require that some or all of the fellowship costs be repaid if the  
15 postfellowship employment requirement is not met.

16 (4) The department shall report to the legislature on the  
17 Washington trade corps fellowship program by December 1, 2006, and by  
18 December 1st of every other year thereafter.

19 NEW SECTION. **Sec. 7.** Neither the department, the institution, nor  
20 any other division of the state is liable for injuries caused by a  
21 change in the security situation of the country in which a fellow is  
22 stationed. Fellows shall follow all travel advisories published by the  
23 United States department of state for the country in which they are  
24 stationed.

25 NEW SECTION. **Sec. 8.** The department of community, trade, and  
26 economic development shall make rules necessary to implement this act.

27 NEW SECTION. **Sec. 9.** Sections 1 through 7 of this act are each  
28 added to chapter 43.31 RCW.

29 NEW SECTION. **Sec. 10.** If specific funding for the purposes of  
30 this act, referencing this act by bill or chapter number, is not  
31 provided by June 30, 2006, in the omnibus appropriations act, this act

1 is null and void.
