HB 3306 By Representatives Orcutt, Roach, Curtis, Shabro, Hinkle, Nixon, McDonald, Ahern, Ericksen, Kretz, Schindler, Walsh, Woods, Cox, Bailey, McCune, Alexander, Clements, Haler, Sump, Strow, Dunn, Armstrong and Serben
