1 On page 2, after line 16, insert the following:

2 "Sec. 2. RCW 82.24.026 and 2005 c 514 s 1102 are each amended
3 to read as follows:

4 (1) In addition to the tax imposed upon the sale, use,
5 consumption, handling, possession, or distribution of cigarettes
6 set forth in RCW 82.24.020, there is imposed a tax in an amount
7 equal to the rate of thirty mills per cigarette.

8 (2) The revenue collected under this section shall be deposited
9 as follows:

10 (a) 21.7 percent shall be deposited into the health services
11 account.

12 (b) 2.8 percent shall be deposited into the general fund.

13 (c) 2.3 percent shall be deposited into the violence reduction
14 and drug enforcement account under RCW 69.50.520.

15 (d) 1.7 percent shall be deposited into the water quality
16 account under RCW 70.146.030.

17 (e) The remainder shall be deposited into the (~~education~~
18 ~~legacy trust account~~) local public health financing account
19 created in section 5 of this act.

20 **Sec. 3.** RCW 28A.505.220 and 2005 c 514 s 1103 are each amended
21 to read as follows:

22 (1) Total distributions from the student achievement fund to
23 each school district shall be based upon the average number of
24 full-time equivalent students in the school district during the
25 previous school year as reported to the office of the
26 superintendent of public instruction by August 31st of the previous
27 school year.

28 (2) The allocation rate per full-time equivalent student shall
29 be (~~three hundred dollars in the 2005-06 school year, three~~
30 ~~hundred seventy-five dollars in the 2006-07 school year, and~~) four

1 hundred fifty dollars in the 2007-08 school year. For each
2 subsequent school year, the amount allocated per full-time
3 equivalent student shall be adjusted for inflation as defined in
4 (~~RCW 43.135.025(8)~~) this section. These allocations per full-
5 time equivalent student from the student achievement fund shall be
6 supported from the following sources:

7 (a) distributions from state property tax proceeds deposited
8 into the student achievement fund under RCW 84.52.068(;

9 (b) Distributions from the education legacy trust account
10 created in RCW 83.100.230.

11 (3) Any funds deposited in the student achievement fund under
12 RCW 43.135.045 shall be allocated to school districts on a one-time
13 basis using a rate per full-time equivalent student. These funds
14 are provided in addition to any amounts allocated in subsection (2)
15 of this section.

16 (4) The school district annual amounts as defined in subsection
17 (2) of this section shall be distributed on the monthly
18 apportionment schedule as defined in RCW 28A.510.250.

19 (5) "Inflation" means the percentage change in the implicit
20 price deflator for the United States for each fiscal year as
21 published by the federal bureau of labor statistics.

22 **Sec. 4.** RCW 84.52.068 and 2005 c 514 s 1104 are each amended
23 to read as follows:

24 (1) A portion of the proceeds of the state property tax levy
25 shall be deposited into the student achievement fund as provided in
26 this section.

27 (2)(a) The amount of the deposit shall be based upon the
28 average number of full-time equivalent students in the school
29 districts during the previous school year as reported to the office
30 of the superintendent of public instruction by August 31st of the
31 previous school year.

32 (b) For the (~~2004-2005 through 2007-2008 school years, an~~
33 ~~annual amount equal to two hundred fifty-four dollars per full-time~~
34 ~~equivalent student in all school districts shall be deposited in~~
35 ~~the student achievement fund.~~

36 ~~(c) For the 2008-2009 school year, an annual amount equal to~~
37 ~~two hundred sixty-five dollars per full-time equivalent student in~~

11 ~~— (f))~~ (c) Each subsequent year following the 2007-08 school
12 year, the amount deposited shall be adjusted for inflation as
13 defined in RCW 28A.505.220.

14 (d) The school district annual amounts shall be deposited based
15 on the monthly apportionment schedule as defined in RCW
16 28A.510.250. The office of the superintendent of public
17 instruction shall notify the department of the monthly amounts to
18 be deposited into the student achievement fund to meet the
19 apportionment schedule."

20 Renumber the sections consecutively and correct any internal
21 references accordingly.

22 On page 3, line 15, after "treasury." insert "A portion of the
23 proceeds from taxes on cigarettes must be deposited into the
24 account, as provided in RCW 82.24.026(2)."

25 Correct the title.

EFFECT: Redirects certain cigarette tax revenues from the Education Legacy Trust Account into the new Public Health Financing Account created by the substitute bill. Eliminates the Education Legacy Trust Account contributions to the Student Achievement Fund that are attributable to cigarette tax revenues. Replaces the revenue reduction to the Student Achievement Fund with increased distributions from the state property tax.
