- 1 Strike everything after the enacting clause and insert the 2. following:
- "NEW SECTION. Sec. 1. DEFINITIONS. The definitions in this 3 4 section apply throughout this chapter unless the context clearly 5 requires otherwise.
  - (1) "Board" means the home inspector advisory licensing board.
  - (2) "Department" means the department of licensing.
  - (3) "Director" means the director of the department of licensing.
- "entities" means 9 (4)"Entity" or educational groups organizations, national organizations or associations, or a national 10 11 test organization.
- 12 (5) "Home inspection" means a professional examination of the current condition of a house. 13
  - (6) "Home inspector" means a person who carries out a noninvasive examination of the condition of a home, often in connection with the sale of that home, using special training and education to carry out the inspection.
- 18 (7) "Report" means a written report prepared and issued after a 19 home inspection.
- (8) "Wood destroying organism" means insects or fungi that consume, 20 21 excavate, develop in, or otherwise modify the integrity of wood or wood 22 products. "Wood destroying organism" includes but is not limited to 23 carpenter ants, moisture ants, subterranean termites, termites, beetles in the family Anobiidae, and wood decay fungi, known 24 25 as wood rot.
- 26 NEW SECTION. Sec. 2. LICENSURE REQUIRED. (1) Beginning September 27 1, 2009, a person shall not engage in or conduct, or advertise or hold 2.8 himself or herself out as engaging in or conducting, the business of or

acting in the capacity of a home inspector within this state without first obtaining a license as provided in this chapter.

- (2) Any person performing the duties of a home inspector on the effective date of this act has until July 1, 2010, to meet the licensing requirements of this chapter. However, if a person performing the duties of a home inspector on the effective date of this act has proof that he or she has worked as a home inspector for at least two years and has conducted at least one hundred home inspections, he or she may apply to the board before September 1, 2009, for licensure without meeting the instruction and training requirements of this chapter.
- 12 (3) The director may begin issuing licenses under this section 13 beginning on July 1, 2009.
- NEW SECTION. Sec. 3. DUTIES OF A LICENSED HOME INSPECTOR. A 14 person licensed under this chapter is responsible for performing a 15 16 visual and noninvasive inspection of the following readily accessible 17 systems and components of a home and reporting on the general condition of those systems and components at the time of the inspection in his or 18 her written report: The roof, foundation, exterior, heating system, 19 20 air-conditioning system, structure, plumbing and electrical systems, 21 and other aspects of the home as may be identified by the board. inspection must include looking for certain fire and safety hazards as 22 23 defined by the board. The standards of practice to be developed by the 24 board will be used as the minimum standards for an inspection. duties of the home inspector with regard to wood destroying organisms 25 26 are provided in section 19 of this act.
- NEW SECTION. Sec. 4. HOME INSPECTOR ADVISORY LICENSING BOARD. 27 (1) The state home inspector advisory licensing board is created. 28 board consists of seven members appointed by the governor, who shall 29 30 advise the director concerning the administration of this chapter. the appointments to this board, six must be actively engaged as home 31 inspectors immediately prior to their appointment to the board, and one 32 must be currently teaching in a home inspector education program. 33 34 Insofar as possible, the composition of the appointed home inspector 35 members of the board must be generally representative of the geographic

distribution of home inspectors licensed under this chapter. No more 1 2 than two board members may be members of a particular national home inspector association or organization. 3

- (2) A home inspector must have the following qualifications to be appointed to the board:
- (a) Actively engaged as a home inspector in the state of Washington 6 7 for five years;
- 8 (b) Licensed as a home inspector under this chapter, except for 9 initial appointments; and
- (c) Performed a minimum of five hundred home inspections in the 10 state of Washington. 11
- (3) Members of the board are appointed for three-year terms. Terms 12 must be staggered so that not more than two appointments are scheduled 13 to be made in any calendar year. Members hold office until the 14 expiration of the terms for which they were appointed. The governor 15 16 may remove a board member for just cause. The governor may appoint a 17 new member to fill a vacancy on the board for the remainder of the unexpired term. All board members are limited to two consecutive 18 19 terms.
- (4) Each board member is entitled to compensation for each day 20 spent conducting official business and to reimbursement for travel 21 22 expenses in accordance with RCW 43.03.240, 43.03.050, and 43.03.060.
- 23 NEW SECTION. Sec. 5. DIRECTOR'S AUTHORITY. The director has the 24 following authority in administering this chapter:
- (1) To adopt, amend, and rescind rules approved by the board as 25 26 deemed necessary to carry out this chapter;
- (2) To administer licensing examinations approved by the board and 27 to adopt or recognize examinations prepared by other entities as 28 29 approved by the board; and
- (3) To adopt standards of professional conduct, practice, and 30 31 ethics as approved by the board.
- NEW SECTION. Sec. 6. BOARD'S AUTHORITY. The board has the 32 following authority in administering this chapter: 33
- (1) To establish rules, including board organization and assignment 34 35 of terms, and meeting frequency and timing, for adoption by the 36 director;

To establish the minimum qualifications for licensing 1 2 applicants as provided in this chapter;

- (3) To approve the method of administration of examinations required by this chapter or by rule as established by the director;
- 5 (4) To approve the content of or recognition of examinations prepared by other entities for adoption by the director; 6
- 7 (5) To set the time and place of examinations with the approval of 8 the director; and
- (6) To establish and review standards of professional conduct, 9 practice, and ethics for adoption by the director. These standards 10 must address what constitutes certain fire and safety hazards as used 11 in section 3 of this act. 12
- NEW SECTION. Sec. 7. QUALIFICATIONS FOR LICENSURE. In order to 13 become licensed as a home inspector, an applicant must submit the 14 following to the department: 15
  - (1) An application on a form developed by the department;
- (2) Proof of a minimum of one hundred twenty hours of classroom 17 instruction approved by the board; 18
- (3) Proof of up to forty hours of field training supervised by a 19 licensed home inspector; and 20
- 21 (4) Evidence of successful passage of the written exam as required in section 8 of this act. 22
- 23 NEW SECTION. Sec. 8. WRITTEN EXAMS. Applicants for licensure must pass an exam that is psychometrically valid, reliable, and legally 24 25 defensible by the state. The exam is to be developed, maintained, and administered by the department. The board shall recommend to the 26 director whether to use an exam that is prepared by a national entity. 27 If an exam prepared by a national entity is used, a section specific to 28 29 Washington shall be developed by the director and included as part of 30 the entire exam.
- NEW SECTION. Sec. 9. LICENSE LENGTH AND RENEWAL. Licenses are 31 issued for a term of two years and expire on the applicant's second 32 birthday following issuance of the license. 33

- NEW SECTION. Sec. 10. ADVERTISING. The term "licensed home 1 2 inspector" and the license number of the inspector must appear on all advertising, correspondence, and documents incidental to a home 3 4 inspection. However, businesses and organizations that conduct 5 national or interstate general marketing and advertising campaigns may omit the license number of the inspector in advertising so long as it 6 7 is included on all documents incident to a home inspection.
- 8 NEW SECTION. Sec. 11. CONTINUING EDUCATION REQUIREMENTS. (1) As a condition of renewing a license under this chapter, a licensed home 9 inspector shall present satisfactory evidence to the board of having 10 11 completed the continuing education requirements provided for in this 12 section.
- (2) Each applicant for license renewal shall complete at least 13 twenty-four hours of instruction in courses approved by the board every 14 15 two years.
- NEW SECTION. Sec. 12. WRITTEN REPORTS. (1) A licensed home 16 inspector shall provide a written report of the home inspection to each 17 person for whom the inspector performs a home inspection within a time 18 19 period set by the board in rule. The issues to be addressed in the 20 report shall be set by the board in rule.

- (2) A licensed home inspector, or other licensed home inspectors or employees who work for the same company or for any company in which the home inspector has a financial interest, shall not, from the time of the inspection until one year from the date of the report, perform any work other than home inspection-related consultation on the home upon which he or she has performed a home inspection.
- 27 NEW SECTION. Sec. 13. SUSPENSION OF LICENSE. (1) The director 28 shall immediately suspend the license of a person who has been 29 certified pursuant to RCW 74.20A.320 by the department of social and health services as a person who is not in compliance with a child 30 support order. If the person has continued to meet all other 31 requirements for a license under this chapter during the suspension, 32 reissuance of the license is automatic upon the board's receipt of a 33 34 release issued by the department of social and health services stating 35 that the licensee is in compliance with the child support order.

procedure in RCW 74.20A.320 is the exclusive administrative remedy for 1 2 contesting the establishment of noncompliance with a child support order, and suspension of a license under this subsection, and satisfies 3 the requirements of RCW 34.05.422. 4

- (2) The director, with the assistance of the board, shall establish by rule under what circumstances a home inspector license may be suspended or revoked. These circumstances shall be based upon accepted industry standards and the board's cumulative experience.
- (3) Any person aggrieved by a decision of the director under this 9 section may appeal the decision as provided in chapter 34.05 RCW. 10 11 adjudicative proceeding shall be conducted under chapter 34.05 RCW by an administrative law judge appointed pursuant to RCW 34.12.030. 12
- NEW SECTION. Sec. 14. CIVIL INFRACTIONS. The department has the 13 authority to issue civil infractions under chapter 7.80 RCW in the 14 15 following instances:
- 16 (1) Conducting or offering to conduct a home inspection without being licensed in accordance with this chapter; 17
- (2) Presenting or attempting to use as his or her own the home 18 inspector license of another; 19
- (3) Giving any false or forged evidence of any kind to the director 20 21 or his or her authorized representative in obtaining a license;
  - (4) Falsely impersonating any other licensee; or
- (5) Attempting to use an expired or revoked license. 23
- 24 All fines and penalties collected or assessed by a court because of a violation of this section must be remitted to the department to be 25 26 deposited into the business and professions account created in RCW 27 43.24.150.
- NEW SECTION. Sec. 15. The uniform regulation of business and 28 29 professions act, chapter 18.235 RCW, governs unlicensed practice, the 30 issuance and denial of licenses, and the discipline of licensees under this chapter. 31
- NEW SECTION. Sec. 16. RELIEF BY INJUNCTION. The director is 32 authorized to apply for relief by injunction without bond, to restrain 33 34 a person from the commission of any act that is prohibited under 35 section 14 of this act. In such a proceeding, it is not necessary to

- 1 allege or prove either that an adequate remedy at law does not exist,
- 2 or that substantial or irreparable damage would result from continued
- 3 violation. The director, individuals acting on the director's behalf,
- 4 and members of the board are immune from suit in any action, civil or
- 5 criminal, based on disciplinary proceedings or other official acts
- 6 performed in the course of their duties in the administration and
- 7 enforcement of this chapter.
- 8 <u>NEW SECTION.</u> **Sec. 17.** EXEMPTION FROM LICENSING. The following
- 9 persons are exempt from the licensing requirements of this chapter when
- 10 acting within the scope of their license or profession:
