1 Strike everything after the enacting clause and insert the
2 following:

3 "Sec. 1. RCW 70.190.010 and 1996 c 132 s 2 are each amended to
4 read as follows:

5 Unless the context clearly requires otherwise, the definitions in
6 this section apply throughout this chapter.

7 (1) "Administrative costs" means the costs associated with
8 procurement; payroll processing; personnel functions; management;
9 maintenance and operation of space and property; data processing and
10 computer services; accounting; budgeting; auditing; indirect costs; and
11 organizational planning, consultation, coordination, and training.

12 (2) "Assessment" has the same meaning as provided in RCW 43.70.010.

13 (3) "At-risk" children are children who engage in or are victims of
14 at-risk behaviors.

15 (4) "At-risk behaviors" means violent delinquent acts, teen
16 substance abuse, teen pregnancy and male parentage, teen suicide
17 attempts, dropping out of school, child abuse or neglect, and domestic
18 violence.

19 (5) "Community public health and safety networks" or "networks"
20 means the organizations authorized under RCW 70.190.060.

21 (6) "Comprehensive plan" means a two-year plan that examines
22 available resources and unmet needs for a county or multicounty area,
23 barriers that limit the effective use of resources, and a plan to
24 address these issues that is broadly supported by local residents.

25 (7) "Participating state agencies" means the office of the
26 superintendent of public instruction, the department of social and
27 health services, the department of health, the employment security
28 department, the department of community, trade, and economic
29 development, and such other departments as may be specifically
30 designated by the governor.

1 (8) "Family policy council" or "council" means the superintendent
2 of public instruction, the secretary of social and health services, the
3 secretary of health, the commissioner of the employment security
4 department, (~~and~~) the director of the department of community, trade,
5 and economic development, the director of the office of public defense,
6 and the director of the department of early learning or their
7 designees, one legislator from each caucus of the senate and house of
8 representatives, and one representative of the governor.

9 (9) "Fiduciary interest" means (a) the right to compensation from
10 a health, educational, social service, or justice system organization
11 that receives public funds, or (b) budgetary or policy-making authority
12 for an organization listed in (a) of this subsection. A person who
13 acts solely in an advisory capacity and receives no compensation from
14 a health, educational, social service, or justice system organization,
15 and who has no budgetary or policy-making authority is deemed to have
16 no fiduciary interest in the organization.

17 (10) "Outcome" or "outcome based" means defined and measurable
18 outcomes used to evaluate progress in reducing the rate of at-risk
19 children and youth through reducing risk factors and increasing
20 protective factors.

21 (11) "Matching funds" means an amount no less than twenty-five
22 percent of the amount budgeted for a network. The network's matching
23 funds may be in-kind goods and services. Funding sources allowable for
24 match include appropriate federal or local levy funds, private
25 charitable funding, and other charitable giving. Basic education funds
26 shall not be used as a match. State general funds shall not be used as
27 a match for violence reduction and drug enforcement account funds
28 created under RCW 69.50.520.

29 (12) "Policy development" has the same meaning as provided in RCW
30 43.70.010.

31 (13) "Protective factors" means those factors determined by the
32 department of health to be empirically associated with behaviors that
33 contribute to socially acceptable and healthy nonviolent behaviors.
34 Protective factors include promulgation, identification, and acceptance
35 of community norms regarding appropriate behaviors in the area of
36 delinquency, early sexual activity, alcohol and substance abuse,
37 educational opportunities, employment opportunities, and absence of
38 crime.

1 (14) "Risk factors" means those factors determined by the
2 department of health to be empirically associated with at-risk
3 behaviors that contribute to violence."
