1       "(2) Premium subsidy payments may be provided to eligible employees  
2 if:  
3       (a) The eligible employee is employed by a small employer;  
4       (b) The actuarial value of the health benefit plan offered by the  
5 small employer is at least substantially equivalent to that of the  
6 basic health plan benefit offered under chapter 70.47 RCW. The office  
7 of the insurance commissioner under Title 48 RCW shall certify those  
8 small employer health benefit plans that are at least ninety percent  
9 actuarially equivalent to the basic health plan benefit; and  
10       (c) The small employer will pay at least forty percent of the  
11 monthly premium cost for health benefit plan coverage of the eligible  
12 employee.  
13       (3) The amount of an eligible employee's premium subsidy shall be  
14 determined by applying the sliding scale subsidy schedule similar to  
15 the subsidy scale used for subsidized basic health plan enrollees under  
16 RCW 70.47.060.  
17       (4) After an eligible individual has enrolled in the program, the  
18 program shall issue subsidies in an amount determined pursuant to  
19 subsection (3) of this section to either the eligible employee or to  
20 the carrier designated by the eligible employee.  
21       (5) An eligible employee must agree to provide verification of  
22 continued enrollment in his or her small employer's health benefit plan  
23 on a semiannual basis or to notify the administrator whenever his or  
24 her enrollment status changes, whichever is earlier. Verification or  
25 notification may be made directly by the employee, or through his or  
26 her employer or the carrier providing the small employer health benefit  
27 plan. When necessary, the administrator has the authority to perform  
28 retrospective audits on premium subsidy accounts. The administrator  
29 may suspend or terminate an employee's participation in the program and  
30 seek repayment of any subsidy amounts paid due to the omission or  
31 misrepresentation of an applicant or enrolled employee. The  
32 administrator shall adopt rules to define the appropriate application  
33 of these sanctions and the processes to implement the sanctions  
34 provided in this subsection, within available resources."

11 "and 70.47A.070; repealing RCW 70.47A.100 and 70.47A.110; repealing  
12 2007 c 260 s 10 (uncodified); and repealing 2007 c 260 s 11  
13 (uncodified)."

**EFFECT:**  Allows benefit plans offered by small employers including self-funded MEWAs and other ERISA plans; Employer benefit products must be certified by the OIC as meeting 90% equivalency with BH. Premium assistance will be developed on a similar scale used for the Basic Health program. Eliminates the HIP Board and the purchasing program. The HIP studies are eliminated.
