7 ~~hereby renamed~~) the children's trust of Washington is hereby renamed
8 the council for children and families. (~~All references to the~~
9 ~~Washington council for the prevention of child abuse and neglect in~~

12 **Sec. 6** RCW 43.121.180 and 2007 c 466 s 3 are each amended to read
13 as follows:

14 (1) Within available funds, the (~~children's trust of~~
15 ~~Washington~~) council for children and families shall fund evidence-
16 based and research-based home visitation programs for improving
17 parenting skills and outcomes for children. Home visitation programs
18 must be voluntary and must address the needs of families to alleviate
19 the effect on child development of factors such as poverty, single
20 parenthood, parental unemployment or underemployment, parental
21 disability, or parental lack of high school diploma, which research
22 shows are risk factors for child abuse and neglect and poor
23 educational outcomes.

24 (2) The (~~children's trust of Washington~~) council for children
25 and families shall develop a plan with the department of social and
26 health services, the department of health, the department of early
27 learning, and the family policy council to coordinate or consolidate

1 home visitation services for children and families and report to the
2 appropriate committees of the legislature by December 1, 2007, with
3 their recommendations for implementation of the plan.

4 **Sec. 7** RCW 43.121.020 and 2007 c 144 s 1 are each amended to read
5 as follows:

6 (1) There is established in the executive office of the governor
7 a (~~Washington council for the prevention of child abuse and~~
8 ~~neglect~~) council for children and families subject to the
9 jurisdiction of the governor.

10 (2) The council shall be composed of the chairperson and
11 fourteen other members as follows:

12 (a) The chairperson and six other members shall be appointed by
13 the governor and shall be selected for their interest and expertise
14 in the prevention of child abuse. A minimum of four designees by the
15 governor shall not be affiliated with governmental agencies. The
16 appointments shall be made on a geographic basis to assure statewide
17 representation. Members appointed by the governor shall serve for
18 three-year terms. Vacancies shall be filled for any unexpired term by
19 appointment in the same manner as the original appointments were made.

20 (b) The secretary of social and health services or the
21 secretary's designee, the superintendent of public instruction or the
22 superintendent's designee, the director of the department of early
23 learning or the director's designee, and the secretary of the
24 department of health or the secretary's designee shall serve as
25 voting members of the council.

26 (c) In addition to the members of the council, four members of
27 the legislature shall serve as nonvoting, ex officio members of the
28 council, one from each political caucus of the house of
29 representatives to be appointed by the speaker of the house of
30 representatives and one from each political caucus of the senate to
31 be appointed by the president of the senate.

36 (1) "Child" means an unmarried person who is under eighteen

2 (3) "Primary prevention" of child abuse and neglect means any
3 effort designed to inhibit or preclude the initial occurrence of

5 and family interaction, and the remediation of factors linked to
6 causes of child maltreatment.

7 (4) "Secondary prevention" means services and programs that
8 identify and assist families under such stress that abuse or neglect
9 is likely or families display symptoms associated with child abuse or
10 neglect.
