## HOUSE BILL 1487

State of Washington 60th Legislature 2007 Regular Session

Read first time 01/22/2007. Referred to Committee on Public Safety & Emergency Preparedness.

- 1 AN ACT Relating to fraudulent pseudoephedrine procurement;
- 2 reenacting and amending RCW 9.94A.515; adding a new section to chapter
- 3 69.50 RCW; and prescribing penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 69.50 RCW 6 to read as follows:
- 7 (1) A person is guilty of fraudulent pseudoephedrine procurement if 8 he or she knowingly procures or purchases pseudoephedrine or any of its 9 salts, isomers, or salts of isomers, with an identification card of 10 another person or a false identification.
- 11 (2) Fraudulent pseudoephedrine procurement is a class C felony.
