1 AN ACT Relating to background check requirements for the department
2 of social and health services and the department of early learning;
3 amending RCW 26.33.190, 26.44.030, 41.06.475, 43.43.830, 43.43.832,
4 43.43.842, 70.128.120, 70.128.130, 70.129.130, 71.09.115, 71.09.300,
5 and 72.23.035; reenacting and amending RCW 74.15.030; adding a new
6 chapter to Title 43 RCW; creating a new section; repealing RCW
7 41.06.476, 43.20A.710, 41.06.480, and 72.05.440; prescribing penalties;
8 providing effective dates; and declaring an emergency.

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

10 NEW SECTION. **Sec. 1.** DEFINITIONS. As used in this chapter,
11 unless the context indicates otherwise:

12 (1) "Applicant" means a current or prospective department or
13 service provider employee, volunteer, student, intern, researcher,
14 contractor, or any other individual who will or may have unsupervised
15 access because of the nature of the work or services he or she
16 provides. "Applicant" includes but is not limited to any individual
17 that will or may have unsupervised access and is:

- 18 (a) Applying for a license or certification from the department;
19 (b) Seeking a contract with the department or a service provider;

1 (c) Applying for employment, promotion, reallocation, or transfer;

2 (d) An individual that a department client or guardian of a
3 department client chooses to hire or engage to provide services to
4 himself or herself or another vulnerable adult, juvenile, or child and
5 who might be eligible to receive payment from the department for
6 services rendered; or

7 (e) A department applicant who will or may work in a
8 department-covered position.

9 (2) "Authorized" means the department grants an applicant, home, or
10 facility permission to:

11 (a) Conduct licensing, certification, or contracting activities;

12 (b) Have unsupervised access;

13 (c) Receive payments from a department program; or

14 (d) Work or serve in a department-covered position.

15 (3) "Background check or investigation" means obtaining and
16 reviewing existing records, files, documents, databases, other sources
17 of tangible information, or background information disclosed by an
18 applicant or service provider under this chapter. "Background check"
19 may include a fingerprint-based background check conducted by the
20 Washington state patrol or federal bureau of investigation.

21 (4) "Background information" means the information obtained during
22 the background check conducted under this chapter to determine whether
23 an applicant or service provider must be disqualified; lacks the
24 character, competence, and suitability to have unsupervised access; or
25 is not eligible for payment from the department for services rendered.

26 (5) "Certified" means a determination by the department that a
27 person, home, or facility that is not required by law to be licensed
28 has met the applicable statutory or regulatory minimum licensing
29 requirements.

30 (6) "Character, competence, and suitability" means the personal and
31 professional capability of an applicant or service provider to have
32 unsupervised access. An assessment of "character, competence, and
33 suitability" includes disqualifying offenses, and may include any other
34 information indicating that an applicant or service provider does not
35 have the personal or professional capability to have unsupervised
36 access.

37 (7) "Children" and "youth" are used interchangeably in this chapter
38 to mean:

- 1 (a) A child or youth who is under the care of a legal guardian,
2 custodian, or the department, including individuals under eighteen
3 years of age;
- 4 (b) Any person eighteen to twenty-one years of age to whom the
5 department is providing continued foster care pursuant to chapter 74.15
6 RCW; or
- 7 (c) An individual with a developmental disability up to twenty-one
8 years of age.
- 9 (8) "Conviction" means the outcome of a criminal charge in which an
10 adult or juvenile has been found guilty of a crime, pled guilty to a
11 crime, or pled no contest resulting in a court finding of guilty.
- 12 (9) "Crimes relating to drugs" means a conviction of a crime of
13 manufacture, delivery, or possession with intent to manufacture or
14 deliver a controlled substance.
- 15 (10) "Criminal history" means criminal history record information,
16 nonconviction data, conviction record, or disposition as defined in RCW
17 10.97.030.
- 18 (11) "Department" means the department of social and health
19 services.
- 20 (12) "Department-covered position" means any position within the
21 department in which a current or prospective department employee,
22 volunteer, student, or intern will or may have unsupervised access.
- 23 (13) "Disqualified" or "disqualifying" means, after considering the
24 applicant or service provider's background information or character,
25 competence, and suitability, it is determined that he or she is not
26 allowed unsupervised access or is not eligible for payment from the
27 department for services rendered.
- 28 (14) "Juvenile" means a juvenile offender under the jurisdiction of
29 juvenile rehabilitation administration or a youthful offender under the
30 jurisdiction of the department of corrections who is placed in a
31 juvenile rehabilitation administration facility.
- 32 (15) "License" means authorized by the department to provide
33 services after meeting minimum licensing requirements.
- 34 (16) "Negative action" means a written decision, finding, or
35 action, regardless of any applicable ongoing appeal process, made or
36 taken by an authorized judicial, administrative, or governmental entity
37 against an applicant or service provider for any matter involving:

1 (a) Dishonesty including but not limited to deliberate
2 falsification of business records, theft, deliberate deception, or
3 lying;

4 (b) Civil adjudication proceeding finding of, or upholding an
5 agency finding of, domestic violence, abuse, sexual abuse, neglect,
6 abandonment, exploitation, financial exploitation, or misappropriation
7 of resident funds or property, under any applicable chapter including
8 but not limited to chapters 13.34, 18.51, 18.130, 26.44, 26.50, 74.34,
9 and 74.42 RCW, or rules adopted under these or other applicable
10 chapters;

11 (c) Domestic violence, unlawful harassment, sexual assault, or any
12 other type of harassment or assault offense involving a vulnerable
13 adult, juvenile, or child, which results in a protection order being
14 issued against the perpetrator;

15 (d) Termination, revocation, suspension, restriction, or denial of
16 a license, professional license, certification, or contract by a
17 governmental entity for a matter that relates to the character,
18 competence, and suitability of an applicant or service provider to have
19 unsupervised access;

20 (e) A department of health disciplining authority final decision
21 including but not limited to unprofessional conduct relating to the
22 following actions:

23 (i) Sexual misconduct;

24 (ii) Abuse, neglect, exploitation, or financial exploitation of
25 anyone who is not considered vulnerable;

26 (iii) Practicing without a license; or

27 (iv) Practicing outside of licensed authority;

28 (f) Adult protective services, resident protection, or supported
29 living program final finding;

30 (g) Child protective services final finding; or

31 (h) Federal government finding that if such applicant or service
32 provider were licensed, certified, employed, volunteered, issued a
33 contract, authorized to receive payment, or authorized to have
34 unsupervised access, the receipt of federal funds by the state could be
35 jeopardized. "Negative action" includes all written findings,
36 decisions, or actions that become final due to the failure of the
37 alleged perpetrator to timely exercise a legal right to appeal a

1 negative action made or taken by an authorized judicial,
2 administrative, or governmental entity.

3 (17) "Offense" means any background information, criminal history,
4 conviction, negative action, or pending matter covered under this
5 chapter that will or may cause an applicant or service provider to be
6 disqualified from having unsupervised access.

7 (18) "Payment" means money the department directly pays to an
8 applicant or service provider for providing services to department
9 clients who are vulnerable adults, juveniles, or children.

10 (19) "Pending matter" means an arrest, charge, or written
11 allegation by a judicial, administrative, or governmental entity
12 relating to an offense that, when final, may lead to a determination
13 that an applicant or service provider must be disqualified pursuant to
14 this chapter, and has not yet been decided by an authorized judicial,
15 administrative, or governmental entity. "Pending matter" may include
16 an ongoing investigation without a charge or allegation. "Pending
17 matter" does not include the applicable ongoing appeal period, if any.

18 (20) "Protection order" means any protective, no-contact, or
19 restraining order against an applicant or service provider, issued by
20 an authorized judicial, administrative, or governmental entity after a
21 hearing, because of domestic violence, unlawful harassment, sexual
22 assault, or any other type of harassment or assault offense involving
23 a victim that is a vulnerable adult, juvenile, or child. "Protection
24 order" does not include any temporary protection, no-contact, or
25 restraining order that a requesting party obtains prior to notice and
26 hearing being given to the alleged perpetrator.

27 (21) "Result" means the outcome of a background check.

28 (22) "Secretary" means the secretary of the department of social
29 and health services.

30 (23) "Secure facility" has the meaning provided in RCW 71.09.020.

31 (24) "Service provider" means entities, facilities, agencies,
32 businesses, or individuals who are licensed, certified, authorized, or
33 regulated by, receive payment from, or have contracts or agreements
34 with, the department to provide services to vulnerable adults,
35 juveniles, or children. "Service provider" includes individuals whom
36 a department client or guardian of a department client may choose to
37 hire or engage to provide services to themselves or another vulnerable

1 adult, juvenile, or child and who might be eligible to receive payment
2 from the department for services rendered. "Service provider" does not
3 include those certified under chapter 70.96A RCW.

4 (25) "Unsupervised access" means working with or being in the
5 presence of vulnerable adults, juveniles, or children out of sight of:

6 (a) Another applicant or service provider who has passed a
7 background check; or

8 (b) A parent, relative, or guardian.

9 (26) "Vulnerable adult" means an adult who is:

10 (a) A vulnerable adult as defined in chapter 74.34 RCW;

11 (b) Sixty years of age or older who has the functional, mental, or
12 physical inability to care for himself or herself;

13 (c) Found incapacitated under chapter 11.88 RCW;

14 (d) Developmentally disabled as defined under RCW 71A.10.020;

15 (e) Admitted to any facility operated by the department;

16 (f) Receiving services from applicants or department service
17 providers; or

18 (g) Receiving services through home health, hospice, or home care
19 agencies required to be licensed under chapter 70.127 RCW.

20 "Vulnerable adult" does not include: Individuals receiving
21 services under chapter 70.96A RCW unless they have been admitted to a
22 detoxification facility or detained or committed to a chemical
23 dependency treatment facility certified under chapter 70.96A RCW; or
24 juveniles between eighteen and twenty-one years of age who are under
25 the jurisdiction of the juvenile rehabilitation administration or the
26 department of corrections.

27 NEW SECTION. **Sec. 2.** INVESTIGATION AND ACCEPTANCE OF BACKGROUND
28 INFORMATION. The legislature finds that the department of social and
29 health services, service providers regulated by the department,
30 parents, vulnerable adults, in-home care service providers licensed
31 under chapter 70.127 RCW, department clients, guardians of department
32 clients, and others need adequate information to determine the
33 character, competence, and suitability of an applicant or service
34 provider to have unsupervised access.

35 (1) The secretary may require applicants or service providers to
36 obtain and provide background information, and the secretary may accept
37 background information provided by outside entities or persons. The

1 secretary shall obtain or require the applicant or service provider to
2 obtain and provide background information relating to criminal history,
3 convictions, negative actions, offenses, and pending matters as defined
4 in section 1 of this act, and any out-of-state equivalent when:

5 (a) Licensing, certifying, contracting, subcontracting, regulating,
6 authorizing receipt of payments from the department, or authorizing
7 applicants or service providers, who will or may have unsupervised
8 access;

9 (b) Contracting with applicants or service providers for in-home
10 services, case management, care, supervision, or treatment of
11 vulnerable adults, juveniles, or children;

12 (c) Obtaining or causing to be obtained the background information
13 of applicants or service providers, including providers paid by home
14 care agencies for services, and their employees, volunteers, interns,
15 and other persons, who will or may have unsupervised access;

16 (d) Authorizing unsupervised access for department applicants who
17 may work in a department-covered position, including but not limited
18 to:

19 (i) Positions that conduct comprehensive assessments, financial
20 eligibility determinations, licensing certification, contract and
21 fiscal activities, investigations, surveys, or case management; or

22 (ii) Positions otherwise required by federal law to meet employment
23 standards.

24 (2) Department employees hired prior to the effective date of this
25 section shall:

26 (a) Retain their department-covered position unless any background
27 check performed after the effective date of this section reveals
28 disqualifying background information that was not identified in a
29 previous background check. If the new disqualifying background
30 information is identified in a background check performed after the
31 effective date of this section, the department employee may not retain
32 his or her department-covered position;

33 (b) Be subject to the standards and rules developed for all
34 department applicants under this chapter if they are reallocated from
35 their current department-covered position or are laid off, transferred,
36 promoted, or demoted into a different department-covered position.

37 (3) At the request of an in-home care service provider licensed
38 under chapter 70.127 RCW, unless otherwise prohibited by law, the

1 department may release information indicating that the applicant or
2 service provider has a final civil adjudication proceeding finding
3 under section 1(16) (b), (f), or (g) of this act. Unless permitted by
4 law, or an authorized written release is required and provided, the
5 department shall not release substantive information about the nature
6 of the finding under section 1(16) (b), (f), or (g) of this act.

7 (4) The secretary may require in-home care service providers
8 licensed under chapter 70.127 RCW requesting information in subsection
9 (3) of this section to pay reasonable costs associated with performing
10 the services specified in subsection (3) of this section.

11 (5) The secretary shall adopt rules and set standards to implement
12 subsections (3) and (4) of this section.

13 NEW SECTION. **Sec. 3.** BACKGROUND CHECK STANDARDS AND RULES. (1)

14 The secretary shall adopt rules and set standards to:

15 (a) Require specific procedures and action when disqualifying
16 background information is discovered by the department or by service
17 providers who conduct background investigations as required under this
18 chapter; and

19 (b) Regulate the release of background information as defined in
20 section 1 of this act.

21 (2) The secretary and service providers may consider background
22 information from any jurisdiction including but not limited to in-
23 state, national, international, out-of-state, and any equivalent
24 background information for any offense covered under this chapter to
25 determine the character, competence, and suitability of applicants or
26 service providers.

27 (3) The secretary shall adopt rules regarding applicants or service
28 providers that provide in-home care services under contract with the
29 department. The rules must include permanent disqualification for a
30 record of a conviction of a crime relating to drugs as defined in
31 section 1 of this act when in-home care is provided through:

32 (a) Medicaid personal care under RCW 74.09.520;

33 (b) Community options program entry system waiver services under
34 RCW 74.39A.030;

35 (c) Chore services under RCW 74.39A.110; or

36 (d) Other home and community long-term care programs, established
37 under chapters 74.39 and 74.39A RCW, administered by the department.

1 (4) A department client, or his or her legal guardian, who is
2 directly hiring or engaging an applicant or service provider must be
3 given background information to determine the character, competence,
4 and suitability of the applicant or service provider.

5 (5) A department client, or his or her legal guardian, may choose
6 to hire or retain an applicant or service provider after receiving
7 notice from the department of a disqualifying offense; however the
8 secretary shall deny payment for any subsequent services rendered by
9 the disqualified applicant or service provider. The client does not
10 have a right to a fair hearing under chapter 34.05 RCW and RCW
11 74.39A.095 for the department's denial of payment based on
12 disqualifying offenses.

13 (6) The secretary shall adopt rules regarding current and
14 prospective department applicants in department-covered positions and
15 shall include requirements to:

16 (a) Conduct an initial background check and any additional
17 background check including rechecks under section 6 of this act;

18 (b) Assess background check results by applying the standards set
19 out in this chapter;

20 (c) Review background check results for up to three applicants
21 under final consideration for a department-covered position;

22 (d) Specify when a conditional appointment of an applicant is
23 allowed;

24 (e) Specify when and how a department position that is not a
25 covered position is changed to a covered position;

26 (f) Address any appeal rights; and

27 (g) Conduct fingerprint-based background checks as allowed under
28 state or federal law.

29 NEW SECTION. **Sec. 4.** DISCLOSURE. (1) Applicants and service
30 providers who are required to have a background check under this
31 chapter must disclose, in writing, background information relating to
32 any offense covered under this chapter and swear to the truth of the
33 written disclosure under penalty of perjury. The disclosure must
34 include all background information and offenses that occurred in any
35 jurisdiction, including jurisdictions outside the state of Washington
36 and the United States of America.

1 (2) After a background check has been completed, the applicant or
2 service provider is under a continuing obligation to disclose any
3 subsequent offenses within seven calendar days of the subsequent
4 offense.

5 (3) Service providers must disclose subsequent offenses as required
6 in subsections (1) and (2) of this section to the department staff
7 responsible to license, certify, contract, authorize, regulate, or
8 monitor services.

9 (4) Service providers and applicants subject to this chapter must
10 disclose subsequent offenses as required in subsections (1) and (2) of
11 this section to the responsible service provider.

12 (5) Department applicants in department-covered positions must
13 disclose subsequent offenses as required in subsections (1) and (2) of
14 this section to the department hiring authority.

15 (6) Upon receipt of a report of subsequent offenses as required
16 under subsections (1) and (2) of this section, the responsible
17 department staff, department hiring authority, and service provider
18 must:

19 (a) Require the subject of the disclosure to undergo another
20 background check; and

21 (b) Assess the background check result using the standards or rules
22 adopted under this chapter.

23 (7) Failure of an applicant or service provider to disclose
24 subsequent offenses as required in this section constitutes misconduct
25 under Title 50 RCW.

26 (8) Failure of a department applicant in a covered position to
27 disclose as required in subsection (5) of this section is cause for
28 disciplinary action.

29 NEW SECTION. **Sec. 5.** FINGERPRINT-BASED BACKGROUND CHECKS--FEES.

30 (1) In order to determine the character, competence, and suitability of
31 any applicant or service provider to have unsupervised access, the
32 secretary may require a fingerprint-based background check through the
33 Washington state patrol and the federal bureau of investigation at
34 anytime, but shall require a fingerprint-based background check when
35 the applicant or service provider has resided in the state less than
36 three consecutive years before application, and:

1 (a) Is an applicant or service provider providing services to
2 children or people with developmental disabilities under RCW 74.15.030;

3 (b) Is an individual residing in an applicant or service provider's
4 home, facility, entity, agency, or business or who is authorized by the
5 department to provide services to children or people with developmental
6 disabilities under RCW 74.15.030; or

7 (c) Is an applicant or service provider providing in-home services
8 funded by:

9 (i) Medicaid personal care under RCW 74.09.520;

10 (ii) Community options program entry system waiver services under
11 RCW 74.39A.030;

12 (iii) Chore services under RCW 74.39A.110; or

13 (iv) Other home and community long-term care programs, established
14 pursuant to chapters 74.39 and 74.39A RCW, administered by the
15 department.

16 (2) The secretary shall require a fingerprint-based background
17 check through the Washington state patrol identification and criminal
18 history section and the federal bureau of investigation when the
19 department seeks to approve an applicant or service provider for a
20 foster or adoptive placement of children in accordance with federal and
21 state law.

22 (3) Any secure facility operated by the department under chapter
23 71.09 RCW shall require applicants and service providers to undergo a
24 fingerprint-based background check through the Washington state patrol
25 identification and criminal history section and the federal bureau of
26 investigation.

27 (4) Service providers and service provider applicants who are
28 required to complete a fingerprint-based background check may be hired
29 for a one hundred twenty-day provisional period as allowed under law or
30 program rules when:

31 (a) A fingerprint-based background check is pending; and

32 (b) The applicant or service provider is not disqualified based on
33 the immediate result of the background check.

34 (5) Fees charged by the Washington state patrol and the federal
35 bureau of investigation for fingerprint-based background checks shall
36 be paid by the department for applicants or service providers
37 providing:

- 1 (a) Services to people with a developmental disability under RCW
2 74.15.030;
- 3 (b) In-home services funded by medicaid personal care under RCW
4 74.09.520;
- 5 (c) Community options program entry system waiver services under
6 RCW 74.39A.030;
- 7 (d) Chore services under RCW 74.39A.110;
- 8 (e) Services under other home and community long-term care
9 programs, established pursuant to chapters 74.39 and 74.39A RCW,
10 administered by the department;
- 11 (f) Services in, or to residents of, a secure facility under RCW
12 71.09.115; and
- 13 (g) Foster care when fees create a hardship as required under RCW
14 74.15.030.
- 15 (6) Service providers licensed under RCW 74.15.030 must pay fees
16 charged by the Washington state patrol and the federal bureau of
17 investigation for conducting fingerprint-based background checks.
- 18 (7) Children's administration service providers licensed under RCW
19 74.15.030 may not pass on the cost of the background check fees to
20 their applicants unless the individual is determined to be disqualified
21 due to the background information.
- 22 (8) Unless otherwise prohibited, the department may pay, or charge
23 and collect from other state agencies, service providers, applicants,
24 or any person or business authorized under this chapter to request
25 background information, the reasonable costs incurred in conducting
26 background checks or fingerprint-based background checks, and may pay,
27 charge, or collect the fees established by the Washington state patrol
28 or federal bureau of investigation for background checks or
29 fingerprint-based background checks.
- 30 (9) The department shall develop rules identifying the financial
31 responsibility and the process for implementing subsection (8) of this
32 section.

33 NEW SECTION. **Sec. 6.** RECHECKS--RELEASE OF BACKGROUND INFORMATION.
34 (1) The secretary shall adopt rules regarding the requirements for
35 subsequent or additional background checks. These rules may include,
36 but are not limited to, requiring additional background checks:

1 (a) For renewal of a license, contract, certification, or
2 authorization for applicants or service providers;

3 (b) When there is reason to believe, or it is reported, that an
4 offense identified in section 7 or 8 of this act may have occurred
5 subsequent to the applicant's or service provider's last background
6 check;

7 (c) At two-year intervals from the date of the last background
8 check for department applicants in department-covered positions;

9 (d) When a department applicant is seeking a department-covered
10 position because of a layoff, reallocation, transfer, promotion, or
11 demotion.

12 (2) For any background information released under this chapter by
13 the state, its agencies, or its employees, the state does not provide
14 any assurance that the applicant or service provider:

15 (a) Does not have convictions, criminal history, negative actions,
16 pending matters, or offenses covered under this chapter; and

17 (b) Is suitable for unsupervised access or employment by any
18 department client, guardian, individual, service provider, contractor,
19 employer, governmental entity, or any other entity.

20 (3) The state of Washington, its agencies, and its employees are
21 not liable for defamation, invasion of privacy, negligence, or any
22 other claim in connection with any lawful dissemination of information
23 under this chapter.

24 (4) Nothing in this chapter limits or restricts the ability of the
25 department to obtain or consider additional background information as
26 allowed under state or federal law.

27 NEW SECTION. **Sec. 7.** DISQUALIFYING CRIMES AND NEGATIVE ACTIONS.

28 (1) Permanently disqualifying crimes include the following offenses
29 regardless of how much time has passed since the date of conviction:

30 (a) Abandonment of a dependent person first degree (RCW 9A.42.060);

31 (b) Abandonment of a dependent person second degree (RCW
32 9A.42.070);

33 (c) Abandonment of a dependent person third degree (RCW 9A.42.080);

34 (d) Arson first degree (RCW 9A.48.020);

35 (e) Arson second degree (RCW 9A.48.030);

36 (f) Assault first degree (RCW 9A.36.011);

37 (g) Assault second degree (RCW 9A.36.021);

1 (h) Assault of a child first degree (RCW 9A.36.120);
2 (i) Assault of a child second degree (RCW 9A.36.130);
3 (j) Assault of a child third degree (RCW 9A.36.140);
4 (k) Bail jumping (RCW 9A.76.170) for any crime listed in this
5 section;
6 (l) Burglary first degree (RCW 9A.52.020);
7 (m) Child molestation first degree (RCW 9A.44.083);
8 (n) Child molestation second degree (RCW 9A.44.086);
9 (o) Child molestation third degree (RCW 9A.44.089);
10 (p) Child selling/child buying (RCW 9A.64.030);
11 (q) Communication with minor for immoral purposes (RCW 9.68A.090);
12 (r) Controlled substances homicide (RCW 69.50.415);
13 (s) Criminal attempt (RCW 9A.28.020) for any crime listed in this
14 section;
15 (t) Criminal conspiracy (RCW 9A.28.040) for any crime listed in
16 this section;
17 (u) Criminal mistreatment first degree (RCW 9A.42.020);
18 (v) Criminal mistreatment second degree (RCW 9A.42.030);
19 (w) Criminal mistreatment third degree (RCW 9A.42.035);
20 (x) Criminal mistreatment fourth degree (RCW 9A.42.037);
21 (y) Criminal solicitation (RCW 9A.28.030) for any crime listed in
22 this section;
23 (z) Custodial interference first degree (RCW 9A.40.060);
24 (aa) Custodial sexual misconduct first degree (RCW 9A.44.160);
25 (bb) Custodial sexual misconduct second degree (RCW 9A.44.170);
26 (cc) Dealing in depictions of a minor engaged in sexually explicit
27 conduct (RCW 9.68A.050);

17 approved individual, or the court may reduce or waive the fee if the
18 financial condition of the person requesting the report so warrants.
19 An agency's, the department's, or court approved individual's, fee is
20 subject to review by the court upon request of the person requesting

23 the department, the court approved individual, or the court in writing
24 the county in which the preplacement report is to be filed. If the

24 does not apply to the discovery of abuse or neglect that occurred
25 during childhood if it is discovered after the child has become an
26 adult. However, if there is reasonable cause to believe other children
27 are or may be at risk of abuse or neglect by the accused, the reporting
28 requirement of subsection (1) of this section does apply.

29 (3) Any other person who has reasonable cause to believe that a
30 child has suffered abuse or neglect may report such incident to the
31 proper law enforcement agency or to the department of social and health

29 consultation with those persons or agencies required to report under
30 this section, with consultants designated by the department, and with

34 planning and consultation with those persons required to report under

20 department or law enforcement agency may interview children. The
21 interviews may be conducted on school premises, at day-care facilities,
22 at the child's home, or at other suitable locations outside of the
23 presence of parents. Parental notification of the interview must occur
24 at the earliest possible point in the investigation that will not
25 jeopardize the safety or protection of the child or the course of the
