SENATE JOINT RESOLUTION 8212

1            BE IT RESOLVED, BY THE SENATE AND HOUSE OF REPRESENTATIVES OF THE  
2 STATE OF WASHINGTON, IN LEGISLATIVE SESSION ASSEMBLED:

3            THAT, At the next general election to be held in this state the  
4 secretary of state shall submit to the qualified voters of the state  
5 for their approval and ratification, or rejection, an amendment to  
6 Article II, section 29 of the Constitution of the state of Washington  
7 to read as follows:

8            Article II, section 29. (~~After the first day of January eighteen~~  
9 ~~hundred and ninety~~) The labor of (~~convicts~~) inmates of this state  
10 shall not be let out by contract to any person, copartnership, company,  
11 or corporation, except as provided by statute, and the legislature  
12 shall by law provide for the working of (~~convicts~~) inmates for the  
13 benefit of the state, including the working of inmates in state-run  
14 inmate labor programs. Inmate labor programs provided by statute that  
15 are operated and managed, in total or in part, by any profit or  
16 nonprofit entities shall be operated so that the programs do not  
17 unfairly compete with Washington businesses as determined by law.

18            BE IT FURTHER RESOLVED, That the secretary of state shall cause

1 notice of this constitutional amendment to be published at least four  
2 times during the four weeks next preceding the election in every legal  
3 newspaper in the state.
