1 On page 8, line 25 of the striking amendment, after "46.16.385."  
2 insert "In addition to any penalty or fine imposed under this  
3 subsection, two hundred dollars shall be assessed."

5 On page 9, line 1 of the striking amendment, after "((The  
6 ~~penalties~~))" strike "Two hundred dollars from each full penalty" and  
7 insert "The assessment"

8  
9 On page 9, line 4 of the striking amendment, after "act." strike  
10 all material through "remaining" on line 6 and insert "Any reduction  
11 in any penalty, fine, or assessment imposed under subsections (7),  
12 (8), and (9) of this section shall be applied proportionally between  
13 the penalty and the assessment. The"

**EFFECT:** Changes the structure of the penalties imposed for parking infractions related to the unauthorized use of placards and license plates, blocking access aisles of parking spaces reserved for persons with disabilities, and unlawfully parking in a space reserved for a person with a physical disability. Instead of a \$450 penalty, a \$250 penalty for the parking infraction plus a separate \$200 assessment will be imposed. The \$200 assessment, or any proportion imposed, will be deposited in the Accessible Communities Account.
