2 following:

3 "NEW SECTION. **Sec. 1.** This act is intended to streamline and make
4 technical amendments to certain codified statutes that deal with
5 vehicle and vessel registration and title. Any statutory changes made
6 by this act should be interpreted as technical in nature and not be
7 interpreted to have any substantive policy or legal implications.

8 **PART I. DEFINITIONS**

9 NEW SECTION. **Sec. 101.** A new section is added to chapter 46.04
10 RCW to read as follows:

11 "Affidavit of loss" means a written statement confirming that the
12 certificate of title, registration certificate, gross weight license,
13 validation tab, or decal has been lost, stolen, destroyed, or
14 mutilated. The statement must be in a form prescribed by the director.

15 NEW SECTION. **Sec. 102.** A new section is added to chapter 46.04
16 RCW to read as follows:

17 "Agent," for the purposes of entering into the standard contract
18 required under RCW 46.01.140(1), means any county auditor or other
19 individual, government, or business entity other than a subagent that
20 is appointed to carry out vehicle registration and certificate of title
21 functions for the department.

22 NEW SECTION. **Sec. 103.** A new section is added to chapter 46.04
23 RCW to read as follows:

24 "Amateur radio operator license plates" means special license
25 plates displaying amateur radio call letters assigned by the federal
26 communications commission.

1 NEW SECTION. **Sec. 104.** A new section is added to chapter 46.04
2 RCW to read as follows:

3 "Armed forces license plate collection" means the collection of six
4 separate license plate designs issued under section 612 of this act.
5 Each license plate design displays a symbol representing one of the
6 five branches of the armed forces, and one representing the national
7 guard.

8 NEW SECTION. **Sec. 105.** A new section is added to chapter 46.04
9 RCW to read as follows:

10 "Baseball stadium license plate" means special license plates
11 commemorating the construction of a baseball stadium as defined in RCW
12 82.14.0485.

13 NEW SECTION. **Sec. 106.** A new section is added to chapter 46.04
14 RCW to read as follows:

15 "Business day" means Monday through Friday and excludes Saturday,
16 Sunday, and state and federal holidays.

17 NEW SECTION. **Sec. 107.** A new section is added to chapter 46.04
18 RCW to read as follows:

19 "Cab and chassis" means an incomplete vehicle manufactured and sold
20 with only a cab, frame, and running gear.

21 **Sec. 108.** RCW 46.04.125 and 1996 c 225 s 2 are each amended to
22 read as follows:

23 "Collector" means the owner of one or more vehicles described in
24 (~~RCW 46.16.305(1)~~) section 617(1) of this act who collects,
25 purchases, acquires, trades, or disposes of the vehicle or parts of it,
26 for his or her personal use, in order to preserve, restore, and
27 maintain the vehicle for hobby or historical purposes.

28 NEW SECTION. **Sec. 109.** A new section is added to chapter 46.04
29 RCW to read as follows:

30 "Collector vehicle license plate" means a special license plate
31 that may be assigned to a vehicle that is more than thirty years old.

1 NEW SECTION. **Sec. 110.** A new section is added to chapter 46.04
2 RCW to read as follows:

3 "Commercial trailer" means a trailer that is principally used to
4 transport commodities, merchandise, produce, freight, or animals.

5 NEW SECTION. **Sec. 111.** A new section is added to chapter 46.04
6 RCW to read as follows:

7 "Confidential license plates" and "undercover license plates" mean
8 standard issue license plates assigned to vehicles owned or operated by
9 public agencies. These license plates are used as specifically
10 authorized under RCW 46.08.066.

11 NEW SECTION. **Sec. 112.** A new section is added to chapter 46.04
12 RCW to read as follows:

13 "Converter gear" means an auxiliary axle, booster axle, dolly, or
14 jeep axle.

15 NEW SECTION. **Sec. 113.** A new section is added to chapter 46.04
16 RCW to read as follows:

17 "Disabled American veteran license plates" means special license
18 plates issued to a veteran, as defined in RCW 41.04.007, who meets the
19 requirements provided in section 619 of this act.

20 NEW SECTION. **Sec. 114.** A new section is added to chapter 46.04
21 RCW to read as follows:

22 "Empty scale weight" means the weight of a vehicle as it stands
23 without a load.

24 NEW SECTION. **Sec. 115.** A new section is added to chapter 46.04
25 RCW to read as follows:

26 "Endangered wildlife license plates" means special license plates
27 that display a symbol or artwork symbolizing endangered wildlife in
28 Washington state.

29 NEW SECTION. **Sec. 116.** A new section is added to chapter 46.04
30 RCW to read as follows:

31 "Fixed load vehicle" means a commercial vehicle that has a
32 structure or machinery permanently attached such as, but not limited

1 to, an air compressor, a bunk house, a conveyor, a cook house, a donkey
2 engine, a hoist, a rock crusher, a tool house, or a well drilling
3 machine. Fixed load vehicles are not capable of carrying any
4 additional load other than the structure or machinery permanently
5 attached.

6 NEW SECTION. **Sec. 117.** A new section is added to chapter 46.04
7 RCW to read as follows:

8 "Former prisoner of war license plates" means special license
9 plates that may be issued to former prisoners of war as authorized
10 under section 619 of this act.

11 NEW SECTION. **Sec. 118.** A new section is added to chapter 46.04
12 RCW to read as follows:

13 "Gross vehicle weight rating" means the value specified by the
14 manufacturer as the maximum load weight of a single vehicle.

15 NEW SECTION. **Sec. 119.** A new section is added to chapter 46.04
16 RCW to read as follows:

17 "Helping kids speak license plates" means special license plates
18 that commemorate an organization that supports programs that provide
19 free diagnostic and therapeutic services to children who have a severe
20 delay in language or speech development.

21 NEW SECTION. **Sec. 120.** A new section is added to chapter 46.04
22 RCW to read as follows:

23 "Horseless carriage license plate" is a special license plate that
24 may be assigned to a vehicle that is more than forty years old.

25 NEW SECTION. **Sec. 121.** A new section is added to chapter 46.04
26 RCW to read as follows:

27 "Hybrid motor vehicle" means a motor vehicle that uses multiple
28 power sources or fuel types for propulsion and meets the federal
29 definition of a hybrid motor vehicle.

30 NEW SECTION. **Sec. 122.** A new section is added to chapter 46.04
31 RCW to read as follows:

1 "Light truck" means a motor vehicle manufactured as a truck with a
2 declared gross weight of twelve thousand pounds or less.

3 NEW SECTION. **Sec. 123.** A new section is added to chapter 46.04
4 RCW to read as follows:

5 "Market value threshold amount" means an amount set by rule by the
6 department that is used to determine, together with the age of the
7 vehicle, whether vehicle certificates of title for vehicles aged six
8 years through twenty years should be identified as having been
9 previously destroyed or reported as an insurance total loss.

10 NEW SECTION. **Sec. 124.** A new section is added to chapter 46.04
11 RCW to read as follows:

12 "Military affiliate radio system license plates" means special
13 license plates displaying official military affiliate radio system call
14 letters assigned by the United States department of defense.

15 NEW SECTION. **Sec. 125.** A new section is added to chapter 46.04
16 RCW to read as follows:

17 "Natural person" means a human being.

18 NEW SECTION. **Sec. 126.** A new section is added to chapter 46.04
19 RCW to read as follows:

20 "New motor vehicle" means any motor vehicle that (1) is
21 self-propelled and is required to be registered and titled under this
22 title, (2) has not been previously titled to a retail purchaser or
23 lessee, and (3) is not a used vehicle as defined under RCW 46.04.660.

24 NEW SECTION. **Sec. 127.** A new section is added to chapter 46.04
25 RCW to read as follows:

26 "Off-road vehicle" or "ORV" means a nonstreet registered vehicle
27 when used for recreational purposes on nonhighway roads, trails, or a
28 variety of other natural terrain. "Off-road vehicle" or "ORV"
29 includes, but is not limited to, all-terrain vehicles, motorcycles,
30 four-wheel drive vehicles, and dune buggies.

31 NEW SECTION. **Sec. 128.** A new section is added to chapter 46.04
32 RCW to read as follows:

1 "ORV registration" means a registration certificate or decal issued
2 under the laws of this state pertaining to the registration of off-road
3 vehicles under chapter 46.09 RCW.

4 NEW SECTION. **Sec. 129.** A new section is added to chapter 46.04
5 RCW to read as follows:

6 "Ownership in doubt" means that a vehicle or vessel owner is unable
7 to obtain satisfactory evidence of ownership or releases of interest
8 and is permitted to apply for a three-year registration period without
9 a certificate of title or a three-year period with a bond covering the
10 certificate of title.

11 **Sec. 130.** RCW 46.04.3815 and 1996 c 225 s 3 are each amended to
12 read as follows:

13 "Parts car" means a motor vehicle that is owned by a collector to
14 furnish parts for restoration or maintenance of a vehicle described in
15 (~~RCW 46.16.305(1)~~) section 617(1) of this act, thus enabling a
16 collector to preserve, restore, and maintain such a vehicle.

17 NEW SECTION. **Sec. 131.** A new section is added to chapter 46.04
18 RCW to read as follows:

19 "Personalized license plates" means license plates that display the
20 license plate number assigned to the vehicle or camper for which the
21 license plate number was issued in a combination of letters or numbers,
22 or both, requested by the owner of the vehicle or camper in accordance
23 with chapter 46.... RCW (the new chapter created in section 1224 of
24 this act).

25 NEW SECTION. **Sec. 132.** A new section is added to chapter 46.04
26 RCW to read as follows:

27 "Private use single-axle trailer" means a trailer owned by a
28 natural person and used for the private noncommercial use of the owner.

29 NEW SECTION. **Sec. 133.** A new section is added to chapter 46.04
30 RCW to read as follows:

31 "Purple heart license plates" means special license plates that may
32 be assigned to a motor vehicle to recipients of the Purple Heart medal
33 or to another qualified person.

1 NEW SECTION. **Sec. 134.** A new section is added to chapter 46.04
2 RCW to read as follows:

3 "Registration" means the registration certificate or license plates
4 issued under the laws of this state pertaining to the registration of
5 vehicles.

6 NEW SECTION. **Sec. 135.** A new section is added to chapter 46.04
7 RCW to read as follows:

8 "Renewal notice" means the notice to renew a vehicle registration
9 sent to the registered owner by the department.

10 NEW SECTION. **Sec. 136.** A new section is added to chapter 46.04
11 RCW to read as follows:

12 "Report of sale" means a document or electronic record transaction
13 that when properly completed and filed protects the seller of a vehicle
14 from certain criminal and civil liabilities arising from use of the
15 vehicle by another person after the vehicle has been sold or a change
16 in ownership has occurred.

17 NEW SECTION. **Sec. 137.** A new section is added to chapter 46.04
18 RCW to read as follows:

19 "Ride share license plates" means special license plates issued for
20 motor vehicles that are used primarily for commuter ride sharing as
21 defined in RCW 46.74.010.

22 NEW SECTION. **Sec. 138.** A new section is added to chapter 46.04
23 RCW to read as follows:

24 "Salvage vehicle" means a vehicle whose certificate of title has
25 been surrendered to the department under RCW 46.12.070 (as recodified
26 by this act) due to the vehicle's destruction or declaration as a total
27 loss or for which there is documentation indicating that the vehicle
28 has been declared salvage or has been damaged to the extent that the
29 owner, an insurer, or other person acting on behalf of the owner, has
30 determined that the cost of parts and labor plus the salvage value has
31 made it uneconomical to repair the vehicle. "Salvage vehicle" does not
32 include a motor vehicle having a model year designation of a calendar
33 year that is at least six years before the calendar year in which the
34 vehicle was wrecked, destroyed, or damaged, unless, after June 13,

1 2002, and immediately before the vehicle was wrecked, destroyed, or
2 damaged, the vehicle had a retail fair market value of at least the
3 then market value threshold amount and has a model year designation of
4 a calendar year not more than twenty years before the calendar year in
5 which the vehicle was wrecked, destroyed, or damaged.

6 NEW SECTION. **Sec. 139.** A new section is added to chapter 46.04
7 RCW to read as follows:

8 "Scale weight" means the weight of a vehicle without a load.

9 NEW SECTION. **Sec. 140.** A new section is added to chapter 46.04
10 RCW to read as follows:

11 "Secured party" has the same meaning as in RCW 62A.1-201.

12 NEW SECTION. **Sec. 141.** A new section is added to chapter 46.04
13 RCW to read as follows:

14 "Security interest" has the same meaning as in RCW 62A.1-201.

15 NEW SECTION. **Sec. 142.** A new section is added to chapter 46.04
16 RCW to read as follows:

17 "Share the road license plates" means special license plates
18 displaying a symbol or artwork recognizing an organization that
19 promotes bicycle safety and awareness education. Share the road
20 license plates commemorate the life of Cooper Jones.

21 NEW SECTION. **Sec. 143.** A new section is added to chapter 46.04
22 RCW to read as follows:

23 "Ski & ride Washington license plates" means special license plates
24 displaying a symbol or artwork recognizing the Washington snowsports
25 industry.

26 NEW SECTION. **Sec. 144.** A new section is added to chapter 46.04
27 RCW to read as follows:

28 (1) "Special highway construction equipment" means any vehicle that
29 is (a) designed and used primarily for the grading of highways, the
30 paving of highways, earth moving, and other construction work on
31 highways, (b) not designed or used primarily to transport persons or

1 property on a public highway, and (c) only incidentally operated or
2 moved over the highway.

3 (2) "Special highway construction equipment" includes, but is not
4 limited to, road construction and maintenance machinery that is
5 designed and used for the purposes described under subsection (1) of
6 this section, such as portable air compressors, air drills, asphalt
7 spreaders, bituminous mixers, bucket loaders, track laying tractors,
8 ditchers, leveling graders, finishing machines, motor graders, paving
9 mixers, road rollers, scarifiers, earth moving scrapers and carryalls,
10 lighting plants, welders, pumps, power shovels and draglines, and
11 self-propelled and tractor-drawn earth moving equipment and machinery,
12 including dump trucks and tractor-dump trailer combinations that (a)
13 are in excess of the legal width, (b) because of their length, height,
14 or unladen weight, may not be moved on a public highway without the
15 permit specified in RCW 46.44.090 and are not operated laden except
16 within the boundaries of the project limits as defined by the contract,
17 and other similar types of construction equipment, or (c) are driven or
18 moved upon a public highway only for the purpose of crossing the
19 highway from one property to another, provided that the movement does
20 not exceed five hundred feet and the vehicle is equipped with wheels or
21 pads that will not damage the roadway surface.

22 NEW SECTION. **Sec. 145.** A new section is added to chapter 46.04
23 RCW to read as follows:

24 "Snowmobile" means a self-propelled vehicle that is capable of
25 traveling over snow or ice that (1) utilizes as its means of propulsion
26 an endless belt tread or cleats, or any combination of these or other
27 similar means of contact with the surface upon which it is operated,
28 (2) is steered wholly or in part by skis or sled type runners, and (3)
29 is not otherwise registered as, or subject to, the motor vehicle excise
30 tax in the state of Washington.

31 NEW SECTION. **Sec. 146.** A new section is added to chapter 46.04
32 RCW to read as follows:

33 "Sport utility vehicle" means a high performance motor vehicle
34 weighing six thousand pounds or less, designed to carry ten passengers
35 or less or designated as a sport utility vehicle by the manufacturer.

1 NEW SECTION. **Sec. 147.** A new section is added to chapter 46.04
2 RCW to read as follows:

3 "Square dancer license plates" means special license plates
4 displaying a symbol of square dancers.

5 NEW SECTION. **Sec. 148.** A new section is added to chapter 46.04
6 RCW to read as follows:

7 "Standard issue license plates" means license plates that are held
8 for general issue, and does not mean personalized license plates or any
9 other special license plate.

10 NEW SECTION. **Sec. 149.** A new section is added to chapter 46.04
11 RCW to read as follows:

12 "Subagency" means the licensing office in which vehicle title and
13 registration functions are carried out by a subagent.

14 NEW SECTION. **Sec. 150.** A new section is added to chapter 46.04
15 RCW to read as follows:

16 "Subagent" means a person or governmental entity recommended by a
17 county auditor or other agent and who is appointed by the director to
18 provide vehicle registration and certificate of title services under
19 contract with the county auditor or other agent.

20 NEW SECTION. **Sec. 151.** A new section is added to chapter 46.04
21 RCW to read as follows:

22 "Tab" or "license tab" means a sticker issued by the department and
23 affixed to the rear license plate to identify the vehicle license
24 expiration month and year for a specific vehicle.

25 NEW SECTION. **Sec. 152.** A new section is added to chapter 46.04
26 RCW to read as follows:

27 "Total loss vehicle" means a vehicle that has been reported to the
28 department as destroyed by an insurance company, self-insurer, or the
29 vehicle owner or the owner's authorized representative.

30 NEW SECTION. **Sec. 153.** A new section is added to chapter 46.04
31 RCW to read as follows:

32 "Tow dolly" means a trailer equipped with between one and three

1 axles designed to connect to a tow bar on the rear of a motor vehicle
2 that is used to tow another vehicle. The front or rear wheels of the
3 towed vehicle are secured to and rest on the tow dolly.

4 NEW SECTION. **Sec. 154.** A new section is added to chapter 46.04
5 RCW to read as follows:

6 "Transit permit" means a document that authorizes a person to
7 operate a vehicle on a public highway of this state solely for the
8 purpose of obtaining the necessary documentation to complete and apply
9 for a Washington certificate of title or vehicle registration.
10 Unlimited use of the vehicle is prohibited when operated under a
11 transit permit.

12 **Sec. 155.** RCW 46.04.670 and 2003 c 141 s 6 are each amended to
13 read as follows:

14 "Vehicle" includes every device capable of being moved upon a
15 public highway and in, upon, or by which any persons or property is or
16 may be transported or drawn upon a public highway, including bicycles.
17 (~~The term~~) "Vehicle" does not include power wheelchairs or devices
18 other than bicycles moved by human or animal power or used exclusively
19 upon stationary rails or tracks. Mopeds (~~shall~~) are not (~~be~~)
20 considered vehicles or motor vehicles for the purposes of chapter 46.70
21 RCW. Bicycles (~~shall~~) are not (~~be~~) considered vehicles for the
22 purposes of chapter 46.12, 46.16, or 46.70 RCW or RCW 82.12.045.
23 Electric personal assistive mobility devices are not considered
24 vehicles or motor vehicles for the purposes of chapter 46.12, 46.16,
25 46.29, 46.37, or 46.70 RCW.

26 NEW SECTION. **Sec. 156.** A new section is added to chapter 46.04
27 RCW to read as follows:

28 "Vehicle license fee" means a fee collected by the state of
29 Washington as a license fee, as that term is construed in Article II,
30 section 40 of the state Constitution, for the act of registering a
31 vehicle under chapter 46.16 RCW. "Vehicle license fee" does not
32 include license plate fees, or taxes and fees collected by the
33 department for other jurisdictions.

1 NEW SECTION. **Sec. 157.** A new section is added to chapter 46.04
2 RCW to read as follows:

3 "Vintage snowmobile" means a snowmobile manufactured at least
4 thirty years ago.

5 NEW SECTION. **Sec. 158.** A new section is added to chapter 46.04
6 RCW to read as follows:

7 "Washington state parks license plates" means special license
8 plates displaying a symbol or artwork recognizing Washington state
9 parks as premier destinations of uncommon quality that preserve
10 significant natural, cultural, historical, and recreational resources.

11 NEW SECTION. **Sec. 159.** A new section is added to chapter 46.04
12 RCW to read as follows:

13 "Washington's wildlife license plate collection" means the
14 collection of three separate license plate designs. Each license plate
15 design displays a distinct symbol or artwork, to include bear, deer,
16 and elk, recognizing the wildlife of Washington.

17 NEW SECTION. **Sec. 160.** A new section is added to chapter 46.04
18 RCW to read as follows:

19 "We love our pets license plates" means special license plates
20 displaying a symbol or artwork recognizing an organization that assists
21 local member agencies of the federation of animal welfare and control
22 agencies to promote and perform spay or neuter surgery on Washington
23 state pets in order to reduce pet overpopulation.

24 NEW SECTION. **Sec. 161.** A new section is added to chapter 46.04
25 RCW to read as follows:

26 "Wild on Washington license plates" means special license plates
27 that display a symbol or artwork symbolizing wildlife viewing in
28 Washington state.

29 **PART II. GENERAL PROVISIONS AND NONHIGHWAY VEHICLES**

30 **Sec. 201.** RCW 46.01.011 and 1994 c 92 s 500 are each amended to
31 read as follows:

32 The legislature finds that the department of licensing administers

1 laws relating to the licensing and regulation of professions,
2 businesses, (~~gambling,~~) and other activities in addition to
3 administering laws relating to the licensing and regulation of vehicles
4 and vehicle operators, dealers, and manufacturers. The laws
5 administered by the department have the common denominator of licensing
6 and regulation and are directed toward protecting and enhancing the
7 well-being of the residents of the state.

8 **Sec. 202.** RCW 46.01.110 and 1995 c 403 s 108 are each amended to
9 read as follows:

10 The director (~~of licensing is hereby authorized to~~) may adopt and
11 enforce (~~such reasonable rules as may be consistent with and~~
12 ~~necessary~~) rules to carry out (~~the~~) provisions (~~relating~~) related
13 to vehicle (~~licenses~~) registrations, certificates of (~~ownership and~~
14 ~~license registration and drivers' licenses not in conflict with the~~
15 ~~provisions of Title 46 RCW: PROVIDED, That the director of licensing~~
16 ~~may not adopt rules after July 23, 1995, that are based~~) title, and
17 drivers' licenses. These rules must not be based:

18 (1) Solely on a section of law stating a statute's intent or
19 purpose(~~τ~~);

20 (2) On the enabling provisions of the statute establishing the
21 agency(~~τ~~); or

22 (3) On any combination of (~~such provisions, for statutory~~
23 authority to adopt any rule) subsections (1) and (2) of this section.

24 **Sec. 203.** RCW 46.01.130 and 2009 c 169 s 1 are each amended to
25 read as follows:

26 (~~(1) The department of licensing shall have the general~~
27 ~~supervision~~) The director:

28 (1) Shall supervise and control (~~of~~) the issuing of vehicle
29 (~~licenses~~) certificates of title, vehicle registrations, and vehicle
30 license (~~number~~) plates, and (~~shall have~~) has the full power to do
31 all things necessary and proper to carry out the provisions of the law
32 relating to the (~~licensing~~) registration of vehicles; (~~the director~~
33 ~~shall have the power to~~)

34 (2) May appoint and employ deputies, assistants (~~and~~),
35 representatives, and (~~such clerks as may be required from time to~~

9 (5)(a) Shall investigate the conviction records and pending charges
10 of any current employee of or prospective employee being considered for
11 any position with the department that has or will have:

12 (i) The ability to create or modify records of applicants for
13 enhanced drivers' licenses and identicards issued under RCW 46.20.202;
14 and

15 (ii) The ability to issue enhanced drivers' licenses and
16 identicards under RCW 46.20.202.

17 (b) The investigation consists of a background check as authorized
18 under RCW 10.97.050, 43.43.833, and 43.43.834, and the federal bureau
19 of investigation. The background check must be conducted through the
20 Washington state patrol criminal identification section and may include
21 a national check from the federal bureau of investigation, which is
22 through the submission of fingerprints. The director shall use the
23 information solely to determine the character, suitability, and
24 competence of current or prospective employees subject to this section.

25 (c) The director shall investigate the conviction records and
26 pending charges of an employee subject to this subsection every five
27 years.

28 (d) Criminal justice agencies shall provide the director with
29 information that they may possess and that the director may require
30 solely to determine the employment suitability of current or
31 prospective employees subject to this section.

5 **A. REVIEW BOARD**

8 The legislature has seen an increase in the demand from constituent
9 groups seeking recognition and funding through the establishment of
10 commemorative or special license plates. The high cost of implementing
11 a new special license plate series coupled with the uncertainty of the
12 state's ability to recoup its costs((~~7~~)) has led the legislature to
13 delay the implementation of new special license plates. In order to
14 address these issues, it is the intent of the legislature to create a
15 mechanism that will allow for the evaluation of special license plate
16 requests and establish a funding policy that will alleviate the
17 financial burden currently placed on the state. Using these two
18 strategies, the legislature will be better equipped to efficiently
19 process special license plate legislation.

20 **Sec. 602.** RCW 46.16.705 and 2005 c 319 s 117 are each amended to
21 read as follows:

22 (1) The special license plate review board is created.

23 (2) The board will consist of seven members: One member appointed
24 by the governor ((~~and~~)) who will serve as chair of the board; four
25 members of the legislature, one from each caucus of the house of
26 representatives and the senate; a department of licensing

28 representative appointed by the chief.

33 (c) Process special license plate applications and confirm that the
34 sponsoring organization has submitted all required documentation. If
35 an incomplete application is received, the department must return it to
36 the sponsoring organization; and

1 (d) Compile the annual financial reports submitted by sponsoring
2 organizations with active special license plate series and present
3 those reports to the board for review and approval.

30 (e) Provide policy guidance and directions to the department
31 concerning the adoption of rules necessary to limit the number of
32 special license plates ~~((that))~~ for which an organization or a
33 governmental entity may apply ~~((for))~~.

34 (4) Except as provided in ~~((chapter 72, Laws of 2008))~~ section 621
35 of this act, in order to assess the effects and impact of the
36 proliferation of special license plates, the legislature declares a
37 temporary moratorium on the issuance of any additional plates until

1 July 1, 2011. During this period of time, the special license plate

32 prepayment requirements in (a) of this subsection and can demonstrate
33 this fact to the satisfaction of the department, the revenues generated
34 from the sale of the special license plates must be deposited in the
35 motor vehicle (~~account~~) fund created in RCW 46.68.070 until the
36 department determines that the state's portion of the implementation
37 costs have been fully reimbursed. When it (~~is~~) has determined that

1 the state has been fully reimbursed, the department must notify the
2 treasurer to commence distribution of the revenue according to
3 statutory provisions.

4 (c) The sponsoring organization must provide a proposed special
5 license plate design to the department within thirty days of enactment
6 of the legislation creating the special license plate series.

7 (2) The state must be reimbursed for its portion of the
8 implementation costs within two years from the date the new special
9 license plate series goes on sale to the public. If the reimbursement
10 does not occur within the two-year time frame, the special license
11 plate series must be placed in probationary status for a period of one
12 year from that date. If the state is still not fully reimbursed for
13 its implementation costs after the one-year probation, the special
14 license plate series must be discontinued immediately. Those special
15 license plates issued before discontinuation are valid until replaced
16 under ((RCW 46.16.233)) section 422(10) of this act.

17 (3) If the sponsoring organization ceases to exist or the purpose
18 of the special license plate series ceases to exist, revenues generated
19 from the sale of the special license plates must be deposited into the
20 motor vehicle ((account)) fund created in RCW 46.68.070.

21 (4) A sponsoring organization may not seek to redesign ((their))
22 its special license plate series until ((all of)) the entire existing
23 inventory is sold or purchased by the organization itself. All costs
24 for the redesign of a special license plate series must be paid by the
25 sponsoring organization.

26 **Sec. 610.** RCW 46.16.690 and 2005 c 210 s 6 are each amended to
27 read as follows:

28 The department shall offer special license plate design services to
29 organizations that are sponsoring a new special license plate series
30 ((or are)) and organizations seeking to redesign the appearance of an
31 existing special license plate series that they sponsored. In
32 providing this service, the department must work with the requesting
33 organization in determining the specific qualities of the new special
34 license plate design and must provide full design services to the
35 organization. The department shall collect from the requesting
36 organization a fee of two hundred dollars for providing special license
37 plate design services. This fee includes one original special license

1 plate design and up to five additional renditions of the original
2 design. If the organization requests the department to provide further
3 renditions, in addition to the five renditions provided for under the
4 original fee, the department shall collect an additional fee of one
5 hundred dollars per rendition. All revenue collected under this
6 section must be deposited into the multimodal transportation account
7 created in RCW 47.66.070.

8 **C. PLATE TYPES, DECALS, AND EMBLEMS**

9 NEW SECTION. **Sec. 611.** (1) The legislature recognizes that the
10 special license plate review board established in RCW 46.16.705 (as
11 recodified by this act) reviews and approves applications for special
12 license plate series.

13 (2) Special license plate series reviewed and approved by the
14 special license plate review board:

15 (a) May be issued in lieu of standard issue or personalized license
16 plates for vehicles required to display one and two license plates
17 unless otherwise specified;

18 (b) Must be issued under terms and conditions established by the
19 department;

20 (c) Must not be issued for vehicles registered under chapter 46.87
21 RCW; and

22 (d) Must display a symbol or artwork approved by the special
23 license plate review board.

24 (3) The special license plate review board approves, and the
25 department shall issue, the following special license plates:

Armed forces collection	Recognizes the contribution of veterans, active duty military personnel, reservists, and members of the national guard, and includes six separate designs, each containing a symbol representing a different branch of the armed forces to include army, navy, air force, marine corps, coast guard, and national guard.
Endangered wildlife	Displays a symbol or artwork, approved by the special license plate review board and the legislature.

31 (4) Applicants for initial and renewal professional firefighters
32 and paramedics special license plates must show proof eligibility by
33 providing a certificate of current membership from the Washington state
34 council of firefighters.

35 NEW SECTION. **Sec. 612.** (1) A registered owner may apply to the

1 department for special armed forces license plates for motor vehicles
2 representing the following:

- 3 (a) Air force;
- 4 (b) Army;
- 5 (c) Coast guard;
- 6 (d) Marine corps;
- 7 (e) National guard; or
- 8 (f) Navy.

9 (2) Armed forces license plates may be purchased by:

- 10 (a) Active duty military personnel;
- 11 (b) Families of veterans and service members;
- 12 (c) Members of the national guard;
- 13 (d) Reservists; or
- 14 (e) Veterans, as defined in RCW 41.04.007.

15 (3) A person who applies for special armed forces license plates
16 shall provide:

- 17 (a) DD-214 or discharge papers if the applicant is a veteran;
- 18 (b) A military identification card or retired military
19 identification card; or
- 20 (c) A declaration of fact attesting to the applicant's eligibility
21 as required under this section.

22 (4) For the purposes of this section:

- 23 (a) "Child" includes stepchild, adopted child, foster child,
24 grandchild, or son or daughter-in-law.
- 25 (b) "Family" or "families" includes an individual's spouse, child,
26 parent, sibling, aunt, uncle, or cousin.
- 27 (c) "Parent" includes stepparent, grandparent, or in-laws.
- 28 (d) "Sibling" includes brother, half brother, stepbrother, sister,
29 half sister, stepsister, or brother or sister-in-law.

30 (5) Armed forces license plates are not free of charge to disabled
31 veterans, former prisoners of war, or spouses or domestic partners of
32 deceased former prisoners of war under section 619 of this act.

33 NEW SECTION. **Sec. 613.** (1) The department must make available,
34 upon request by a purchaser of special armed forces license plates, at
35 no additional cost, a decal indicating the purchaser's military status.
36 The list of available decals must include, but is not limited to:

- 37 (a) Active duty;

- 1 (b) Disabled veteran;
- 2 (c) Reservist;
- 3 (d) Retiree;
- 4 (e) Veteran; or
- 5 (f) Other decals established in cooperation with the department of
- 6 veterans affairs.

7 (2) Armed forces decals must be made available only for standard
8 six-inch by twelve-inch license plates. The department may specify
9 where the decal may be placed on the license plate.

10 (3) The department of veterans affairs must enter into an agreement
11 with the department to reimburse the department for the costs
12 associated with providing military status decals described in this
13 section.

14 **Sec. 614.** RCW 46.16.301 and 1997 c 291 s 5 are each amended to
15 read as follows:

16 The department shall create, design, and issue a special baseball
17 stadium license plate that may be used in lieu of (~~regular~~) standard
18 issue or personalized license plates for motor vehicles required to
19 display two (~~motor vehicle~~) license plates, excluding vehicles
20 registered under chapter 46.87 RCW, upon terms and conditions
21 established by the department. The special license plates (~~shall~~)
22 commemorate the construction of a baseball stadium, as defined in RCW
23 82.14.0485. The department shall also issue to each recipient of a
24 special baseball stadium license plate a certificate of participation
25 in the construction of the baseball stadium.

26 **Sec. 615.** RCW 46.16.324 and 1994 c 194 s 3 are each amended to
27 read as follows:

28 (~~Effective January 1, 1995,~~) A state university, regional
29 university, or state college as defined in RCW 28B.10.016 may apply to
30 the department, in a form (~~prescribed~~) approved by the
31 department(~~)~~ and request the department to issue a series of
32 collegiate license plates, for display on motor vehicles, depicting the
33 name and mascot or symbol of the college or university, as submitted
34 and approved for use by the requesting institution.

1 NEW SECTION. **Sec. 616.** (1) A registered owner may apply to the
2 department for special license plates showing the official amateur
3 radio call letters assigned by the federal communications commission.
4 The amateur radio operator must:

5 (a) Provide a copy of the current valid federal communications
6 commission amateur radio license;

7 (b) Pay the amateur radio license plate fee required under section
8 521(1)(a) of this act, in addition to any other fees and taxes due; and

9 (c) Be recorded as the registered owner of the vehicle on which the
10 amateur radio license plates will be displayed.

11 (2) Amateur radio license plates must be issued only for motor
12 vehicles owned by persons who have a valid official radio operator
13 license issued by the federal communications commission.

15 radio license plates that display the consecutive letters "WSP."

16 (4) A person who has been issued amateur radio operator license
17 plates as provided in this section must:

20 return the amateur radio license plates; and

21 (b) Provide a copy of the renewed federal communications commission
22 license to the department after it is renewed.

23 (5) Amateur radio license plates may be transferred from one motor
24 vehicle to another motor vehicle owned by the amateur radio operator
25 upon application to the department, county auditor or other agent, or
26 subagent appointed by the director.

27 (6) Facilities of official amateur radio stations may be utilized
28 to the fullest extent in the work of governmental agencies. The
29 director shall furnish the state military department, the department of
30 commerce, the Washington state patrol, and all county sheriffs a list
31 of the names, addresses, and license plate or official amateur radio
32 call letters of each person possessing the amateur radio license
33 plates.

34 (7) Failure to return the amateur radio license plates as required
35 under subsection (4) of this section is a traffic infraction.

36 NEW SECTION. **Sec. 617.** (1) A registered owner may apply to the
37 department, county auditor or other agent, or subagent appointed by the

1 director for a collector vehicle license plate for a motor vehicle that
2 is at least thirty years old. The motor vehicle must be operated
3 primarily as a collector vehicle and be in good running order. The
4 applicant for the collector vehicle license plate shall:

5 (a) Purchase a registration for the motor vehicle as required under
6 chapters 46.16 and 46.17 RCW; and

7 (b) Pay the special license plate fee established under section
8 521(1)(d) of this act, in addition to any other fees or taxes required
9 by law.

10 (2) A person applying for a collector vehicle license plate may:

11 (a) Receive a collector vehicle license plate assigned by the
12 department; or

13 (b) Provide a Washington state issued license plate designated for
14 general use in the year of the vehicle's manufacture.

15 (3) Collector vehicle license plates:

16 (a) Are valid for the life of the motor vehicle;

17 (b) Are not required to be renewed; and

18 (c) Must be displayed on the rear of the motor vehicle.

19 (4) A collector vehicle registered under this section may only be
20 used for participation in club activities, exhibitions, tours, parades,
21 and occasional pleasure driving.

22 (5) Collector vehicle license plates may be transferred from one
23 motor vehicle to another motor vehicle described in subsection (1) of
24 this section upon application to the department, county auditor or
25 other agent, or subagent appointed by the director.

26 NEW SECTION. **Sec. 618.** (1) A registered owner who has been
27 awarded the Congressional Medal of Honor may apply to the department
28 for special license plates for use on a passenger vehicle. The
29 Congressional Medal of Honor recipient must:

30 (a) Provide proof from the Washington state department of veterans
31 affairs showing receipt of the medal; and

32 (b) Be recorded as the registered owner of the vehicle on which the
33 Congressional Medal of Honor license plates will be displayed.

34 (2) Congressional Medal of Honor license plates must be issued:

35 (a) Only for a personal passenger motor vehicle owned by persons
36 who have received the Congressional Medal of Honor; and

1 (b) Without payment of vehicle license fees, license plate fees,
2 and motor vehicle excise taxes.

3 (3) Congressional Medal of Honor license plates must be replaced,
4 free of charge, if the license plates become lost, stolen, damaged,
5 defaced, or destroyed.

6 (4) Congressional Medal of Honor license plates may be transferred,
7 free of charge, from one motor vehicle to another motor vehicle owned
8 by the Congressional Medal of Honor recipient upon application to the
9 department, county auditor or other agent, or subagent appointed by the
10 director.

11 NEW SECTION. **Sec. 619.** (1) A registered owner who is a veteran,
12 as defined in RCW 41.04.007, may apply to the department for disabled
13 American veteran or former prisoner of war license plates, for use on
14 one personal use motor vehicle. The veteran must be recorded as the
15 registered owner of the vehicle on which the disabled American veteran
16 or former prisoner of war license plates will be displayed and:

17 (a) Provide certification from the veterans administration or the
18 military service from which the veteran was discharged that the veteran
19 has a service-connected disability rating;

20 (b) Have lost the use of both hands or one foot;

21 (c) Have been captured and incarcerated by an enemy of the United
22 States during a period of war with the United States and have received
23 a prisoner of war medal;

24 (d) Have become blind in both eyes as the result of military
25 service; or

26 (e) Be rated by the veterans administration or the military service
27 from which the veteran was discharged and be receiving service-
28 connected compensation at the one hundred percent rate that is expected
29 to exist for more than one year.

30 (2) The special license plates under this section must:

31 (a) Display distinguishing marks, letters, or numerals indicating
32 that the registered owner is a disabled American veteran or former
33 prisoner of war; and

34 (b) Be issued for one personal use vehicle without the payment of
35 any vehicle license fees, license plate fees, or excise taxes.

36 (3) A registered owner who is a veteran, as defined in RCW
37 41.04.007, may, in lieu of applying for the special license plates

1 under this section, apply for regular issue or any qualifying special
2 license plate and receive the full benefit of the vehicle license fee
3 and excise tax exemption provided in subsection (2)(b) of this section.

4 (4) The department may periodically verify the one hundred percent
5 rate as described in subsection (1)(e) of this section.

6 (5) A veteran who has been issued disabled American veteran or
7 former prisoner of war license plates under this section before July 1,
8 1983, continues to be eligible for the vehicle license fee and excise
9 tax exemption described in subsection (2)(b) of this section.

10 (6) Disabled American veteran and former prisoner of war license
11 plates may be transferred from one motor vehicle to another motor
12 vehicle owned by the veteran upon application to the department, county
13 auditor or other agent, or subagent appointed by the director.

14 (7) For the purposes of this section:

15 (a) "Blind" means the definition of "blind" used by the state of
16 Washington in determining eligibility for financial assistance to the
17 blind under Title 74 RCW; and

18 (b) "Special license plates" does not include any plate from the
19 armed forces license plate collection established in section 611(3) of
20 this act.

21 (8) Any unauthorized use of a special license plate under this
22 section is a gross misdemeanor.

23 NEW SECTION. **Sec. 620.** (1) A registered owner who is an officer
24 of the Taipei economic and cultural office may apply to the department
25 for special license plates for a motor vehicle owned or leased by the
26 officer. The special license plates must:

27 (a) Be issued for passenger vehicles having a manufacturer's rated
28 carrying capacity of one ton or less;

29 (b) Show the words "Foreign Organization";

30 (c) Be in a distinguishing color and a separate numerical series;

31 (d) Be returned to the department when no longer in use or when the
32 owner or lessee is relieved of his or her duties as a representative of
33 the recognized foreign organization; and

34 (e) Be removed from the vehicle when the officer of the Taipei
35 economic and cultural office transfers or assigns the interest or

2 exempt from the vehicle license fees under section 531 of this act.

3 (3) Foreign organization license plates may be transferred from one
4 motor vehicle to another motor vehicle owned by the officer as
5 described in subsection (1) of this section upon application to the
6 department, county auditor or other agent, or subagent appointed by the
7 director.

8 (4) The Taipei economic and cultural office shall bear the entire
9 cost of production of the special license plates described in
10 subsection (1) of this section.

11 NEW SECTION. **Sec. 621.** (1) A registered owner who is the mother
12 or father of a member of the United States armed forces who died while
13 in service to his or her country, or as a result of his or her service,
14 may apply to the department for special gold star license plates for
15 use on a motor vehicle. The registered owner must:

16 (a) Be a resident of this state;

17 (b) Provide certification from the Washington state department of
18 veterans affairs that the registered owner qualifies for the special
19 license plate under this section;

20 (c) Be recorded as the registered owner of the motor vehicle on
21 which the gold star license plates will be displayed; and

22 (d) Pay all fees and taxes required by law for registering the
23 motor vehicle.

24 (2) Gold star license plates must be issued:

25 (a) Only for motor vehicles owned by qualifying applicants; and

26 (b) Without payment of any license plate fee.

27 (3) Gold star license plates must be replaced, free of charge, if
28 the license plates become lost, stolen, damaged, defaced, or destroyed.

29 (4) Gold star license plates may be transferred from one motor
30 vehicle to another motor vehicle owned by the mother or father, as
31 described in subsection (1) of this section, upon application to the
32 department, county auditor or other agent, or subagent appointed by the
33 director.

34 NEW SECTION. **Sec. 622.** (1) A registered owner who is an honorary
35 consul or official representative of any foreign government may apply
36 to the department for special license plates for a motor vehicle owned

1 or leased by the honorary consul or official representative. The
2 honorary consul or official representative must be a citizen of the
3 United States, pay all required vehicle license fees and taxes, and
4 either (a) provide a copy of the honorary consul identification card or
5 (b) show the exequatur issued by the United States department of state.

6 (2) The special honorary consul license plates must be:

7 (a) A distinguishing color and separate numerical series;

8 (b) Returned to the department when no longer in use or when the
9 honorary consul or official representative is relieved of his or her
10 official duties; and

11 (c) Removed from the vehicle when the honorary consul or official
12 representative transfers or assigns the interest or certificate of
13 title in the motor vehicle for which the special license plates were
14 issued.

15 (3) The special honorary consul license plates may be transferred
16 to a replacement vehicle. The honorary consul or official
17 representative shall immediately notify the department of the transfer
18 of the special license plates.

19 NEW SECTION. **Sec. 623.** (1) A registered owner may apply to the
20 department, county auditor or other agent, or subagent appointed by the
21 director for a horseless carriage license plate for a motor vehicle
22 that is at least forty years old. The motor vehicle must be operated
23 primarily as a collector vehicle and be in good running order. The
24 applicant for the horseless carriage license plate shall:

25 (a) Purchase a registration for the motor vehicle as required under
26 chapters 46.16 and 46.17 RCW; and

27 (b) Pay the special license plate fee established under section
28 521(1)(i) of this act, in addition to any other fees or taxes required
29 by law.

30 (2) Horseless carriage license plates:

31 (a) Are valid for the life of the motor vehicle;

32 (b) Are not required to be renewed;

33 (c) Are not transferrable to any other motor vehicle; and

34 (d) Must be displayed on the rear of the motor vehicle.

35 NEW SECTION. **Sec. 624.** (1) A registered owner who has a valid

1 military affiliate radio system station license may apply to the
2 department for special license plates for use on only one motor vehicle
3 owned by the qualified applicant. The applicant must:

4 (a) Be a resident of this state;

5 (b) Provide a copy of the current official military affiliate radio
6 system station license authorized by the department of defense and
7 issued by the United States army, air force, navy, or marine corps;

8 (c) Be recorded as the registered owner of the motor vehicle on
9 which the military affiliate radio system license plates will be
10 displayed; and

11 (d) Pay the military affiliate radio system license plate fee
12 required under section 521(1)(1) of this act, in addition to any other
13 fees or taxes required by law.

14 (2) A person who has been issued military affiliate radio system
15 license plates as provided in this section must:

16 (a) Notify the department if the military affiliate radio system
17 station license assigned is canceled or expires; and

18 (b) Provide a copy of the renewed military affiliate radio system
19 station license to the department when it is renewed.

20 (3) Military affiliate radio system license plates:

21 (a) Are not available for motorcycles; and

22 (b) May be transferred from one motor vehicle to another motor
23 vehicle owned by the military affiliate radio system operator upon
24 application to the department, county auditor or other agent, or
25 subagent appointed by the director.

26 NEW SECTION. **Sec. 625.** (1) A registered owner who has survived
27 the attack on Pearl Harbor on December 7, 1941, may apply to the
28 department for special license plates for use on only one motor vehicle
29 owned by the qualified applicant. The applicant must:

30 (a) Be a resident of this state;

31 (b) Have been a member of the United States armed forces on
32 December 7, 1941;

33 (c) Have been on station on December 7, 1941, between the hours of
34 7:55 a.m. and 9:45 a.m. Hawaii time at Pearl Harbor, the island of
35 Oahu, or offshore at a distance not to exceed three miles;

36 (d) Have received an honorable discharge from the United States
37 armed forces;

1 (e) Provide certification by a Washington state chapter of the
2 Pearl Harbor survivors association showing that qualifications in (c)
3 of this subsection have been met;

4 (f) Be recorded as the registered owner of the vehicle on which the
5 Pearl Harbor survivor license plates will be displayed; and

6 (g) Pay all fees and taxes required by law for registering the
7 motor vehicle.

8 (2) Pearl Harbor survivor license plates must be issued without the
9 payment of any license plate fee.

10 (3) Pearl Harbor survivor license plates must be replaced, free of
11 charge, if the license plates have become lost, stolen, damaged,
12 defaced, or destroyed.

13 (4) Pearl Harbor survivor license plates may be issued to the
14 surviving spouse or domestic partner of a Pearl Harbor survivor who met
15 the requirements in subsection (1) of this section. The surviving
16 spouse or domestic partner must be a resident of this state. If the
17 surviving spouse remarries or the surviving domestic partner marries or
18 enters into a new domestic partnership, he or she must return the
19 special plates to the department within fifteen days and apply for
20 regular license plates or another type of special license plate.

21 (5) Pearl Harbor survivor license plates may be transferred from
22 one motor vehicle to another motor vehicle owned by the Pearl Harbor
23 survivor or the surviving spouse or domestic partner as described in
24 subsection (4) of this section upon application to the department,
25 county auditor or other agent, or subagent appointed by the director.

26 NEW SECTION. **Sec. 626.** (1) A registered owner may apply to the
27 department for a personalized license plate for any vehicle required to
28 display one or two vehicle license plates, excluding vehicles
29 registered under chapter 46.87 RCW, upon terms and conditions
30 established by the department. The application for personalized
31 license plates must contain the combination of letters or numbers, or
32 both, requested by the registered owner.

33 (2) Personalized license plates must:

34 (a) Be the same design as standard issue license plates;

35 (b) Consist of numbers or letters or any combination of numbers or
36 letters;

1 (c) Not exceed seven positions unless proposed by the department
2 and approved by the Washington state patrol; and

3 (d) Not contain less than one character.

4 (3) A person who purchased personalized license plates containing
5 three letters and three digits on or between the dates of August 9,
6 1971, and November 6, 1973, is not required to pay the additional
7 annual renewal fee described in section 520 of this act.

8 (4) The department shall not issue or may refuse to issue
9 personalized license plates that:

10 (a) Duplicate or conflict with an existing or projected vehicle
11 license plate series or other numbering systems for records kept by the
12 department; or

13 (b) May carry connotations offensive to good taste and decency or
14 which would be misleading.

15 (5) Personalized license plates must be issued only to the
16 registered owner of the vehicle on which they are to be displayed. The
17 registered owner must:

18 (a) Pay the personalized license plate fee required under section
19 520 of this act, in addition to any other fee or taxes due;

20 (b) Renew personalized license plates annually, regardless of
21 whether or not the vehicle on which the personalized license plates are
22 displayed will be driven on the public highways;

23 (c) Surrender personalized license plates that have not been
24 renewed to the department. The failure to surrender expired
25 personalized license plates is a traffic infraction; and

26 (d) Immediately report to the department when personalized license
27 plates have been transferred to another vehicle or another owner.

28 (6) The department may establish rules as necessary to carry out
29 this section including, but not limited to, identifying the maximum

19 (b) May carry connotations offensive to good taste and decency or

1 NEW SECTION. **Sec. 629.** A registered owner who uses a passenger
2 motor vehicle for commuter ride sharing or ride sharing for persons

4 apply to the director, county auditor or other agent, or subagent
5 appointed by the director for special ride share license plates. The
6 registered owner must qualify for the tax exemptions provided in RCW

21 other agent, or subagent appointed by the director.

23 fact in the application for a special license plate under subsection
24 (1) of this section is guilty of a gross misdemeanor.

25 NEW SECTION. **Sec. 630.** A registered owner may apply to the
26 department, county auditor or other agent, or subagent appointed by the
27 director for a square dancer license plate. The registered owner shall
28 pay the special license plate fee required under section 521(1)(q) of
29 this act, in addition to any other fee or tax required by law. The
30 square dancer license plate may be issued in lieu of standard issue or

32 license plates, but may not be issued for vehicles registered under

7 **SPECIAL PARKING PRIVILEGES FOR PERSONS WITH DISABILITIES**

8 NEW SECTION. **Sec. 701.** (1) A natural person who has a disability
9 that meets one of the following criteria may apply for special parking
10 privileges:

11 (a) Cannot walk two hundred feet without stopping to rest;

12 (b) Is severely limited in ability to walk due to arthritic,
13 neurological, or orthopedic condition;

14 (c) Has such a severe disability that the person cannot walk
15 without the use of or assistance from a brace, cane, another person,
16 prosthetic device, wheelchair, or other assistive device;

17 (d) Uses portable oxygen;

18 (e) Is restricted by lung disease to an extent that forced
19 expiratory respiratory volume, when measured by spirometry, is less
20 than one liter per second or the arterial oxygen tension is less than
21 sixty mm/hg on room air at rest;

22 (f) Impairment by cardiovascular disease or cardiac condition to
23 the extent that the person's functional limitations are classified as
24 class III or IV under standards accepted by the American heart
25 association;

26 (g) Has a disability resulting from an acute sensitivity to
27 automobile emissions that limits or impairs the ability to walk. The
28 personal physician, advanced registered nurse practitioner, or
29 physician assistant of the applicant shall document that the disability
30 is comparable in severity to the others listed in this subsection;

31 (h) Has limited mobility and has no vision or whose vision with
32 corrective lenses is so limited that the person requires alternative
33 methods or skills to do efficiently those things that are ordinarily
34 done with sight by persons with normal vision;

35 (i) Has an eye condition of a progressive nature that may lead to
36 blindness; or

1 (j) Is restricted by a form of porphyria to the extent that the
2 applicant would significantly benefit from a decrease in exposure to
3 light.

4 (2) The disability must be determined by either:

5 (a) A licensed physician;

6 (b) An advanced registered nurse practitioner licensed under
7 chapter 18.79 RCW; or

8 (c) A physician assistant licensed under chapter 18.71A or 18.57A
9 RCW.

10 (3) The application for special parking privileges for persons with
11 disabilities must contain:

12 (a) The following statement immediately below the physician's,
13 advanced registered nurse practitioner's, or physician assistant's
14 signature: "A parking permit for a person with disabilities may be
15 issued only for a medical necessity that severely affects mobility or
16 involves acute sensitivity to light (section 701 of this act).
17 Knowingly providing false information on this application is a gross
18 misdemeanor. The penalty is up to one year in jail and a fine of up to
19 \$5,000 or both"; and

20 (b) Other information as required by the department.

21 (4) A natural person who has a disability described in subsection
22 (1) of this section and is expected to improve within six months may be
23 issued a temporary placard for a period not to exceed six months. If
24 the disability exists after six months, a new temporary placard must be
25 issued upon receipt of a new application with certification from the
26 person's physician. Special license plates for persons with
27 disabilities may not be issued to a person with a temporary disability.

28 (5) A natural person who qualifies for special parking privileges
29 under this section must receive an identification card showing the name
30 and date of birth of the person to whom the parking privilege has been
31 issued and the serial number of the placard.

32 (6) A natural person who qualifies for permanent special parking
33 privileges under this section may receive one of the following:

34 (a) Up to two parking placards;

35 (b) One set of special license plates for persons with disabilities
36 if the person with the disability is the registered owner of the
37 vehicle on which the license plates will be displayed;

1 (c) One parking placard and one set of special license plates for
2 persons with disabilities if the person with the disability is the
3 registered owner of the vehicle on which the license plates will be
4 displayed; or

5 (d) One special parking year tab for persons with disabilities and
6 one parking placard.

7 (7) Parking placards and identification cards described in this
8 section must be issued free of charge.

9 (8) The parking placard and identification card must be immediately
10 returned to the department upon the placard holder's death.

11 NEW SECTION. **Sec. 702.** (1) The following organizations may apply
12 for special parking privileges:

13 (a) Public transportation authorities;

14 (b) Nursing homes licensed under chapter 18.51 RCW;

15 (c) Boarding homes licensed under chapter 18.20 RCW;

16 (d) Senior citizen centers;

17 (e) Private nonprofit corporations, as defined in RCW 24.03.005;
18 and

19 (f) Cabulance companies that regularly transport persons with
20 disabilities who have been determined eligible for special parking
21 privileges under this section and who are registered with the
22 department under chapter 46.72 RCW.

23 (2) An organization that qualifies for special parking privileges
24 may receive, upon application, parking license plates or placards, or
25 both, for persons with disabilities as defined by the department.

26 (3) Public transportation authorities, nursing homes, boarding
27 homes, senior citizen centers, private nonprofit corporations, and
28 cabulance services are responsible for ensuring that the special
29 placards and license plates are not used improperly and are responsible
30 for all fines and penalties for improper use.

31 (4) The department shall adopt rules to determine organization
32 eligibility.

33 NEW SECTION. **Sec. 703.** (1) Parking privileges for persons with
34 disabilities must be renewed at least every five years, as required by
35 the director, by satisfactory proof of the right to continued use of
36 the privileges.

1 (2) The department shall match and purge its database of parking
2 permits issued to persons with disabilities with available death record
3 information at least every twelve months.

4 (3) The department shall adopt rules to administer the parking
5 privileges for persons with disabilities program.

6 NEW SECTION. **Sec. 704.** (1) The department shall design special
7 license plates for persons with disabilities, parking placards, and
8 year tabs displaying the international symbol of access.

9 (2) Special license plates for persons with disabilities must be
10 displayed on the motor vehicle as standard issue license plates as
11 described in section 422 of this act.

12 (3) Parking placards must be displayed when the motor vehicle is
13 parked by suspending it from the rearview mirror. In the absence of a
14 rearview mirror, the parking placard must be displayed on the
15 dashboard.

16 (4) Special year tabs for persons with disabilities must be
17 displayed on license plates as defined by the department.

18 (5) Persons who have been issued special license plates for persons
19 with disabilities, parking placards, or special license plates with a
20 special year tab for persons with disabilities may park in places

22 NEW SECTION. **Sec. 705.** (1) An additional fee may not be charged
23 for special license plates for persons with disabilities except for any
24 other fees and taxes required to be paid upon registration of a motor

26 license plates with a special year tab for persons with disabilities
27 must be renewed in the same manner and at the time required for the
28 renewal of standard motor vehicle license plates under chapter 46.16
29 RCW.

30 (5) Special license plates for persons with disabilities or special
31 license plates with a special year tab for persons with disabilities
32 may be transferred from one motor vehicle to another motor vehicle

17 (4) **Parking without placard/plate.** It is a parking infraction,

22 this chapter. If a person is charged with a violation, the person will
23 not be determined to have committed an infraction if the person

27 reserved for persons with physical disabilities may impose by ordinance

27 shall be removed from the tax rolls and upon notification by the
28 assessor, any outstanding taxes on the destroyed mobile home or park
29 model trailer shall be removed by the county treasurer.

17 realized at auction. If the date of sale is after the date of
18 impoundment, the previous registered owner is assumed to be liable for
19 such costs. A licensed vehicle dealer is not liable under subsections
20 (1) and (2) of this section if the dealer, as transferee or assignee of
21 the last registered owner of the vehicle involved, has complied with
22 the requirements of RCW 46.70.122 upon selling or otherwise disposing
23 of the vehicle, or if the dealer has timely filed a transitional
24 ownership record or report of sale under RCW 46.12.103 (as recodified
25 by this act). In that case the person to whom the licensed vehicle
26 dealer has sold or transferred the vehicle is assumed liable for the
27 costs incurred in removing, storing, and disposing of the abandoned
28 vehicle, less amounts realized at auction.

29 (5) For the purposes of reporting notices of traffic infraction to
30 the department under RCW 46.20.270 and 46.52.101, and for purposes of
31 reporting notices of failure to appear, respond, or comply regarding a
32 notice of traffic infraction to the department under RCW 46.63.070(6),
33 a traffic infraction under subsection (2) of this section is not
34 considered to be a standing, stopping, or parking violation.

35 (6) A notice of infraction for a violation of this section may be
36 filed with a court of limited jurisdiction organized under Title 3, 35,
37 or 35A RCW, or with a violations bureau subject to the court's
38 jurisdiction.

1 auction dealers to franchise motor vehicle dealers of the same make
2 licensed under this title (~~(46-RCW)~~) or franchise motor vehicle dealers
3 of the same make licensed by any other state;

4 (viii) Is insolvent, either in the sense that their liabilities
5 exceed their assets, or in the sense that they cannot meet their
6 obligations as they mature;

7 (ix) Fails to pay any civil monetary penalty assessed by the
8 director pursuant to this section within ten days after such assessment
9 becomes final;

10 (x) Fails to notify the department of bankruptcy proceedings in the

12 (xi) Knowingly, or with reason to know, allows a salesperson
13 employed by the dealer, or acting as their agent, to commit any of the

17 department of revenue.

18 (b) The applicant or licensee, or any partner, officer, director,
19 owner of ten percent of the assets of the firm, or any employee or
20 agent:

21 (i) Has failed to comply with the applicable provisions of chapter
22 46.12 or 46.16 RCW or this chapter or any rules and regulations adopted
23 thereunder;

24 (ii) Has defrauded or attempted to defraud the state, or a
25 political subdivision thereof of any taxes or fees in connection with
26 the sale, lease, or transfer of a vehicle;

27 (iii) Has forged the signature of the registered or legal owner on
28 a certificate of title;

29 (iv) Has purchased, sold, disposed of, or has in his or her
30 possession any vehicle which he or she knows or has reason to know has
31 been stolen or appropriated without the consent of the owner;

32 (v) Has willfully failed to deliver to a purchaser or owner a
33 certificate of (~~ownership~~) title to a vehicle which he or she has
34 sold or leased;

35 (vi) Has committed any act in violation of RCW 46.70.090 relating
36 to vehicle dealer license plates or manufacturer license plates;

37 (vii) Has committed any act in violation of RCW 46.70.180 relating
38 to unlawful acts and practices;

2 the citizens of the state of Washington including but not limited to

23 (c) The licensee or any partner, officer, director, or owner of ten
24 percent or more of the assets of the firm holds or has held any such
25 position in any other vehicle dealership licensed pursuant to this
26 chapter which is subject to final proceedings under this section.

27 (2) In the case of a manufacturer, or any partner, officer,
28 director, or majority shareholder:

29 (a) Was or is the holder of a license issued pursuant to this
30 chapter which was revoked for cause and never reissued by the
31 department, or which license was suspended for cause and the terms of
32 the suspension have not been fulfilled, or which license was assessed
33 a civil penalty and the assessed amount has not been paid;

34 (b) Has knowingly or with reason to know, made a false statement of
35 a material fact in his or her application for license, or any data
36 attached thereto, or in any matter under investigation by the
37 department;

- 1 (c) Has failed to comply with the applicable provisions of chapter
2 46.12 or 46.16 RCW or this chapter or any rules and regulations adopted
3 thereunder;
- 4 (d) Has defrauded or attempted to defraud the state or a political

29 to any new or unused vehicle sold, leased, or distributed in this state

31 manufacturer;
- 32 (k) Engaged in practices inimical to the health and safety of the
33 citizens of the state of Washington including, but not limited to,
34 failure to comply with standards set by the state of Washington or the
35 federal government pertaining to the construction and safety of
36 vehicles;
- 37 (l) Is insolvent either in the sense that his or her liabilities

1 exceed his or her assets or in the sense that he or she cannot meet his
2 or her obligations as they mature;

3 (m) Fails to notify the department of bankruptcy proceedings in the

27 Each of the following acts or practices is unlawful:

28 (1) To cause or permit to be advertised, printed, displayed,
29 published, distributed, broadcasted, televised, or disseminated in any
30 manner whatsoever, any statement or representation with regard to the
31 sale, lease, or financing of a vehicle which is false, deceptive, or
32 misleading, including but not limited to the following:

33 (a) That no down payment is required in connection with the sale of
34 a vehicle when a down payment is in fact required, or that a vehicle
35 may be purchased for a smaller down payment than is actually required;

36 (b) That a certain percentage of the sale price of a vehicle may be

1 financed when such financing is not offered in a single document
2 evidencing the entire security transaction;

3 (c) That a certain percentage is the amount of the service charge
4 to be charged for financing, without stating whether this percentage
5 charge is a monthly amount or an amount to be charged per year;

6 (d) That a new vehicle will be sold for a certain amount above or
7 below cost without computing cost as the exact amount of the factory
8 invoice on the specific vehicle to be sold;

9 (e) That a vehicle will be sold upon a monthly payment of a certain
10 amount, without including in the statement the number of payments of
11 that same amount which are required to liquidate the unpaid purchase
12 price.

13 (2)(a)(i) To incorporate within the terms of any purchase and sale
14 or lease agreement any statement or representation with regard to the
15 sale, lease, or financing of a vehicle which is false, deceptive, or
16 misleading, including but not limited to terms that include as an added
17 cost to the selling price or capitalized cost of a vehicle an amount
18 for licensing or transfer of title of that vehicle which is not
19 actually due to the state, unless such amount has in fact been paid by
20 the dealer prior to such sale.

21 (ii) However, an amount not to exceed the applicable amount
22 provided in (iii)(A) and (B) of this subsection (2)(a) per vehicle sale
23 or lease may be charged by a dealer to recover administrative costs for
24 collecting motor vehicle excise taxes, licensing and registration fees
25 and other agency fees, verifying and clearing titles, transferring
26 titles, perfecting, releasing, or satisfying liens or other security
27 interests, and other administrative and documentary services rendered
28 by a dealer in connection with the sale or lease of a vehicle and in
29 carrying out the requirements of this chapter or any other provisions
30 of state law.

31 (iii) A dealer may charge under (a)(ii) of this subsection:

32 (A) As of July 26, 2009, through June 30, 2014, an amount not to
33 exceed one hundred fifty dollars; and

34 (B) As of July 1, 2014, an amount not to exceed fifty dollars.

35 (b) A dealer may charge the documentary service fee in (a) of this
36 subsection under the following conditions:

37 (i) The documentary service fee is disclosed in writing to a

1 prospective purchaser or lessee before the execution of a purchase and
2 sale or lease agreement;

3 (ii) The dealer discloses to the purchaser or lessee in writing
4 that the documentary service fee is a negotiable fee. The disclosure
5 must be written in a typeface that is at least as large as the typeface
6 used in the standard text of the document that contains the disclosure
7 and that is bold faced, capitalized, underlined, or otherwise set out
8 from the surrounding material so as to be conspicuous. The dealer
9 shall not represent to the purchaser or lessee that the fee or charge
10 is required by the state to be paid by either the dealer or prospective
11 purchaser or lessee;

12 (iii) The documentary service fee is separately designated from the
13 selling price or capitalized cost of the vehicle and from any other
14 taxes, fees, or charges; and

15 (iv) Dealers disclose in any advertisement that a documentary
16 service fee in an amount provided in (iv)(A) and (B) of this subsection
17 (2)(b) may be added to the sale price or the capitalized cost:

18 (A) As of July 26, 2009, through June 30, 2014, an amount up to one
19 hundred fifty dollars; and

20 (B) As of July 1, 2014, an amount up to fifty dollars.

21 For the purposes of this subsection (2), the term "documentary
22 service fee" means the optional amount charged by a dealer to provide
23 the services specified in (a) of this subsection.

24 (3) To set up, promote, or aid in the promotion of a plan by which
25 vehicles are to be sold or leased to a person for a consideration and
26 upon further consideration that the purchaser or lessee agrees to
27 secure one or more persons to participate in the plan by respectively
28 making a similar purchase and in turn agreeing to secure one or more
29 persons likewise to join in said plan, each purchaser or lessee being
30 given the right to secure money, credits, goods, or something of value,
31 depending upon the number of persons joining the plan.

32 (4) To commit, allow, or ratify any act of "bushing" which is
33 defined as follows: Entering into a written contract, written purchase
34 order or agreement, retail installment sales agreement, note and
35 security agreement, or written lease agreement, hereinafter
36 collectively referred to as contract or lease, signed by the
37 prospective buyer or lessee of a vehicle, which:

1 (a) Is subject to any conditions or the dealer's or his or her
2 authorized representative's future acceptance, and the dealer fails or
3 refuses within four calendar days, exclusive of Saturday, Sunday, or
4 legal holiday, and prior to any further negotiations with said buyer or
5 lessee to inform the buyer or lessee either: (i) That the dealer
6 unconditionally accepts the contract or lease, having satisfied,
7 removed, or waived all conditions to acceptance or performance,

9 approval; or (ii) that the dealer rejects the contract or lease,
10 thereby automatically voiding the contract or lease, as long as such
11 voiding does not negate commercially reasonable contract or lease
12 provisions pertaining to the return of the subject vehicle and any
13 physical damage, excessive mileage after the demand for return of the
14 vehicle, and attorneys' fees authorized by law, and tenders the refund
15 of any initial payment or security made or given by the buyer or
16 lessee, including, but not limited to, any down payment, and tenders
17 return of the trade-in vehicle, key, other trade-in, or certificate of
18 title to a trade-in. Tender may be conditioned on return of the
19 subject vehicle if previously delivered to the buyer or lessee.

20 The provisions of this subsection (4)(a) do not impair, prejudice,
21 or abrogate the rights of a dealer to assert a claim against the buyer
22 or lessee for misrepresentation or breach of contract and to exercise
23 all remedies available at law or in equity, including those under
24 chapter 62A.9A RCW, if the dealer, bank, or other lender or leasing
25 company discovers that approval of the contract or financing or
26 approval of the lease was based upon material misrepresentations made
27 by the buyer or lessee, including, but not limited to,
28 misrepresentations regarding income, employment, or debt of the buyer

1 When a dealer informs a buyer or lessee under this subsection
2 (4)(a) regarding the unconditional acceptance or rejection of the
3 contract, lease, or financing by an electronic mail message, the dealer
4 must also transmit the communication by any additional means;

5 (b) Permits the dealer to renegotiate a dollar amount specified as
6 trade-in allowance on a vehicle delivered or to be delivered by the
7 buyer or lessee as part of the purchase price or lease, for any reason
8 except:

9 (i) Failure to disclose that the vehicle's certificate of
10 (~~ownership~~) title has been branded for any reason, including, but not
11 limited to, status as a rebuilt vehicle as provided in RCW 46.12.050
12 (as recodified by this act) and (~~46.12.075~~) section 303 of this act;
13 or

14 (ii) Substantial physical damage or latent mechanical defect
15 occurring before the dealer took possession of the vehicle and which
16 could not have been reasonably discoverable at the time of the taking
17 of the order, offer, or contract; or

18 (iii) Excessive additional miles or a discrepancy in the mileage.
19 "Excessive additional miles" means the addition of five hundred miles
20 or more, as reflected on the vehicle's odometer, between the time the
21 vehicle was first valued by the dealer for purposes of determining its
22 trade-in value and the time of actual delivery of the vehicle to the
23 dealer. "A discrepancy in the mileage" means (A) a discrepancy between
24 the mileage reflected on the vehicle's odometer and the stated mileage
25 on the signed odometer statement; or (B) a discrepancy between the
26 mileage stated on the signed odometer statement and the actual mileage
27 on the vehicle; or

28 (c) Fails to comply with the obligation of any written warranty or
29 guarantee given by the dealer requiring the furnishing of services or
30 repairs within a reasonable time.

31 (5) To commit any offense relating to odometers, as such offenses
32 are defined in RCW 46.37.540, 46.37.550, 46.37.560, and 46.37.570. A
33 violation of this subsection is a class C felony punishable under
34 chapter 9A.20 RCW.

35 (6) For any vehicle dealer or vehicle salesperson to refuse to
36 furnish, upon request of a prospective purchaser or lessee, for
37 vehicles previously registered to a business or governmental entity,
38 the name and address of the business or governmental entity.

1 (7) To commit any other offense under RCW 46.37.423, 46.37.424, or
2 46.37.425.

3 (8) To commit any offense relating to a dealer's temporary license
4 permit, including but not limited to failure to properly complete each
5 such permit, or the issuance of more than one such permit on any one
6 vehicle. However, a dealer may issue a second temporary permit on a
7 vehicle if the following conditions are met:

8 (a) The lienholder fails to deliver the vehicle title to the dealer
9 within the required time period;

10 (b) The dealer has satisfied the lien; and

11 (c) The dealer has proof that payment of the lien was made within
12 two calendar days, exclusive of Saturday, Sunday, or a legal holiday,
13 after the sales contract has been executed by all parties and all
14 conditions and contingencies in the sales contract have been met or
15 otherwise satisfied.

16 (9) For a dealer, salesperson, or mobile home manufacturer, having
17 taken an instrument or cash "on deposit" from a purchaser or lessee
18 prior to the delivery of the bargained-for vehicle, to commingle the
19 "on deposit" funds with assets of the dealer, salesperson, or mobile
20 home manufacturer instead of holding the "on deposit" funds as trustee
21 in a separate trust account until the purchaser or lessee has taken
22 delivery of the bargained-for vehicle. Delivery of a manufactured home
23 shall be deemed to occur in accordance with RCW 46.70.135(5). Failure,
24 immediately upon receipt, to endorse "on deposit" instruments to such
25 a trust account, or to set aside "on deposit" cash for deposit in such
26 trust account, and failure to deposit such instruments or cash in such
27 trust account by the close of banking hours on the day following
28 receipt thereof, shall be evidence of intent to commit this unlawful
29 practice: PROVIDED, HOWEVER, That a motor vehicle dealer may keep a
30 separate trust account which equals his or her customary total customer
31 deposits for vehicles for future delivery. For purposes of this
32 section, "on deposit" funds received from a purchaser of a manufactured
33 home means those funds that a seller requires a purchaser to advance
34 before ordering the manufactured home, but does not include any loan
35 proceeds or moneys that might have been paid on an installment
36 contract.

37 (10) For a dealer or manufacturer to fail to comply with the
38 obligations of any written warranty or guarantee given by the dealer or

1 manufacturer requiring the furnishing of goods and services or repairs
2 within a reasonable period of time, or to fail to furnish to a
3 purchaser or lessee, all parts which attach to the manufactured unit
4 including but not limited to the undercarriage, and all items specified
5 in the terms of a sales or lease agreement signed by the seller and
6 buyer or lessee.

7 (11) For a vehicle dealer to pay to or receive from any person,
8 firm, partnership, association, or corporation acting, either directly
9 or through a subsidiary, as a buyer's agent for consumers, any
10 compensation, fee, purchase moneys or funds that have been deposited
11 into or withdrawn out of any account controlled or used by any buyer's
12 agent, gratuity, or reward in connection with the purchase, sale, or
13 lease of a new motor vehicle.

14 (12) For a buyer's agent, acting directly or through a subsidiary,
15 to pay to or to receive from any motor vehicle dealer any compensation,
16 fee, gratuity, or reward in connection with the purchase, sale, or
17 lease of a new motor vehicle. In addition, it is unlawful for any
18 buyer's agent to engage in any of the following acts on behalf of or in
19 the name of the consumer:

20 (a) Receiving or paying any purchase moneys or funds into or out of
21 any account controlled or used by any buyer's agent;

22 (b) Signing any vehicle purchase orders, sales contracts, leases,
23 odometer statements, or title documents, or having the name of the
24 buyer's agent appear on the vehicle purchase order, sales contract,
25 lease, or title; or

26 (c) Signing any other documentation relating to the purchase, sale,
27 lease, or transfer of any new motor vehicle.

28 It is unlawful for a buyer's agent to use a power of attorney
29 obtained from the consumer to accomplish or effect the purchase, sale,
30 lease, or transfer of ownership documents of any new motor vehicle by
31 any means which would otherwise be prohibited under (a) through (c) of
32 this subsection. However, the buyer's agent may use a power of
33 attorney for physical delivery of motor vehicle license plates to the
34 consumer.

35 Further, it is unlawful for a buyer's agent to engage in any false,
36 deceptive, or misleading advertising, disseminated in any manner
37 whatsoever, including but not limited to making any claim or statement

1 that the buyer's agent offers, obtains, or guarantees the lowest price
2 on any motor vehicle or words to similar effect.

3 (13) For a buyer's agent to arrange for or to negotiate the
4 purchase, or both, of a new motor vehicle through an out-of-state
5 dealer without disclosing in writing to the customer that the new
6 vehicle would not be subject to chapter 19.118 RCW. This subsection
7 also applies to leased vehicles. In addition, it is unlawful for any
8 buyer's agent to fail to have a written agreement with the customer
9 that: (a) Sets forth the terms of the parties' agreement; (b)
10 discloses to the customer the total amount of any fees or other
11 compensation being paid by the customer to the buyer's agent for the
12 agent's services; and (c) further discloses whether the fee or any
13 portion of the fee is refundable.

14 (14) Being a manufacturer, other than a motorcycle manufacturer
15 governed by chapter 46.93 RCW, to:

16 (a) Coerce or attempt to coerce any vehicle dealer to order or
17 accept delivery of any vehicle or vehicles, parts or accessories, or
18 any other commodities which have not been voluntarily ordered by the
19 vehicle dealer: PROVIDED, That recommendation, endorsement,
20 exposition, persuasion, urging, or argument are not deemed to
21 constitute coercion;

22 (b) Cancel or fail to renew the franchise or selling agreement of
23 any vehicle dealer doing business in this state without fairly
24 compensating the dealer at a fair going business value for his or her
25 capital investment which shall include but not be limited to tools,
26 equipment, and parts inventory possessed by the dealer on the day he or
27 she is notified of such cancellation or termination and which are still
28 within the dealer's possession on the day the cancellation or
29 termination is effective, if: (i) The capital investment has been
30 entered into with reasonable and prudent business judgment for the
31 purpose of fulfilling the franchise; and (ii) the cancellation or
32 nonrenewal was not done in good faith. Good faith is defined as the
33 duty of each party to any franchise to act in a fair and equitable
34 manner towards each other, so as to guarantee one party freedom from
35 coercion, intimidation, or threats of coercion or intimidation from the
36 other party: PROVIDED, That recommendation, endorsement, exposition,
37 persuasion, urging, or argument are not deemed to constitute a lack of
38 good faith;

1 (c) Encourage, aid, abet, or teach a vehicle dealer to sell or
2 lease vehicles through any false, deceptive, or misleading sales or
3 financing practices including but not limited to those practices
4 declared unlawful in this section;

5 (d) Coerce or attempt to coerce a vehicle dealer to engage in any
6 practice forbidden in this section by either threats of actual
7 cancellation or failure to renew the dealer's franchise agreement;

8 (e) Refuse to deliver any vehicle publicly advertised for immediate
9 delivery to any duly licensed vehicle dealer having a franchise or
10 contractual agreement for the retail sale or lease of new and unused
11 vehicles sold or distributed by such manufacturer within sixty days
12 after such dealer's order has been received in writing unless caused by
13 inability to deliver because of shortage or curtailment of material,
14 labor, transportation, or utility services, or by any labor or
15 production difficulty, or by any cause beyond the reasonable control of
16 the manufacturer;

17 (f) To provide under the terms of any warranty that a purchaser or
18 lessee of any new or unused vehicle that has been sold or leased,
19 distributed for sale or lease, or transferred into this state for
20 resale or lease by the vehicle manufacturer may only make any warranty
21 claim on any item included as an integral part of the vehicle against
22 the manufacturer of that item.

23 Nothing in this section may be construed to impair the obligations
24 of a contract or to prevent a manufacturer, distributor,
25 representative, or any other person, whether or not licensed under this
26 chapter, from requiring performance of a written contract entered into
27 with any licensee hereunder, nor does the requirement of such
28 performance constitute a violation of any of the provisions of this
29 section if any such contract or the terms thereof requiring
30 performance, have been freely entered into and executed between the
31 contracting parties. This paragraph and subsection (14)(b) of this
32 section do not apply to new motor vehicle manufacturers governed by
33 chapter 46.96 RCW.

34 (15) Unlawful transfer of an ownership interest in a motor vehicle
35 as defined in RCW 19.116.050.

36 (16) To knowingly and intentionally engage in collusion with a
37 registered owner of a vehicle to repossess and return or resell the
38 vehicle to the registered owner in an attempt to avoid a suspended

1 license impound under chapter 46.55 RCW. However, compliance with
2 chapter 62A.9A RCW in repossessing, selling, leasing, or otherwise
3 disposing of the vehicle, including providing redemption rights to the
4 debtor, is not a violation of this section.

5 (17)(a) For a dealer to enter into a new motor vehicle sales
6 contract without disclosing in writing to a buyer of the new motor
7 vehicle, or to a dealer in the case of an unregistered motor vehicle,
8 any known damage and repair to the new motor vehicle if the damage
9 exceeds five percent of the manufacturer's suggested retail price as
10 calculated at the dealer's authorized warranty rate for labor and
11 parts, or one thousand dollars, whichever amount is greater. A
12 manufacturer or new motor vehicle dealer is not required to disclose to
13 a dealer or buyer that glass, tires, bumpers, or cosmetic parts of a
14 new motor vehicle were damaged at any time if the damaged item has been
15 replaced with original or comparable equipment. A replaced part is not
16 part of the cumulative damage required to be disclosed under this
17 subsection.

18 (b) A manufacturer is required to provide the same disclosure to a
19 dealer of any known damage or repair as required in (a) of this
20 subsection.

21 (c) If disclosure of any known damage or repair is not required
22 under this section, a buyer may not revoke or rescind a sales contract
23 due to the fact that the new motor vehicle was damaged and repaired
24 before completion of the sale.

25 (d) As used in this section:

26 (i) "Cosmetic parts" means parts that are attached by and can be
27 replaced in total through the use of screws, bolts, or other fasteners
28 without the use of welding or thermal cutting, and includes
29 windshields, bumpers, hoods, or trim panels.

30 (ii) "Manufacturer's suggested retail price" means the retail price
31 of the new motor vehicle suggested by the manufacturer, and includes
32 the retail delivered price suggested by the manufacturer for each
33 accessory or item of optional equipment physically attached to the new
34 motor vehicle at the time of delivery to the new motor vehicle dealer
35 that is not included within the retail price suggested by the
36 manufacturer for the new motor vehicle.

1 **Sec. 1137.** RCW 46.72.060 and 1961 c 12 s 46.72.060 are each
2 amended to read as follows:

3 Every person having a cause of action for damages against any
4 person, firm, or corporation receiving a permit under the provisions of
5 this chapter, for injury, damages or wrongful death caused by any
6 careless, negligent or unlawful act of any such person, firm, or
7 corporation or his, their, or its agents or employees in conducting or
8 carrying on said business or in operating any motor propelled vehicle
9 for the carrying and transporting of passengers (~~over and along~~) on
10 any public street, road or highway shall have a cause of action against
11 the principal and surety upon the bond or the insurance company and the
12 insured for all damages sustained, and in any such action the full
13 amount of damages sustained may be recovered against the principal, but
14 the recovery against the surety shall be limited to the amount of the
15 bond.

16 **Sec. 1138.** RCW 46.80.010 and 1999 c 278 s 1 are each amended to
17 read as follows:

18 The definitions set forth in this section apply throughout this
19 chapter.

20 (1) "Vehicle wrecker" means every person, firm, partnership,
21 association, or corporation engaged in the business of buying, selling,
22 or dealing in vehicles of a type required to be (~~licensed~~) registered
23 under the laws of this state, for the purpose of wrecking, dismantling,
24 disassembling, or substantially changing the form of a vehicle, or who
25 buys or sells integral secondhand parts of component material thereof,
26 in whole or in part, or who deals in secondhand vehicle parts.

27 (2) "Core" means a major component part received by a vehicle
28 wrecker in exchange for a like part sold by the vehicle wrecker, is not
29 resold as a major component part except for scrap metal value or for
30 remanufacture, and the vehicle wrecker maintains records for three
31 years from the date of acquisition to identify the name of the person
32 from whom the core was received.

33 (3) "Established place of business" means a building or enclosure
34 which the vehicle wrecker occupies either continuously or at regular
35 periods and where his books and records are kept and business is
36 transacted and which must conform with zoning regulations.

1 (4) "Interim owner" means the owner of a vehicle who has the
2 original certificate of (~~ownership~~) title for the vehicle, which
3 certificate has been released by the person named on the certificate
4 and assigned to the person offering to sell the vehicle to the wrecker.

5 (5) "Major component part" includes at least each of the following
6 vehicle parts: (a) Engines and short blocks; (b) frame; (c)
7 transmission and/or transfer case; (d) cab; (e) door; (f) front or rear
8 differential; (g) front or rear clip; (h) quarter panel; (i) truck bed
9 or box; (j) seat; (k) hood; (l) bumper; (m) fender; and (n) airbag.
10 The director may supplement this list by rule.

11 (6) "Wrecked vehicle" means a vehicle which is disassembled or
12 dismantled or a vehicle which is acquired with the intent to dismantle
13 or disassemble and never again to operate as a vehicle, or a vehicle
14 which has sustained such damage that its cost to repair exceeds the
15 fair market value of a like vehicle which has not sustained such
16 damage, or a damaged vehicle whose salvage value plus cost to repair
17 equals or exceeds its fair market value, if repaired, or a vehicle
18 which has sustained such damage or deterioration that it may not
19 lawfully operate upon the highways of this state for which the salvage
20 value plus cost to repair exceeds its fair market value, if repaired;
21 further, it is presumed that a vehicle is a wreck if it has sustained
22 such damage or deterioration that it may not lawfully operate upon the
23 highways of this state.

24 **Sec. 1139.** RCW 46.80.090 and 1999 c 278 s 3 are each amended to
25 read as follows:

26 Within thirty days after acquiring a vehicle, the vehicle wrecker
27 shall furnish a written report to the department. This report shall be
28 in such form as the department shall prescribe and shall be accompanied
29 by evidence of ownership as determined by the department. No vehicle
30 wrecker may acquire a vehicle, including a vehicle from an interim
31 owner, without first obtaining evidence of ownership as determined by
32 the department. For a vehicle from an interim owner, the evidence of
33 ownership may not require that a title be issued in the name of the

35 The vehicle wrecker shall furnish a monthly report of all acquired

3 or before an officer or employee of the department designated by the
4 director to administer oaths or acknowledge signatures, pursuant to RCW

6 **Sec. 1140.** RCW 46.87.010 and 2005 c 194 s 1 are each amended to
7 read as follows:

8 This chapter applies to proportional registration and reciprocity
9 granted under the provisions of the International Registration Plan
10 (IRP). This chapter shall become effective and be implemented
11 beginning with the 1988 registration year.

12 (1) Provisions and terms of the IRP prevail unless given a
13 different meaning in chapter 46.04 RCW, this chapter, or in rules
14 adopted under the authority of this chapter.

15 (2) The director may adopt and enforce rules deemed necessary to
16 implement and administer this chapter.

17 (3) Owners having a fleet of apportionable vehicles operating in
18 two or more IRP member jurisdictions may elect to proportionally
19 register the vehicles of the fleet under the provisions of the IRP and
20 this chapter in lieu of full or temporary registration as provided for
21 in chapter((s)) 46.16 ((~~or 46.88~~)) RCW.

22 (4) If a due date or an expiration date established under authority
23 of this chapter falls on a Saturday, Sunday, or a state legal holiday,
24 such period is automatically extended through the end of the next
25 business day.

26 **Sec. 1141.** RCW 46.87.020 and 2005 c 194 s 2 are each amended to
27 read as follows:

28 Terms used in this chapter have the meaning given to them in the
29 International Registration Plan (IRP), in chapter 46.04 RCW, or as
30 otherwise defined in this section. Definitions given to terms by the
31 IRP prevail unless given a different meaning in this chapter or in
32 rules adopted under authority of this chapter.

33 (1) "Apportionable vehicle" has the meaning given by the IRP,
34 except that it does not include vehicles with a declared gross weight
35 of twelve thousand pounds or less. Apportionable vehicles include

1 trucks, tractors, truck tractors, road tractors, and buses, each as
2 separate and licensable vehicles.

3 (2) "Cab card" is a certificate of registration issued for a
4 vehicle upon which is disclosed the jurisdictions and registered gross
5 weights in such jurisdictions for which the vehicle is registered.

6 (3) "Credentials" means cab cards, apportioned plates (for
7 Washington-based fleets), and validation tabs issued for proportionally
8 registered vehicles.

9 (4) "Declared combined gross weight" means the total unladen weight

11 be carried on the combination of vehicles as set by the registrant in
12 the application pursuant to chapter 46.44 RCW and for which
13 registration fees have been or are to be paid.

14 (5) "Declared gross weight" means the total unladen weight of any
15 vehicle plus the weight of the maximum load to be carried on the
16 vehicle as set by the registrant in the application pursuant to chapter
17 46.44 RCW and for which registration fees have been or are to be paid.
18 In the case of a bus, auto stage, or a passenger-carrying for hire
19 vehicle with a seating capacity of more than six, the declared gross
20 weight shall be determined by multiplying the average load factor of
21 one hundred and fifty pounds by the number of seats in the vehicle,
22 including the driver's seat, and add this amount to the unladen weight
23 of the vehicle. If the resultant gross weight is not listed in ((RCW
24 ~~46.16.070~~) section 530 of this act, it will be increased to the next
25 higher gross weight so listed pursuant to chapter 46.44 RCW.

26 (6) "Department" means the department of licensing.

27 (7) "Fleet" means one or more apportionable vehicles in the IRP.

28 (8) "In-jurisdiction miles" means the total miles accumulated in a
29 jurisdiction during the preceding year by vehicles of the fleet while
30 they were a part of the fleet.

31 (9) "IRP" means the International Registration Plan.

32 (10) "Jurisdiction" means and includes a state, territory or
33 possession of the United States, the District of Columbia, the
34 Commonwealth of Puerto Rico, a foreign country, and a state or province
35 of a foreign country.

36 (11) "Motor carrier" means an entity engaged in the transportation
37 of goods or persons. The term includes a for-hire motor carrier,

1 private motor carrier, contract motor carrier, or exempt motor carrier.
2 The term includes a registrant licensed under this chapter, a motor
3 vehicle lessor, and a motor vehicle lessee.

4 (12) "Owner" means a person or business firm who holds the legal
5 title to a vehicle, or if a vehicle is the subject of an agreement for
6 its conditional sale with the right of purchase upon performance of the
7 conditions stated in the agreement and with an immediate right of
8 possession vested in the conditional vendee, or if a vehicle is subject
9 to a lease, contract, or other legal arrangement vesting right of
10 possession or control, for security or otherwise, or if a mortgagor of
11 a vehicle is entitled to possession, then the owner is deemed to be the
12 person or business firm in whom is vested right of possession or
13 control.

14 (13) "Preceding year" means the period of twelve consecutive months
15 immediately before July 1st of the year immediately before the
16 commencement of the registration or license year for which apportioned
17 registration is sought.

18 (14) "Prorate percentage" is the factor that is applied to the
19 total proratable fees and taxes to determine the apportionable or
20 prorate fees required for registration in a particular jurisdiction.

24 (15) "Registrant" means a person, business firm, or corporation in

28 according to the laws of the base jurisdiction.

29 (17) "Total miles" means the total number of miles accumulated in
30 all jurisdictions during the preceding year by all vehicles of the
31 fleet while they were a part of the fleet. Mileage accumulated by
32 vehicles of the fleet that did not engage in interstate operations is
33 not included in the fleet miles.

34 **Sec. 1142.** RCW 46.87.030 and 2005 c 194 s 3 are each amended to

36 (1) When application to register an apportionable vehicle is made,
37 the Washington prorated fees may be reduced by one-twelfth for each

33 amount be credited against fees other than those for the registration
34 year from which the credit was obtained nor is any amount subject to

37 read as follows:

1 (1) Any owner engaged in interstate operations of one or more
2 fleets of apportionable vehicles may, in lieu of registration of the
3 vehicles under chapter 46.16 RCW, register and license the vehicles of
4 each fleet under this chapter by filing a proportional registration
5 application for each fleet with the department. The application shall
6 contain the following information and such other information pertinent
7 to vehicle registration as the department may require:

8 (a) A description and identification of each vehicle of the fleet.

9 (b) The member jurisdictions in which registration is desired and
10 such other information as member jurisdictions require.

11 (c) An original or renewal application shall also be accompanied by
12 a mileage schedule for each fleet.

13 (d) The USDOT number issued to the registrant and the USDOT number
14 of the motor carrier responsible for the safety of the vehicle, if
15 different.

16 (e) A completed Motor Carrier Identification Report (MCS-150) at
17 the time of fleet renewal or at the time of vehicle registration, if
18 required by the department.

19 (f) The Taxpayer Identification Number of the registrant and the
20 motor carrier responsible for the safety of the vehicle, if different.

21 (2) Each application shall, at the time and in the manner required
22 by the department, be supported by payment of a fee computed as
23 follows:

24 (a) Divide the in-jurisdiction miles by the total miles and carry
25 the answer to the nearest thousandth of a percent (three places beyond
26 the decimal, e.g. 10.543%). This factor is known as the prorate
27 percentage.

28 (b) Determine the total proratable fees and taxes required for each
29 vehicle in the fleet for which registration is requested, based on the
30 regular annual fees and taxes or applicable fees and taxes for the
31 unexpired portion of the registration year under the laws of each
32 jurisdiction for which fees or taxes are to be calculated.

33 Applicable fees and taxes for vehicles of Washington-based fleets
34 are those prescribed under (~~(RCW 46.16.070)~~) section 530 of this act,
35 (~~(46.16.085)~~) section 531(1)(c) of this act, and RCW 82.38.075, as
36 applicable. If, during the registration period, the lessor of an
37 apportioned vehicle changes and the vehicle remains in the fleet of the

1 registrant, the department shall only charge those fees prescribed for
2 the issuance of new apportioned license plates, validation tabs, and
3 cab card.

4 (c) Multiply the total, proratable fees or taxes for each motor
5 vehicle by the prorate percentage applicable to the desired
6 jurisdiction and round the results to the nearest cent.

7 (d) Add the total fees and taxes determined in (c) of this
8 subsection for each vehicle to the nonproratable fees required under
9 the laws of the jurisdiction for which fees are being calculated.
10 Nonproratable fees required for vehicles of Washington-based fleets are
11 the administrative fee required by RCW 82.38.075, if applicable, and
12 the vehicle transaction fee pursuant to the provisions of RCW
13 46.87.130.

14 (e) The amount due and payable for the application is the sum of
15 the fees and taxes calculated for each member jurisdiction in which
16 registration of the fleet is desired.

17 (3) All assessments for proportional registration fees are due and
18 payable in United States funds on the date presented or mailed to the
19 registrant at the address listed in the proportional registration
20 records of the department. The registrant may petition for
21 reassessment of the fees or taxes due under this section within thirty
22 days of the date of original service as provided for in this chapter.

23 **Sec. 1144.** RCW 46.87.220 and 1987 c 244 s 35 are each amended to
24 read as follows:

25 The gross weight in the case of a motor truck, tractor, or truck
26 tractor is the scale weight of the motor truck, tractor, or truck
27 tractor, plus the scale weight of any trailer, semitrailer, converter
28 gear, or pole trailer to be towed by it, to which shall be added the
29 weight of the maximum load to be carried on it or towed by it as set
30 forth by the licensee in the application providing it does not exceed
31 the weight limitations prescribed by chapter 46.44 RCW.

32 The gross weight in the case of a bus, auto stage, or for hire
33 vehicle, except a taxicab, with a seating capacity over six, is the
34 scale weight of the bus, auto stage, or for hire vehicle plus the
35 seating capacity, including the operator's seat, computed at one
36 hundred and fifty pounds per seat.

1 If the resultant gross weight, according to this section, is not
2 listed in ((RCW 46.16.070)) section 530 of this act, it will be
3 increased to the next higher gross weight so listed pursuant to chapter
4 46.44 RCW.

5 A motor vehicle or combination of vehicles found to be loaded
6 beyond the licensed gross weight of the motor vehicle registered under
7 this chapter shall be cited and handled under RCW 46.16.140 and
8 46.16.145 (as recodified by this act).

9 NEW SECTION. **Sec. 1145.** A new section is added to chapter 47.06
10 RCW to read as follows:

11 (1) The department of transportation may increase the recreational
12 vehicle sanitary disposal fee charged under section 534 of this act as
13 authorized in RCW 43.135.055 by a percentage that exceeds the fiscal
14 growth factor. After consultation with citizen representatives of the
15 recreational vehicle user community, the department of transportation
16 may implement RV account fee adjustments no more than once every four
17 years. RV account fee adjustments must be preceded by an evaluation of
18 the following factors:

- 19 (a) Maintenance of a self-supporting program;
- 20 (b) Levels of service at existing recreational vehicle sanitary

32 amended to read as follows:

33 In order to facilitate vehicular traffic through and between the
34 cities of Tacoma, Seattle, and Everett and to remove the present
35 handicaps and hazards ((over and along)) on primary state highway No.
36 1 as presently established, the state highway commission is authorized

1 to realign, redesign, and reconstruct primary state highway No. 1 upon
2 a newly located right-of-way or upon portions of existing right-of-way
3 through and between the cities of Tacoma, Seattle, and Everett and as
4 an additional alternate route bypassing Seattle east of Lake
5 Washington. The route of the proposed project is established as
6 follows: Beginning in the vicinity of Ponders Corner, thence in a
7 general northeasterly and northerly direction through the cities of
8 Tacoma and Seattle to a point in the vicinity of the city of Everett
9 and as an additional alternate route bypassing Seattle east of Lake
10 Washington.

11 **Sec. 1147.** RCW 47.68.255 and 2003 c 53 s 266 are each amended to
12 read as follows:

21 services as an organ procurement organization.

24 (18) "Part" means an organ, an eye, or tissue of a human being.
25 The term does not include the whole body.

26 (19) "Person" means an individual, corporation, business trust,
27 estate, trust, partnership, limited liability company, association,
28 joint venture, public corporation, government or governmental

32 authorized to practice medicine and surgery or osteopathic medicine and

37 imminent and has been determined by a procurement organization to have

4 (23) "Reasonable costs" include: (a) Programming and software
5 installation and upgrades; (b) employee training that is specific to
6 the organ and tissue donor registry or the donation program created in
7 RCW ((~~46.12.510~~)) 46.16.076(2) (as recodified by this act); (c)
8 literature that is specific to the organ and tissue donor registry or
9 the donation program created in RCW ((~~46.12.510~~)) 46.16.076(2) (as
10 recodified by this act); and (d) hardware upgrades or other issues
11 important to the organ and tissue donor registry or the donation

16 (24) "Reasonably available" means able to be contacted by a

20 (25) "Recipient" means an individual into whose body a decedent's
21 part has been or is intended to be transplanted.

22 (26) "Record" means information that is inscribed on a tangible
23 medium or that is stored in an electronic or other medium and is
24 retrievable in perceivable form.

25 (27) "Refusal" means a record created under RCW 68.64.060 that
26 expressly states an intent to bar other persons from making an
27 anatomical gift of an individual's body or part.

28 (28) "Sign" means, with the present intent to authenticate or adopt
29 a record:

30 (a) To execute or adopt a tangible symbol; or

31 (b) To attach to or logically associate with the record an
32 electronic symbol, sound, or process.

33 (29) "State" means a state of the United States, the District of
34 Columbia, Puerto Rico, the United States Virgin Islands, or any
35 territory or insular possession subject to the jurisdiction of the
36 United States.

37 (30) "Technician" means an individual determined to be qualified to

1 remove or process parts by an appropriate organization that is
2 licensed, accredited, or regulated under federal or state law. The
3 term includes an enucleator.

4 (31) "Tissue" means a portion of the human body other than an organ
5 or an eye. The term does not include blood unless the blood is donated
6 for the purpose of research or education.

7 (32) "Tissue bank" means a person that is licensed to conduct
8 business in this state, accredited, and regulated under federal or
9 state law to engage in the recovery, screening, testing, processing,
10 storage, or distribution of tissue.

11 (33) "Transplant hospital" means a hospital that furnishes organ
12 transplants and other medical and surgical specialty services required
13 for the care of transplant patients.

14 (34) "Washington state organ procurement organization" means an
15 organ procurement organization that has been designated by the United
16 States department of health and human services to coordinate organ
17 procurement activities for any portion of Washington state.

18 **Sec. 1157.** RCW 68.64.210 and 2003 c 94 s 7 are each amended to
19 read as follows:

20 (1) The organ and tissue donation awareness account is created in
21 the custody of the state treasurer. All receipts from donations made
