1 On page 24, line 6 of the amendment, after "Washington" insert "by
2 road"

3 On page 53, after line 8 of the amendment, insert the following:

4 "**Sec. 72.** RCW 77.32.350 and 2002 c 283 s 1 are each amended to
5 read as follows:

6 In addition to a small game hunting license, a supplemental permit
7 or stamp is required to hunt for (~~western Washington pheasant or~~)
8 migratory birds.

9 (~~1) ((A western Washington pheasant permit is required to hunt for
10 pheasant in western Washington. Western Washington pheasant permits
11 must contain numbered spaces for recording the location and date of
12 harvest of each western Washington pheasant.~~

13 ~~(2) The permit shall be available as a season option, a youth full
14 season option, or a three-day option. The fee for this permit is:~~

15 ~~(a) For the resident and nonresident full season option, thirty-six
16 dollars;~~

17 ~~(b) For the youth full season option, eighteen dollars;~~

18 ~~(c) For the three-day option, twenty dollars.~~

19 ~~(3))~~ A migratory bird validation is required for all persons
20 sixteen years of age or older to hunt migratory birds. The fee for the
21 validation for hunters is ten dollars for residents and nonresidents.
22 The fee for the stamp for collectors is ten dollars.

23 ~~((4))~~ (2) The migratory bird license must be validated at the
24 time of signature of the licensee."

25 Renumber the remaining sections consecutively and correct any
26 internal references accordingly.

27 On page 57, after line 19 of the amendment, insert the following:

1 "NEW SECTION. **Sec. 80.** A new section is added to chapter 77.32
2 RCW to read as follows:

3 (1) A western Washington pheasant permit is required to hunt for
4 pheasant in western Washington.

5 (2) The permit is available as a season option, a youth full season
6 option, or a three-day option. The fee for the permit is:

7 (a) For the resident full season option, seventy-five dollars;

8 (b) For the nonresident full season option, one hundred fifty
9 dollars;

10 (c) For the youth full season option, thirty-five dollars;

11 (d) For the three-day option for a resident, thirty-five dollars
12 and for a nonresident, seventy dollars."

13 Renumber the remaining section consecutively and correct any
14 internal references accordingly.
