Brief Summary of Substitute Bill

- Requires that ballots have a clear delineation between the instructions and where voting is to begin.

Background:

Clear and concise instructions must be printed at the top of each ballot directing the voter on how to mark the ballot. Questions of adopting constitutional amendments or any other state measure must appear immediately after the ballot instructions and before listing any offices.

Summary of Substitute Bill:

This analysis was prepared by non-partisan legislative staff for the use of legislative members in their deliberations. This analysis is not a part of the legislation nor does it constitute a statement of legislative intent.

Ballots must have a clear delineation between the ballot instructions and where the voting is to begin. This delineation may be through the use of white space, illustration, shading, color, symbol, font size, or bold type. Following ballot instructions, the words "BEGIN VOTING HERE" must appear and be in a font size larger than what is used for ballot instructions and ballot questions.

Substitute Bill Compared to Original Bill:

The substitute bill requires that the clear delineation between ballot instructions and ballot questions consist of white space, illustration, shading, color, symbol, font size, or bold type.

Appropriation: None.

Fiscal Note: Not requested.

Effective Date of Substitute Bill: The bill takes effect 90 days after adjournment of the session in which the bill is passed.

Staff Summary of Public Testimony:

(In support) The ballot was very full. The ballot design made it difficult to see Initiative 1033, which may have dropped off some voting on that question. The bill still allows flexibility in ballot design, but there must be a clear delineation between the ballot instructions and questions.

(Opposed) None.
