1 AN ACT Relating to punishment for domestic violence offenders;
2 amending RCW 9.94A.525; reenacting and amending RCW 9.94A.030 and
3 9.94A.535; creating a new section; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature recognizes the substantial
6 and great impact upon society, families, children, and the victims of
7 offenses occurring between cohabitants. The legislature recognizes the
8 continuing nature of domestic violence, and the lasting psychological
9 trauma caused by such violence. The legislature finds that the
10 prevention of domestic violence, and the proper punishment for such
11 offenses, is a compelling state interest that has not been under
12 current sentencing provisions. Toward this end, this act is necessary
13 to ensure that domestic violence offenders are punished accordingly and
14 that an end to domestic violence can be achieved.

15 **Sec. 2.** RCW 9.94A.030 and 2008 c 276 s 309, 2008 c 231 s 23, 2008
16 c 230 s 2, and 2008 c 7 s 1 are each reenacted and amended to read as
17 follows:

1 Unless the context clearly requires otherwise, the definitions in
2 this section apply throughout this chapter.

3 (1) "Board" means the indeterminate sentence review board created
4 under chapter 9.95 RCW.

5 (2) "Collect," or any derivative thereof, "collect and remit," or
6 "collect and deliver," when used with reference to the department,
7 means that the department, either directly or through a collection
8 agreement authorized by RCW 9.94A.760, is responsible for monitoring
9 and enforcing the offender's sentence with regard to the legal
10 financial obligation, receiving payment thereof from the offender, and,
11 consistent with current law, delivering daily the entire payment to the
12 superior court clerk without depositing it in a departmental account.

13 (3) "Commission" means the sentencing guidelines commission.

14 (4) "Community corrections officer" means an employee of the
15 department who is responsible for carrying out specific duties in
16 supervision of sentenced offenders and monitoring of sentence
17 conditions.

18 (5) "Community custody" means that portion of an offender's
19 sentence of confinement in lieu of earned release time or imposed as
20 part of a sentence and served in the community subject to controls
21 placed on the offender's movement and activities by the department.

22 (6) "Community custody range" means the minimum and maximum period
23 of community custody included as part of a sentence under RCW
24 (~~(9.94A.715)~~) 9.94A.701, as established by the commission or the
25 legislature under RCW 9.94A.850.

26 (7) "Community protection zone" means the area within eight hundred
27 eighty feet of the facilities and grounds of a public or private
28 school.

29 (8) "Community restitution" means compulsory service, without
30 compensation, performed for the benefit of the community by the
31 offender.

32 (9) "Confinement" means total or partial confinement.

33 (10) "Conviction" means an adjudication of guilt pursuant to
34 Title(~~(§)~~) 10 or 13 RCW and includes a verdict of guilty, a finding of
35 guilty, and acceptance of a plea of guilty.

36 (11) "Crime-related prohibition" means an order of a court
37 prohibiting conduct that directly relates to the circumstances of the
38 crime for which the offender has been convicted, and shall not be

1 construed to mean orders directing an offender affirmatively to
2 participate in rehabilitative programs or to otherwise perform
3 affirmative conduct. However, affirmative acts necessary to monitor
4 compliance with the order of a court may be required by the department.

5 (12) "Criminal history" means the list of a defendant's prior
6 convictions and juvenile adjudications, whether in this state, in
7 federal court, or elsewhere.

8 (a) The history shall include, where known, for each conviction (i)
9 whether the defendant has been placed on probation and the length and
10 terms thereof; and (ii) whether the defendant has been incarcerated and
11 the length of incarceration.

12 (b) A conviction may be removed from a defendant's criminal history
13 only if it is vacated pursuant to RCW 9.96.060, 9.94A.640, 9.95.240, or
14 a similar out-of-state statute, or if the conviction has been vacated
15 pursuant to a governor's pardon.

16 (c) The determination of a defendant's criminal history is distinct
17 from the determination of an offender score. A prior conviction that
18 was not included in an offender score calculated pursuant to a former
19 version of the sentencing reform act remains part of the defendant's
20 criminal history.

21 (13) "Criminal street gang" means any ongoing organization,
22 association, or group of three or more persons, whether formal or
23 informal, having a common name or common identifying sign or symbol,
24 having as one of its primary activities the commission of criminal
25 acts, and whose members or associates individually or collectively
26 engage in or have engaged in a pattern of criminal street gang
27 activity. This definition does not apply to employees engaged in
28 concerted activities for their mutual aid and protection, or to the
29 activities of labor and bona fide nonprofit organizations or their
30 members or agents.

31 (14) "Criminal street gang associate or member" means any person
32 who actively participates in any criminal street gang and who
33 intentionally promotes, furthers, or assists in any criminal act by the
34 criminal street gang.

35 (15) "Criminal street gang-related offense" means any felony or
36 misdemeanor offense, whether in this state or elsewhere, that is
37 committed for the benefit of, at the direction of, or in association

1 with any criminal street gang, or is committed with the intent to
2 promote, further, or assist in any criminal conduct by the gang, or is
3 committed for one or more of the following reasons:

4 (a) To gain admission, prestige, or promotion within the gang;

5 (b) To increase or maintain the gang's size, membership, prestige,
6 dominance, or control in any geographical area;

7 (c) To exact revenge or retribution for the gang or any member of
8 the gang;

9 (d) To obstruct justice, or intimidate or eliminate any witness
10 against the gang or any member of the gang;

11 (e) To directly or indirectly cause any benefit, aggrandizement,
12 gain, profit, or other advantage for the gang, its reputation,
13 influence, or membership; or

14 (f) To provide the gang with any advantage in, or any control or
15 dominance over any criminal market sector, including, but not limited
16 to, manufacturing, delivering, or selling any controlled substance
17 (chapter 69.50 RCW); arson (chapter 9A.48 RCW); trafficking in stolen
18 property (chapter 9A.82 RCW); promoting prostitution (chapter 9A.88
19 RCW); human trafficking (RCW 9A.40.100); or promoting pornography
20 (chapter 9.68 RCW).

21 (16) "Day fine" means a fine imposed by the sentencing court that
22 equals the difference between the offender's net daily income and the
23 reasonable obligations that the offender has for the support of the
24 offender and any dependents.

25 (17) "Day reporting" means a program of enhanced supervision
26 designed to monitor the offender's daily activities and compliance with
27 sentence conditions, and in which the offender is required to report
28 daily to a specific location designated by the department or the
29 sentencing court.

30 (18) "Department" means the department of corrections.

31 (19) "Determinate sentence" means a sentence that states with
32 exactitude the number of actual years, months, or days of total
33 confinement, of partial confinement, of community custody, the number
34 of actual hours or days of community restitution work, or dollars or
35 terms of a legal financial obligation. The fact that an offender
36 through earned release can reduce the actual period of confinement
37 shall not affect the classification of the sentence as a determinate
38 sentence.

1 (20) "Disposable earnings" means that part of the earnings of an
2 offender remaining after the deduction from those earnings of any
3 amount required by law to be withheld. For the purposes of this
4 definition, "earnings" means compensation paid or payable for personal
5 services, whether denominated as wages, salary, commission, bonuses, or
6 otherwise, and, notwithstanding any other provision of law making the
7 payments exempt from garnishment, attachment, or other process to
8 satisfy a court-ordered legal financial obligation, specifically
9 includes periodic payments pursuant to pension or retirement programs,
10 or insurance policies of any type, but does not include payments made
11 under Title 50 RCW, except as provided in RCW 50.40.020 and 50.40.050,
12 or Title 74 RCW.

13 (21) "Domestic violence" has the same meaning as defined in RCW
14 10.99.020(5) and 26.50.010.

15 (22) "Drug offender sentencing alternative" is a sentencing option
16 available to persons convicted of a felony offense other than a violent
17 offense or a sex offense and who are eligible for the option under RCW
18 9.94A.660.

19 ((+22+)) (23) "Drug offense" means:

20 (a) Any felony violation of chapter 69.50 RCW except possession of
21 a controlled substance (RCW 69.50.4013) or forged prescription for a
22 controlled substance (RCW 69.50.403);

23 (b) Any offense defined as a felony under federal law that relates
24 to the possession, manufacture, distribution, or transportation of a
25 controlled substance; or

26 (c) Any out-of-state conviction for an offense that under the laws
27 of this state would be a felony classified as a drug offense under (a)
28 of this subsection.

29 ((+23+)) (24) "Earned release" means earned release from
30 confinement as provided in RCW 9.94A.728.

31 ((+24+)) (25) "Escape" means:

32 (a) Sexually violent predator escape (RCW 9A.76.115), escape in the
33 first degree (RCW 9A.76.110), escape in the second degree (RCW
34 9A.76.120), willful failure to return from furlough (RCW 72.66.060),
35 willful failure to return from work release (RCW 72.65.070), or willful
36 failure to be available for supervision by the department while in
37 community custody (RCW 72.09.310); or

1 (b) Any federal or out-of-state conviction for an offense that
2 under the laws of this state would be a felony classified as an escape
3 under (a) of this subsection.

4 (~~(+25+)~~) (26) "Felony traffic offense" means:

5 (a) Vehicular homicide (RCW 46.61.520), vehicular assault (RCW
6 46.61.522), eluding a police officer (RCW 46.61.024), felony hit-and-
7 run injury-accident (RCW 46.52.020(4)), felony driving while under the
8 influence of intoxicating liquor or any drug (RCW 46.61.502(6)), or
9 felony physical control of a vehicle while under the influence of
10 intoxicating liquor or any drug (RCW 46.61.504(6)); or

11 (b) Any federal or out-of-state conviction for an offense that
12 under the laws of this state would be a felony classified as a felony
13 traffic offense under (a) of this subsection.

14 (~~(+26+)~~) (27) "Fine" means a specific sum of money ordered by the
15 sentencing court to be paid by the offender to the court over a
16 specific period of time.

17 (~~(+27+)~~) (28) "First-time offender" means any person who has no
18 prior convictions for a felony and is eligible for the first-time
19 offender waiver under RCW 9.94A.650.

20 (~~(+28+)~~) (29) "Home detention" means a program of partial
21 confinement available to offenders wherein the offender is confined in
22 a private residence subject to electronic surveillance.

23 (~~(+29+)~~) (30) "Legal financial obligation" means a sum of money
24 that is ordered by a superior court of the state of Washington for
25 legal financial obligations which may include restitution to the
26 victim, statutorily imposed crime victims' compensation fees as
27 assessed pursuant to RCW 7.68.035, court costs, county or interlocal
28 drug funds, court-appointed attorneys' fees, and costs of defense,
29 fines, and any other financial obligation that is assessed to the
30 offender as a result of a felony conviction. Upon conviction for
31 vehicular assault while under the influence of intoxicating liquor or
32 any drug, RCW 46.61.522(1)(b), or vehicular homicide while under the
33 influence of intoxicating liquor or any drug, RCW 46.61.520(1)(a),
34 legal financial obligations may also include payment to a public agency
35 of the expense of an emergency response to the incident resulting in
36 the conviction, subject to RCW 38.52.430.

37 (~~(+30+)~~) (31) "Most serious offense" means any of the following
38 felonies or a felony attempt to commit any of the following felonies:

1 (a) Any felony defined under any law as a class A felony or
2 criminal solicitation of or criminal conspiracy to commit a class A
3 felony;
4 (b) Assault in the second degree;
5 (c) Assault of a child in the second degree;
6 (d) Child molestation in the second degree;
7 (e) Controlled substance homicide;
8 (f) Extortion in the first degree;
9 (g) Incest when committed against a child under age fourteen;
10 (h) Indecent liberties;
11 (i) Kidnapping in the second degree;
12 (j) Leading organized crime;
13 (k) Manslaughter in the first degree;
14 (l) Manslaughter in the second degree;
15 (m) Promoting prostitution in the first degree;
16 (n) Rape in the third degree;
17 (o) Robbery in the second degree;
18 (p) Sexual exploitation;
19 (q) Vehicular assault, when caused by the operation or driving of
20 a vehicle by a person while under the influence of intoxicating liquor
21 or any drug or by the operation or driving of a vehicle in a reckless
22 manner;
23 (r) Vehicular homicide, when proximately caused by the driving of
24 any vehicle by any person while under the influence of intoxicating
25 liquor or any drug as defined by RCW 46.61.502, or by the operation of
26 any vehicle in a reckless manner;
27 (s) Any other class B felony offense with a finding of sexual
28 motivation;
29 (t) Any other felony with a deadly weapon verdict under RCW
30 9.94A.602;
31 (u) Any felony offense in effect at any time prior to December 2,
32 1993, that is comparable to a most serious offense under this
33 subsection, or any federal or out-of-state conviction for an offense
34 that under the laws of this state would be a felony classified as a
35 most serious offense under this subsection;
36 (v)(i) A prior conviction for indecent liberties under RCW
37 9A.88.100(1) (a), (b), and (c), chapter 260, Laws of 1975 1st ex. sess.

1 as it existed until July 1, 1979, RCW 9A.44.100(1) (a), (b), and (c) as
2 it existed from July 1, 1979, until June 11, 1986, and RCW 9A.44.100(1)
3 (a), (b), and (d) as it existed from June 11, 1986, until July 1, 1988;

4 (ii) A prior conviction for indecent liberties under RCW
5 9A.44.100(1)(c) as it existed from June 11, 1986, until July 1, 1988,
6 if: (A) The crime was committed against a child under the age of
7 fourteen; or (B) the relationship between the victim and perpetrator is
8 included in the definition of indecent liberties under RCW
9 9A.44.100(1)(c) as it existed from July 1, 1988, through July 27, 1997,
10 or RCW 9A.44.100(1) (d) or (e) as it existed from July 25, 1993,
11 through July 27, 1997;

12 (w) Any out-of-state conviction for a felony offense with a finding
13 of sexual motivation if the minimum sentence imposed was ten years or
14 more; provided that the out-of-state felony offense must be comparable
15 to a felony offense under Title 9 or 9A RCW and the out-of-state
16 definition of sexual motivation must be comparable to the definition of
17 sexual motivation contained in this section.

18 ~~((+31+))~~ (32) "Nonviolent offense" means an offense which is not a
19 violent offense.

20 ~~((+32+))~~ (33) "Offender" means a person who has committed a felony
21 established by state law and is eighteen years of age or older or is
22 less than eighteen years of age but whose case is under superior court
23 jurisdiction under RCW 13.04.030 or has been transferred by the
24 appropriate juvenile court to a criminal court pursuant to RCW
25 13.40.110. Throughout this chapter, the terms "offender" and
26 "defendant" are used interchangeably.

27 ~~((+33+))~~ (34) "Partial confinement" means confinement for no more
28 than one year in a facility or institution operated or utilized under
29 contract by the state or any other unit of government, or, if home
30 detention or work crew has been ordered by the court, in an approved
31 residence, for a substantial portion of each day with the balance of
32 the day spent in the community. Partial confinement includes work
33 release, home detention, work crew, and a combination of work crew and
34 home detention.

36 (a) The commission, attempt, conspiracy, or solicitation of, or any
37 prior juvenile adjudication of or adult conviction of, two or more of
38 the following criminal street gang-related offenses:

2 9.94A.030, excluding Homicide by Abuse (RCW 9A.32.055) and Assault of
3 a Child 1 (RCW 9A.36.120);
4 (ii) Any "violent" offense as defined by RCW 9.94A.030, excluding
5 Assault of a Child 2 (RCW 9A.36.130);
6 (iii) Deliver or Possession with Intent to Deliver a Controlled
7 Substance (chapter 69.50 RCW);
8 (iv) Any violation of the firearms and dangerous weapon act
9 (chapter 9.41 RCW);
10 (v) Theft of a Firearm (RCW 9A.56.300);
11 (vi) Possession of a Stolen Firearm (RCW 9A.56.310);
12 (vii) Malicious Harassment (RCW 9A.36.080);
13 (viii) Harassment where a subsequent violation or deadly threat is
14 made (RCW 9A.46.020(2)(b));
15 (ix) Criminal Gang Intimidation (RCW 9A.46.120);
16 (x) Any felony conviction by a person eighteen years of age or
17 older with a special finding of involving a juvenile in a felony
18 offense under RCW 9.94A.833;

5 the offenses occurred on separate occasions or were committed by two or
6 more persons.

7 (~~(+35+)~~) (36) "Persistent offender" is an offender who:

8 (a)(i) Has been convicted in this state of any felony considered a
9 most serious offense; and

10 (ii) Has, before the commission of the offense under (a) of this
11 subsection, been convicted as an offender on at least two separate
12 occasions, whether in this state or elsewhere, of felonies that under
13 the laws of this state would be considered most serious offenses and
14 would be included in the offender score under RCW 9.94A.525; provided
15 that of the two or more previous convictions, at least one conviction
16 must have occurred before the commission of any of the other most
17 serious offenses for which the offender was previously convicted; or

18 (b)(i) Has been convicted of: (A) Rape in the first degree, rape
19 of a child in the first degree, child molestation in the first degree,
20 rape in the second degree, rape of a child in the second degree, or
21 indecent liberties by forcible compulsion; (B) any of the following
22 offenses with a finding of sexual motivation: Murder in the first
23 degree, murder in the second degree, homicide by abuse, kidnapping in
24 the first degree, kidnapping in the second degree, assault in the first
25 degree, assault in the second degree, assault of a child in the first
26 degree, assault of a child in the second degree, or burglary in the
27 first degree; or (C) an attempt to commit any crime listed in this
28 subsection (~~(+35+)~~) (36)(b)(i); and

29 (ii) Has, before the commission of the offense under (b)(i) of this
30 subsection, been convicted as an offender on at least one occasion,
31 whether in this state or elsewhere, of an offense listed in (b)(i) of
32 this subsection or any federal or out-of-state offense or offense under
33 prior Washington law that is comparable to the offenses listed in
34 (b)(i) of this subsection. A conviction for rape of a child in the
35 first degree constitutes a conviction under (b)(i) of this subsection
36 only when the offender was sixteen years of age or older when the
37 offender committed the offense. A conviction for rape of a child in

1 the second degree constitutes a conviction under (b)(i) of this
2 subsection only when the offender was eighteen years of age or older
3 when the offender committed the offense.

4 ~~((+36+))~~ (37) "Predatory" means: (a) The perpetrator of the crime
5 was a stranger to the victim, as defined in this section; (b) the
6 perpetrator established or promoted a relationship with the victim
7 prior to the offense and the victimization of the victim was a
8 significant reason the perpetrator established or promoted the
9 relationship; or (c) the perpetrator was: (i) A teacher, counselor,
10 volunteer, or other person in authority in any public or private school
11 and the victim was a student of the school under his or her authority
12 or supervision. For purposes of this subsection, "school" does not
13 include home-based instruction as defined in RCW 28A.225.010; (ii) a
14 coach, trainer, volunteer, or other person in authority in any
15 recreational activity and the victim was a participant in the activity
16 under his or her authority or supervision; or (iii) a pastor, elder,
17 volunteer, or other person in authority in any church or religious
18 organization, and the victim was a member or participant of the
19 organization under his or her authority.

20 ~~((+37+))~~ (38) "Private school" means a school regulated under
21 chapter 28A.195 or 28A.205 RCW.

22 ~~((+38+))~~ (39) "Public school" has the same meaning as in RCW
23 28A.150.010.

24 ~~((+39+))~~ (40) "Restitution" means a specific sum of money ordered
25 by the sentencing court to be paid by the offender to the court over a
26 specified period of time as payment of damages. The sum may include
27 both public and private costs.

28 ~~((+40+))~~ (41) "Risk assessment" means the application of an
29 objective instrument supported by research and adopted by the
30 department for the purpose of assessing an offender's risk of
31 reoffense, taking into consideration the nature of the harm done by the
32 offender, place and circumstances of the offender related to risk, the
33 offender's relationship to any victim, and any information provided to
34 the department by victims. The results of a risk assessment shall not
35 be based on unconfirmed or unconfirmable allegations.

12 liquor or any drug (RCW 46.61.502), nonfelony actual physical control
13 while under the influence of intoxicating liquor or any drug (RCW
14 46.61.504), reckless driving (RCW 46.61.500), or hit-and-run an
15 attended vehicle (RCW 46.52.020(5)); or

16 (b) Any federal, out-of-state, county, or municipal conviction for
17 an offense that under the laws of this state would be classified as a
18 serious traffic offense under (a) of this subsection.

19 ~~((42))~~ (44) "Serious violent offense" is a subcategory of violent
20 offense and means:

21 (a)(i) Murder in the first degree;

22 (ii) Homicide by abuse;

23 (iii) Murder in the second degree;

24 (iv) Manslaughter in the first degree;

25 (v) Assault in the first degree;

26 (vi) Kidnapping in the first degree;

27 (vii) Rape in the first degree;

28 (viii) Assault of a child in the first degree; or

29 (ix) An attempt, criminal solicitation, or criminal conspiracy to
30 commit one of these felonies; or

31 (b) Any federal or out-of-state conviction for an offense that

21 (a) To a significant degree, the victim was an initiator, willing
22 participant, aggressor, or provoker of the incident.

25 damage or injury sustained.

26 (c) The defendant committed the crime under duress, coercion,
27 threat, or compulsion insufficient to constitute a complete defense but

29 (d) The defendant, with no apparent predisposition to do so, was
30 induced by others to participate in the crime.

31 (e) The defendant's capacity to appreciate the wrongfulness of his
32 or her conduct, or to conform his or her conduct to the requirements of
33 the law, was significantly impaired. Voluntary use of drugs or alcohol
34 is excluded.

35 (f) The offense was principally accomplished by another person and
36 the defendant manifested extreme caution or sincere concern for the
37 safety or well-being of the victim.

1 (g) The operation of the multiple offense policy of RCW 9.94A.589
2 results in a presumptive sentence that is clearly excessive in light of
3 the purpose of this chapter, as expressed in RCW 9.94A.010.

4 (h) The defendant or the defendant's children suffered a continuing
5 pattern of physical or sexual abuse by the victim of the offense and
6 the offense is a response to that abuse.

7 (2) Aggravating Circumstances - Considered and Imposed by the Court

8 The trial court may impose an aggravated exceptional sentence
9 without a finding of fact by a jury under the following circumstances:

10 (a) The defendant and the state both stipulate that justice is best
11 served by the imposition of an exceptional sentence outside the
12 standard range, and the court finds the exceptional sentence to be
13 consistent with and in furtherance of the interests of justice and the
14 purposes of the sentencing reform act.

15 (b) The defendant's prior unscored misdemeanor or prior unscored
16 foreign criminal history results in a presumptive sentence that is
17 clearly too lenient in light of the purpose of this chapter, as
18 expressed in RCW 9.94A.010.

19 (c) The defendant has committed multiple current offenses and the
20 defendant's high offender score results in some of the current offenses
21 going unpunished.

22 (d) The failure to consider the defendant's prior criminal history
23 which was omitted from the offender score calculation pursuant to RCW
24 9.94A.525 results in a presumptive sentence that is clearly too
25 lenient.

26 (3) Aggravating Circumstances - Considered by a Jury -Imposed by
27 the Court

28 Except for circumstances listed in subsection (2) of this section,
29 the following circumstances are an exclusive list of factors that can
30 support a sentence above the standard range. Such facts should be
31 determined by procedures specified in RCW 9.94A.537.

32 (a) The defendant's conduct during the commission of the current
33 offense manifested deliberate cruelty to the victim.

34 (b) The defendant knew or should have known that the victim of the
35 current offense was particularly vulnerable or incapable of resistance.

36 (c) The current offense was a violent offense, and the defendant
37 knew that the victim of the current offense was pregnant.

1 (d) The current offense was a major economic offense or series of
2 offenses, so identified by a consideration of any of the following
3 factors:

4 (i) The current offense involved multiple victims or multiple
5 incidents per victim;

6 (ii) The current offense involved attempted or actual monetary loss
7 substantially greater than typical for the offense;

8 (iii) The current offense involved a high degree of sophistication
9 or planning or occurred over a lengthy period of time; or

10 (iv) The defendant used his or her position of trust, confidence,
11 or fiduciary responsibility to facilitate the commission of the current
12 offense.

13 (e) The current offense was a major violation of the Uniform
14 Controlled Substances Act, chapter 69.50 RCW (VUCSA), related to
15 trafficking in controlled substances, which was more onerous than the
16 typical offense of its statutory definition: The presence of ANY of
17 the following may identify a current offense as a major VUCSA:

18 (i) The current offense involved at least three separate
19 transactions in which controlled substances were sold, transferred, or
20 possessed with intent to do so;

21 (ii) The current offense involved an attempted or actual sale or
22 transfer of controlled substances in quantities substantially larger
23 than for personal use;

24 (iii) The current offense involved the manufacture of controlled
25 substances for use by other parties;

26 (iv) The circumstances of the current offense reveal the offender
27 to have occupied a high position in the drug distribution hierarchy;

28 (v) The current offense involved a high degree of sophistication or
29 planning, occurred over a lengthy period of time, or involved a broad
30 geographic area of disbursement; or

31 (vi) The offender used his or her position or status to facilitate
32 the commission of the current offense, including positions of trust,
33 confidence or fiduciary responsibility (e.g., pharmacist, physician, or
34 other medical professional).

35 (f) The current offense included a finding of sexual motivation
36 pursuant to RCW 9.94A.835.

37 (g) The offense was part of an ongoing pattern of sexual abuse of

1 the same victim under the age of eighteen years manifested by multiple
2 incidents over a prolonged period of time.

3 (h) The current offense involved domestic violence, as defined in
4 RCW 10.99.020, and one or more of the following was present:

5 (i) The offense was part of an ongoing pattern of psychological,
6 physical, or sexual abuse of ((the)) a victim or multiple victims
7 manifested by multiple incidents over a prolonged period of time;

8 (ii) The offense occurred within sight or sound of the victim's or
9 the offender's minor children under the age of eighteen years; or

10 (iii) The offender's conduct during the commission of the current
11 offense manifested deliberate cruelty or intimidation of the victim.

12 (i) The offense resulted in the pregnancy of a child victim of
13 rape.

14 (j) The defendant knew that the victim of the current offense was
15 a youth who was not residing with a legal custodian and the defendant
16 established or promoted the relationship for the primary purpose of
17 victimization.

18 (k) The offense was committed with the intent to obstruct or impair
19 human or animal health care or agricultural or forestry research or
20 commercial production.

21 (l) The current offense is trafficking in the first degree or
22 trafficking in the second degree and any victim was a minor at the time
23 of the offense.

24 (m) The offense involved a high degree of sophistication or
25 planning.

26 (n) The defendant used his or her position of trust, confidence, or
27 fiduciary responsibility to facilitate the commission of the current
28 offense.

29 (o) The defendant committed a current sex offense, has a history of
30 sex offenses, and is not amenable to treatment.

31 (p) The offense involved an invasion of the victim's privacy.

32 (q) The defendant demonstrated or displayed an egregious lack of
33 remorse.

34 (r) The offense involved a destructive and foreseeable impact on
35 persons other than the victim.

36 (s) The defendant committed the offense to obtain or maintain his
37 or her membership or to advance his or her position in the hierarchy of
38 an organization, association, or identifiable group.

1 (t) The defendant committed the current offense shortly after being
2 released from incarceration.

3 (u) The current offense is a burglary and the victim of the
4 burglary was present in the building or residence when the crime was
5 committed.

6 (v) The offense was committed against a law enforcement officer who
7 was performing his or her official duties at the time of the offense,
8 the offender knew that the victim was a law enforcement officer, and
9 the victim's status as a law enforcement officer is not an element of
10 the offense.

11 (w) The defendant committed the offense against a victim who was
12 acting as a good samaritan.

13 (x) The defendant committed the offense against a public official
14 or officer of the court in retaliation of the public official's
15 performance of his or her duty to the criminal justice system.

16 (y) The victim's injuries substantially exceed the level of bodily
17 harm necessary to satisfy the elements of the offense. This aggravator
18 is not an exception to RCW 9.94A.530(2).

19 (z)(i)(A) The current offense is theft in the first degree, theft
20 in the second degree, possession of stolen property in the first
21 degree, or possession of stolen property in the second degree; (B) the
22 stolen property involved is metal property; and (C) the property damage
23 to the victim caused in the course of the theft of metal property is
24 more than three times the value of the stolen metal property, or the
25 theft of the metal property creates a public hazard.

26 (ii) For purposes of this subsection, "metal property" means
27 commercial metal property, private metal property, or nonferrous metal

29 (aa) The defendant committed the offense with the intent to
30 directly or indirectly cause any benefit, aggrandizement, gain, profit,
31 or other advantage to or for a criminal street gang as defined in RCW
32 9.94A.030, its reputation, influence, or membership.
