1 AN ACT Relating to the establishment of a license limitation
2 program for the harvest and delivery of Pacific sardines into the
3 state; amending RCW 77.65.200; and adding new sections to chapter 77.70
4 RCW.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** A new section is added to chapter 77.70 RCW
7 to read as follows:

8 The definitions in this section apply throughout this chapter and
9 related rules adopted by the department unless the context clearly
10 requires otherwise.

11 (1) "Deliver" or "delivery" means arrival at a place or port, and
12 includes arrivals from offshore waters to waters within the state and
13 arrivals ashore from offshore waters.

14 (2) "Pacific sardine" and "pilchard" means the species *Sardinops*
15 *sagax*.

16 NEW SECTION. **Sec. 2.** A new section is added to chapter 77.70 RCW
17 to read as follows:

18 (1) A Washington sardine purse seine fishery license or temporary

1 annual fishery permit is required to use purse seine gear to fish for
2 or possess Pacific sardines in offshore waters. This requirement does
3 not affect persons authorized to fish for or possess sardines in
4 offshore waters under a valid Oregon or California license or permit.

5 (2) A Washington sardine purse seine fishery license or temporary
6 annual fishery permit is required to deliver Pacific sardines into the
7 state.

8 (3) Washington sardine purse seine fishery licenses and temporary
9 annual fishery permits require vessel designation under RCW 77.65.100.

10 (4) Pacific sardines may not be taken or retained in state waters
11 except for incidental harvest authorized by rule of the department.

12 NEW SECTION. **Sec. 3.** A new section is added to chapter 77.70 RCW
13 to read as follows:

14 (1) A Washington Pacific sardine purse seine fishery license:

15 (a) May only be issued to a person that held a coastal pilchard
16 experimental fishery permit in 2008, except as otherwise provided in
17 this section;

18 (b) Must be renewed annually to remain active; and

19 (c) Subject to the restrictions of subsections (5) and (6) of this
20 section and RCW 77.65.040, is transferable from one license holder to
21 another.

22 (2) A Washington Pacific sardine purse seine fishery license may be
23 issued to any person that held a coastal pilchard experimental fishery
24 permit in 2005, 2006, or 2007 and is precluded from qualifying under
25 subsection (1) of this section because the vessel designated on the
26 permit sank prior to 2008.

27 (3) Beginning in 2010, after taking into consideration the status
28 of the Pacific sardine population and the market for Pacific sardines
29 in the state, the director may issue:

30 (a) A Washington Pacific sardine purse seine fishery license to any
31 person provided that the issuance would not raise the number of
32 licenses beyond the number initially issued in 2009;

33 (b) A Washington Pacific sardine purse seine temporary annual
34 fishery permit to any person if the combined number of active
35 Washington Pacific sardine purse seine fishery licenses and annual
36 temporary permits already issued during the year is less than twenty-
37 five.

1 (4) The annual fee for a Washington Pacific sardine purse seine
2 fishery license is one hundred eighty-five dollars for residents and
3 two hundred ninety-five dollars for nonresidents.

4 (5) The fee for a Washington Pacific sardine purse seine temporary
5 annual fishery permit is one hundred eighty-five dollars for residents
6 and two hundred ninety-five dollars for nonresidents. A temporary
7 annual fishery permit expires at the end of the calendar year in which
8 the permit is issued.

9 (6) Only a person who owns or operates the vessel designated on the
10 license or permit may hold a Washington Pacific sardine purse seine
11 fishery license or temporary annual fishery permit.

12 (7) A person may not own or hold an ownership interest in more than
13 two Washington Pacific sardine purse seine fishery licenses.

14 **Sec. 4.** RCW 77.65.200 and 2000 c 107 s 41 are each amended to read
15 as follows:

16 (1) This section establishes commercial fishery licenses required
17 for food fish fisheries and the annual fees for those licenses. As
18 used in this section, "food fish" does not include salmon. The
19 director may issue a limited-entry commercial fishery license only to
20 a person who meets the qualifications established in applicable
21 governing sections of this title.

32 (2) The director may by rule determine the species of food fish
33 that may be taken with the commercial fishery licenses established in
34 this section, the gear that may be used with the licenses, and the
35 areas or waters in which the licenses may be used. Where a fishery
36 license has been established for a particular species, gear,
37 geographical area, or combination thereof, a more general fishery
38 license may not be used to take food fish in that fishery.
