1 AN ACT Relating to escrow agents; amending RCW 18.44.011,
2 18.44.021, 18.44.031, 18.44.091, 18.44.121, 18.44.201, 18.44.301,
3 18.44.195, and 18.44.430; and adding new sections to chapter 18.44 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 18.44.011 and 1999 c 30 s 1 are each amended to read
6 as follows:

7 ~~((Unless a different meaning is apparent from the context, terms~~
8 ~~used in this chapter shall have the following meanings:)) The
9 definitions in this section apply throughout this chapter unless the
10 context clearly requires otherwise.~~

11 (1) "Department" means the department of financial institutions.

12 (2) "Director" means the director of financial institutions, or his
13 or her duly authorized representative.

14 (3) "Director of licensing" means the director of the department of
15 licensing, or his or her duly authorized representative.

16 (4) "Escrow" means any transaction, except the acts of a qualified
17 intermediary in facilitating an exchange under section 1031 of the
18 internal revenue code, wherein any person or persons, for the purpose
19 of effecting and closing the sale, purchase, exchange, transfer,

1 encumbrance, or lease of real or personal property to another person or
2 persons, delivers any written instrument, money, evidence of title to
3 real or personal property, or other thing of value to a third person to
4 be held by such third person until the happening of a specified event
5 or the performance of a prescribed condition or conditions, when it is
6 then to be delivered by such third person, in compliance with
7 instructions under which he or she is to act, to a grantee, grantor,
8 promisee, promisor, obligee, obligor, lessee, lessor, bailee, bailor,
9 or any agent or employee thereof. For purposes of this definition,
10 escrow includes the collection of payments and the performance of
11 related services by a third party in connection with a loan secured by
12 a lien on real or personal property but excludes vessel transfers.

13 (5) "Split escrow" means a transaction in which two or more escrow
14 agents act to effect and close an escrow transaction.

15 (6) "Escrow agent" means any person engaged in the business of
16 performing for compensation the duties of the third person referred to
17 in subsection (4) of this section.

18 (7) "Licensed escrow agent" means any sole proprietorship, firm,
19 association, partnership, or corporation holding a license as an escrow
20 agent under the provisions of this chapter.

21 (8) "Person" means a natural person, firm, association,
22 partnership, corporation, limited liability company, or the plural
23 thereof, whether resident, nonresident, citizen, or not.

24 (9) "Licensed escrow officer" means any natural person handling
25 escrow transactions and licensed as such by the director.

26 (10) "Designated escrow officer" means any licensed escrow officer
27 designated by a licensed escrow agent and approved by the director as
28 the licensed escrow officer responsible for supervising that agent's
29 handling of escrow transactions, management of the agent's trust
30 account, and supervision of all other licensed escrow officers employed
31 by the agent.

32 (11) "Escrow commission" means the escrow commission of the state
33 of Washington created by RCW 18.44.500.

34 (12) "Controlling person" is any person who owns or controls ten
35 percent or more of the beneficial ownership of any escrow agent,
36 regardless of the form of business organization employed and regardless
37 of whether such interest stands in such person's true name or in the
38 name of a nominee.

1 **Sec. 2.** RCW 18.44.021 and 1999 c 30 s 2 are each amended to read
2 as follows:

3 It shall be unlawful for any person to engage in business as an
4 escrow agent by performing escrows or any of the functions of an escrow
5 agent as described in RCW 18.44.011(4) within this state or with
6 respect to transactions that involve personal property or real property
7 located in this state unless such person possesses a valid license
8 issued by the director pursuant to this chapter. The licensing
9 requirements of this chapter shall not apply to:

10 (1) Any person doing business under the law of this state or the
11 United States relating to banks, trust companies, mutual savings banks,
12 savings and loan associations, credit unions, insurance companies, or
13 any federally approved agency or lending institution under the national
14 housing act (12 U.S.C. Sec. 1703).

15 (2) Any person licensed to practice law in this state while engaged
16 in the performance of his or her professional duties: PROVIDED, That
17 no separate compensation or gain is received for escrow services, and
18 the service is provided under the same legal entity as the law
19 practice. Any attorney who is principally engaged as an escrow agent
20 is required to be licensed. If an attorney holds himself or herself
21 out publicly as being able to perform the services of an escrow agent,
22 he or she is principally engaged as an escrow agent.

23 (3) Any real estate company, broker, or agent subject to the
24 jurisdiction of the director of licensing while performing acts in the
25 course of or incidental to sales or purchases of real or personal
26 property handled or negotiated by such real estate company, broker, or
27 agent: PROVIDED, That no compensation is received for escrow services.

28 (4) Any transaction in which money or other property is paid to,
29 deposited with, or transferred to a joint control agent for disbursal
30 or use in payment of the cost of labor, material, services, permits,
31 fees, or other items of expense incurred in the construction of
32 improvements upon real property.

33 (5) Any receiver, trustee in bankruptcy, executor, administrator,
34 guardian, or other person acting under the supervision or order of any
35 superior court of this state or of any federal court.

36 (6) Title insurance companies having a valid certificate of
37 authority issued by the insurance commissioner of this state and title

1 insurance agents having a valid license as a title insurance agent
2 issued by the insurance commissioner of this state.

3 **Sec. 3.** RCW 18.44.031 and 2005 c 274 s 224 are each amended to
4 read as follows:

5 An application for an escrow agent license shall be in writing in
6 such form as is prescribed by the director, and shall be verified on
7 oath by the applicant. An application for an escrow agent license
8 shall include (~~((fingerprints for all officers, directors, owners,
9 partners, and controlling persons, and, unless waived by the
10 director,~~)) the following:

11 (1) The applicant's form of business organization and place of
12 organization;

13 (2) Information concerning the identity of the applicant, and its
14 officers, directors, owners, partners, controlling persons, and
15 employees, including fingerprints for submission to the Washington
16 state patrol, the federal bureau of investigation, and any government
17 agency or subdivision authorized to receive information for state and
18 national criminal history background checks; personal history;
19 experience; business record; purposes; and other pertinent facts, as
20 the director may reasonably require. The director may also request
21 criminal history record information, including nonconviction data, as
22 defined by RCW 10.97.030. The department may disseminate nonconviction
23 data obtained under this section only to criminal justice agencies.
24 The applicant must pay the cost of fingerprinting and processing the
25 fingerprints by the department;

26 (3) If the applicant is a corporation or limited liability company,
27 the address of its physical location, a list of officers, controlling
28 persons, and directors of such corporation or company and their
29 residential addresses, telephone numbers, and other identifying
30 information as the director may determine by rule. If the applicant is
31 a sole proprietorship or partnership, the address of its business
32 location, a list of owners, partners, or controlling persons and their
33 residential addresses, telephone numbers, and other identifying
34 information as the director may determine by rule. Any information in
35 the application regarding the personal residential address or telephone
36 number of any officer, director, partner, owner, controlling person, or

1 employee is exempt from the public records disclosure requirements of
2 chapter 42.56 RCW;

3 ((+3)) (4) In the event the applicant is doing business under an
4 assumed name, a copy of the master business license with the registered
5 trade name shown;

6 ((+4)) (5) The qualifications and business history of the
7 applicant and all of its officers, directors, owners, partners, and
8 controlling persons;

9 ((+5)) (6) A personal credit report from a recognized credit
10 reporting bureau satisfactory to the director on all officers,
11 directors, owners, partners, and controlling persons of the applicant;

12 ((+6)) (7) Whether any of the officers, directors, owners,
13 partners, or controlling persons have been convicted of any crime
14 within the preceding ten years which relates directly to the business
15 or duties of escrow agents, or have suffered a judgment within the
16 preceding five years in any civil action involving fraud,
17 misrepresentation, any unfair or deceptive act or practice, or
18 conversion;

19 ((+7)) (8) The identity of the licensed escrow officer designated
20 by the escrow agent as the designated escrow officer responsible for
21 supervising the agent's escrow activity;

22 ((+8)) (9) Evidence of compliance with the bonding and insurance
23 requirements of RCW 18.44.201; and

24 ((+9)) (10) Any other information the director may require by
25 rule. The director may share any information contained within a
26 license application, including fingerprints, with the federal bureau of
27 investigation and other regulatory or law enforcement agencies.

28 NEW SECTION. **Sec. 4.** A new section is added to chapter 18.44 RCW
29 to read as follows:

30 (1) A licensed escrow agent may not directly or indirectly employ
31 a person who will be handling escrow transactions who has been
32 convicted of, or pled guilty or nolo contendere to, a felony or a gross
33 misdemeanor involving dishonesty within the last seven years.

34 (2) A licensed escrow agent may not directly or indirectly employ
35 a person who receives money for trust accounts, disburses funds, or
36 acts as a signatory on trust accounts if the person has shown a

1 disregard in the management of his or her financial condition in the
2 last three years.

3 (3) The director may adopt rules to implement this section.

4 **Sec. 5.** RCW 18.44.091 and 1999 c 30 s 25 are each amended to read
5 as follows:

6 Every escrow officer license issued under the provisions of this
7 chapter expires on the date one year from the date of issue which date
8 will henceforth be the renewal date. An annual license renewal fee in
9 the same amount must be paid on or before each renewal date: PROVIDED,
10 That licenses issued or renewed prior to September 21, 1977, shall use
11 the existing renewal date as the date of issue. If the application for
12 a license renewal is not received by the director on or before the
13 renewal date such license is expired and any activity conducted is
14 unlicensed activity in violation of this chapter. The license may be
15 reinstated at any time prior to (~~the next succeeding renewal date~~
16 ~~following its expiration~~) sixty days after renewal upon the payment to
17 the director of the annual renewal fee (~~then in default~~). Acceptance
18 by the director of an application for renewal after the renewal date
19 shall not be a waiver of the delinquency. Licenses not renewed within
20 (~~one year of~~) sixty days after the renewal date (~~then in default~~)
21 shall be canceled. A new license may be obtained by satisfying the
22 procedures and qualifications for initial licensing, including where
23 applicable successful completion of examinations.

24 **Sec. 6.** RCW 18.44.121 and 2001 c 177 s 3 are each amended to read
25 as follows:

26 (1) The director shall charge and collect the following fees (~~as~~
27 ~~established by rule by the director~~):

28 (~~(1)~~) (a) A fee for filing an original or a renewal application
29 for an escrow agent license, a fee for each application for an
30 additional licensed location, a fee for an application for a change of
31 address for an escrow agent, annual fees for the first office or
32 location and for each additional office or location, and under RCW
33 43.135.055 the director shall set the annual fee for an escrow agent
34 license up to five hundred sixty-five dollars in fiscal year 2000.

35 (~~(2)~~) (b) A fee for filing an original or a renewal application
36 for an escrow officer license, a fee for an application for a change of

1 address for each escrow officer license being so changed, a fee to
2 activate an inactive escrow officer license or transfer an escrow
3 officer license, and under RCW 43.135.055 the director shall set the
4 annual fee for an escrow officer license up to two hundred thirty-five
5 dollars in fiscal year 2000.

6 ~~((+3))~~ (c) A fee for filing an application for a duplicate of an
7 escrow agent license or of an escrow officer license lost, stolen,
8 destroyed, or for replacement.

9 ~~((+4))~~ (d) A fee for providing license examinations.

10 ~~((+5))~~ (e) An hourly audit fee. In setting this fee, the director
11 shall ensure that every examination and audit, or any part of the
12 examination or audit, of any person licensed or subject to licensing in
13 this state requiring travel and services outside this state by the
14 director or by employees designated by the director, shall be at the
15 expense of the person examined or audited at the hourly rate
16 established by the director, plus the per diem compensation and actual
17 travel expenses incurred by the director or his or her employees
18 conducting the examination or audit. When making any examination or
19 audit under this chapter, the director may retain attorneys,
20 appraisers, independent certified public accountants, or other
21 professionals and specialists as examiners or auditors, the cost of
22 which shall be borne by the person who is the subject of the
23 examination or audit.

24 (2) In establishing these fees, the director shall set the fees at
25 a sufficient level to defray the costs of administering this chapter.

26 (3) All fees received by the director under this chapter shall be
27 paid into the state treasury to the credit of the financial services
28 regulation fund.

29 **Sec. 7.** RCW 18.44.201 and 1999 c 30 s 5 are each amended to read
30 as follows:

31 (1) At the time of filing an application for an escrow agent
32 license, or any renewal or reinstatement of an escrow agent license,
33 the applicant shall provide satisfactory evidence to the director of
34 having obtained the following as evidence of financial responsibility:

35 (a) A fidelity bond providing coverage in the aggregate amount of
36 two hundred thousand dollars with a deductible no greater than ten

1 thousand dollars covering each corporate officer, partner, escrow
2 officer, and employee of the applicant engaged in escrow transactions;

3 (b) An errors and omissions policy issued to the escrow agent
4 providing coverage in the minimum aggregate amount of fifty thousand
5 dollars or, alternatively, cash or securities in the principal amount
6 of fifty thousand dollars deposited in an approved depository on
7 condition that they be available for payment of any claim payable under
8 an equivalent errors and omissions policy in that amount and pursuant
9 to rules and regulations adopted by the department for that purpose;
10 and

11 (c) A surety bond in the amount of ten thousand dollars executed by
12 the applicant as obligor and by a surety company authorized to do a
13 surety business in this state as surety, unless the fidelity bond
14 obtained by the licensee to satisfy the requirement in (a) of this
15 subsection does not have a deductible. The bond shall run to the state
16 of Washington as obligee, and shall run to the benefit of the state and
17 any person or persons who suffer loss by reason of the applicant's or
18 its employee's violation of this chapter. The bond shall be
19 conditioned that the obligor as licensee will faithfully conform to and
20 abide by this chapter and all rules adopted under this chapter, and
21 shall reimburse all persons who suffer loss by reason of a violation of
22 this chapter or rules adopted under this chapter. The bond shall be
23 continuous and may be canceled by the surety upon the surety giving
24 written notice to the director of its intent to cancel the bond. The
25 cancellation shall be effective thirty days after the notice is
26 received by the director. Whether or not the bond is renewed,
27 continued, reinstated, reissued, or otherwise extended, replaced, or
28 modified, including increases or decreases in the penal sum, it shall
29 be considered one continuous obligation, and the surety upon the bond
30 shall not be liable in an aggregate amount exceeding the penal sum set
31 forth on the face of the bond. In no event shall the penal sum, or any
32 portion thereof, at two or more points in time be added together in
33 determining the surety's liability. The bond shall not be liable for
34 any penalties imposed on the licensee, including but not limited to,
35 any increased damages or attorneys' fees, or both, awarded under RCW
36 19.86.090.

37 (2) For the purposes of this section, a "fidelity bond" shall mean
38 a primary commercial blanket bond or its equivalent satisfactory to the

1 director and written by an insurer authorized to transact this line of
2 business in the state of Washington. Such bond shall provide fidelity
3 coverage for any fraudulent or dishonest acts committed by any one or
4 more of the (~~employees or officers as defined in the bond,~~) corporate
5 officers, partners, sole practitioners, escrow officers, and employees
6 of the applicant engaged in escrow transactions acting alone or in
7 collusion with others. This bond shall be for the sole benefit of the
8 escrow agent and under no circumstances whatsoever shall the bonding
9 company be liable under the bond to any other party unless the
10 corporate officer, partner, or sole practitioner commits a fraudulent
11 or dishonest act, in which case, the bond shall be for the benefit of
12 the harmed consumer. The bond shall name the escrow agent as obligee
13 and shall protect the obligee against the loss of money or other real
14 or personal property belonging to the obligee, or in which the obligee
15 has a pecuniary interest, or for which the obligee is legally liable or
16 held by the obligee in any capacity, whether the obligee is legally
17 liable therefor or not. An escrow agent's bond must be maintained
18 until all accounts have been reconciled and the escrow trust account
19 balance is zero. The bond may be canceled by the insurer upon delivery
20 of thirty days' written notice to the director and to the escrow agent.

21 (3) In the event that fidelity coverage is not available for any
22 fraudulent or dishonest act committed by any one or more of the
23 corporate officers, partners, sole practitioners, escrow officers, and
24 employees of the applicant engaged in escrow transactions acting alone
25 or in collusion with others, the applicant shall file and maintain a
26 surety bond in an amount the director deems adequate to protect the
27 public interest, executed by the applicant as obligor and by a surety
28 company authorized to do a surety business in this state as surety.
29 The bonding requirement as established by the director by rule shall
30 take the form of a range of bond amounts that vary according to the
31 average monthly balance of client trust funds of the applicant. The
32 minimum surety bond is twenty thousand dollars, and the maximum is two
33 hundred fifty thousand dollars. The bond shall run to the state of
34 Washington as obligee, and shall run to the benefit of the state and
35 any person or persons who suffer loss by reason of a violation of this
36 chapter by the applicant, corporate officers, partners, sole
37 practitioners, escrow officers, or employees. The bond shall be
38 conditioned that the obligor as licensee will faithfully conform to and

1 abide by this chapter and all rules adopted under this chapter and
2 shall reimburse all persons who suffer loss by reason of a violation of
3 this chapter or rules adopted under this chapter. The bond shall be
4 continuous and may be canceled by the surety upon the surety giving
5 written notice to the director of its intent to cancel the bond. The
6 cancellation is effective thirty days after the notice is received by
7 the director. Whether or not the bond is renewed, continued,
8 reinstated, reissued, or otherwise extended, replaced, or modified,
9 including increases or decreases in the penal sum, it shall be
10 considered one continuous obligation, and the surety upon the bond
11 shall not be liable in an aggregate amount exceeding the penal sum set
12 forth on the face of the bond. In no event shall the penal sum, or any
13 portion thereof, at two or more points in time be added together in
14 determining the surety's liability. The bond shall not be liable for
15 any penalties imposed on the licensee, including but not limited to,
16 any increased damages or attorneys' fees, or both, awarded under RCW
17 19.86.090.

18 (4) For the purposes of this section, an "errors and omissions
19 policy" shall mean a group or individual insurance policy satisfactory
20 to the director and issued by an insurer authorized to transact
21 insurance business in the state of Washington. Such policy shall
22 provide coverage for unintentional errors and omissions of the escrow
23 agent and its employees, and may be canceled by the insurer upon
24 delivery of thirty days' written notice to the director and to the
25 escrow agent.

26 ((+4)) (5) Except as provided in RCW 18.44.221, the fidelity bond,
27 surety bond, and the errors and omissions policy required by this
28 section shall be kept in full force and effect as a condition precedent
29 to the escrow agent's authority to transact escrow business in this
30 state, and the escrow agent shall supply the director with satisfactory
31 evidence thereof upon request.

32 **Sec. 8.** RCW 18.44.301 and 1999 c 30 s 9 are each amended to read
33 as follows:

34 It is a violation of this chapter for any escrow agent, controlling
35 person, officer, designated escrow officer, independent contractor,
36 employee of an escrow business, or other person subject to this chapter
37 to:

- 1 (1) Directly or indirectly employ any scheme, device, or artifice
2 to defraud or mislead borrowers or lenders or to defraud any person;
- 3 (2) Directly or indirectly engage in any unfair or deceptive
4 practice toward any person;
- 5 (3) Directly or indirectly obtain property by fraud or
6 misrepresentation;
- 7 (4) Knowingly make, publish, or disseminate any false, deceptive,
8 or misleading information in the conduct of the business of escrow, or
9 relative to the business of escrow or relative to any person engaged
10 therein;
- 11 (5) Knowingly receive or take possession for personal use of any
12 property of any escrow business, other than in payment authorized by
13 this chapter, and with intent to defraud, omit to make, or cause or
14 direct to be made, a full and true entry thereof in the books and
15 accounts of the business;
- 16 (6) Make or concur in making any false entry, or omit or concur in
17 omitting to make any material entry, in its books or accounts;
- 18 (7) Knowingly make or publish, or concur in making or publishing
19 any written report, exhibit, or statement of its affairs or pecuniary
20 condition containing any material statement which is false, or omit or
21 concur in omitting any statement required by law to be contained
22 therein;
- 23 (8) Willfully fail to make any proper entry in the books of the
24 escrow business as required by law;
- 25 (9) Fail to disclose in a timely manner to the other officers,
26 directors, controlling persons, designated escrow officer, or other
27 licensed escrow officers the receipt of service of a notice of an
28 application for an injunction or other legal process affecting the
29 property or business of an escrow agent, including in the case of a
30 licensed escrow agent an order to cease and desist or other order of
31 the director; ((~~or~~))
- 32 (10) Fail to make any report or statement lawfully required by the
33 director or other public official;
- 34 (11) Fail to comply with any requirement of any applicable federal
35 or state act including the truth-in-lending act, 15 U.S.C. Sec. 1601 et
36 seq. and Regulation Z, 12 C.F.R. Sec. 226; the real estate settlement
37 procedures act, 12 U.S.C. Sec. 2601 et seq. and Regulation X, 24 C.F.R.
38 Sec. 3500; the equal credit opportunity act, 15 U.S.C. Sec. 1691 et

1 seq. and Regulation B, Sec. 202.9, 202.11, and 202.12; Title V,
2 Subtitle A of the financial modernization act of 1999 (known as the
3 Gramm-Leach-Bliley act), 12 U.S.C. Secs. 6801-6809; the federal trade
4 commission's privacy rules, 16 C.F.R. Secs. 313-314, mandated by the

13 (1) Any person desiring to become a licensed escrow officer must
14 successfully pass an examination as required by the director.

35 **Sec. 10.** RCW 18.44.430 and 1999 c 30 s 22 are each amended to read
36 as follows:

1 (1) The director may, upon notice to the escrow agent and to the
2 insurer providing coverage under RCW 18.44.201, deny, suspend, decline
3 to renew, or revoke the license of any escrow agent or escrow officer
4 if the director finds that the applicant or any partner, officer,
5 director, controlling person, or employee has committed any of the
6 following acts or engaged in any of the following conduct:

7 (a) Obtaining a license by means of fraud, misrepresentation,
8 concealment, or through the mistake or inadvertence of the director.

9 (b) Violating any of the provisions of this chapter or any lawful
10 rules made by the director pursuant thereto.

11 (c) The commission of a crime against the laws of this or any other
12 state or government, involving moral turpitude or dishonest dealings.

13 (d) Knowingly committing or being a party to, any material fraud,
14 misrepresentation, concealment, conspiracy, collusion, trick, scheme,
15 or device whereby any other person lawfully relying upon the word,
16 representation, or conduct of the licensee or agent or any partner,
17 officer, director, controlling person, or employee acts to his or her
18 injury or damage.

19 (e) Conversion of any money, contract, deed, note, mortgage, or
20 abstract or other evidence of title to his or her own use or to the use
21 of his or her principal or of any other person, when delivered to him
22 or her in trust or on condition, in violation of the trust or before
23 the happening of the condition; and failure to return any money or
24 contract, deed, note, mortgage, abstract, or other evidence of title
25 within thirty days after the owner thereof is entitled thereto, and
26 makes demand therefor, shall be prima facie evidence of such
27 conversion.

28 (f) Failing, upon demand, to disclose any information within his or
29 her knowledge to, or to produce any document, book, or record in his or
30 her possession for inspection of, the director or his or her authorized
31 representatives.

32 (g) Committing any act of fraudulent or dishonest dealing, and a
33 certified copy of the final holding of any court of competent
34 jurisdiction in such matter shall be conclusive evidence in any hearing
35 under this chapter.

36 (h) Accepting, taking, or charging any undisclosed commission,
37 rebate, or direct profit on expenditures made for the principal.

1 (i) Committing acts or engaging in conduct that demonstrates the
2 applicant or licensee to be incompetent or untrustworthy, or a source
3 of injury and loss to the public.

4 (2) Any conduct of an applicant or licensee that constitutes
5 grounds for enforcement action under this chapter is sufficient
6 regardless of whether the conduct took place within or outside of the
7 state of Washington.

8 (3) In addition to or in lieu of a license suspension, revocation,
9 or denial, the director may assess a fine of up to one hundred dollars
10 per day for each (~~day's~~) violation of this chapter or rules adopted
11 under this chapter and may remove and/or prohibit from participation in
12 the conduct of the affairs of any licensed escrow agent, any officer,
13 controlling person, director, employee, or licensed escrow officer.

14 (4) In addition to or in lieu of (a) a license suspension,
15 revocation, or denial, or (b) fines payable to the department, the
16 director may order an escrow agent, officer, controlling person,
17 director, employee, or licensed escrow officer violating this chapter
18 to make restitution to an injured consumer.

19 NEW SECTION. Sec. 11. A new section is added to chapter 18.44 RCW
20 to read as follows:

21 (1) The director may immediately take possession of the property
22 and business of a licensee whenever it appears to the director that, as
23 a result of an examination, report, investigation, or complaint:

24 (a) The licensee is conducting its business in such an unsafe or
25 unsound manner as to render its further operations hazardous to the
26 public;

27 (b) The licensee has suspended payment of its trust obligations; or

28 (c) The licensee neglects or refuses to comply with any order of
29 the director made pursuant to this chapter unless the enforcement of
30 such an order is restrained in a proceeding brought by the licensee.

31 (2) The director may retain possession of the licensee's property
32 and business until the licensee resumes business or its affairs are
33 finally liquidated as provided in RCW 18.44.470. The licensee may only
34 resume business upon those terms as the director may prescribe.

35 NEW SECTION. Sec. 12. A new section is added to chapter 18.44 RCW
36 to read as follows:

1 (1) During the time that the director retains possession of the
2 property and business of a licensee, the director has the power and
3 authority to conduct the licensee's business and take any action on
4 behalf of the licensee that the licensee could lawfully take on its own
5 behalf, including but not limited to discontinuing any violations and
6 unsafe or injurious practices, making good any deficiencies, and making
7 claims against the licensee's fidelity bond, errors and omissions bond,
8 or surety bond on behalf of the company.

9 (2) The director, the department, and its employees are not subject
10 to liability for actions under this section and section 11 of this act
11 and no moneys from the department's fund may be required to be expended
12 on behalf of the licensee or the licensee's clients, creditors,
13 employees, shareholders, members, investors, or any other party or
14 entity.
