1 AN ACT Relating to membership and rules of procedure for the
2 criminal justice training commission and related boards; and amending
3 RCW 43.101.060 and 43.101.315.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 43.101.060 and 1999 c 97 s 2 are each amended to read
6 as follows:

7 The commission shall elect a chair and a vice-chair from among its
8 members. (~~Seven~~) A majority of the members of the commission shall
9 constitute a quorum. The governor shall summon the commission to its
10 first meeting.

11 Meetings may be called by the chair and shall be called by him or
12 her upon the written request of (~~six~~) one-third of the members.

13 **Sec. 2.** RCW 43.101.315 and 1997 c 351 s 3 are each amended to read
14 as follows:

15 (1) The board on law enforcement training standards and education
16 consists of thirteen members, appointed by the executive director and
17 subject to approval by the commission. Members must be selected as
18 follows: (a) Three must represent county law enforcement agencies, at

1 least two of whom must be incumbent sheriffs; (b) three must represent
2 city police agencies, at least two of whom must be incumbent police
3 chiefs, one of whom shall be from a city under five thousand; (c) one
4 must represent community colleges; (d) one must represent the four-year
5 colleges and universities; (e) four must represent the council of
6 police officers, two of whom must be training officers; and (f) one
7 must represent tribal law enforcement in Washington. The six officers
8 under (a) and (b) of this subsection may be appointed by the executive
9 director only after the Washington association of sheriffs and police
10 chiefs provides the director with the names of qualified officers. The
11 four officers under (e) of this subsection may be appointed by the
12 executive director only after the council of police officers provides
13 the director with the names of qualified officers.

14 (2) The board on correctional training standards and education
15 consists of ~~((fourteen))~~ eleven members, appointed by the executive
16 director and subject to approval by the commission. Members must be
17 selected as follows: (a) ~~((Three must be employed in the state
18 correctional system; (b))~~ Three must be employed in county or city
19 correctional systems; ~~((+e))~~ (b) two must be employed in juvenile
20 corrections or probation, one ~~((at the local level))~~ by the state and
21 ~~((the other at the state level))~~ one by a county or city; ~~((+d))~~ (c)
22 two must be employed in community corrections; ~~((+e))~~ (d) one must
23 represent community colleges; ~~((+f))~~ (e) one must represent four-year
24 colleges and universities; and ~~((+g))~~ (f) two must be additional
25 persons with experience and interest in correctional training standards
26 and education. At least ~~((one))~~ two of the members appointed under (a)
27 of this subsection ~~((and at least one of the members appointed under
28 (b) of this subsection))~~ must be currently employed as front line
29 correctional officers.
