1 AN ACT Relating to forest products addressed by chapter 76.48 RCW;
2 amending RCW 76.48.010, 76.48.020, 76.48.060, 76.48.080, 76.48.050,
3 76.48.062, 76.48.094, 76.48.085, 76.48.098, 76.48.030, 76.48.120,
4 76.48.130, 76.48.140, 76.48.040, 76.48.110, 76.48.100, 76.48.210,
5 76.48.150, 76.48.200, 76.48.902, and 76.48.910; adding new sections to
6 chapter 76.48 RCW; creating a new section; recodifying RCW 76.48.010,
7 76.48.020, 76.48.060, 76.48.080, 76.48.050, 76.48.062, 76.48.094,
8 76.48.085, 76.48.098, 76.48.030, 76.48.120, 76.48.130, 76.48.140,
9 76.48.040, 76.48.110, 76.48.100, 76.48.210, 76.48.150, 76.48.200,
10 76.48.900, 76.48.902, and 76.48.910; decodifying RCW 76.48.901;
11 repealing RCW 76.48.070, 76.48.086, 76.48.096, and 76.48.075; and
12 prescribing penalties.

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

14 NEW SECTION. **Sec. 1.** (1) The legislature finds that the
15 specialized forest products work group created pursuant to section 2,
16 chapter 392, Laws of 2007 produced a number of consensus
17 recommendations to the legislature as to how the permitting
18 requirements of chapter 76.48 RCW can be improved. In making

1 recommendations, the work group focused on the goals enumerated in RCW
2 76.48.010 (as recodified by this act).

3 (2) It is the intent of the legislature to enact those
4 recommendations contained in the report submitted to the legislature
5 from the specialized forest products work group in December 2008 that
6 require statutory modifications.

7 (3) It is also the intent of the legislature for the department of
8 natural resources, along with other state and local agencies, to take
9 those administrative actions necessary to execute the recommendations
10 contained in the report that do not require statutory changes. When
11 taking administrative actions regarding specialized forest products,
12 those actions should, when appropriate, be conducted consistent with
13 recommendations contained in the report submitted to the legislature
14 from the specialized forest products work group.

15 **Sec. 2.** RCW 76.48.010 and 1967 ex.s. c 47 s 2 are each amended to
16 read as follows:

17 (1) It is in the public interest of this state to protect ((a
18 great)) an important natural resource and to provide ((a high degree
19 of)) protection to the landowners of the state of Washington from the
20 theft of specialized forest products.

21 (2) To satisfy this public interest, this chapter is intended to:

22 (a) Provide law enforcement with reasonable tools;

23 (b) Reasonably protect landowners from theft;

24 (c) Ensure that requirements are not unduly burdensome to those
25 harvesting, transporting, possessing, and purchasing specialized forest
26 products;

27 (d) Craft requirements that are clear and readily understandable;
28 and

29 (e) Establish requirements that are able to be administered and
30 enforced consistently statewide.

31 **Sec. 3.** RCW 76.48.020 and 2008 c 191 s 9 are each amended to read
32 as follows:

33 The definitions in this section apply throughout this chapter
34 unless the context clearly requires otherwise.

35 (1) "Artistic cedar product" means a product made from the wood of
36 a cedar tree, including western red cedar, that is not included in the

1 definition of "cedar products" and has been carved, turned, or
2 otherwise manipulated to more than an insignificant degree with the
3 objective intent to be an artistic expression and that would be or is
4 recognized by the applicable local market as having an economic value
5 greater than the value of the raw materials used. Examples of artistic
6 cedar products include, but are not limited to:

7 (a) Chainsaw carvings;

8 (b) Hand carvings;

9 (c) Decorative bowls and boxes.

10 (2) "Authorization" means a properly completed preprinted form
11 authorizing the transportation or possession of Christmas trees ((which
12 contains the information required by)) prepared consistent with RCW

13 76.48.080((, a sample of which is filed before the harvesting occurs
14 with the sheriff of the county in which the harvesting is to occur))
15 (as recodified by this act).

16 ~~((+2))~~ (3) "Bill of lading" means a written or printed itemized
17 list or statement of particulars pertinent to the transportation or
18 possession of a specialized forest product prepared consistent with RCW
19 76.48.080 (as recodified by this act).

20 ~~((+3))~~ (4) "Cascara bark" means the bark of a Cascara tree.

21 ~~((+4) "Cedar processor" means any person who purchases, takes, or~~
22 ~~retains possession of cedar products or cedar salvage for later sale in~~
23 ~~the same or modified form following removal and delivery from the land~~
24 ~~where harvested.))~~

25 ~~(5) ("Cedar products" means cedar shakeboards, shake and shingle~~
26 ~~bolts, and rounds one to three feet in length.~~

27 ~~(6) "Cedar salvage" means cedar chunks, slabs, stumps, and logs~~
28 ~~having a volume greater than one cubic foot and being harvested or~~
29 ~~transported from areas not associated with the concurrent logging of~~
30 ~~timber stands (a) under a forest practices application approved or~~
31 ~~notification received by the department of natural resources, or (b)~~
32 ~~under a contract or permit issued by an agency of the United States~~
33 ~~government.))~~ (a) "Cedar products" means the following if made from the
34 wood of a cedar tree, including western red cedar:

35 (i) Shake and shingle bolts;

36 (ii) Fence posts and fence rails;

37 (iii) Logs not covered by a valid approved forest practices
38 application or notification under chapter 76.09 RCW; and

1 (iv) Other pieces measuring fifteen inches or longer.

2 (b) "Cedar products" does not include those materials identified in
3 the definition of "processed cedar products" or "artistic cedar
4 products."

5 ~~((+7))~~ (6) "Christmas trees" means any evergreen trees (or the
6 top thereof, commonly known as Christmas trees, with limbs and
7 branches, with or without roots, including fir, pine, spruce, cedar,
8 and other coniferous species) including fir, pine, spruce, cedar, and
9 other coniferous species commonly known as Christmas trees. The
10 definition of Christmas trees includes trees with or without the roots
11 intact and the tops of the trees. The definition of Christmas trees
12 does not include trees without limbs or branches.

13 ~~((+8))~~ (7) "Cut or picked evergreen foliage(~~(," commonly known as~~
14 brush~~,"~~)" means evergreen boughs, huckleberry foliage, salal, fern,
15 Oregon grape, rhododendron, mosses, bear grass, (~~scotch broom (Cytisus~~
16 scoparius~~,"~~) and other cut or picked evergreen products. "Cut or
17 picked evergreen foliage" does not ((mean)) include cones, berries, any
18 foliage that does not remain green year-round, (~~or~~) seeds, or any
19 plant listed on the state noxious weed list under RCW 17.10.080.

20 ~~((+9))~~ (8) "Department" means the department of natural resources.

21 (9) "First specialized forest products buyer" means the first
22 person that receives any specialized forest products after they leave
23 the harvest site.

24 (10) "Harvest" means to separate, by cutting, prying, picking,
25 peeling, breaking, pulling, splitting, or otherwise removing, a
26 specialized forest product (~~(a) from its physical connection or~~
27 contact with the land or vegetation upon which it is or was growing or
28 (b) from the position in which it is lying upon the land)). "Harvest"
29 includes both removing a specialized forest product from its original
30 physical connection with the land and collecting a specialized forest
31 product that has been previously separated from the land.

32 ~~((+10))~~ (11) "Harvest site" means each location where one or more
33 persons are engaged in harvesting specialized forest products close
34 enough to each other that communication can be conducted with an
35 investigating law enforcement officer in a normal conversational tone.

36 ~~((+11))~~ (12) "Huckleberry" means the following species of edible
37 berries, if they are not nursery grown: Big huckleberry (Vaccinium
38 membranaceum), Cascade blueberry (Vaccinium deliciosum), evergreen

1 huckleberry (Vaccinium ovatum), red huckleberry (Vaccinium
2 parvifolium), globe huckleberry (Vaccinium globulare), oval-leaf
3 huckleberry (Vaccinium ovalifolium), Alaska huckleberry (Vaccinium
4 alaskaense), dwarf huckleberry (Vaccinium caespitosum), western
5 huckleberry (Vaccinium occidentale), bog blueberry (Vaccinium
6 uliginosum), dwarf bilberry (Vaccinium myrtillus), and grouse
7 whortleberry (Vaccinium scoparium).

8 ((+12+)) (13) "Landowner" means, with regard to real property, the
9 private owner, the state of Washington or any political subdivision,
10 the federal government, or a person who by deed, contract, or lease has
11 authority to harvest and sell the specialized forest products of the
12 property. "Landowner" does not include the purchaser or successful
13 high bidder at a public or private timber sale.

14 ((+13+)) (14) "Native ornamental trees and shrubs" means any trees
15 or shrubs which are not nursery grown and which have been removed from
16 the ground with the roots intact.

17 ((+14- "Permit area" means a designated tract of land that may
18 contain single or multiple harvest sites)) (15) "Permittee" means a
19 person who is authorized by a permit issued consistent with this
20 chapter to harvest, possess, and transport specialized forest products
21 or to sell huckleberries.

22 ((+15+)) (16) "Permitter" means the landowner of the land from
23 where specialized forest products were, or are planned to be, harvested
24 under a permit issued consistent with this chapter.

25 (17) "Person" includes the plural and all corporations, foreign or
26 domestic, copartnerships, firms, and associations of persons.

27 ((+16+)) (18) "Processed cedar products" means ((cedar shakes,
28 shingles, fence posts, hop poles, pickets, stakes, rails, or rounds
29 less than one foot in length)) products made from the wood of a cedar
30 tree, including western red cedar, that have undergone more than an
31 insignificant degree of value-added processing and are not included in
32 the definition of "cedar products." Examples of processed cedar
33 products include, but are not limited to:

34 (a) Shakes;

35 (b) Shingles;

36 (c) Hop poles;

37 (d) Pickets; and

38 (e) Stakes.

1 ~~((17) "Sheriff" means, for the purpose of validating specialized~~
2 ~~forest products permits, the county sheriff, deputy sheriff, or an~~
3 ~~authorized employee of the sheriff's office or an agent of the office.~~

4 ~~(18))~~ (19) "Sales invoice" means a written or printed itemized
5 list or statement of particulars pertinent to the transportation or
6 possession of a specialized forest product prepared consistent with RCW
7 76.48.080 (as recodified by this act).

8 (20) "Secondary specialized forest products buyer" means any person
9 who receives any specialized forest products after the transaction with
10 the first specialized forest products buyer.

11 (21) "Specialized forest products" means ~~((Christmas trees, native~~
12 ~~ornamental trees and shrubs, cut or picked evergreen foliage, cedar~~
13 ~~products, cedar salvage, processed cedar products, specialty wood, wild~~
14 ~~edible mushrooms, and Cascara bark))~~ the following:

15 (a) Specialty wood;

16 (b) More than five Christmas trees;

17 (c) More than five native ornamental trees and shrubs;

18 (d) More than twenty pounds of cut or picked evergreen foliage;

19 (e) More than five pounds of Cascara bark; and

20 (f) More than five United States gallons of wild edible mushrooms.

16 **Sec. 4.** RCW 76.48.060 and 2008 c 191 s 3 are each amended to read
17 as follows:

18 (1) Except as provided in RCW 76.48.100 (as recodified by this
19 act), a completed specialized forest products permit ~~((validated by the~~
20 county sheriff shall be obtained by a person prior to)) issued under
21 this chapter is required prior to engaging in the following activities:

22 (a) Harvesting any specialized forest products from any lands,
23 including his or her own~~((, more than five Christmas trees, more than~~
24 five native ornamental trees or shrubs, more than five pounds of cut or
25 picked evergreen foliage, any cedar products, cedar salvage, processed
26 cedar products, or more than five pounds of Cascara bark, or more than
27 five United States gallons of a single species of wild edible mushroom;
28 or

29 ~~(b) Selling, or offering for sale, any amount of raw or unprocessed~~
30 ~~huckleberries.~~

31 ~~(2) Specialized forest products permit forms shall be provided by~~
32 ~~the department of natural resources, and shall be made available~~

34 ~~reasonable quantities. A permit form shall be completed in triplicate~~
35 ~~for each permitter's property on which a permittee harvests specialized~~
36 ~~forest products. A properly completed permit form shall be mailed or~~

1 presented for validation to the sheriff of the county in which the
2 specialized forest products are to be harvested.

3 (3) Before a permit form is validated by the sheriff, sufficient
4 personal identification may be required to reasonably identify the
5 person mailing or presenting the permit form and the sheriff may
6 conduct other investigations as deemed necessary to determine the
7 validity of the information alleged on the form. When the sheriff is
8 reasonably satisfied as to the truth of the information, the form shall
9 be validated with the sheriff's validation stamp.

10 (4) Upon validation, the form shall become the specialized forest
11 products permit authorizing the harvesting, possession, or
12 transportation of specialized forest products and the sale of
13 huckleberries, subject to any other conditions or limitations which the
14 permitter may specify. Two copies of the permit shall be given or
15 mailed to the permitter, or one copy shall be given or mailed to the
16 permitter and the other copy given or mailed to the permittee. The
17 original permit shall be retained in the office of the county sheriff
18 validating the permit.

19 (5) In the event a single land ownership is situated in two or more
20 counties, a specialized forest product permit shall be completed as to
21 the land situated in each county.

22 (6) While engaged in harvesting of specialized forest products,
23 permittees, or their agents or employees, must have readily available
24 at each harvest site a valid permit or true copy of the permit.)) land.

25 (b) Possessing or transporting any specialized forest products,
26 unless the person has in his or her possession either of the following
27 in lieu of a permit:

28 (i) A true copy of the permit;

29 (ii) If the person is transporting the specialized forest product
30 from a location other than the harvest site or is a first or secondary
31 specialized forest products buyer, a sales invoice, bill of lading, or,
32 for the possession and transportation of Christmas trees only, an
33 authorization if a copy of the authorization has been filed prior to
34 the harvest of the Christmas trees with the sheriff's office for the
35 county in which the Christmas trees are to be harvested;

36 (iii) A bill of lading or documentation issued in or by another
37 state, a Canadian province, or the federal government indicating the

1 true origin of the specialized forest products as being outside of
2 Washington; or

3 (iv) If the products were harvested within the operational area
4 defined by a valid forest practices application or notification under
5 chapter 76.09 RCW, a sequentially numbered load ticket generated by the
6 landowner or the landowner's agent that includes, at a minimum, all
7 information required on a bill of lading and the forest practices
8 application number.

9 (c) Selling, or offering for sale, any amount of raw or unprocessed
10 huckleberries, regardless if the huckleberries were harvested with the
11 consent of the landowner, unless the possessor of the huckleberries
12 being offered for sale is able to show that the huckleberries
13 originated on land owned by the United States forest service and
14 displays a valid permit from the United States forest service that
15 lawfully entitles the possessor to harvest the huckleberries in
16 question.

17 (2)(a) Unless otherwise designated by the permittor as provided in
18 this subsection, a permit or true copy must be readily available for
19 inspection at each harvest site.

20 (b) An individual permit or true copy must be carried and made
21 readily available for inspection by each individual permittee at a
22 harvest site if the permittor designated an individual permit or true
23 copy as an additional condition or limitation specified on the permit
24 under RCW 76.48.050 (as recodified by this act).

25 **Sec. 5.** RCW 76.48.080 and 1979 ex.s. c 94 s 7 are each amended to
26 read as follows:

9 NEW SECTION. Sec. 6. A new section is added to chapter 76.48 RCW
10 to read as follows:

11 (1) A true copy of a specialized forest products permit is valid
12 if:

13 (a) The copy is reproduced by a copy machine capable of effectively
14 reproducing the permit information required under RCW 76.48.050 (as
15 recodified by this act); and

16 (b)(i) The permittee has provided an original signature in the
17 space provided on the face of the copy.

18 (ii) An actual signature of the permittor is also required for a
19 true copy to be valid if the permittor indicates on the space provided
20 for signatures on the original permit that the actual signature of the
21 permittor is required for the validation of any copies.

22 (2) A true copy is effective until the expiration date of the
23 underlying permit unless an earlier date is provided by the signatories
24 to the copy.

25 (3) Either signatory to a permit may condition the use of the true
26 copy for only harvesting, only possessing, only transporting, or a
27 combination of harvesting, possessing, and transporting the associated
28 specialized forest products by indicating the limitations of the true
29 copy on the permit or the copy.

30 (4) Any permittee issuing a true copy must record and retain for
31 one year the following information:

32 (a) The date the true copy is issued;

33 (b) The license plate number and make and model of the vehicle to
34 be used with the true copy;

35 (c) The name and address of the person receiving the true copy;

36 (d) The unique number assigned to a valid state identification
37 document issued to the person; and

1 (e) The expiration date of the true copy.

2 NEW SECTION. **Sec. 7.** A new section is added to chapter 76.48 RCW
3 to read as follows:

4 (1)(a) Except for the sale of huckleberries, the permit
5 requirements of RCW 76.48.060 (as recodified by this act) may be
6 satisfied with either a validated permit or a verifiable permit. The
7 decision to use a validated or verifiable permit must be made and
8 agreed upon jointly by the permittee and the permittor.

9 (b) For the sale of huckleberries, only a validated permit
10 satisfies the requirements of RCW 76.48.060 (as recodified by this
11 act).

12 (2)(a) Forms for both validated permits and verifiable permits must
13 be provided by the department and be made available in reasonable
14 quantities through county sheriff offices and other locations deemed
15 appropriate by the department.

16 (b) In designing the forms, the department shall ensure that:

17 (i) All mandatory requirements of this chapter are satisfied;

18 (ii) The type of permit is clearly marked on the form;

19 (iii) Each permit is separately numbered and the issuance of the
20 permits are by unique numbers; and

21 (iv) The form is designed in a manner allowing a permittor to
22 require his or her signature on all true copies as provided in section
23 6 of this act.

24 (3) Permit forms must be completed in triplicate for each property
25 and in each county in which specialized forest products are proposed to
26 be harvested or huckleberries sold.

27 (4)(a) Within five business days after the signature of the
28 permittor on the form for a verifiable permit, as required in RCW
29 76.48.050 (as recodified by this act), the original permit form must be
30 provided by the permittee to the sheriff of the county in which the
31 specialized forest products are to be harvested. The permittee may
32 provide the permit form in a manner convenient to the permittee and the
33 sheriff's office, including in-person presentation or by mail. If
34 mailed, the permit form must be postmarked within the time window
35 established under this subsection.

36 (b) Upon full completion, as provided in RCW 76.48.050 (as
37 recodified by this act), the permit form for a validated permit must,

1 except for permits to sell huckleberries, be mailed or presented for
