1            AN ACT Relating to authority of the board of directors of a public  
2 facilities district; and amending RCW 36.100.160 and 35.57.060.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4            **Sec. 1.** RCW 36.100.160 and 1995 c 396 s 13 are each amended to  
5 read as follows:

6            (1) The board of directors of the public facilities district shall  
7 have authority to authorize the expenditure of funds for the public  
8 purposes of preparing and distributing information to the general  
9 public and promoting, advertising, improving, developing, operating,  
10 and maintaining facilities of the district. For promotional activities  
11 the district board must: (a) Identify the proposed expenditure in its  
12 annual budget; and (b) adopt written rules governing promotional  
13 hosting by employees, agents, and the board, including requirements for  
14 identifying and evaluating the public benefits to be derived and  
15 documenting the public benefits realized.

16            (2) Nothing contained in this section may be construed to authorize  
17 preparation and distribution of information to the general public for  
18 the purpose of influencing the outcome of a district election.

1       **Sec. 2.** RCW 35.57.060 and 1999 c 165 s 6 are each amended to read  
2 as follows:

3       (1) The board of directors of the public facilities district shall  
4 have authority to authorize the expenditure of funds for the public  
5 purposes of preparing and distributing information to the general  
6 public and promoting, advertising, improving, developing, operating,  
7 and maintaining a regional center. For promotional activities the  
8 district board must: (a) Identify the proposed expenditure in its  
9 annual budget; and (b) adopt written rules governing promotional  
10 hosting by employees, agents, and the board, including requirements for  
11 identifying and evaluating the public benefits to be derived and  
12 documenting the public benefits realized.

13       (2) Nothing contained in this section may be construed to authorize

15 the purpose of influencing the outcome of a district election.
