1            AN ACT Relating to the delivery of educational services to children  
2 who are deaf and hearing impaired; amending RCW 72.40.010, 72.40.019,  
3 72.40.024, 72.40.028, 72.40.120, 72.40.200, 72.40.210, 72.40.031,  
4 72.42.010, 72.42.015, 72.42.016, 72.42.021, 72.42.041, 72.40.070,  
5 72.40.220, 72.40.250, 72.40.280, 72.42.060, 26.44.210, 28A.155.160,  
6 28A.310.010, 28A.310.180, 28A.310.200, 28A.335.205, 28A.400.303,  
7 28A.400.305, 28A.600.420, 41.40.088, and 70.198.020; adding new  
8 sections to chapter 72.42 RCW; creating new sections; repealing RCW  
9 72.40.023; and providing an expiration date.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

11            NEW SECTION.    **Sec. 1.** The legislature finds that the education of  
12 children who are deaf presents unique challenges because deafness is a  
13 low-incidence disability significantly impacting the child's ability to  
14 access communication at home, at school, and in the community. The  
15 legislature further finds that over the past fifty years, there have  
16 been numerous advances in technology as well as a growing awareness  
17 about the importance of delivering services to children in a variety of  
18 communication modalities to support their early and continued access to  
19 communication. The legislature intends to enhance the coordination of

1 regionally delivered educational services and supports for children who  
2 are deaf or hard of hearing and to promote the development of  
3 communication-rich learning environments for these children.

4 NEW SECTION. **Sec. 2.** A new section is added to chapter 72.42 RCW  
5 to read as follows:

6 (1) The Washington state center for childhood deafness and hearing  
7 loss is established to provide statewide leadership for the  
8 coordination and delivery of educational services to children who are  
9 deaf or hard of hearing. The activities of the center shall be under  
10 the authority of the director and the board of trustees. The  
11 superintendent and board of trustees of the state school for the deaf  
12 as of the effective date of this section shall be the director and  
13 board of trustees of the center.

14 (2) The center's primary functions are:

15 (a) Managing and directing the supervision of the state school for  
16 the deaf;

17 (b) Providing statewide leadership and support for the coordination  
18 of regionally delivered educational services in the full range of  
19 communication modalities, for children who are deaf or hard of hearing;  
20 and

21 (c) Collaborating with appropriate public and private partners for  
22 the training and professional development of educators serving children  
23 who are deaf or hard of hearing.

24 **Sec. 3.** RCW 72.40.010 and 2002 c 209 s 1 are each amended to read  
25 as follows:

26 There are established at Vancouver, Clark county, a school which  
27 shall be known as the state school for the blind, and a separate school  
28 which shall be known as the state school for the deaf. The primary  
29 purpose of the state school for the blind and the state school for the  
30 deaf is to educate and train hearing and visually impaired children.

31 The school for the blind shall be under the direction of the  
32 superintendent with the advice of the board of trustees. The school  
33 for the deaf shall be under the direction of the (~~superintendent~~)  
34 director of the center or the director's designee and the board of  
35 trustees.

1       **Sec. 4.** RCW 72.40.019 and 1985 c 378 s 14 are each amended to read  
2 as follows:

3       The governor shall appoint a (~~(superintendent)~~) director for the  
4 (~~(state school for the deaf)~~) Washington state center for childhood  
5 deafness and hearing loss. The (~~(superintendent)~~) director shall have  
6 a masters or higher degree from an accredited college or university in  
7 school administration or deaf education, five or more years of  
8 experience teaching or providing habilitative services to deaf or hard  
9 of hearing students (~~(in the classroom)~~), and three or more years  
10 administrative or supervisory experience in programs for deaf or hard  
11 of hearing students.

12       NEW SECTION. **Sec. 5.** A new section is added to chapter 72.42 RCW  
13 to read as follows:

14       In addition to any other powers and duties prescribed by law, the  
15 director of the Washington state center for childhood deafness and  
16 hearing loss:

17       (1) Shall be responsible for the supervision and management of the  
18 center, including the state school for the deaf, and the property of  
19 various kinds. The director may designate an individual to oversee the  
20 day-to-day operation and supervision of students at the school;

21       (2) Shall employ members of the faculty, administrative officers,  
22 and other employees, who shall all be subject to chapter 41.06 RCW, the  
23 state civil service law, unless specifically exempted by other  
24 provisions of law;

25       (3) Shall provide technical assistance and support as appropriate  
26 to local and regional efforts to build critical mass and  
27 communication-rich networking opportunities for children who are deaf  
28 or hard of hearing and their families;

29       (4) Shall establish the course of study including vocational  
30 training, with the assistance of the faculty and the approval of the  
31 board of trustees;

32       (5) Shall, as approved by the board of trustees, control and  
33 authorize the use of the facilities for night school, summer school,  
34 public meetings, applied research and training for the instruction of  
35 students who are deaf or hard of hearing, outreach and support to  
36 families of children who are deaf or hard of hearing, or other purposes  
37 consistent with the purposes of the center;

1 (6) Shall purchase all supplies and lease or purchase equipment and  
2 other personal property needed for the operation or maintenance of the  
3 center;

4 (7) Shall prepare, submit to the board of trustees for approval,  
5 and administer the budget consistent with RCW 43.88.160 and the budget  
6 and accounting act, chapter 43.88 RCW generally, as applicable;

7 (8) Shall provide technical assistance and support to educational  
8 service districts for the regional delivery of a full range of  
9 educational services to students who are deaf or hard of hearing,  
10 including but not limited to services relying on American Sign  
11 Language, auditory oral education, total communication, and signed  
12 exact English;

13 (9) As requested by educational service districts, shall recruit,  
14 employ, and deploy itinerant teachers to provide in-district services  
15 to children who are deaf or hard of hearing;

16 (10) May establish criteria, in addition to state certification,  
17 for the teachers at the school and employees of the center;

18 (11) May establish, with the approval of the board of trustees, new  
19 facilities as needs demand;

20 (12) May adopt rules, under chapter 34.05 RCW, as approved by the  
21 board of trustees and as deemed necessary for the governance,  
22 management, and operation of the center;

23 (13) May adopt rules, as approved by the board of trustees, for  
24 pedestrian and vehicular traffic on property owned, operated, and  
25 maintained by the center;

26 (14) Except as otherwise provided by law, may enter into contracts  
27 as the director deems essential to the purpose of the center;

28 (15) May receive gifts, grants, conveyances, devises, and bequests  
29 of real or personal property from whatever source, as may be made from  
30 time to time, in trust or otherwise, whenever the terms and conditions  
31 will aid in carrying out the programs of the center; sell, lease, or  
32 exchange, invest, or expend the same or the proceeds, rents, profits,  
33 and income thereof except as limited by the terms and conditions  
34 thereof; and adopt rules to govern the receipt and expenditure of the  
35 proceeds, rents, profits, and income thereof;

36 (16) May adopt rules, as approved by the board of trustees,  
37 providing for the transferability of employees between the center and

1 the school for the blind consistent with collective bargaining  
2 agreements in effect; and

3 (17) May adopt rules under chapter 34.05 RCW, as approved by the  
4 board of trustees, and perform all other acts not forbidden by law as  
5 the director deems necessary or appropriate to the administration of  
6 the center.

7 **Sec. 6.** RCW 72.40.024 and 2002 c 209 s 4 are each amended to read  
8 as follows:

9 In addition to the powers and duties under RCW 72.40.022 (~~and~~  
10 ~~72.40.023~~) and section 5 of this act, the superintendent of (~~each~~)  
11 the school for the blind and the director of the Washington state  
12 center for childhood deafness and hearing loss, or the director's  
13 designee, shall:

14 (1) Monitor the location and educational placement of each student  
15 reported to the superintendent(~~s~~) and the director, or the director's  
16 designee, by the educational service district superintendents;

17 (2) Provide information about educational programs, instructional  
18 techniques, materials, equipment, and resources available to students  
19 with visual or auditory impairments to the parent or guardian,  
20 educational service district superintendent, and the superintendent of  
21 the school district where the student resides; and

22 (3) Serve as a consultant to the office of the superintendent of  
23 public instruction, provide instructional leadership, and assist school  
24 districts in improving their instructional programs for students with  
25 visual or hearing impairments.

26 **Sec. 7.** RCW 72.40.028 and 2006 c 263 s 829 are each amended to  
27 read as follows:

28 All teachers (~~at the state school for the deaf~~) employed by the  
29 Washington state center for childhood deafness and hearing loss and the  
30 state school for the blind shall meet all certification requirements  
31 and the programs shall meet all accreditation requirements and conform  
32 to the standards defined by law or by rule of the Washington  
33 professional educator standards board or the office of the state  
34 superintendent of public instruction. The superintendent(~~s~~) and the  
35 director, by rule, may adopt additional educational standards for their  
36 respective (~~schools~~) facilities. Salaries of all certificated

1 employees shall be set so as to conform to and be contemporary with  
2 salaries paid to other certificated employees of similar background and  
3 experience in the school district in which the program or facility is  
4 located. The superintendent(~~(s)~~) and the director may provide for  
5 provisional certification for teachers in their respective (~~(schools)~~)  
6 facilities including certification for emergency, temporary,  
7 substitute, or provisional duty.

8 **Sec. 8.** RCW 72.40.120 and 1991 c 65 s 1 are each amended to read  
9 as follows:

10 Any appropriation for the (~~(school for the deaf)~~) Washington state  
11 center for childhood deafness and hearing loss or the school for the  
12 blind shall be made directly to the (~~(school for the deaf)~~) center or  
13 the school for the blind.

14 **Sec. 9.** RCW 72.40.200 and 2000 c 125 s 1 are each amended to read  
15 as follows:

16 The (~~(state school for the deaf)~~) Washington state center for  
17 childhood deafness and hearing loss and the state school for the blind  
18 shall promote the personal safety of students and protect the children  
19 who attend from child abuse and neglect as defined in RCW 26.44.020.

20 **Sec. 10.** RCW 72.40.210 and 2000 c 125 s 2 are each amended to read  
21 as follows:

22 The (~~(superintendents)~~) director of the (~~(state school for the~~  
23 ~~deaf)~~) Washington state center for childhood deafness and hearing loss  
24 and the superintendent of the state school for the blind or their  
25 designees shall immediately report to the persons indicated the  
26 following events:

27 (1) To the child's parent, custodian, or guardian:

28 (a) The death of the child;

29 (b) Hospitalization of a child in attendance or residence at the  
30 (~~(school)~~) facility;

31 (c) Allegations of child abuse or neglect in which the parent's  
32 child in attendance or residence at the (~~(school)~~) facility is the  
33 alleged victim;

34 (d) Allegations of physical or sexual abuse in which the parent's

1 child in attendance or residence at the (~~school~~) facility is the  
2 alleged perpetrator;

3 (e) Life-threatening illness;

4 (f) The attendance at the (~~school~~) facility of any child who is  
5 a registered sex offender under RCW 9A.44.130 as permitted by RCW  
6 4.24.550.

7 (2) Notification to the parent shall be made by the means most  
8 likely to be received by the parent. If initial notification is made  
9 by telephone, such notification shall be followed by notification in  
10 writing within forty-eight hours after the initial (~~oral~~) verbal  
11 contact is made.

12 NEW SECTION. Sec. 11. (1) The state school for the deaf is hereby  
13 abolished and its powers, duties, and functions are hereby transferred  
14 to the Washington state center for childhood deafness and hearing loss.  
15 All references to the superintendent or the state school for the deaf  
16 in the Revised Code of Washington shall be construed to mean the  
17 director or the Washington state center for childhood deafness and  
18 hearing loss.

19 (2)(a) All reports, documents, surveys, books, records, files,  
20 papers, or written material in the possession of the state school for  
21 the deaf shall be delivered to the custody of the Washington state  
22 center for childhood deafness and hearing loss. All cabinets,  
23 furniture, office equipment, motor vehicles, and other tangible  
24 property employed by the state school for the deaf shall be made  
25 available to the Washington state center for childhood deafness and  
26 hearing loss. All funds, credits, or other assets held by the state  
27 school for the deaf shall be assigned to the Washington state center  
28 for childhood deafness and hearing loss.

29 (b) Any appropriations made to the state school for the deaf shall,  
30 on the effective date of this section, be transferred and credited to  
31 the Washington state center for childhood deafness and hearing loss.

32 (c) If any question arises as to the transfer of any personnel,  
33 funds, books, documents, records, papers, files, equipment, or other  
34 tangible property used or held in the exercise of the powers and the  
35 performance of the duties and functions transferred, the director of  
36 financial management shall make a determination as to the proper  
37 allocation and certify the same to the state agencies concerned.



1 (3) All employees of the state school for the deaf are transferred  
2 to the jurisdiction of the Washington state center for childhood  
3 deafness and hearing loss. All employees classified under chapter  
4 41.06 RCW, the state civil service law, are assigned to the Washington  
5 state center for childhood deafness and hearing loss to perform their  
6 usual duties upon the same terms as formerly, without any loss of  
7 rights, subject to any action that may be appropriate thereafter in  
8 accordance with the laws and rules governing state civil service.

9 (4) All rules and all pending business before the state school for  
10 the deaf shall be continued and acted upon by the Washington state  
11 center for childhood deafness and hearing loss. All existing contracts  
12 and obligations shall remain in full force and shall be performed by  
13 the Washington state center for childhood deafness and hearing loss.

14 (5) The transfer of the powers, duties, functions, and personnel of  
15 the state school for the deaf shall not affect the validity of any act  
16 performed before the effective date of this section.

17 (6) If apportionments of budgeted funds are required because of the  
18 transfers directed by this section, the director of financial  
19 management shall certify the apportionments to the agencies affected,  
20 the state auditor, and the state treasurer. Each of these shall make  
21 the appropriate transfer and adjustments in funds and appropriation  
22 accounts and equipment records in accordance with the certification.

23 (7) The existing bargaining units shall be transferred in their  
24 entirety without the merging of other bargaining units or the inclusion  
25 of employees from other bargaining units. Nothing contained in this  
26 section may be construed to alter any of the existing collective  
27 bargaining units unless the bargaining unit has been modified by action  
28 of the public employment relations commission as provided by law.  
29 Therefore, the certification of the existing bargaining units shall  
30 remain. However, the commission may, upon request, amend the  
31 certification to reflect the name of the new agency. In addition,  
32 nothing in this section may be construed to alter the provisions of any  
33 existing collective bargaining agreement until the agreement has  
34 expired.

35 **Sec. 12.** RCW 72.40.031 and 1985 c 378 s 16 are each amended to  
36 read as follows:

37 The school year for the state school for the blind and the state

1 school for the deaf shall commence on the first day of July of each  
2 year and shall terminate on the 30th day of June of the succeeding  
3 year. The regular school term shall be for a period of nine months and  
4 shall commence as near as reasonably practical at the time of the  
5 commencement of regular terms in ~~((the))~~ other public schools, with the  
6 equivalent number of days as are now required by law, and the  
7 regulations of the superintendent of public instruction as now or  
8 hereafter amended, during the school year in ~~((the))~~ other public  
9 schools. The school and the center shall observe all legal holidays,  
10 in the same manner as other agencies of state government, and ~~((the~~  
11 ~~schools))~~ will not be in session on such days and such other days as  
12 may be approved by the ~~((respective))~~ superintendent~~((s))~~ or the  
13 director. During the period when the schools are not in session during  
14 the regular school term, schools may be operated, subject to the  
15 approval of the ~~((respective))~~ superintendent~~((s))~~ or the director or  
16 the director's designee, for the instruction of students or for such  
17 other reasons which are in furtherance of the objects and purposes of  
18 ~~((such schools))~~ the respective facilities.

19 **Sec. 13.** RCW 72.42.010 and 2002 c 209 s 5 are each amended to read  
20 as follows:

21 It is the intention of the legislature, in creating a board of  
22 trustees for the ~~((state school for the deaf))~~ Washington state center  
23 for childhood deafness and hearing loss to perform the duties set forth  
24 in this chapter, that the board of trustees perform needed oversight  
25 services to the governor and the legislature of the ~~((Washington state~~  
26 ~~school for the deaf))~~ center in the development of programs for the  
27 hard of hearing ~~((impaired))~~, and in the operation of the ~~((Washington~~  
28 ~~state))~~ center, including the school for the deaf.

29 **Sec. 14.** RCW 72.42.015 and 1985 c 378 s 32 are each amended to  
30 read as follows:

31 Unless the context clearly requires otherwise as used in this  
32 chapter "~~((superintendent))~~ director" means ~~((superintendent))~~ the  
33 director of the Washington state ~~((school for the deaf))~~ center for  
34 childhood deafness and hearing loss.

1       **Sec. 15.** RCW 72.42.016 and 2002 c 209 s 6 are each amended to read  
2 as follows:

3       Unless the context clearly requires otherwise, as used in this  
4 chapter:

5       (1) "Center" means the Washington state center for childhood  
6 deafness and hearing loss serving local school districts across the  
7 state; and

8       (2) "School" means the Washington state residential school for the  
9 deaf located in Vancouver, Washington.

10       **Sec. 16.** RCW 72.42.021 and 2002 c 209 s 7 are each amended to read  
11 as follows:

12       (1) The governance of the center and the school shall be vested in  
13 a board of trustees. The board shall consist of nine members appointed  
14 by the governor, with the consent of the senate. The board shall be  
15 composed of a resident from each of the state's congressional districts  
16 and may include:

17       (a) One member who is deaf or hard of hearing (~~(impaired)~~);

18       (b) Two members who are experienced educational professionals;

19       (c) One member who is experienced in providing residential services  
20 to youth; and

21       (d) One member who is the parent of a child who is deaf or hard of  
22 hearing (~~(impaired)~~) and who is receiving or has received educational  
23 services related to deafness or hearing impairment from a public  
24 educational institution.

25       (2) No voting trustee may be an employee of the school or the  
26 center, a member of the board of directors of any school district, a  
27 member of the governing board of any public or private educational  
28 institution(~~(, a school district or educational service district~~  
29 ~~administrator appointed after July 1, 1986,)) or an elected officer or  
30 member of the legislative authority of any municipal corporation. No  
31 more than two voting trustees may be school district or educational  
32 service district administrators appointed after July 1, 1986.~~

33       (3) Trustees shall be appointed by the governor to serve a term of  
34 five years, except that any person appointed to fill a vacancy  
35 occurring prior to the expiration of a term shall be appointed within  
36 sixty days of the vacancy and appointed only for the remainder of the

1 term. Of the initial members, three must be appointed for two-year  
2 terms, three must be appointed for three-year terms, and the remainder  
3 must be appointed for five-year terms.

4 (4) The board shall not be deemed unlawfully constituted and a  
5 trustee shall not be deemed ineligible to serve the remainder of the  
6 trustee's unexpired term on the board solely by reason of the  
7 establishment of new or revised boundaries for congressional districts.  
8 In such an event, each trustee may continue to serve in office for the  
9 balance of the term for which he or she was appointed so long as the  
10 trustee continues to reside within the boundaries of the congressional  
11 district as they existed at the time of his or her appointment.  
12 Vacancies which occur in a trustee position during the balance of any  
13 term shall be filled pursuant to subsection (3) of this section by a  
14 successor who resides within the boundaries of the congressional  
15 district from which the member whose office was vacated was appointed  
16 as they existed at the time of his or her appointment. At the  
17 completion of such term, and thereafter, a successor shall be appointed  
18 from the congressional district which corresponds in number with the  
19 congressional district from which the incumbent was appointed.

20 **Sec. 17.** RCW 72.42.041 and 2002 c 209 s 8 are each amended to read  
21 as follows:

22 The board of trustees of the ((~~school~~)) center:

23 (1) Shall adopt rules and regulations for its own governance;

24 (2) Shall direct the development of, approve, and monitor the  
25 enforcement of policies, rules, and regulations pertaining to the  
26 school and the center, including but not limited to:

27 (a) The use of classrooms and other facilities for summer or night  
28 schools or for public meetings and any other uses consistent with the  
29 mission of the center;

30 (b) Pedestrian and vehicular traffic on property owned, operated,  
31 or maintained by the ((~~school~~)) center;

32 (c) Governance, management, and operation of the residential  
33 facilities;

34 (d) Transferability of employees between the ((~~school for the~~  
35 ~~deaf~~)) center and the school for the blind consistent with collective  
36 bargaining agreements in effect; and

- 1 (e) Compliance with state and federal education civil rights laws  
2 at the school;
- 3 (3) Shall develop a process for recommending candidates for the  
4 position of (~~superintendent~~) director and upon a vacancy shall submit  
5 a list of three qualified candidates for (~~superintendent~~) director to  
6 the governor;
- 7 (4) Shall submit an evaluation of the (~~superintendent~~) director  
8 to the governor by July 1st of each odd-numbered year that includes a  
9 recommendation regarding the retention of the (~~superintendent~~)  
10 director;
- 11 (5) May recommend to the governor at any time that the  
12 (~~superintendent~~) director be removed for conduct deemed by the board  
13 to be detrimental to the interests of the (~~school~~) center;
- 14 (6) Shall prepare and submit by July 1st of each even-numbered year  
15 a report to the governor and the appropriate committees of the  
16 legislature which contains a detailed summary of the (~~school's~~)  
17 center's progress on performance objectives and the (~~school's~~)  
18 center's work, facility conditions, and revenues and costs of the  
19 (~~school~~) center for the previous year and which contains those  
20 recommendations it deems necessary and advisable for the governor and  
21 the legislature to act on;
- 22 (7) Shall approve the (~~school's~~) center's budget and all funding  
23 requests, both operating and capital, submitted to the governor;
- 24 (8) Shall direct and approve the development and implementation of  
25 comprehensive programs of education, training, and as needed  
26 residential living, such that students served by the school receive a  
27 challenging and quality education in a safe school environment;
- 28 (9) Shall direct, monitor, and approve the implementation of a  
29 comprehensive continuous quality improvement system for the (~~school~~)  
30 center;
- 31 (10) Shall monitor and inspect all existing facilities of the  
32 (~~school~~) center and report its findings in its biennial report to the  
33 governor and appropriate committees of the legislature; and
- 34 (11) May grant to every student of the school, upon graduation or  
35 completion of a program or course of study, a suitable diploma,  
36 nonbaccalaureate degree, or certificate.

1       **Sec. 18.** RCW 72.40.070 and 1985 c 378 s 22 are each amended to  
2 read as follows:

3       It shall be the duty of each educational service district to make  
4 a full and specific report of visually (~~or hearing~~) impaired or deaf  
5 or hard of hearing youth to the superintendent of the school for the  
6 blind or the (~~school for the deaf~~) director of the Washington state  
7 center for childhood deafness and hearing loss, or the director's  
8 designee, as the case may be and the superintendent of public  
9 instruction, annually. The superintendent of public instruction shall  
10 report about the deaf or hard of hearing or visually impaired youth to  
11 the school for the blind and the (~~school for the deaf~~) Washington  
12 state center for childhood deafness and hearing loss, as the case may  
13 be, annually.

14       **Sec. 19.** RCW 72.40.220 and 2000 c 125 s 3 are each amended to read  
15 as follows:

16       (1) The (~~superintendents~~) director of the (~~state school for the~~  
17 ~~deaf~~) Washington state center for childhood deafness and hearing loss,  
18 or the director's designee, and the superintendent of the state school  
19 for the blind shall maintain in writing and implement behavior  
20 management policies and procedures that accomplish the following:

21       (a) Support the child's appropriate social behavior, self-control,  
22 and the rights of others;

23       (b) Foster dignity and self-respect for the child;

24       (c) Reflect the ages and developmental levels of children in care.

25       (2) The state school for the deaf and the state school for the

33 deaf or hard of hearing. One demonstration site shall be in an  
34 educational service district in eastern Washington. Information may be  
35 gathered through meetings conducted in educational service district

1 regions and through other appropriate means, including the P-20 network  
2 and internet technologies. Stakeholders from whom information shall be  
3 solicited include, but are not limited to:

4 (a) The office of the superintendent of public instruction,  
5 including the Washington sensory disabilities services office;

6 (b) The office of deaf and hard of hearing services in the  
7 department of social and health services;

8 (c) Educational service district superintendents and school  
9 district superintendents;

10 (d) Parents of school-age children who are deaf or hard of hearing,  
11 including organizations advocating for the educational interests of all  
12 children who are deaf or hard of hearing without regard to any specific  
13 communication modality;

14 (e) Students who are deaf or hard of hearing;

15 (f) Adults who are deaf or hard of hearing;

16 (g) Nongovernmental entities providing educational services in the  
17 following communication modalities: Oral communication, manual  
18 communication, and total communication;

19 (h) The department of health; and

20 (i) The department of early learning.

21 (2) Based on the information gathered from stakeholders, the board  
22 and the director of the center for childhood deafness and hearing loss  
23 shall develop a structure and plan for implementing regional education  
24 programs at two demonstration sites that:

25 (a) Are established within an educational service district and  
26 managed through shared governance by the school districts;

27 (b) Collaborate and partner with, enhance, and avoid duplication of  
28 existing and available services and programs, both public and private;

29 (c) Provide services at one or more central locations in the  
30 education service districts;

31 (d) Provide services to students in their resident districts,  
32 including students who are deaf or hard of hearing who may not qualify  
33 for special education services;

34 (e) Include educational and transportation services for children,  
35 consultation for teachers and staff, and outreach to families; and

36 (f) Support communication-rich learning environments and  
37 instruction of students in the full spectrum of communication

1 modalities by qualified professionals, including American Sign  
2 Language, auditory oral education, total communication, and signed  
3 exact English.

4 (3) By December 1, 2010, the board and the director shall brief the  
5 legislature and the governor with a recommendation for the location,  
6 structure, and governance of the demonstration sites.

7 (4) This section expires January 1, 2011.
