1 AN ACT Relating to modernizing the criteria for membership on the
2 board of natural resources without altering the number of members; and
3 amending RCW 43.30.205.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 43.30.205 and 2003 c 334 s 104 are each amended to
6 read as follows:

7 (1) The board shall consist of six members:

8 (a) The governor or the governor's designee((~~τ~~));

9 (b) The superintendent of public instruction((~~τ~~));

10 (c) The commissioner ((~~of public lands, the dean of the college of~~
11 forest resources of the University of Washington, the dean of the
12 college of agriculture of Washington State University,));

13 (d) The director of the University of Washington school of forest
14 resources;

15 (e) The dean of the Washington State University college of
16 agricultural, human, and natural resource sciences; and

17 (f) A representative of those counties that contain state forest
18 lands acquired or transferred under RCW 79.22.010, 79.22.040, and
19 79.22.020.

1 (2)(a) The county representative on the board shall be selected by
2 the legislative authorities of those counties that contain state forest
3 lands acquired or transferred under RCW 79.22.010, 79.22.040, and
4 79.22.020. In the selection of the county representative, each
5 participating county shall have one vote. The Washington state
6 association of counties shall (~~conduct~~) convene a meeting for the
7 purpose of making the selection and shall notify the board of the
8 selection.

9 (b) The county representative (~~shall~~) must be a duly elected
10 member of a county legislative authority who shall serve a term of four
11 years unless the representative should leave office for any reason.
12 The initial term shall begin on July 1, 1986.
