1 AN ACT Relating to the administration of irrigation districts; and
2 amending RCW 87.03.001, 87.03.436, and 87.03.443.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 87.03.001 and 1989 c 84 s 66 are each amended to read
5 as follows:

6 The formation of an irrigation district may be subject to potential
7 review by a boundary review board under chapter 36.93 RCW. The
8 alteration of the boundaries of an irrigation district, including but
9 not limited to a consolidation, addition of lands, exclusion of lands,
10 or merger, may be subject to potential review by a boundary review
11 board under chapter 36.93 RCW, except that additions or exclusions of
12 land to an irrigation district, when those lands are within the
13 boundary of a federal reclamation project, are not subject to review by
14 a boundary review board under chapter 36.93 RCW.

15 **Sec. 2.** RCW 87.03.436 and 1990 c 39 s 2 are each amended to read
16 as follows:

17 All contract projects, the estimated cost of which is less than
18 ((one)) three hundred thousand dollars, may be awarded ((to—a

1 contractor on)) using the small works roster(~~(. The small works roster~~
2 ~~shall be comprised of all responsible contractors who have requested to~~
3 ~~be on the list. The board of directors shall authorize by resolution~~
4 ~~a procedure for securing telephone and/or written quotations from the~~
5 ~~contractors on the small works roster to assure establishment of a~~
6 ~~competitive price and for awarding contracts to the lowest responsible~~
7 ~~bidder. Such procedure shall require that a good faith effort be made~~
8 ~~to request quotations from all responsible contractors on the small~~
9 ~~works roster. Immediately after an award is made, the bid quotations~~
10 ~~obtained shall be recorded, open to public inspection, and available by~~
11 ~~telephone inquiry. The small works roster shall be revised once a~~
12 ~~year)) process under RCW 39.04.155.~~

13 **Sec. 3.** RCW 87.03.443 and 2004 c 215 s 3 are each amended to read
14 as follows:

15 There may be created (~~for~~) by each irrigation district or
16 separate legal authority created pursuant to RCW 87.03.018 a fund to be
17 known as the upgrading and improvement fund. The board of directors
18 shall determine what portion of the annual revenue of the irrigation
19 district or separate legal authority will be placed into its upgrading
20 and improvement fund, including all or any part of the funds received
21 by a district or separate legal authority from the sale, delivery, and
22 distribution of electrical energy. Moneys from the upgrading and
23 improvement fund may (~~only~~) be used to modernize, improve, or upgrade
24 (~~the~~) irrigation and hydroelectric power facilities (~~of the~~
25 ~~irrigation district~~) or to respond to an emergency affecting such
26 facilities. The funds may also be used for licensing hydroelectric
27 power facilities and for payment of capital improvements.
