

1 NEW SECTION. **Sec. 101.** DESIGNATION. The college located and
2 established in Bellevue, King county, shall be designated Bellevue
3 College.

4 NEW SECTION. **Sec. 102.** TRUSTEES--APPOINTMENT--TERMS--QUORUM--
5 VACANCIES. (1) The governance of Bellevue College shall be vested in
6 a board of trustees consisting of eight members, one of whom shall be
7 a student. The governor shall select the student member from a list of
8 candidates, of at least three and not more than five, submitted by the
9 student body. They shall be appointed by the governor with the consent
10 of the senate and, except for the student member, shall hold their
11 offices for a term of six years from the first day of October and until
12 their successors are appointed and qualified. The student member shall
13 hold his or her office for a term of one year from the first day of
14 July and until the first day of July of the following year or until his
15 or her successor is appointed and qualified, whichever is later. The
16 student member shall be a full-time student in good standing at the
17 college at the time of appointment.

18 (2) Five members of the board constitute a quorum for the
19 transaction of business. In case of a vacancy, or when an appointment
20 is made after the date of expiration of the term, the governor shall
21 fill the vacancy for the remainder of the term of the trustee whose
22 office has become vacant or expired.

23 (3) Except for the term of the student member, no more than the
24 terms of two members will expire simultaneously on the last day of
25 September in any one year.

26 (4) A student appointed under this section shall excuse himself or
27 herself from participation or voting on matters relating to the hiring,
28 discipline, or tenure of faculty members and personnel.

29 (5) Beginning October 1, 2010, the members of the board of trustees
30 for the Bellevue community college district shall serve as members of
31 the board of trustees of Bellevue College until the expiration of their
32 terms.

33 NEW SECTION. **Sec. 103.** TRUSTEES--ORGANIZATION AND OFFICERS OF
34 BOARD--QUORUM. The board of trustees of Bellevue College shall elect
35 one of its members chairman, and it shall elect a secretary, who may or
36 may not be a member of the board. The board shall have power to adopt

1 bylaws for its government and for the government of the school, which
2 bylaws shall not be inconsistent with law, and to prescribe the duties
3 of its officers, committees and employees. A majority of the board
4 shall constitute a quorum for the transaction of all business.

5 NEW SECTION. **Sec. 104.** TRUSTEES--MEETINGS OF BOARD. The board of
6 Bellevue College trustees shall hold at least two regular meetings each
7 year, at such times as may be provided by the board. Special meetings
8 shall be held as may be deemed necessary, whenever called by the
9 chairman or by a majority of the board. Public notice of all meetings
10 shall be given in accordance with chapter 42.32 RCW.

11 NEW SECTION. **Sec. 105.** TRUSTEES--GENERAL POWERS AND DUTIES OF
12 BOARD. In addition to any other powers and duties prescribed by law,
13 the board of trustees of Bellevue College:

14 (1) Shall have full control of the college and its property of
15 various kinds, except as otherwise provided by law;

16 (2) Shall employ the president of the college, his or her
17 assistants, members of the faculty, and other employees of the
18 institution, who, except as otherwise provided by law, shall hold their
19 positions, until discharged therefrom by the board for good and lawful
20 reason;

21 (3) With the consultation of the faculty of the college, shall
22 prescribe the course of study in the various schools and departments
23 thereof and publish such catalogues thereof as the board deems
24 necessary: PROVIDED, That the Washington professional educator
25 standards board shall determine the requisites for and give program
26 approval of all courses leading to teacher certification by such board;

27 (4) Shall create comprehensive programs of community and technical
28 college education and training and maintain an open-door policy in
29 accordance with the provisions of RCW 28B.50.090(3);

30 (5) Establish such divisions, schools or departments necessary to
31 carry out the purposes of the college and not otherwise proscribed by
32 law;

33 (6) Except as otherwise provided by law, may establish and erect
34 such new facilities as determined by the board to be necessary for the
35 college;

1 (7) May acquire real and other property as provided in RCW
2 28B.10.020;

3 (8) Except as otherwise provided by law, may purchase all supplies
4 and purchase or lease equipment and other personal property needed for
5 the operation or maintenance of the college;

6 (9) May establish, lease, operate, equip and maintain self-
7 supporting facilities in the manner provided in RCW 28B.10.300 through
8 28B.10.330;

9 (10) Except as otherwise provided by law, to enter into such
10 contracts as the trustees deem essential to college purposes;

11 (11) May receive such gifts, grants, conveyances, devises and
12 bequests of real or personal property from whatsoever source, as may be
13 made from time to time, in trust or otherwise, whenever the terms and
14 conditions thereof will aid in carrying out the college programs; sell,
15 lease or exchange, invest or expend the same or the proceeds, rents,
16 profits and income thereof except as limited by the terms and
17 conditions thereof; and adopt regulations to govern the receipt and
18 expenditure of the proceeds, rents, profits and income thereof;

19 (12) Subject to the approval of the higher education coordinating
20 board pursuant to RCW 28B.76.230, offer new degree programs, offer off-
21 campus programs, participate in consortia or centers, contract for off-
22 campus educational programs, and purchase or lease major off-campus
23 facilities;

24 (13) May adopt such rules, and perform all other acts not forbidden
25 by law, as the board of trustees may in its discretion deem necessary
26 or appropriate to the administration of the college; and

27 (14) May participate in higher education centers and consortia that
28 involve any four-year public or independent college or university,
29 however, new degree programs or off-campus programs offered by a four-
30 year public or independent college or university in collaboration with
31 Bellevue College are subject to approval by the higher education
32 coordinating board under RCW 28B.76.230.

33 NEW SECTION. **Sec. 106.** TRUSTEES--FIRE PROTECTION SERVICES. (1)
34 Subject to the provisions of RCW 35.21.779, the board of trustees of
35 Bellevue College may:

36 (a) Contract for such fire protection services as may be necessary

1 for the protection and safety of the students, staff and property of
2 the college;

3 (b) By agreement pursuant to chapter 39.34 RCW, join together with
4 other agencies or political subdivisions of the state or federal
5 government and otherwise share in the accomplishment of any of the
6 purposes of (a) of this subsection.

7 (2) Neither the failure of the trustees to exercise any of its
8 powers under this section nor anything in this section may detract from
9 the lawful and existing powers and duties of political subdivisions of
10 the state to provide the necessary fire protection equipment and
11 services to persons and property within their jurisdiction.

12 NEW SECTION. **Sec. 107.** TREASURER--APPOINTMENT, TERM, DUTIES,
13 BONDS. The board of trustees shall appoint a treasurer who shall be
14 the financial officer of the board and who shall hold office during the
15 pleasure of the board. The treasurer shall render a true and faithful
16 account of all moneys received and paid out by him or her, and shall
17 give bond for the faithful performance of the duties of the office in
18 such amount as the trustees require.

19 NEW SECTION. **Sec. 108.** BACHELOR'S DEGREES AUTHORIZED. The degree
20 of bachelor of arts or the degree of bachelor of science, the degree of
21 bachelor of arts in education, and the degree of bachelor of applied
22 science may be granted to any student who has completed a four-year
23 course of study or the equivalent thereof at Bellevue College.

24 NEW SECTION. **Sec. 109.** DEGREES THROUGH BACHELOR'S DEGREES
25 AUTHORIZED--LIMITATIONS--HONORARY BACHELOR'S DEGREES. In addition to
26 all other powers and duties given to them by law, the board of trustees
27 of Bellevue College may grant any degree through the bachelor's degree
28 to any student who has completed a program of study and/or research in
29 those areas which are determined by the faculty and board of trustees
30 of the college to be appropriate for the granting of such degree:
31 PROVIDED, That any degree authorized under this section shall be
32 subject to the review and approval of the higher education coordinating
33 board.

34 The board of trustees, upon recommendation of the faculty, may also
35 confer honorary bachelor's degrees upon persons other than graduates of

1 the institution, in recognition of their learning or devotion to
2 education, literature, art, or science. No degree may be conferred in
3 consideration of the payment of money or the donation of any kind of
4 property.

5 NEW SECTION. **Sec. 110.** CERTIFICATES, DIPLOMAS--SIGNING--CONTENTS.
6 Every diploma issued by the board of Bellevue College shall be signed
7 by the chairman of the board of trustees and by the president of the
8 college, and sealed with the appropriate seal. In addition to the
9 foregoing, teaching certificates shall be countersigned by the state
10 superintendent of public instruction. Every certificate shall
11 specifically state what course of study the holder has completed and
12 for what length of time such certificate is valid in the schools of the
13 state.

14 NEW SECTION. **Sec. 111.** MODEL SCHOOLS AND TRAINING DEPARTMENTS.
15 (1) A model school or schools or training departments may be provided
16 for Bellevue College, in which students, before graduation, may have
17 actual practice in teaching or courses under the supervision and
18 observation of critic teachers. All schools or departments involved
19 shall organize and direct their work being cognizant of public school
20 needs.

21 (2) The board of trustees of Bellevue College, if having a model
22 school or training department as authorized by this section, shall, on
23 or before the first Monday of September of each year, file with the
24 board of the school district or districts in which the college is
25 situated, a certified statement showing an estimate of the number of
26 public school pupils who will be required to make up such model school
27 and specifying the number required for each grade for which training
28 for students is required.

29 (3) It is the duty of the board of the school district or districts
30 with which a certified statement has been filed, to apportion for
31 attendance to the model school or training department, a sufficient
32 number of pupils from the public schools under the supervision of the
33 board as will furnish to Bellevue College the number of pupils required
34 to maintain the facility: PROVIDED, That the president of Bellevue
35 College may refuse to accept any pupil as in his or her judgment would

1 tend to reduce the efficiency of the model school or training
2 department.

3 (4) Annually, on or before the date for reporting the school
4 attendance of the school district in which the model school or training
5 department is situated, for the purpose of taxation for the support of
6 the common schools, the board of trustees of Bellevue College shall
7 file with the board of the school district or districts in which the
8 model school or training department is situated a report showing the
9 number of common school pupils at each model school or training
10 department during the school last year, and the period of their
11 attendance in the same form that reports of public schools are made.
12 Any superintendent of the school district affected shall, in reporting
13 the attendance in the school district, segregate the attendance at the
14 model school or training department from the attendance in the other
15 schools of said district: PROVIDED, That attendance shall be credited,
16 if credit is given, to the school district in which the pupil resides.

17 NEW SECTION. **Sec. 112.** SUSPENSION AND EXPULSION. Any student may
18 be suspended or expelled from Bellevue College who is found to be
19 guilty of an infraction of the regulations of the institution.

20 NEW SECTION. **Sec. 113.** STATE COLLEGE FEES. (1) Building fees
21 collected from students who are enrolled for the purposes of obtaining
22 a baccalaureate degree are subject to the provisions of RCW 28B.35.370.

23 (2) Building fees collected from students who are enrolled for the
24 purposes of obtaining an associate or technical degree are subject to
25 the provisions of RCW 28B.50.360.

26 (3) The higher education coordinating board, the state board for
27 community and technical colleges, and the board of trustees for
28 Bellevue College shall establish a method for determining the
29 allocation of building fees under this section.

30 NEW SECTION. **Sec. 114.** DUTIES OF PRESIDENT. The president of
31 Bellevue College shall have general supervision of the college and see
32 that all laws and rules of the board of trustees are observed.

33 NEW SECTION. **Sec. 115.** PARTICIPATION IN OPPORTUNITY GRANT

1 PROGRAM. Bellevue College shall participate in the opportunity grant
2 program pursuant to RCW 28B.50.271 through 28B.50.274.

3 **PART II**

4 **OTHER COLLEGE PROVISIONS**

5 **Sec. 201.** RCW 28B.10.020 and 2004 c 275 s 47 are each amended to
6 read as follows:

7 The boards of regents of the University of Washington and
8 Washington State University, respectively, and the boards of trustees
9 of Central Washington University, Eastern Washington University,
10 Western Washington University, ~~((and))~~ The Evergreen State College, and
11 Bellevue College, respectively, shall have the power and authority to
12 acquire by exchange, gift, purchase, lease, or condemnation in the
13 manner provided by chapter 8.04 RCW for condemnation of property for
14 public use, such lands, real estate and other property, and interests
15 therein as they may deem necessary for the use of said institutions
16 respectively. However, the purchase or lease of major off-campus
17 facilities is subject to the approval of the higher education
18 coordinating board under RCW 28B.76.230.

19 **Sec. 202.** RCW 28B.10.022 and 2003 c 6 s 1 are each amended to read
20 as follows:

21 (1) The boards of regents of the state universities and the boards
22 of trustees of the regional universities, The Evergreen State College,
23 Bellevue College, and the state board for community and technical
24 colleges, are severally authorized to enter into financing contracts as
25 provided in chapter 39.94 RCW. Except as provided in subsection (2) of
26 this section, financing contracts shall be subject to the approval of
27 the state finance committee.

28 (2) The board of regents of a state university may enter into
29 financing contracts which are payable solely from and secured by all or
30 any component of the fees and revenues of the university derived from
31 its ownership and operation of its facilities not subject to
32 appropriation by the legislature and not constituting "general state
33 revenues," as defined in Article VIII, section 1 of the state
34 Constitution, without the prior approval of the state finance
35 committee.

1 (3) Except for financing contracts for facilities or equipment
2 described under chapter 28B.140 RCW, the board of regents shall notify
3 the state finance committee at least sixty days prior to entering into
4 such contract and provide information relating to such contract as
5 requested by the state finance committee.

6 **Sec. 203.** RCW 28B.10.025 and 2005 c 36 s 2 are each amended to
7 read as follows:

8 The Washington state arts commission shall, in consultation with
9 the boards of regents of the University of Washington and Washington
10 State University and with the boards of trustees of the regional
11 universities, The Evergreen State College, Bellevue College, and the
12 community college districts, determine the amount to be made available
13 for the purchases of art under RCW 28B.10.027, and payment therefor
14 shall be made in accordance with law. The designation of projects and
15 sites, the selection, contracting, purchase, commissioning, reviewing
16 of design, execution and placement, acceptance, maintenance, and sale,
17 exchange, or disposition of works of art shall be the responsibility of
18 the Washington state arts commission in consultation with the board of
19 regents or trustees.

20 **Sec. 204.** RCW 28B.10.280 and 1977 ex.s. c 169 s 11 are each
21 amended to read as follows:

22 The boards of regents of the state universities and the boards of
23 trustees of regional universities, The Evergreen State College,
24 Bellevue College, and community college districts may each create
25 student loan funds, and qualify and participate in the National Defense
26 Education Act of 1958 and such other similar federal student aid
27 programs as are or may be enacted from time to time, and to that end
28 may comply with all of the laws of the United States, and all of the
29 rules, regulations and requirements promulgated pursuant thereto.

30 **Sec. 205.** RCW 28B.10.300 and 1977 ex.s. c 169 s 13 are each
31 amended to read as follows:

32 The boards of regents of the state universities and the boards of
33 trustees of the regional universities, Bellevue College, and The
34 Evergreen State College are severally authorized to:

1 (1) Enter into contracts with persons, firms or corporations for
2 the construction, installation, equipping, repairing, renovating and
3 betterment of buildings and facilities for the following:

4 (a) Dormitories

5 (b) Hospitals

6 (c) Infirmaries

7 (d) Dining halls

8 (e) Student activities

9 (f) Services of every kind for students, including, but not limited
10 to, housing, employment, registration, financial aid, counseling,
11 testing and offices of the dean of students

12 (g) Vehicular parking

13 (h) Student, faculty and employee housing and boarding;

14 (2) Purchase or lease lands and other appurtenances necessary for
15 the construction and installation of such buildings and facilities and
16 to purchase or lease lands with buildings and facilities constructed or
17 installed thereon suitable for the purposes aforesaid;

18 (3) Lease to any persons, firms, or corporations such portions of
19 the campus of their respective institutions as may be necessary for the
20 construction and installation of buildings and facilities for the
21 purposes aforesaid and the reasonable use thereof;

22 (4) Borrow money to pay the cost of the acquisition of such lands
23 and of the construction, installation, equipping, repairing,
24 renovating, and betterment of such buildings and facilities, including
25 interest during construction and other incidental costs, and to issue
26 revenue bonds or other evidence of indebtedness therefor, and to
27 refinance the same before or at maturity and to provide for the
28 amortization of such indebtedness from services and activities fees or
29 from the rentals, fees, charges, and other income derived through the
30 ownership, operation and use of such lands, buildings, and facilities
31 and any other dormitory, hospital, infirmary, dining, student
32 activities, student services, vehicular parking, housing or boarding
33 building or facility at the institution;

34 (5) Contract to pay as rental or otherwise the cost of the
35 acquisition of such lands and of the construction and installation of
36 such buildings and facilities on the amortization plan; the contract
37 not to run over forty years;

1 (6) Expend on the amortization plan services and activities fees
2 and/or any part of all of the fees, charges, rentals, and other income
3 derived from any or all revenue-producing lands, buildings, and
4 facilities of their respective institutions, heretofore or hereafter
5 acquired, constructed or installed, including but not limited to income
6 from rooms, dormitories, dining rooms, hospitals, infirmaries, housing
7 or student activity buildings, vehicular parking facilities, land or
8 the appurtenances thereon, and to pledge such services and activities
9 fees and/or the net income derived through the ownership, operation and
10 use of any lands, buildings or facilities of the nature described in
11 subsection (1) (~~hereof~~) of this section for the payment of part or
12 all of the rental, acquisition, construction, and installation, and the
13 betterment, repair, and renovation or other contract charges, bonds or
14 other evidence of indebtedness agreed to be paid on account of the
15 acquisition, construction, installation or rental of, or the
16 betterment, repair or renovation of, lands, buildings, facilities and
17 equipment of the nature authorized by this section.

18 **Sec. 206.** RCW 28B.10.350 and 2007 c 495 s 1 are each amended to
19 read as follows:

20 (1) When the cost to The Evergreen State College, Bellevue College,
21 or any regional or state university of any building, construction,
22 renovation, remodeling, or demolition, other than maintenance or
23 repairs, will equal or exceed the sum of fifty-five thousand dollars,
24 or thirty-five thousand dollars if the work involves one trade or craft
25 area, complete plans and specifications for the work shall be prepared,
26 the work shall be put out for public bid, and the contract shall be
27 awarded to the responsible bidder who submits the lowest responsive
28 bid.

29 (2) Any building, construction, renovation, remodeling, or
30 demolition project that exceeds the dollar amounts in subsection (1) of
31 this section is subject to the provisions of chapter 39.12 RCW.

32 (3) The Evergreen State College, Bellevue College, or any regional
33 or state university may require a project to be put to public bid even
34 when it is not required to do so under subsection (1) of this section.
35 Any project publicly bid under this subsection is subject to the
36 provisions of chapter 39.12 RCW.

1 (4) Where the estimated cost of any building, construction,
2 renovation, remodeling, or demolition is less than fifty-five thousand
3 dollars or the contract is awarded by the small works roster procedure
4 authorized in RCW 39.04.155, the publication requirements of RCW
5 39.04.020 do not apply.

6 (5) In the event of any emergency when the public interest or
7 property of The Evergreen State College, Bellevue College, or a
8 regional or state university would suffer material injury or damage by
9 delay, the president of such college or university may declare the
10 existence of an emergency and, reciting the facts constituting the
11 same, may waive the requirements of this section with reference to any
12 contract in order to correct the condition causing the emergency. For
13 the purposes of this section, "emergency" means a condition likely to
14 result in immediate physical injury to persons or to property of the
15 college or university in the absence of prompt remedial action or a
16 condition which immediately impairs the institution's ability to
17 perform its educational obligations.

18 (6) This section does not apply when a contract is awarded by the
19 small works roster procedure authorized in RCW 39.04.155 or under any
20 other procedure authorized for an institution of higher education.

21 **Sec. 207.** RCW 28B.10.400 and 1979 ex.s. c 259 s 1 are each amended
22 to read as follows:

23 The boards of regents of the state universities, the boards of
24 trustees of the regional universities (~~(and of)~~), The Evergreen State
25 College, and Bellevue College, and the state board for community and
26 technical colleges (~~(education)~~) are authorized and empowered:

27 (1) To assist the faculties and such other employees as any such
28 board may designate in the purchase of old age annuities or retirement
29 income plans under such rules (~~(and regulations)~~) as any such board may
30 prescribe. County agricultural agents, home demonstration agents, 4-H
31 club agents, and assistant county agricultural agents paid jointly by
32 the Washington State University and the several counties shall be
33 deemed to be full-time employees of the Washington State University for
34 the purposes hereof;

35 (2) To provide, under such rules (~~(and regulations)~~) as any such
36 board may prescribe for the faculty members or other employees under
37 its supervision, for the retirement of any such faculty member or other

1 employee on account of age or condition of health, retirement on
2 account of age to be not earlier than the sixty-fifth birthday:
3 PROVIDED, That such faculty member or such other employee may elect to
4 retire at the earliest age specified for retirement by federal social
5 security law: PROVIDED FURTHER, That any supplemental payment
6 authorized by subsection (3) of this section and paid as a result of
7 retirement earlier than age sixty-five shall be at an actuarially
8 reduced rate;

9 (3) To pay to any such retired person or to his or her designated
10 beneficiary(s), each year after his or her retirement, a supplemental
11 amount which, when added to the amount of such annuity or retirement
12 income plan, or retirement income benefit pursuant to RCW 28B.10.415,
13 received by him or her, or his or her designated beneficiary(s) in such
14 year, will not exceed fifty percent of the average annual salary paid
15 to such retired person for his or her highest two consecutive years of
16 full-time service under an annuity or retirement income plan
17 established pursuant to subsection (1) of this section at an
18 institution of higher education: PROVIDED, HOWEVER, That if such
19 retired person prior to his or her retirement elected a supplemental
20 payment survivors option, any such supplemental payments to such
21 retired person or his or her designated beneficiary(s) shall be at
22 actuarially reduced rates: PROVIDED FURTHER, That if a faculty member
23 or other employee of an institution of higher education who is a
24 participant in a retirement plan authorized by this section dies, or
25 has died before retirement but after becoming eligible for retirement
26 on account of age, the designated beneficiary(s) shall be entitled to
27 receive the supplemental payment authorized by this subsection (3) of
28 this section to which such designated beneficiary(s) would have been
29 entitled had said deceased faculty member or other employee retired on
30 the date of death after electing a supplemental payment survivors
31 option: PROVIDED FURTHER, That for the purpose of this subsection, the
32 designated beneficiary(s) shall be (a) the surviving spouse of the
33 retiree; or, (b) with the written consent of such spouse, if any, such
34 other person or persons as shall have an insurable interest in the
35 retiree's life and shall have been nominated by written designation
36 duly executed and filed with the retiree's institution of higher
37 education.

1 **Sec. 208.** RCW 28B.10.401 and 1979 ex.s. c 259 s 3 are each amended
2 to read as follows:

3 The boards of regents of the state universities, the boards of
4 trustees of the state colleges and Bellevue College, and the state
5 board for community and technical colleges (~~(education)~~), when
6 establishing the amount of supplemental payment under RCW 28B.10.400(3)
7 (~~(as now or hereafter amended)~~), shall apply the following assumptions:

8 (1) That the faculty member or such other employee at the time of
9 retirement elected a joint and two-thirds survivor option on (~~(their)~~)
10 his or her annuity or retirement income plan using actual ages, but not
11 exceeding a five-year age difference if married, or an actuarial
12 equivalent option if single, which represents accumulations including
13 all dividends from all matching contributions and any benefit that such
14 faculty member is eligible to receive from any Washington state public
15 retirement plan while employed at an institution of higher education;

16 (2) That on and after July 1, 1974, matching contributions were
17 allocated equally between a fixed dollar and a variable dollar annuity;

18 (3) That for each year after age fifty, the maximum amount of
19 contributions pursuant to RCW 28B.10.410 (~~(as now or hereafter~~
20 ~~amended)~~) be contributed toward the purchase of such annuity or
21 retirement income plan, otherwise three-fourths of the formula
22 described in RCW 28B.10.415(~~(, as now or hereafter amended,)~~) shall be
23 applied.

24 **Sec. 209.** RCW 28B.10.405 and 1977 ex.s. c 169 s 16 are each
25 amended to read as follows:

26 Members of the faculties and such other employees as are designated
27 by the boards of regents of the state universities, the boards of
28 trustees of the regional universities (~~(and of)~~), The Evergreen State
29 College, and Bellevue College, or the state board for community and
30 technical colleges (~~(education)~~) shall be required to contribute not
31 less than five percent of their salaries during each year of full-time
32 service after the first two years of such service toward the purchase
33 of such annuity or retirement income plan; such contributions may be in
34 addition to federal social security tax contributions, if any.

35 **Sec. 210.** RCW 28B.10.407 and 1987 c 448 s 1 are each amended to
36 read as follows:

1 (1) A faculty member or other employee designated by the boards of
2 regents of the state universities, the boards of trustees of the

13 (4) Subject to the conditions in subsection (5) of this section and
14 the limitations in RCW 28B.15.910, the governing boards of the state
15 universities, the regional universities, The Evergreen State College,
16 Bellevue College, and the community colleges, shall waive all tuition
17 and fees for the following persons:

18 (a) A child and the spouse or the domestic partner or surviving
19 spouse or surviving domestic partner of an eligible veteran or national
20 guard member who became totally disabled, as defined in RCW 28B.15.385,
21 as a result of serving in active federal military or naval service, or
22 who is determined by the federal government to be a prisoner of war or
23 missing in action; and

24 (b) A child and the surviving spouse or surviving domestic partner
25 of an eligible veteran or national guard member who lost his or her
26 life as a result of serving in active federal military or naval
27 service.

28 (5) The conditions in this subsection (5) apply to waivers under
29 subsection (4) of this section.

30 (a) A child must be a Washington domiciliary between the age of
31 seventeen and twenty-six to be eligible for the tuition waiver. A
32 child's marital status does not affect eligibility.

33 (b)(i) A surviving spouse or surviving domestic partner must be a
34 Washington domiciliary.

35 (ii) Except as provided in (b)(iii) of this subsection, a surviving
36 spouse or surviving domestic partner has ten years from the date of the
37 death, total disability, or federal determination of prisoner of war or
38 missing in action status of the eligible veteran or national guard

1 member to receive benefits under the waiver. Upon remarriage or
2 registration in a subsequent domestic partnership, the surviving spouse
3 or surviving domestic partner is ineligible for the waiver of all

8 (c) Each recipient's continued participation is subject to the
9 school's satisfactory progress policy.

10 (d) Tuition waivers for graduate students are not required for
11 those who qualify under subsection (4) of this section but are
12 encouraged.

13 (e) Recipients who receive a waiver under subsection (4) of this
14 section may attend full-time or part-time. Total credits earned using
15 the waiver may not exceed two hundred quarter credits, or the
16 equivalent of semester credits.

17 (6) Required waivers of all tuition and fees under subsection (4)
18 of this section shall not affect permissive waivers of tuition and fees
19 under subsection (3) of this section.

20 (7) Private vocational schools and private higher education
21 institutions are encouraged to provide waivers consistent with the
22 terms in subsections (2) through (5) of this section.

23 (8) The definitions in this subsection apply throughout this
24 section.

25 (a) "Eligible veteran or national guard member" means a Washington
26 domiciliary who was an active or reserve member of the United States
27 military or naval forces, or a national guard member called to active
28 duty, who served in active federal service, under either Title 10 or
29 Title 32 of the United States Code, in a war or conflict fought on
30 foreign soil or in international waters or in another location in
31 support of those serving on foreign soil or in international waters,
32 and if discharged from service, has received an honorable discharge.

33 (b) "Totally disabled" means a person who has been determined to be
34 one hundred percent disabled by the federal department of veterans
35 affairs.

36 (c) "Washington domiciliary" means a person whose true, fixed, and
37 permanent house and place of habitation is the state of Washington.
38 "Washington domiciliary" includes a person who is residing in rental

1 housing or residing in base housing. In ascertaining whether a child
2 or surviving spouse or surviving domestic partner is domiciled in the
3 state of Washington, public institutions of higher education shall, to
4 the fullest extent possible, rely upon the standards provided in RCW
5 28B.15.013.

6 (9) As used in subsection (4) of this section, "fees" includes all
7 assessments for costs incurred as a condition to a student's full
8 participation in coursework and related activities at an institution of
9 higher education.

10 (10) The governing boards of the state universities, the regional
11 universities, The Evergreen State College, Bellevue College, and the
12 community colleges shall report to the higher education committees of
13 the legislature by November 15, 2010, and every two years thereafter,
14 regarding the status of implementation of the waivers under subsection
15 (4) of this section. The reports shall include the following data and

30 amount not obligated to repayment of bonds; Eastern Washington
31 University, Central Washington University, and Western Washington
32 University shall each receive equal amounts of the remaining amount.

21 application of their technical course credits toward the baccalaureate
22 degree; and

23 (b) Based on a curriculum that incorporates both theoretical and
24 applied knowledge and skills in a specific technical field.

25 (20) "Qualified institutions of higher education" means:

26 (a) Washington public community and technical colleges;

27 (b) Private career schools that are members of an accrediting
28 association recognized by rule of the higher education coordinating
29 board for the purposes of chapter 28B.92 RCW; (~~and~~)

30 (c) Washington state apprenticeship and training council-approved
31 apprenticeship programs; and

32 (d) Bellevue College.

33 **Sec. 263.** RCW 28B.50.252 and 1991 c 238 s 77 are each amended to
34 read as follows:

35 (1) Bellevue College and each local education agency or college
36 district offering vocational educational programs shall establish local

1 advisory committees to provide that agency or district with advice on

4 (a) Participate in the determination of program goals;

5 (b) Review and evaluate program curricula, equipment, and

24 process to analyze the need for additional degrees and programs,
25 additional off-campus centers and locations for degree programs, and
26 consolidation or elimination of programs by the four-year institutions.

27 (2) As part of the needs assessment process, the board shall
28 examine:

29 (a) Projections of student, employer, and community demand for
30 education and degrees, including liberal arts degrees, on a regional
31 and statewide basis;

32 (b) Current and projected degree programs and enrollment at public
33 and private institutions of higher education, by location and mode of
34 service delivery; and

35 (c) Data from the workforce training and education coordinating

1 board and the state board for community and technical colleges on the
2 supply and demand for workforce education and certificates and
3 associate degrees.

4 (3) Every two years the board shall produce, jointly with the state
5 board for community and technical colleges and the workforce training

34 decision-making criteria regarding approval of proposals under this
35 section, which must include review and consultation with the
36 institution and other interested agencies and individuals.

37 (8) The board shall periodically recommend consolidation or

1 elimination of programs at the four-year institutions, based on the
2 needs assessment analysis.

10 NEW SECTION. **Sec. 303.** Sections 101 through 115 and 301 of this
11 act constitute a new chapter in Title 28B RCW.

12 NEW SECTION. **Sec. 304.** Section 103 of this act takes effect
13 October 1, 2010.
