### House Bills

**HB 2327** by Representatives Linville and Ericks; by request of Office of Financial Management

Eliminating or reducing the frequency of reports prepared by state agencies.

**HB 2328** by Representatives Linville and Ericks; by request of Office of Financial Management

Reducing the administrative cost of state government.

Revises chapter 5, Laws of 2009 by adding exceptions to the prohibitions and limitations placed on state agencies and employees relating to creating new positions, filling vacant positions, salary increases, personal service contracts, equipment purchases, travel, and training.

### Senate Bills

**SB 5352-S** by Senate Committee on Transportation (originally sponsored by Senators Haugen and Marr; by request of Governor Gregoire)

Making 2009-11 transportation appropriations.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Makes transportation appropriations for 2009-2011.

Mar 26 Public hearing in the Senate Committee on Transportation at 1:30 PM.

Mar 31 TRAN - Majority; 1st substitute bill be substituted, do pass.

Minority; without recommendation.

Passed to Rules Committee for second reading.

Placed on second reading by Rules Committee.

**SB 6146** by Senator Prentice

Consolidating the gambling commission into the department of licensing as the office of gambling regulation.

Declares that the public interest in the regulation and control of gambling is best served in collaboration with and oversight of the department of licensing to ensure consistency in the regulatory framework of the state.

Creates the office of gambling regulation within the department of licensing.
