**HB 2576-S2** by House Committee on Ways & Means (originally sponsored by Representatives Kenney, Liias, Moeller, Pedersen, and Armstrong; by request of Secretary of State)

Restructuring fees for the division of corporations and affirming authority to establish fees for the charities program of the office of the secretary of state.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Restructures certain fees for the division of corporations of the office of the secretary of state in a manner that has minimal revenue impact but moves the division of corporations towards a more self-sustaining budget.

**HB 2759-S2** by House Committee on Ways & Means (originally sponsored by Representatives Maxwell, Anderson, Roberts, White, Goodman, Clibborn, Kenney, Hunter, Morrell, and Haigh)

Adjusting local school finance related to nonresident students enrolled in online learning.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Finds that, while the legislature supports online learning, there are unintended financial consequences for taxpayers, both locally and statewide, when significant numbers of nonresident students enroll in a school district for purposes of enrolling in an online school program.

Adjusts finance policy related to voter-approved excess levies and a district's qualification for local effort enhancement funds to eliminate these unintended consequences.

Repeals the authority of the Washington higher education facilities authority to originate and purchase educational loans and to issue revenue bonds payable from and secured by educational loans.

**HB 2956-S2** by House Committee on Ways & Means (originally sponsored by Representatives Pettigrew, Williams, and Maxwell; by request of Governor Gregoire)

Concerning the hospital safety net.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Creates the hospital safety net assessment and hospital safety net assessment fund to allow the state to generate additional federal financial participation for the medicaid program and provide for increased reimbursement to hospitals.

Imposes a hospital safety net assessment, the funds of which are to be used solely to augment all other funding sources and not as a substitute for any other funds.

Intends: (1) That the total amount assessed not exceed the amount needed, in combination with all other available funds, to support the reimbursement rates and other payments authorized by the act; and

(2) To condition the assessment on receiving federal approval for receipt of additional federal financial participation and on continuation of other funding sufficient to maintain hospital inpatient and outpatient reimbursement rates and small rural disproportionate share payments at least at the levels in effect on June 30, 2009.

Requires the department of social and health services to:  
(1) Design a system of hospital quality incentive payments; and

(2) Increase assessments to support rate increases for inpatient psychiatric services for certain persons.  
Expires July 1, 2013.

**HB 3027-S** by House Committee on Finance (originally sponsored by Representatives Ormsby, White, and Kenney)

Concerning the governance and financing of the Washington state convention and trade center.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides for the transfer of the governance and financing of the state convention and trade center to a public facilities district formed by a county with a population of one million five hundred thousand or more to acquire, own, and operate the convention and trade center.

Replaces, in connection with such transfer, the authority under chapter 67.40 RCW (convention and trade facilities) of the state and city to impose excise taxes on the sale of or charge made for the furnishing of lodging to fund the state convention and trade center with authority for the public facilities district to impose lodging taxes at these rates, without affecting the existing authority of the state, county, cities, and other municipal corporations to impose taxes on the sale or charge made for the furnishing of lodging under existing caps on the aggregate rate that may be charged.

Extending expiring tax incentives for certain clean alternative fuel vehicles, producers of certain biofuels, and

federal aviation regulation part 145 certificated repair stations.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Extends expiring tax incentives for: (1) Certain clean alternative fuel vehicles;

(2) Producers of certain biofuels; and

(3) Federal aviation regulation part 145 certificated repair stations.

Making the governor the public employer of language access providers.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Requires the office of financial management to: (1) Establish a working group on language access services to develop a plan to improve the efficiency and effectiveness of language access services; and

(2) Certify, authorize, and qualify language access providers as needed to maintain a pool of certified, authorized, and qualified providers.

Makes the governor the public employer of language access providers, with certain limitations.

Directs the governor after meeting certain requirements to submit, as part of the proposed biennial or supplemental operating budget submitted to the legislature, a request for funds necessary to implement the compensation and benefit provisions of a collective bargaining agreement or for legislation necessary to implement the agreement.

Addresses collective bargaining and the deduction of monthly dues.

Concerning sales and use tax exemptions for certain equipment and infrastructure contained in data centers.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides a tax exemption for the sales to, or the use by, qualifying businesses of eligible server equipment to be installed, without intervening use, in an eligible computer data center, and for the use of, or charges made for, labor and services rendered in respect to installing eligible server equipment.

Expires April 1, 2018.

Creating efficiencies in the use of technology in state government.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Organizes, consolidates, and, where appropriate, contracts with private providers for technology systems and resources.

Establishes spending restrictions for information technology for the 2009-2011 biennium.

Concerning the clean water act of 2010 funding cleanup of water pollution and other programs necessary for the health and well-being of Washington citizens through an increase in the tax on hazardous substances.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Imposes an additional tax on the privilege of possession of hazardous substances in this state to fund programs that will offset the burdens that pollution places on the environment and the waters of the state.

Requires the department of transportation to use the additional taxes deposited in the motor vehicle account to fund certain activities or projects that address contamination of storm water related to transportation infrastructure.

Requires the Puget Sound partnership to use the additional taxes deposited in the Puget Sound recovery account to fund activities or capital projects that are consistent with the prioritization of the 2020 action agenda.

Exempts from the tax, possession of petroleum products that are exported for use or sale outside the state as fuel.

Creates the storm water account.

Imposing a tax on home and community based services to fund services for seniors and people with disabilities.

Imposes a public utility tax on community residential service businesses and adult day health businesses.

Creates the community residential investment account and the home and community based services investment account.

**SB 6316-S2** by Senate Committee on Ways & Means (originally sponsored by Senators Carrell, King, Hewitt, Stevens, and Delvin)

Addressing the coordination between local law enforcement and the department of corrections.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Authorizes a police officer who has probable cause to believe that a person being supervised by the department of corrections has violated a condition of his or her community

custody to detain and arrest the person if the officer has obtained oral or written authorization from the department of corrections to detain the person.

Requires the Washington association of sheriffs and police chiefs to implement procedures as part of the city and county jail booking and reporting system to automatically notify the department of corrections when certain events affect a department-supervised offender housed in any city or county jail.

Requires the department of corrections, subject to funds appropriated for this purpose, to provide law enforcement with access to a hotline where they can obtain authorization to detain an individual under the supervision of the department.

Provides that the act is null and void if appropriations are not approved.

**SB 6409-S2** by Senate Committee on Ways & Means (originally sponsored by Senators Kastama, Rockefeller, Shin, and Kohl-Welles)

Creating the Washington opportunity pathways account.  
(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Creates the Washington opportunity pathways account. Directs lottery account moneys toward the Washington opportunity pathways account and requires those funds to stabilize and increase existing resources for the recruitment of entrepreneurial researchers, innovation partnership zones and research teams, early childhood education, opportunity grants, educational opportunity grants, get ready for math and science scholarships, passport to college promise scholarships, college bound scholarships, the state work study program, the state need grant, Washington scholars

awards, the Washington award for vocational excellence, and Washington promise scholarships.

Continues funding the education construction fund by redirecting a portion of general state revenues to that fund.

Requires the state treasurer to transfer funds from the general fund to the education construction fund.

Requires the lottery commission to develop a strategy and plan for actively marketing the state lottery as an essential contributor to Washington's opportunity pathways.

Requires the joint legislative audit and review committee to conduct a review of marketing and vendor expenditures and incentive payment programs at the state lottery commission to identify cost savings and efficiencies to maximize contributions to beneficiaries under the act.
