2 following:

3 "Sec. 1. RCW 7.84.030 and 2011 c 320 s 14 are each amended to read
4 as follows:

5 (1) An infraction proceeding is initiated by the issuance and
6 service of a printed notice of infraction and filing of a printed or
7 electronic copy of the notice of infraction.

8 (2)(a) A notice of infraction may be issued by a person authorized
9 to enforce the provisions of the title or chapter in which the
10 infraction is established, or by a person authorized by an interlocal
11 agreement entered into under RCW 7.84.140, when the infraction occurs
12 in that person's presence.

13 (b) A person who is a peace officer as defined in chapter 10.93 RCW
14 may detain the person receiving the infraction for a reasonable period
15 of time necessary to identify the person, check for outstanding
16 warrants, and complete and issue a notice of infraction under RCW
17 7.84.050. A person who is to receive a notice of infraction is
18 required to identify himself or herself to the peace officer by giving
19 the person's name, address, and date of birth. Upon request, the
20 person shall produce reasonable identification, which may include a
21 driver's license or identicard. Any person who fails to comply with
22 the requirement to identify himself or herself and give the person's
23 current address may be found to have committed an infraction.

24 (3) A court may issue a notice of infraction if a person authorized
25 to enforce the provisions of the title or chapter in which the
26 infraction is established, or by a person authorized by an interlocal
27 agreement entered into under RCW 7.84.140, files with the court a
28 written statement that the infraction was committed in that person's
29 presence or that the officer has reason to believe an infraction was
30 committed.

1 (4) Service of a notice of infraction issued under subsection (2)
2 or (3) of this section shall be as provided by court rule.

3 (5) A notice of infraction shall be filed with a court having
4 jurisdiction within five days of issuance, excluding Saturdays,
5 Sundays, and holidays.

6 **Sec. 2.** RCW 7.84.020 and 2003 c 39 s 3 are each amended to read as

8 ((~~Unless the context clearly requires otherwise,~~) The definition
9 in this section applies throughout this chapter unless the context
10 clearly requires otherwise.

11 "Infraction" means an offense which, by the terms of Title 76, 77,
12 79, or 79A RCW or ((~~chapter 43.30 RCW~~) RCW 7.84.030(2)(b) and rules
13 adopted under these titles and ((~~chapters~~) section, is declared not to
14 be a criminal offense and is subject to the provisions of this chapter.

14 amended to read as follows:

15 The definitions in this section apply throughout this title or
16 rules adopted under this title unless the context clearly requires
17 otherwise.

18 (1) "Angling gear" means a line attached to a rod and reel capable
19 of being held in hand while landing the fish or a hand-held line
20 operated without rod or reel.

21 (2) "Aquatic invasive species" means any invasive, prohibited,
22 regulated, unregulated, or unlisted aquatic animal or plant species as
23 defined under subsections (3), (28), (40), (44), (60), and (61) of this
24 section, aquatic noxious weeds as defined under RCW 17.26.020(5)(c),
25 and aquatic nuisance species as defined under RCW 77.60.130(1).

26 (3) "Aquatic plant species" means an emergent, submersed, partially
27 submersed, free-floating, or floating-leaving plant species that grows
28 in or near a body of water or wetland.

29 (4) "Bag limit" means the maximum number of game animals, game
30 birds, or game fish which may be taken, caught, killed, or possessed by
31 a person, as specified by rule of the commission for a particular
32 period of time, or as to size, sex, or species.

33 (5) "Closed area" means a place where the hunting of some or all
34 species of wild animals or wild birds is prohibited.

35 (6) "Closed season" means all times, manners of taking, and places
36 or waters other than those established by rule of the commission as an
37 open season. "Closed season" also means all hunting, fishing, taking,

1 or possession of game animals, game birds, game fish, food fish, or
2 shellfish that do not conform to the special restrictions or physical
3 descriptions established by rule of the commission as an open season or
4 that have not otherwise been deemed legal to hunt, fish, take, harvest,
5 or possess by rule of the commission as an open season.

6 (7) "Closed waters" means all or part of a lake, river, stream, or
7 other body of water, where fishing or harvesting is prohibited.

8 (8) "Commercial" means related to or connected with buying,
9 selling, or bartering.

10 (9) "Commission" means the state fish and wildlife commission.

11 (10) "Concurrent waters of the Columbia river" means those waters
12 of the Columbia river that coincide with the Washington-Oregon state
13 boundary.

14 (11) "Contraband" means any property that is unlawful to produce or
15 possess.

16 (12) "Deleterious exotic wildlife" means species of the animal
17 kingdom not native to Washington and designated as dangerous to the
18 environment or wildlife of the state.

19 (13) "Department" means the department of fish and wildlife.

20 (14) "Director" means the director of fish and wildlife.

21 (15) "Endangered species" means wildlife designated by the
22 commission as seriously threatened with extinction.

23 (16) "Ex officio fish and wildlife officer" means (~~(a commissioned~~
24 ~~officer of a municipal, county, state, or federal agency having as its~~
25 ~~primary function the enforcement of criminal laws in general, while the~~
26 ~~officer is in the appropriate jurisdiction. The term "ex officio fish~~
27 ~~and wildlife officer" includes special agents of the national marine~~
28 ~~fisheries service, state parks commissioned officers, United States~~
29 ~~fish and wildlife special agents, department of natural resources~~
30 ~~enforcement officers, and United States forest service officers, while~~
31 ~~the agents and officers are within their respective jurisdictions)):~~

32 (a) A commissioned officer of a municipal, county, or state agency
33 having as its primary function the enforcement of criminal laws in
34 general, while the officer is acting in the respective jurisdiction of
35 that agency;

36 (b) An officer or special agent commissioned by one of the
37 following: The national marine fisheries service; the Washington state
38 parks and recreation commission; the United States fish and wildlife

1 service; the Washington state department of natural resources; the
2 United States forest service; or the United States parks service, if
3 the agent or officer is in the respective jurisdiction of the primary
4 commissioning agency and is acting under a mutual law enforcement
5 assistance agreement between the department and the primary
6 commissioning agency;

7 (c) A commissioned fish and wildlife peace officer from another
8 state who meets the training standards set by the Washington state
9 criminal justice training commission pursuant to RCW 10.93.090,
10 43.101.080, and 43.101.200, and who is acting under a mutual law
11 enforcement assistance agreement between the department and the primary
12 commissioning agency; or

13 (d) A Washington state tribal police officer who successfully
14 completes the requirements set forth under RCW 43.101.157, is employed
15 by a tribal nation that has complied with RCW 10.92.020(2) (a) and (b),
16 and is acting under a mutual law enforcement assistance agreement
17 between the department and the tribal government.

18 (17) "Fish" includes all species classified as game fish or food
19 fish by statute or rule, as well as all fin fish not currently
20 classified as food fish or game fish if such species exist in state
21 waters. The term "fish" includes all stages of development and the
22 bodily parts of fish species.

32 (20) "Fishery" means the taking of one or more particular species
33 of fish or shellfish with particular gear in a particular geographical
34 area.

35 (21) "Freshwater" means all waters not defined as saltwater
36 including, but not limited to, rivers upstream of the river mouth,
37 lakes, ponds, and reservoirs.

1 (22) "Fur-bearing animals" means game animals that shall not be
2 trapped except as authorized by the commission.

3 (23) "Game animals" means wild animals that shall not be hunted
4 except as authorized by the commission.

5 (24) "Game birds" means wild birds that shall not be hunted except
6 as authorized by the commission.

7 (25) "Game farm" means property on which wildlife is held (~~(or)~~),
8 confined, propagated, hatched, fed, or otherwise raised for commercial
9 purposes, trade, or gift. The term "game farm" does not include
10 publicly owned facilities.

11 (26) "Game reserve" means a closed area where hunting for all wild
12 animals and wild birds is prohibited.

10 (47) "Saltwater" means those marine waters seaward of river mouths.

11 (48) "Seaweed" means marine aquatic plant species that are
12 dependent upon the marine aquatic or tidal environment, and exist in
13 either an attached or free floating form, and includes but is not
14 limited to marine aquatic plants in the classes Chlorophyta,
15 Phaeophyta, and Rhodophyta.

16 (49) "Senior" means a person seventy years old or older.

17 (50) "Shark fin" means a raw, dried, or otherwise processed
18 detached fin or tail of a shark.

19 (51)(a) "Shark fin derivative product" means any product intended
20 for use by humans or animals that is derived in whole or in part from
21 shark fins or shark fin cartilage.

6 (2) If a fish and wildlife officer, ex officio fish and wildlife
7 officer, or animal control authority, as defined in RCW 16.30.010, has
8 probable cause to believe that a person is negligently feeding,
9 attempting to feed, or attracting large wild carnivores to land or a
10 building by placing or locating food, food waste, or other substance
11 in, on, or about any land or building, and the food, food waste, or
12 other substance poses a risk to the safety of any person, livestock, or
13 pet because it is attracting or could attract large wild carnivores to
14 the land or building, that person commits an infraction under chapter
15 7.84 RCW.

16 (3) Subsection (2) of this section does not apply to:

17 (a) A person who is engaging in forest practices in accordance with
18 chapter 76.09 RCW or in hunting or trapping wildlife in accordance with
19 all other applicable provisions of this title or rules of the
20 commission or the director;

21 (b) A person who is engaging in a farming or ranching operation
22 that is using generally accepted farming or ranching practices
23 consistent with Titles 15 and 16 RCW;

24 (c) Waste disposal facilities that are operating in accordance with
25 applicable federal, state, and municipal laws;

26 (d) Entities listed in RCW 16.30.020(1) (a) through (j) and
27 scientific collection permit holders; or

28 (e) A fish and wildlife officer or employee or agent of the
29 department operating under the authority of or upon request from an
30 officer conducting authorized wildlife capture activities to address a
31 threat to human safety or a wildlife interaction as defined in RCW
32 77.36.010.

33 (4) For persons and entities listed in subsection (3) of this
34 section, a fish and wildlife officer, ex officio fish and wildlife
35 officer, or animal control authority, as defined in RCW 16.30.010, may
36 issue a written warning to the person or entity if:

37 (a) The officer or animal control authority can articulate facts to

1 support that the person or entity has placed or is responsible for
2 placing food, food waste, or other substance in, on, or about the
3 person's or entity's land or buildings; and

4 (b) The food, food waste, or other substance poses a risk to the
5 safety of any person, livestock, or pet because the food, food waste,

13 subsection fails to contain, move, or remove the food, food waste, or
14 other substance as directed, the person commits an infraction under
15 chapter 7.84 RCW.

16 NEW SECTION. **Sec. 39.** A new section is added to chapter 77.15 RCW
17 to read as follows:

18 (1) A person may not intentionally feed or attempt to feed large
19 wild carnivores or intentionally attract large wild carnivores to land
20 or a building.

21 (2) A person who intentionally feeds, attempts to feed, or attracts
22 large wild carnivores to land or a building is guilty of a misdemeanor.

23 (3) A person who is issued an infraction under section 38 of this
24 act for negligently feeding, attempting to feed, or attracting large
25 wild carnivores to land or a building, and who fails to contain, move,
26 or remove the food, food waste, or other substance within twenty-four
27 hours of being issued the infraction, is guilty of a misdemeanor.

3 NEW SECTION. **Sec. 41.** If any provision of this act or its
4 application to any person or circumstance is held invalid, the
5 remainder of the act or the application of the provision to other
6 persons or circumstances is not affected."

7 Correct the title.

EFFECT: Creates a defense to the crime of unlawful hunting, or
retrieving hunted wildlife from, the property of another for a person
who retrieves wildlife to avoid a violation of the unlawful waste of
fish or wildlife; changes the new crime of failure to show
identification to a peace officer involved in a natural resources
infraction detainment to a civil infraction; and makes a driver's
license one of the acceptable forms of identification (and not the only
one).
