- "Sec. 4. RCW 28B.122.010 and 2011 c 8 s 1 are each amended to read
 as follows:
- The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
 - (1) "Aerospace training or educational program" means a course in the aerospace industry offered ((either)) by the Washington aerospace training and research center ((either)), the Spokane aerospace technology center, or Renton technical college.
- 10 (2) (("Board" means the higher education coordinating board.
- (3)) "Eligible student" means a student who is registered for an aerospace training or educational program, is making satisfactory progress as defined by the program, and has a declared intention to work in the aerospace industry in the state of Washington.
 - (3) "Office" means the office of student financial assistance.
- 16 (4) "Participant" means an eligible student who has received an 17 aerospace training student loan.
- 18 (5) "Student loan" means a loan that is approved by the ((board))
 19 office and awarded to an eligible student.
- 20 **Sec. 5.** RCW 28B.122.020 and 2011 c 8 s 2 are each amended to read 21 as follows:
- 22 (1) The aerospace training student loan program is established.
- 23 (2) The program shall be designed in consultation with 24 representatives of aerospace employers, aerospace workers, and 25 aerospace training or educational programs.
- 26 (3) The program shall be administered by the ((board)) office. In 27 administering the program, the ((board)) office has the following 28 powers and duties:

- 1 (a) To screen and select, in coordination with representatives of 2 aerospace training or educational programs, eligible students to 3 receive an aerospace training student loan;
 - (b) To consider an eligible student's financial inability to meet the total cost of the aerospace training or educational program in the selection process;
 - (c) To issue low-interest student loans;
- 8 (d) To establish an annual loan limit equal to the cost of 9 attendance minus any other financial aid received;
- 10 (e) To define the terms of repayment, including applicable interest 11 rates, fees, and deferments;
- 12 (f) To collect and manage repayments from students who do not meet 13 their obligations under this chapter;
- 14 (g) To solicit and accept grants and donations from public and 15 private sources for the program; and
- 16 (h) To adopt necessary rules.

- 17 **Sec. 6.** RCW 28B.122.040 and 2011 c 8 s 4 are each amended to read 18 as follows:
- The ((board)) office may award aerospace training student loans to eligible students from the funds available in the aerospace training student loan account for this program. The amount of the student loan awarded an individual may not exceed tuition and fees for the program of study.
- 24 **Sec. 7.** RCW 28B.122.050 and 2011 c 8 s 5 are each amended to read 25 as follows:
 - (1) The aerospace training student loan account is created in the custody of the state treasurer. No appropriation is required for expenditures of funds from the account for student loans. An appropriation is required for expenditures of funds from the account for costs associated with program administration by the ((board)) office. The account is not subject to allotment procedures under chapter 43.88 RCW.
- 33 (2) The ((board)) <u>office</u> shall deposit into the account all moneys 34 received for the program. The account shall be self-sustaining and 35 consist of moneys received for the program by the ((board)) <u>office</u>, and 36 receipts from participant repayments, including principal and interest.

- 1 (3) Expenditures from the account may be used solely for student 2 loans to participants in the program established by this chapter and 3 costs associated with program administration by the ((board)) office.

 - (1) The ((board)) office, in collaboration with aerospace training or educational programs, shall submit an annual report regarding the aerospace training student loan program to the governor and to the appropriate committees of the legislature.
- 12 (2) The annual report shall describe the design and implementation 13 of the aerospace training student loan program, and shall include the 14 following:
 - (a) The number of applicants for loans;

- (b) The number of participants in the loan program;
- (c) The number of participants in the loan program who complete an aerospace training or educational program;

- (e) The nature of that employment, including: (i) The type of job;

 whether the job pays annual wages that are: (A) Less than thirty
 thousand dollars; (B) thirty thousand dollars or greater, but less than
 sixty thousand dollars; or (C) sixty thousand dollars or more; and

Adds language allowing the Aerospace Training Student Loan Program to be made available to students enrolled in the aerospace industry courses offered by Renton Technical College. Replaces references to the Higher Education Coordinating Board with references to the Office of Student Financial Assistance.
