21 The acceptance by the secretary of state or the county auditor is
22 conditional upon the document being filed in a timely manner, being
23 legible, and otherwise satisfying the requirements of state law or
24 rules with respect to form and content.

27 ~~original copy must be subsequently filed with the official with whom~~

4 **Sec. 2.** RCW 29A.04.311 and 2006 c 344 s 1 are each amended to read
5 as follows:

6 ((~~Nominating~~)) Primaries for general elections to be held in
7 November, and the election of precinct committee officers, must be held
8 on the ((~~third~~)) first Tuesday of the preceding August.

9 **Sec. 3.** RCW 29A.04.321 and 2009 c 413 s 2 are each amended to read
10 as follows:

11 (1) All state, county, city, town, and district general elections
12 for the election of federal, state, legislative, judicial, county,
13 city, town, and district officers, and for the submission to the voters
14 of the state, county, city, town, or district of any measure for their
15 adoption and approval or rejection, shall be held on the first Tuesday
16 after the first Monday of November, in the year in which they may be
17 called. A statewide general election shall be held on the first
18 Tuesday after the first Monday of November of each year. However, the
19 statewide general election held in odd-numbered years shall be limited
20 to (a) city, town, and district general elections as provided for in
21 RCW 29A.04.330, or as otherwise provided by law; (b) the election of
22 federal officers for the remainder of any unexpired terms in the
23 membership of either branch of the Congress of the United States; (c)
24 the election of state and county officers for the remainder of any
25 unexpired terms of offices created by or whose duties are described in
26 Article II, section 15, Article III, sections 16, 17, 19, 20, 21, 22,
27 and 23, and Article IV, sections 3 and 5 of the state Constitution and
28 RCW 2.06.080; (d) the election of county officers in any county
29 governed by a charter containing provisions calling for general county
30 elections at this time; and (e) the approval or rejection of state
31 measures, including proposed constitutional amendments, matters
32 pertaining to any proposed constitutional convention, initiative
33 measures and referendum measures proposed by the electorate, referendum
34 bills, and any other matter provided by the legislature for submission
35 to the electorate.

1 (2) A county legislative authority may call a special county
2 election by presenting a resolution to the county auditor prior to the
3 proposed election date. A special election called by the county
4 legislative authority shall be held on one of the following dates as
5 decided by such governing body:

6 (a) The second Tuesday in February;

7 (b) The third Tuesday in April until January 1, 2013;

8 (c) The fourth Tuesday in April on or after January 1, 2013;

16 election on a date set forth in subsection (2)~~((c) or)~~ (d) of this
17 section must be presented to the county auditor ~~((at least eighty-four~~
18 ~~days prior to the election date))~~ no later than the Friday immediately
19 before the first day of regular candidate filing. A resolution calling
20 for a special election on a date set forth in subsection (2)(e) of this
21 section must be presented to the county auditor no later than the day
22 of the primary.

23 (4) In addition to the dates set forth in subsection (2)(a) through
24 ~~((d))~~ (e) of this section, a special election to validate an excess
25 levy or bond issue may be called at any time to meet the needs
26 resulting from fire, flood, earthquake, or other act of God. Such
27 county special election shall be noticed and conducted in the manner
28 provided by law.

29 (5) This section shall supersede the provisions of any and all
30 other statutes, whether general or special in nature, having different
31 dates for such city, town, and district elections, the purpose of this
32 section being to establish mandatory dates for holding elections
33 ~~((except for those elections held pursuant to a home rule charter~~
34 ~~adopted under Article XI, section 4 of the state Constitution)).~~ This
35 section shall not be construed as fixing the time for holding primary
36 elections, or elections for the recall of any elective public officer.

1 **Sec. 4.** RCW 29A.04.330 and 2009 c 413 s 4, 2009 c 144 s 3, and
2 2009 c 413 s 3 are each reenacted and amended to read as follows:

3 (1) All city, town, and district general elections shall be held
4 throughout the state of Washington on the first Tuesday following the
5 first Monday in November in the odd-numbered years.

6 This section shall not apply to:

7 (a) Elections for the recall of any elective public officer;

8 (b) Public utility districts, conservation districts, or district
9 elections at which the ownership of property within those districts is
10 a prerequisite to voting, all of which elections shall be held at the
11 times prescribed in the laws specifically applicable thereto;

12 (c) Consolidation proposals as provided for in RCW 28A.315.235 and
13 nonhigh capital fund aid proposals as provided for in chapter 28A.540
14 RCW; and

15 (d) Special flood control districts consisting of three or more
16 counties.

17 (2) The county auditor, as ex officio supervisor of elections, upon
18 request in the form of a resolution of the governing body of a city,
19 town, or district, presented to the auditor prior to the proposed
20 election date, may call a special election in such city, town, or
21 district, and for the purpose of such special election he or she may
22 combine, unite, or divide precincts. Such a special election shall be
23 held on one of the following dates as decided by the governing body:

24 (a) The second Tuesday in February;

35 section must be presented to the county auditor ~~((at least eighty-four~~
36 ~~days prior to the election date))~~ no later than the Friday immediately
37 before the first day of regular candidate filing. A resolution calling

2 section must be presented to the county auditor no later than the day
3 of the primary.

4 (4) In addition to subsection (2)(a) through ~~((d))~~ (e) of this
5 section, a special election to validate an excess levy or bond issue
6 may be called at any time to meet the needs resulting from fire, flood,
7 earthquake, or other act of God, except that no special election may be
8 held between the first day for candidates to file for public office and
9 the last day to certify the returns of the general election other than
10 as provided in subsection (2)~~((e) and))~~ (d) and (e) of this section.
11 Such special election shall be conducted and notice thereof given in
12 the manner provided by law.

13 (5) This section shall supersede the provisions of any and all
14 other statutes, whether general or special in nature, having different
15 dates for such city, town, and district elections, the purpose of this
16 section being to establish mandatory dates for holding elections.

17 **Sec. 5.** RCW 29A.16.040 and 2004 c 266 s 10 are each amended to
18 read as follows:

19 The county legislative authority of each county in the state
20 hereafter formed shall, at their first session, divide their respective
21 counties into election precincts and establish the boundaries of the
22 precincts. The county auditor shall thereupon designate the voting
23 place for each such precinct or whether the precinct is a vote by mail
24 precinct.

25 (1) Precinct boundaries may be altered at any time as long as
26 sufficient time exists prior to a given election for the necessary
27 procedural steps to be honored. Except as permitted under subsection
28 (5) of this section, no precinct ~~((boundaries))~~ changes may be
29 ~~((changed))~~ made during the period starting ~~((on the thirtieth))~~
30 fourteen days prior to the first day for candidates to file for the
31 primary election and ending with the day of the general election.

32 (2) The county legislative authority may establish by ordinance a
33 limitation on the maximum number of active registered voters in each
34 precinct within its jurisdiction. The limitation may be different for
35 precincts based upon the method of voting used for such precincts and
36 the number may be less than the number established by law, but in no
37 case may the number exceed that authorized by law.

1 (3) Precincts in which voting machines or electronic voting devices
2 are used may contain as many as nine hundred active registered voters.
3 The number of poll-site ballot counting devices at each polling place
4 is at the discretion of the auditor. The number of devices must be
5 adequate to meet the expected voter turnout.

6 (4) On petition of twenty-five or more voters resident more than
7 ten miles from any polling site, the county legislative authority shall
8 establish a separate voting precinct therefor.

9 (5) The county auditor shall temporarily adjust precinct boundaries
10 when a city or town annexes unincorporated territory to the city or
11 town, or whenever unincorporated territory is incorporated as a city or
12 town. The adjustment must be made as soon as possible after the
13 approval of the annexation or incorporation. The temporary adjustment
14 must be limited to the minimum changes necessary to accommodate the
15 addition of the territory to the city or town, or to establish the
16 eligible voters within the boundaries of the new city or town, and
17 remains in effect only until precinct boundary modifications reflecting
18 the annexation or incorporation are adopted by the county legislative
19 authority.

20 (6) In determining the number of active registered voters for the
21 purposes of this section, persons who are ongoing absentee voters under
22 RCW 29A.40.040 shall not be counted. Nothing in this subsection may be
23 construed as altering the vote tallying requirements of RCW 29A.60.230.

24 **Sec. 6.** RCW 29A.24.040 and 2006 c 344 s 5 are each amended to read
25 as follows:

26 A candidate may file his or her declaration of candidacy for an
27 office by electronic means on a system specifically designed and
28 authorized by a filing officer to accept filings.

29 (1) Filings that are received electronically must capture all
30 information specified in RCW 29A.24.031 (1) through (4).

31 (2) Electronic filing may begin at 9:00 a.m. the first (~~Monday in~~
32 ~~June~~) day of the filing period and continue through 4:00 p.m. the

1 **Sec. 7.** RCW 29A.24.050 and 2006 c 344 s 6 are each amended to read
2 as follows:

3 Except where otherwise provided by this title, declarations of
4 candidacy for the following offices shall be filed during regular
5 business hours with the filing officer (~~((no earlier than the first~~
6 ~~Monday in June))~~ beginning the Monday two weeks before Memorial day and
7 (~~((no later than))~~) ending the following Friday in the year in which the
8 office is scheduled to be voted upon:

9 (1) Offices that are scheduled to be voted upon for full terms or
10 both full terms and short terms at, or in conjunction with, a state
11 general election; and

12 (2) Offices where a vacancy, other than a short term, exists that
13 has not been filled by election and for which an election to fill the
14 vacancy is required in conjunction with the next state general
15 election.

16 This section supersedes all other statutes that provide for a
17 different filing period for these offices.

18 **Sec. 8.** RCW 29A.24.131 and 2004 c 271 s 115 are each amended to
19 read as follows:

20 A candidate may withdraw his or her declaration of candidacy at any
21 time before the close of business on the (~~(Thursday))~~ Monday following
22 the last day for candidates to file under RCW 29A.24.050 by filing,
23 with the officer with whom the declaration of candidacy was filed, a
24 signed request that his or her name not be printed on the ballot.
25 There shall be no withdrawal period for declarations of candidacy filed
26 during special filing periods held under this title. (~~(The filing~~
27 ~~officer may permit the withdrawal of a filing for the office of~~
28 ~~precinct committee officer at the request of the candidate at any time~~
29 ~~if no absentee ballots have been issued for that office and the ballots~~

6 position or all persons filing such valid declarations of candidacy
7 have died or been disqualified.

17 **Sec. 13.** RCW 29A.24.311 and 2004 c 271 s 117 are each amended to
18 read as follows:

19 Any person who desires to be a write-in candidate and have such
20 votes counted at a primary or election may file a declaration of
21 candidacy with the officer designated in RCW 29A.24.070 not later than
22 the day ~~((before the primary or election))~~ ballots must be mailed
23 according to RCW 29A.40.070. Declarations of candidacy for write-in
24 candidates must be accompanied by a filing fee in the same manner as
25 required of other candidates filing for the office as provided in RCW
26 29A.24.091.

27 Votes cast for write-in candidates who have filed such declarations
28 of candidacy and write-in votes for persons appointed by major

14 unless that candidate qualifies to have his or her name printed on the
15 general election ballot. The legislative authority of any jurisdiction
16 producing a local voter's pamphlet under chapter 29A.32 RCW may
17 provide, by ordinance, for the inclusion of write-in candidates in such
18 pamphlets.

19 **Sec. 14.** RCW 29A.28.041 and 2006 c 344 s 12 are each amended to
20 read as follows:

21 (1) Whenever a vacancy occurs in the United States house of
22 representatives or the United States senate from this state, the
23 governor shall order a special election to fill the vacancy. Minor
24 political party candidates and independent candidates may be nominated
25 through the convention procedures provided in chapter 29A.20 RCW.

26 (2) Within ten days of such vacancy occurring, he or she shall
27 issue a writ of election fixing a date for the (~~(special vacancy
