Background: Under current law, military service means a service member under a call to active service authorized by the President of the United States or the Secretary of Defense for a period of more than 30 consecutive days. Military service members and their dependents are provided protection against default judgments, judgments given as a result of the defendant's failure to appear.

Summary of Bill (Recommended Substitute): Military service includes National Guard members under a call to service authorized by the Governor for a period of more than 30 consecutive days.

Protection against default judgments is provided to service members, their dependents, and National Guard members under a call to active service authorized by the Governor of the state of Washington.

Senate Bill Report - 1 - SB 5627

This analysis was prepared by non-partisan legislative staff for the use of legislative members in their deliberations. This analysis is not a part of the legislation nor does it constitute a statement of legislative intent.

EFFECT OF CHANGES MADE BY JUDICIARY COMMITTEE (Recommended Substitute): A technical change is made with regard to terminology, i.e. changes the word person to service member.

The word emergency is removed so that service members and National Guard members under a call to service for a 30-day period are protected against default judgments even if the call is not for emergency service.

Effective Date: Ninety days after adjournment of session in which bill is passed.

Staff Summary of Public Testimony on Original Bill: PRO: This bill clears up oversights in the current statute. It includes National Guard members as those who can be protected against default judgments while they are away on active service.
