1 AN ACT Relating to extending the expiration of the agency council
2 on coordinated transportation; amending RCW 47.06B.900 and 47.06B.901;
3 providing an effective date; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 47.06B.900 and 2009 c 515 s 17 are each amended to
6 read as follows:

7 The agency council on coordinated transportation is terminated on
8 June 30, (~~(2011, as provided in RCW 47.06B.901)~~) 2013.
