18 program. The review shall examine workplace safety inspection,  
19 enforcement, training, and outreach efforts compared to other states

(2) By December 1, 2011, the office of public defense shall submit to the appropriate policy and fiscal committees of the legislature a proposal for office of public defense to assume the effective and efficient administration of defense services for indigent persons throughout the state who are involved in proceedings under chapter 71.09 RCW. In developing its proposal, the office of public defense should consult with interested stakeholders, including the King county public defender, the Washington defender association, the Washington association of criminal defense lawyers, the administrative office of the courts, the superior court judges association, the office of the attorney general, the King county prosecuting attorney, the Washington association of counties, and the department of social and health services. At a minimum, the proposal should identify:

(a) Procedures to control costs and require accountability, consistent with the state's obligation to ensure the right to counsel under both the United States Constitution and the Washington Constitution;

(b) Appropriate practice standards for trial-level defense of indigent persons involved in proceedings under chapter 71.09 RCW, an estimated number of attorneys statewide who are qualified to provide such representation, and reasonable compensation for such defense services;

(c) The total budget necessary to implement the proposal statewide for fiscal year 2013, including administrative support; and

(d) Possible savings to the state and counties that might result from implementing the proposal.

12 grades 9-12 but no more than twenty-five average annual full-time

26 (1)(a) The monthly employer funding rate for insurance benefit  
27 premiums, public employees' benefits board administration, and the  
28 uniform medical plan, shall not exceed \$850 per eligible employee for  
29 fiscal year 2012. For fiscal year 2013 the monthly employer funding  
30 rate shall not exceed (~~(\$850)~~) \$800 per eligible employee.

31 (b) In order to achieve the level of funding provided for health  
32 benefits, the public employees' benefits board shall require any or all  
33 of the following: Employee premium copayments, increases in point-of-  
34 service cost sharing, the implementation of managed competition, or  
35 make other changes to benefits consistent with RCW 41.05.065.

36 (c) The health care authority shall deposit any moneys received on  
37 behalf of the uniform medical plan as a result of rebates on

1 prescription drugs, audits of hospitals, subrogation payments, or any  
2 other moneys recovered as a result of prior uniform medical plan claims  
3 payments, into the public employees' and retirees' insurance account to  
4 be used for insurance benefits. Such receipts shall not be used for  
5 administrative expenditures.

6 (2) The health care authority, subject to the approval of the  
7 public employees' benefits board, shall provide subsidies for health  
8 benefit premiums to eligible retired or disabled public employees and  
9 school district employees who are eligible for medicare, pursuant to  
10 RCW 41.05.085. For calendar years 2012 and 2013, the subsidy shall be

14 **LOCAL GOVERNMENT FINANCING**

15 (1) This act assumes adoption of separate local government finance  
16 legislation that changes the relationship between the state and local  
17 governments by reducing state support both in this act and the assumed  
18 legislation for selected areas while giving local governments  
19 additional local taxing authority to offset, at least in part, the  
20 reduction in state support. A contingency fund is created in the  
21 assumed legislation, managed by the office of financial management, to  
22 provide additional assistance to local governments who have used the

20 that impose the mental health/chemical dependency sales and use tax in  
21 the future.

22 (e) Counties may impose up to a 6 percent utility tax.

26 partnership under RCW 90.71.310, and except as otherwise provided in  
27 RCW 79.105.630, and effective one calendar year following the  
28 development and statewide availability of model evergreen community  
29 management plans and ordinances under RCW 35.105.050, whether the  
30 applicant is an entity that has been recognized, and what gradation of  
31 recognition was received, in the evergreen community recognition  
32 program created in RCW 35.105.030 in its prioritization and selection  
33 process; and

34 (c) Develop appropriate outcome-focused performance measures to be  
35 used both for management and performance assessment of the grants.

36 (3) To the extent possible, the department should coordinate its  
37 performance measure system with other natural resource-related agencies  
38 as defined in RCW 43.41.270.

1 (4) The department shall consult with affected interest groups in  
2 implementing this section.

3 (5) After January 1, 2010, any project designed to address the  
4 restoration of Puget Sound may be funded under this chapter only if the  
5 project is not in conflict with the action agenda developed by the  
6 Puget Sound partnership under RCW 90.71.310.

7 **Sec. 925.** RCW 80.01.080 and 2010 1st sp.s. c 37 s 950 are each  
8 amended to read as follows:

9 There is created in the state treasury a public service revolving  
10 fund. Regulatory fees payable by all types of public service companies  
11 shall be deposited to the credit of the public service revolving fund.  
12 Except for expenses payable out of the pipeline safety account, all  
13 expense of operation of the Washington utilities and transportation  
14 commission shall be payable out of the public service revolving fund.

15 During the ((2009-2011)) 2011-2013 fiscal biennium, the legislature  
16 may transfer from the public service revolving fund to the state  
17 general fund such amounts as reflect the excess fund balance of the  
18 fund.

19 **Sec. 926.** 2010 c 23 s 205 (uncodified) is amended to read as  
20 follows:

21 (1) The legislature finds that this state's tax policy with respect  
22 to the taxation of transactions between affiliated entities and the  
23 income derived from such transactions (intercompany transactions) has  
24 motivated some taxpayers to engage in transactions designed solely or  
25 primarily to minimize the tax effects of intercompany transactions.  
26 The legislature further finds that some intercompany transactions  
27 result from taxpayers that are required to establish affiliated  
28 entities to comply with regulatory mandates and that transactions  
29 between such affiliates effectively increases the tax burden in this  
30 state on the affiliated group of entities.

31 (2) Therefore, as existing resources allow, the department of  
32 revenue is directed to conduct a review of the state's tax policy with  
33 respect to the taxation of intercompany transactions. The review must  
34 include the impacts of such transactions under the state's business and  
35 occupation tax and state and local sales and use taxes. The department  
36 may include other taxes in the review as it deems appropriate.

1 (3) In conducting the review, the department must examine how this  
2 state's tax policy compares to the tax policy of other states with  
3 respect to the taxation of intercompany transactions. The department's  
4 review must include an analysis of potential alternatives to the  
5 current policy of taxing intercompany transactions, including their  
6 estimated revenue impacts if practicable.

7 (4) In conducting this review, the department may seek input from  
8 members of the business community and others as it deems appropriate.

9 (5) The department must report its findings to the fiscal  
10 committees of the house of representatives and senate by December 1,  
11 2010. However, if the department has not completed its review by  
12 December 1, 2010, the department must provide the fiscal committees of  
13 the legislature with a brief status report by December 1, 2010, and the  
14 final report by December 1, (~~2011~~) 2012.

15 NEW SECTION. **Sec. 927.** A new section is added to 2011 1st sp.s.  
16 c 50 (uncodified) to read as follows:

17 Chapter 50, Laws of 2011 1st sp. sess. (the biennial operating  
18 budget) included funding for the pension system cost of legislation  
19 adopted during the 2011 session of the legislature. No supplemental  
20 rates are authorized for funding that legislation during the remainder  
21 of the 2011-2013 fiscal biennium. Pension contribution rates for the  
22 public employees' retirement system, the public safety employees'  
23 retirement system, the school employees' retirement systems, and the  
24 teachers' retirement system are established.

25 (1) For the public employees' retirement system:

26 (a) Beginning April 1, 2012, an employer contribution rate of 7.08  
27 percent shall be charged;

28 (b) Beginning July 1, 2012, an employer contribution rate of 7.21  
29 percent shall be charged.

30 (2) For the public safety employees' retirement system:

31 (a) Beginning April 1, 2012, an employer contribution rate of 8.74  
32 percent shall be charged;

33 (b) Beginning July 1, 2012, an employer contribution rate of 8.87  
34 percent shall be charged.

35 (3) For the school employees' retirement system:

36 (a) Beginning April 1, 2012, an employer contribution rate of 7.58  
37 percent shall be charged;

1 (b) Beginning September 1, 2012, an employer contribution rate of  
2 7.59 percent shall be charged.

3 (4) For the teachers' retirement system:

4 (a) Beginning April 1, 2012, an employer contribution rate of 8.04  
5 percent shall be charged; and

6 (b) Beginning September 21, 2012, an employer contribution rate of  
7 8.05 percent shall be charged.

8 These rates are inclusive of a department of retirement systems  
9 expense charge of 0.16 percent. The department of retirement systems  
10 shall collect employee contributions as provided in chapter 41.45 RCW.

11 NEW SECTION. **Sec. 928.** If any provision of this act or its  
12 application to any person or circumstance is held invalid, the  
13 remainder of the act or the application of the provision to other  
14 persons or circumstances is not affected.

15 NEW SECTION. **Sec. 929.** This act is necessary for the immediate  
16 preservation of the public peace, health, or safety, or support of the  
17 state government and its existing public institutions, and takes effect  
18 immediately.
