1            AN ACT Relating to special license plates with a special year tab  
2 for persons with disabilities; and amending RCW 46.19.060.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4            **Sec. 1.** RCW 46.19.060 and 2011 c 171 s 75 are each amended to read  
5 as follows:

6            (1) An additional fee may not be charged for special license plates  
7 for persons with disabilities except for any other fees and taxes  
8 required to be paid upon registration of a motor vehicle.

9            (2) A registered owner who qualifies for special parking privileges  
10 as described in RCW 46.19.010 may apply to the department for special  
11 license plates for persons with disabilities or special license plates  
12 with a special year tab for persons with disabilities. Special license  
13 plates with a special year tab for persons with disabilities are

23 (3) A registered owner who chooses to purchase special license  
24 plates as described in subsection (2) of this section shall pay the  
25 applicable special license plate fee, in addition to any other fees or  
26 taxes required for registering a motor vehicle.

27 (4) Special license plates for persons with disabilities or special  
28 license plates with a special year tab for persons with disabilities  
29 must be renewed in the same manner and at the time required for the  
30 renewal of standard motor vehicle license plates under chapter 46.16A  
31 RCW.

32 (5) Special license plates for persons with disabilities or special  
33 license plates with a special year tab for persons with disabilities  
34 may be transferred from one motor vehicle to another motor vehicle  
35 owned by the person with the parking privilege upon application to the  
36 department, county auditor or other agent, or subagent appointed by the  
37 director.

1           (6) Special license plates for persons with disabilities or special  
2 license plates with a special year tab for persons with disabilities  
3 must be removed from the motor vehicle when the person with  
4 disabilities transfers or assigns his or her interest in the motor  
5 vehicle.
